Councillor Bloch urged the Sub-Committee to limit the sale of alcohol to patrons who purchased meals at the premises and to impose a condition limiting patrons to use the outside area of the premises until 20:00hrs.

In response to the Sub-Committee's questions it was noted that the nearest residential property was approximately 30 yards away from the premises.

The Sub-Committee noted the statement of Mr Hindrich, Muswell Hill road Resident, objecting to the application being granted in full on the grounds of noise nuisance and public safety; the premises was in an unlit area, which was not policed and the ground was uneven and could be dangerous to those intoxicated with alcohol.

Sub-Committee members, officers and the applicant had no questions for Mr Hindrich.

The Sub-Committee noted the statement of Mr McLean, Muswell Hill Road resident, suggesting that alcohol should only be served for consumption inside the premises, which was near to a children's playground, in order to protect children from potential harm.

Sub-Committee members, officers and the applicant had no questions for Mr McLean.

The Sub-Committee noted the statement of local resident, Mr Harvey, requesting definition of the conditions of the application and objecting to the license being granted in full as it could impact local streets due to there being no parking management plan included in the application and potential danger to local wildlife caused by litter being left in the area.

Sub-Committee members, officers and the applicant had no questions for Mr Harvey.

The Sub-Committee noted the statement of local resident, Mr Johns, who raised concerns about noise disturbance and urged the Sub-Committee to not grant the licence in full.

Sub-Committee members, officers and the applicant had no questions for Mr Johns.

The Sub-Committee noted the statement of the Applicant, Mr Shelmerdine, including that that the premises ran as a community project and was eco-friendly but required the licence to be granted to improve financial turnover. The Applicant assured the Sub-Committee that there was no intention of the premises becoming a pub or nightclub of any sort and all evening activities in the premises would be private functions.

In response to some of the objections included in the agenda pack, the Applicant stated that the relevant notices advertising the application had been displayed. Regarding concerns surrounding noise and disturbance the Applicant emphasised that he did not wish for the premises to

become a nuisance to neighbours and there had been no history of complaints in the past 12 year and the premises had supplied alcohol at private functions under a previous licence for 6 of those years.

In response to questions from objectors, the Applicant:

- accepted that there had been 2 previous complaints about noise from children at the premises and he had accepted the conditions of the Noise Team in order to prevent this.
- stated that if alcohol sales were limited to consumption with the sale of food it would have a substantial financial impact on the premises over the course of a year.

In response to Councillor Reid's concern that the site was not well lit, the Applicant accepted responsibility for ensuring the safety of patrons and assured members that staff would be trained and instructed as required. The Applicant confirmed that there was flood-lighting (using sensors) around the premises and lighting on the veranda and when there were events, sometimes additional lighting was used.

In response to Cllr Reid's suggestion for the premises to use door supervisors the Applicant informed the Committee that staff members were always available to deal with any arising situation and that there was never likely to be more than 50 people at the premises at any one time.

Councillor Adamou asked how the venue dealt with litter, particularly that which might be thrown into the children's playground area. The Applicant explained that the premises utilised recycling facilities and event organisers were charged for the clearing of litter after an event, although there were not usually any empty cans or bottles thrown in the surrounding area.

In response to Councillor Reid's question, the Applicant confirmed that no amplified music would be played outside the venue but that the application included non-amplified music to be permitted outside until midnight.

All interested parties were given the opportunity to summarise their previous submissions and no new information was presented.

The Sub-Committee adjourned at 20:35 hrs to deliberate and reconvened at 21:35.

### RESOLUTION

The Sub-Committee fully considered the application, the objectors' representations, the representations of the applicant and those of the responsible authorities. The Committee also gave regard to the borough's Statement of Licensing Policy and the Section 182 guidance.

The Sub-Committee decided to grant the application but only subject to a number of conditions. It was considered that the imposition of the following conditions would be sufficient to promote the licensing

	objectives and that the application should therefore not be refused outright.	
	The conditions proposed in the operating schedule are imposed unless they contradict the following additional conditions:	
	• The premises will close no later than 11pm on Sundays to Thursdays and at no later than midnight on Fridays and Saturdays. Alcohol, however, will cease to be served no less than one hour before all closing times.	
	• The conditions proposed by the police in relation to required proof of age are imposed as is the implementation of the Challenge 21 scheme volunteered by the Applicant.	
	• The conditions proposed by the Noise Team are imposed except that windows will not be required to remain closed at all times on the strict condition that no music played in the premises is audible at or within the site boundary of any residential property.	
	In addition, staff are to encourage patrons to not congregate outside the premises and to remain inside the premises after 10.30pm on all days except to go out for short periods of time for example for those patrons who may wish to smoke.	
	<ul> <li>Recorded music may only be played indoors.</li> </ul>	
	<ul> <li>Non-amplified live music may be played indoors during operating hours and also outdoors but only until 9pm on Sundays to Thursdays and until 10pm on Fridays and Saturdays. The Committee considered it to be unduly restrictive to impose an outright ban at all times on the playing of non-amplified live music outdoors, for example, the playing of a guitar.</li> </ul>	
	• The erection of any tents is not permitted.

variation for the provision of regulated entertainment: live music and anything of a similar description to that of live or recorded music for the hours:

Friday to Saturday:2000 to 0100Sunday:2000 to 2330

The licence was subject to all conditions attached to the existing licence, and the following additional conditions:

- i) All doors and windows shall remain closed during the regulated entertainment licensed activities or in any event after 11pm. The entrance door will be fitted with a self-closing device and staff required to ensure that it is not propped open. A member of staff shall be made responsible to ensure the door is opened for as brief a period as possible. Where necessary, adequate and suitable mechanical ventilation should be provided to public areas.
- ii) All speakers to be mounted on anti-vibration mountings to prevent vibration transmission of sound energy to adjoining properties.
- iii) Entrance and exit from the premises whilst regulated entertainment licensable activities are ongoing shall be via a lobbied door to minimise noise breakout.
- iv) The licensee shall ensure that no music played in the licensed premises is audible at or within the site boundary of any residential property, including any noise escaping the rear sky light.
- All regulated entertainment amplified activity will utilise the in-house amplification system, the maximum output of which is controlled by the duty manager.
- vi) No music shall be played in, or for the benefit of patrons in external areas of the premises.
- vii) No form of loudspeaker or sound amplification equipment is to be sited on or near the exterior premises or in or near any foyer, doorway, window or opening to the premises.
- viii) Signs shall be displayed in the external areas / on the frontage requesting patrons to recognise the residential nature of the area and conduct their behaviour accordingly. The management must reserve the right to ask patrons to move inside the

premises or leave if it is felt that they could be disturbing neighbours.

- ix) Deliveries and collections associated with the premises shall be arranged between the hours of 8am and 8pm so as to minimise the disturbance caused to neighbours.
- x) Empty bottles and non-degradable refuse shall remain in the premises at the end of trading hours and taken out to the refuse point at the start of the working day rather than at the end of trading when neighbours might be unduly disturbed.
- xi) All plant and machinery shall be correctly maintained and regularly serviced to ensure that it is operating efficiently and with minimal disturbance to neighbours arising from noise.
- xii) A complaints book shall be held on the premises to record details of any complaints received from neighbours. The information is to include, where disclosed, the complainants name, location, date, time and subsequent remedial action undertaken. This record must be made available at all times for inspection by council officers.
- xiii) Where people queue to enter the premises, a licensed door supervisor shall supervise and ensure the potential patrons behave in an acceptable manner.
- xiv) Signs should be displayed requesting patrons to respect the neighbours and behave in a courteous manner.
- xv) When licensable live entertainment is occurring, a licensed door supervisor shall be so positioned at the entrance and exit door to prevent unwanted persons entering the premises.
- xvi) When the premises turn out, a licensed door supervisor shall supervise patrons and ensure that they leave in a prompt and courteous manner, respecting the neighbours.
- xvii) A licensed door supervisor shall be positioned on the exit door to ensure, as far as reasonably practicable, that patrons do not leave with drinks.

SLSC06.	APPLICATION FOR A REVIEW OF A PREMISES LICENCE AT KARMENZ RESTAURANT, 192 STROUD GREEN ROAD, N4 The Licensing Officer, Ms Barrett, presented the report on an application by Environmental Health (Noise) Team for a review of Karmenz Restaurant, 192 Stroud Green Road, London N4 on the grounds of the licensing objectives Prevention of Public Nuisance and Prevention of Crime and Disorder in relation to complaints regarding noise, patrons congregating on footpaths, unlicensed activities and operating beyond the permitted hours. Ms Barrett reported that a variation to the existing premises licence had been applied for and heard at a meeting in May 2009, at which a number of representations had been submitted by local residents. A varied licence, including the provision of regulated entertainment and an extension of opening hours, had been granted on condition that the new licence could not be used until an acoustic report had been submitted and a number of works carried out. It was reported that, despite this condition not being complied with, regulated entertainment had been taking place at the premises, and letters had been sent to the licensee reminding them of the need to comply with the conditions of the varied licence before this could come into force.

In response to a point raised by a local resident, Ms Barrett confirmed that the original date for the hearing had been cancelled due to the unavailability of the parties, and that all parties had been informed immediately of the re-scheduled date.

Mr Malcolm, Enforcement Response Service Manager, confirmed that the review had been sought on the grounds of the prevention of public nuisance and the prevention of crime and disorder. Mr Malcolm reported that instances of noise nuisance, disorder, unlicensed activities and exceeding the permitted opening hours had been witnessed and that the review had been called as a result of the numerous complaints received regarding the premises. An application for a licence variation for regulated entertainment and increased hours had been agreed by the licensing committee in May 2009, but conditions had been imposed on the new licence which had not been complied with. Mr Malcolm reported that the Council was not satisfied that the acoustic requirements had been met and that a letter had been sent to the licensee to remind her of the need to comply with the conditions of the varied licence. Mr Malcolm presented a summary of the occasions on which the noise team had attended the premises in response to complaints. and requested that the Committee revoke the licence as the licensee had shown disregard for the Licensing Act and the licensing objectives.

In response to a question from the Committee, Mr Malcolm confirmed that the noise team was not satisfied that the acoustic work undertaken was compliant, as it had not been possible to set the sound limiter at the nearest premises due to the refusal of the resident of the nearest property. Mr Malcolm clarified that this would mean that the original premises licence was still in force, as the conditions of the varied licence had yet to be met. In response to a question from the Committee regarding the application of the licensing objective relating to crime and disorder, Ms Barrett confirmed that case law had established that operating licensable activities for which a licence was not held constituted a criminal offence.

The licensee's representative asked when the Council had formally advised the licensee that the acoustic work undertaken was not acceptable. Mr Malcolm referred to correspondence sent from the Council to Ms Singh reminding her of the need to comply with the conditions of the varied licence, and advised that he had spoken in person to the licensee to explain that the acoustic report was not acceptable to the Council, but did not have a record of when this conversation had taken place. The licensee's representative asked what the specific licensing offences

were on the occasions referred to in the noise team's representation. Mr Malcolm reported that the offences were opening beyond the permitted hours and carrying out a licensable activity for which no licence was in place, namely regulated entertainment. In response to a request from the licensee's representative, Mr Malcolm clarified that music was audible from the premises at 0300 on 23 August 2009 and that music was audible on 6 September 2009.

Joyce Golder, Legal Services, asked whether there was a record of whether the licensee had been spoken to personally, on the occasions listed in the schedule, regarding the concerns raised. Mr Malcolm referred to the correspondence and notes from the occasions listed and reported that a letter had been sent on 20 July 2009, referring to the events of 18 July, but that there was no note of the discussion held with the licensee. It was noted that a discussion had been held with the licensee regarding music being played on 23 August 2009, but no letter relating to this incident was on file. There was no record on file regarding discussions held on the other occasions listed. Mr Malcolm reported that, as standard, a letter should be sent to follow up discussion with a licensee regarding any licensing breach, by first class post to their home address and business premises, copies of which should be kept on file. Ms Golder asked whether there was any record of the licensee stating that an acoustic report had already been submitted in the course of any of the conversations with the noise team, and it was reported that there was no record of this.

A local resident referred to local concerns regarding noise nuisance and litter from the premises, and gave details of the dates on which he had called the noise team regarding noise nuisance from the premises, outside of its licensed opening hours. It was reported that the premises was quiet during the week, but caused a lot of noise and disturbed local residents at weekends. It was also reported that customers of the premises standing in the alleyway outside made this access very threatening.

In response to a question from the licensee's representative, the local resident reported that the noise team had visited the premises in response to his calls, but had not been inside his home to assess the noise nuisance.

The licensee's representative reported that it was notable that the police had not made any representation, as crime and disorder was one of the grounds on which the review had been brought. He reported that further information on the case-law relating to the operation of licensable activities for which a licence was not in force was needed before he

would accept the point that this constituted crime and disorder under the Licensing Act. It was reported that the licensee had managed the premises for a period of five years, and had carried out the acoustic work required by the Council at the previous hearing, but had not been advised by the Council that the work undertaken was not sufficient. The licensee's representative suggested that the work carried out was sufficient, as steps had been taken to adjust the sound limiter to a reasonable level. He reported that the occupant of the nearest sound sensitive premises was within their right not to comply, in which case it would be necessary to set the limiter to the next nearest property. It was reported that the licensee had submitted an acoustic report and, having never been notified by the Council that this was not acceptable, had assumed that this was satisfactory. The licensee reported that she had not been receiving all her post and had advised the Council of this.

The licensee's representative contended that it was not an offence for the licensee to operate beyond the permitted opening hours if no licensable activities were taking place. It was reported that the licensee was trying to address the residents' concerns regarding noise nuisance but it was noted that no statutory nuisance had been observed from within residents' homes and that the complaints received were from before the installation of the sound limiter. There were still some minor works to address noise issues to be completed, and the licensee was willing to offer further conditions to address the concerns of residents, for example limiting the number of smokers permitted outside at any one time to five. It was reported that the licensee was in difficult personal circumstances, and that during this time she would be happy to agree for someone else to replace her as DPS at the premises.

A local resident asked how the licensee proposed to address the issue of the premises opening beyond its agreed hours, in response to which the licensee's representative agreed that on occasion the opening hours had been exceeded and that a new DPS would ensure that management arrangements were stronger to make sure that hours were not exceeded. It was also suggested that local residents could be given prior warning of any private parties that would be going on late. The licensing officer clarified that if there was any charge to hire the room or for attendance then music and dancing would constitute licensable activities and would be covered by licensing law, regardless of whether these were called private parties. The licensee's representative confirmed that the parties referred to were for family and friends, for which no charge at all was made, and were therefore not licensable. The licensee offered to cease holding any private parties in the premises

if this was a concern, as a concession to local residents.

In response to a question from the Committee, it was reported that the licensee had delivered the acoustic report by hand in July, as soon as it was received, and Mr Malcolm confirmed that the report had been received by the Council on 20 July 2009. The Committee asked whether the licensee had told the Council that she was not receiving her post. in response to which the licensee reported that she had advised the Council of this but was not sure when this was and that it may have been when the acoustic report was hand-delivered. In response to a question from the Committee regarding the licensee's understanding of the conditions imposed when the variation of the licence was granted in May 2009, it was reported that the licensee believed that once the acoustic report had been submitted, the condition had been complied with. The licensee accepted that this had been a misunderstanding. In response to a question from the legal officer, the licensee reported that she had never received a letter accepting the acoustic report submitted, and that she could not recall whether she had received written confirmation of the decision of the Committee in May 2009. The licensee's representative confirmed that the licensee had not been receiving all her post, and that her understanding of the decision of the meeting of the Licensing Sub Committee she had attended in May 2009 was not as clear as it could have been.

In response to a question from the Committee, the licensee's representative expressed concern regarding the inconsistency in the evidence of offences provided by the noise team. The licensee was able to confirm that three of the occasions were private parties held at the venue, but that she did not recall the other occasions listed.

Ms Golder reported that a variation to the licence had been granted in May to permit the provision of regulated entertainment, but that this was not to be used until such time as a scheme of works drawn up by acoustic consultants had been implemented to the satisfaction of the Council. Although the premises had been operating as though the varied licence was in force, it was reported that, as the conditions on which the variation had been agreed had not been complied with, the variation should not yet be used. Ms Golder advised that the crime and disorder licensing objective could be taken into account without representations being received from the Police, and that it had been established that the issues of crime and disorder could be considered separately from one another. The licensee's representative reported that there was no evidence of any criminal offence in the documentation.

In conclusion, the local resident stated that until the licensee could prove their ability to comply with the conditions in place on the licence, there should be no extension to the licensable activities.

Mr Malcolm reiterated the grounds for the review and urged the Committee to revoke the licence or impose stringent measures until the licensee had demonstrated that they would comply with the licence conditions.

The licensee's representative concluded by asking the Committee not to revoke the licence. He reported that the licensee had been going through a difficult time and believed that she had complied with the conditions of the licence in fitting a sound limiter and that she now fully understood that no regulated entertainment could be used until the acoustic works had been approved by the Council. It was also stated that the additional conditions offered by the licensee should address the concerns of local residents. The Committee was asked to exercise their discretion, and to realise that in revoking the licence they would be taking away a large part of the licensee's income.

The Committee adjourned to deliberate.

The Committee reconvened, and the legal officer made representations on the status of the varied licence which, it was contended, had no status as the conditions on which it was based had not been met. It was suggested, on this basis, that the only licence in force was the original licence which did not include regulated entertainment, and that this was the only licence that could be considered by the Committee under this review. The licensee's representative disagreed with this position and did not accept that the varied licence granted in May had no status. The licensee's representative stated that this was a decision for the Committee to take.

### RESOLVED

The special licensing sub committee considered quite a novel point in relation to the matter at the hearing. The brief background was that Karmenz Restaurant had a premises licence, number LN00002125, permitting the supply of alcohol and provision of late night refreshment, the opening hours of the premises being Monday to Saturday 0800 to 0000, Sunday and Bank Holidays 0800 to 2300, and subsequently applied for a variation to the aforementioned licence on the 14 May 2009, principally to include the provision of regulated entertainment, namely live and recorded music and an increase in opening hours of the

premises. Whilst this was granted by the Committee, it was conditional on the applicant implementing a scheme approved by a noise consultant to the satisfaction of the Council and on both the licence and the written decision it stated that the applicant could not use the premises licence until she had satisfied that condition. It was made clear in evidence provided by the authority and the applicant herself that, despite the applicant being confused as to the meaning of the condition, the Council had not to date shown themselves to be satisfied that that condition had been met. The Committee therefore considered the varied licence not to be in force and that it therefore could not be reviewed. The Committee reverted to the only premises licence currently in force, to consider the application for review made by the Environmental Health Noise Team.

Based on the representations heard by all parties at the hearing, and with due weight given to all representations, it was the Committee's decision to suspend the original premises licence for a period of two months, namely until the 25<sup>th</sup> January 2010, effective immediately, at which time the applicant would then be permitted to operate under that premises licence number LN00002125. The Committee gave the applicant the opportunity to operate under the premises licence number LN00003217, dated 14 May 2009, from the 25<sup>th</sup> January 2010 only if its conditions were met to the satisfaction of the Council, which satisfaction should be conveyed in writing by the Council to the applicant. Until such time, the varied premises licence would not take effect.

The Committee's reasons for the decision to suspend the premises licence for two months was because the Committee had given due weight to the representations given by the noise team and the local resident under the prevention of public nuisance licensing objective. The Committee felt that these were compelling and clearly outlined a serious concern and therefore warranted a serious response. The Committee reminded the applicant of the responsibilities imposed on her as the premises licence holder and DPS to ensure compliance with the Licensing Act 2003 at all times.

The meeting closed at 22:00hrs.







My grounds for objection are that I understand that the sale and consumption of alcohol, particularly on street, can easily lead, if not necessarily to crime and disorder, at the least to antisocial behaviour and public nuisance. For some time, in recent years, there was a problem of minor youth vandalism on this corner, which has, with the considerable help of the SNT, finally been dealt with. Making alcohol more freely available could easily lead to the resumption of this kind of behaviour. There are already some complaints about street drinking associated with the Elementz bar 50 yards up the road from Eros.

The ample supply of alcohol for sale in the immediate vicinity, either in off sales or in bars and pubs, would seem to be sufficient for anyone except the most desperate and hardened drinkers (not people who we particularly wish to see hanging about in this residential area). I am a woman living on my own, frequently walking home from the bus stops, and am already wary of the odd knots of youths who hang around from time to time; if more alcohol was readily available, I suspect that after about 11.30 the area could begin to feel a bit threatening.

Furthermore, the applicant does not appear to have in any way taken account of the fact that the extension of sales hours is likely to affect the type of people who buy from him and where/when they will consume the alcohol. He has made no effort at all to complete Part P of the form. This he should certainly be asked to do.

Also I know that a number of my constituents in the ward share my feelings. Unfortunately the short notice for objections (about a week or less) and the lack of time for distribution of local publicity (nothing was displayed at the store last week) means that it will be very difficult for people to lodge their objections; and many are away for the weekend at this time of year.

I live only 40 yards from the shop and already suffer a lot of noise and disruption from on-street drinking both outside the Maid of Muswell pub and from drinkers and smokers partying in the bus-stop outside Elementz bar. I have phoned the council's noise line and the police on numerous occasions in the small hours of the morning about this. Extending Eros' license will only make matters worse.

Our grounds for objection are that we understand that the sale and consumption of alcohol, particularly on the street, can easily lead, if not necessarily to crime and disorder, at the least to antisocial behaviour and public nuisance. A shop in that same parade was robbed only a couple of years ago and a 24 hour business is likely to attract more crime.

In addition, in recent years problems of minor youth vandalism have been experienced on this corner, which has, with the considerable help of the SNT, finally been dealt with. I have learnt of the application for a 24 hr license to sell alcohol at the above premises, and wish to take this opportunity to express my concern.

As a resident of Grove Avenue for the past 30-odd years, and as a regular customer of Eros, I am familiar with the shop and its several owners over this time, and also with the character of the immediate area. The corner opposite the shop, by the public library, has undergone redevelopment in recent years: the phone box has been removed, the garden area has been opened out, a private car park for the library has been developed. I have the impression that these changes were designed to discourage the gatherings of local youth which for some unknown reason have tended to cluster around this spot over the years, and continue to do so despite the changes. I am not aware of any major disturbances arising from this street-corner grouping, but it was always perceived as a potential trouble spot.

The shop is also the closest retail outlet to Alexandra Park School, and at given times during the school day it is a focus point for large numbers of pupils who gather outside, consuming food and drink that they have bought in the shop, or next door at the fish and chip shop.

Across the road is a pub, The Maid of Muswell, which serves as a local during the day, but during the evenings it attracts large numbers of predominantly young customers, especially on quiz nights and similar events.

In the parade of shops in which Eros stands, there are several other late-hour minisupermarkets, a restaurant, and another bar, in addition to the usual catholic mix of local shops. Parking in the immediate area is very limited, and above the shops are a large number of short-term rental apartments, popular with students and young people.

My concern can be summarized as arising from the prospect of Eros offering for sale out-of-hours alcohol in an area frequented by comparatively large numbers of young people. The problems caused by the after-hours drinking of alcohol originating from off-licenses, including supermarkets, is well documented and I would urge you not to exacerbate these problems by granting this application for a 24-hour license.

I am resident at 7 Grosvenor Road, N10 2DR.

I am objecting on the basis of public nuisance, & prevention of crime and disorder.

The pub is opposite the shop and they are careful about tightly controlling their hours and do their best to keep disruption to local residents to a minimum. However we still get noise at closing time and debris left on our property. This is to be expected and I do not complain about this as the pub also brings benefits such as community cohesion and I think that a spike of noise at 11pm is not a major issue as it is early enough for most people to still be awake.

However having a shop selling alcohol past closing time hours is likely to lead to more noise at anti social hours, and could lead to people hanging about on that corner at all hours. This was an issue which was helped when the library wall was removed and it would be unfortunate if this got worse again.

It is a predominantly residential family area around the shop and many local people have very young children and are up very early so will suffer from having night time disturbance.

There is the likelihood that people will drink in the pub, then go to the shop to continue.

In one incident a few months ago, my husband & a couple of his friends were subject to threatening behaviour from local youths on that corner, when ordering take away food.

We have had our car keyed when it was on our drive (easily accessible from the pavement- our road is the direct route from the shop to Colney Hatch Lane).

As I am sure you know, the previous owners of the shop were subject to assault & robbery while working there.

I wish to make a representation against the licence application for EROS GROCERS at 120a Alexandra Park Road, Muswell Hill, N10 2AE.

I wish to object against the application for a 24 hour Licence to retail alcohol for the following reasons under each Licensing objective.

#### THE PREVENTION OF CRIME AND DISORDER.

Currently there are no measures in place to cope with the prevention of crime and disorder. Any premises that retails Alcohol after 11pm should have a registered SIA doorperson on duty to help prevent disorder when drunks who leave bars and clubs arrive at the shop to purchase more alcohol. There is no quality, colour, digital, CCTV to monitor sales for 30 days and to act as a deterrent against crime and underage sales.

The location of the shop is predominantly residential and the granting of a later licence at EROS Grocer will have a negative cumulative effect in the immediate surrounding area. The other shops will all wish to have the same hours permitted to retail alcohol. Eros grocers is located in a small parade of shops intended to serve the immediate neighbourhood. There is no demand to purchase alcohol later at night. How will Eros Grocers prevent domestic violence that is on the increase in the borough, i believe it cannot prevent domestic violence but it can fuel it by selling more alcohol. Alcohol consumption will increase and there shall be sales of alcohol to people who have already been drinking in the pubs, clubs and bars long after they have closed. Inevitably the drinking of the alcohol shall be in the parks and open spaces/golf club grounds that surround the Eros grocers store.

I wish to make a representation under the licensing objective prevention of public nuisance. Late night revellers will focus on making the journey to the area in order to purchase alcohol after the pubs and bars have closed.

Boisterous people who have already have had enough to drink are then encouraged to drink even more as the alcohol is readily available. Boisterous people make noise, Car doors slamming as mini cabs & other vehicles arrive and leave. This will lead to more traffic and noise to the neighbourhood late at night.

The area around Eros is predominantly residential and largely populated by families. There is good provision for purchasing alcohol in the area both at the local bars and pubs and from existing off licenses until late into the evening already. The provision of a license to sell alcohol beyond pub closing times can only encourage excessive drinking – often on the street - which can lead to anti social behavior, crime and general public nuisance.

The area around Eros has suffered from antisocial behavior and vandalism in the past with young people congregating on the wall which used to surround the library. Dear Ms Barrett, We wish to lodge an objection to the application from Eros Grocers, 120A Alexandra Park Rd., Muswell Hill N1- 2EA for a licence to sell alcohol 24- hours a day.

This business is located in a quiet residential area where there is no demand or desire for alcohol to be sold around the clock. Our objection is based on the following four points: prevention of crime and disorder, public nuisance, public safety and the protection of children from harm.

Since the shop changed ownership recently it has become a magnet for anti-social youths. On June 29 our 12-year-old son was followed from the shop by an older youth who one of a group who haven taken to loitering outside. The youth demanded money and when our son refused asked him where he lived. Our son managed to get away and ran home in an extremely distressed state. The police were called and our son went with them to try to find and identify his would-be mugger. It did not take long. The youth had already returned to the shop to await his next potential victim. Unfortunately the police were unable to charge him as our son had refused to hand over his money and was lucky enough to escape unhurt. The next child may not be so lucky. We are happy to provide the CAD reference to confirm this incident if required.

The following day we spoke to the staff/owners of both the Eros Mini Mart and the Capital Supermarket next door. There may have been language issues, but the gentleman at Eros was initially dismissive and seemed more concerned that he was being accused of selling alcohol to the youths. However, both shops were aware of the youth and said that he was in the habit of asking adults entering the shops to purchase alcohol and cigarettes on his behalf. They also said they had caught him trying to steal from their shops.

We have since learnt of another, successful, mugging and an incident in which a younger child was bullied and threatened by youths outside the shop.

In the past, staff and management of both the Eros Mini Mart and Capital supermarket have worked together and with the local police to deter antisocial behaviour on this parade of shops. We believe the Capital Supermarket continues to do so but have no confidence that the management and staff of the Eros Mini Mart has either the commitment or capacity to deal with these troublemakers. The fact that both shops said these youths often ask adults to buy alcohol for them would suggest that on some occasions they are successful. If they were not, they would presumably give up and try elsewhere.

An extension of the alcohol licence will attract even more troublemakers and lead to a rise in crime, nuisance and public disorder. We implore you to refuse it.





I would like to confirm that I have considered the above proposal with regard to the prevention of public nuisance on behalf of the Enforcement Response (Noise) Team & would like to **make** representations to the Application.

I have inspected the premises in person and I had a discussion with applicant during my visit.

The operating schedule does not address the prevention of public nuisance but the applicant has agreed to:

- Take measures to control airborne entertainment noise
- Prevent structure borne noise or vibrations from entertainment
- Noise generated by patrons in external areas of the premises e.g. beer garden

The proposed operating hours are appropriate for the main restaurant area. The cessation of licensable activities at 23:30.

The external or annexed seating areas will be unavailable to patrons at 22:30 or earlier. The noise caused by patrons seated or occupying the external seating areas is likely to be detrimental to the residential amenity. The applicant has agreed to advice all patrons to move indoors no later than 22:30.

#### **Supporting Information**





A warning letter was served on Sandero Restaurant on 6 June 2010 in relation to noise nuisance caused by loud music.

If the sub-committee were to grant this application then we would recommend the following alterations/conditions to the operating schedule:

#### Operating hours

That the premises closes no later than 23:30 from Sunday to Thursday, and regulated entertainment shall cease at 23:00 for the inside of the premises and 2230 for the outside area.

#### Prevention of nuisance from noise / vibration

All doors and windows will remain closed during the licensed regulated entertainment activities or in any event after 11pm. The entrance door will be fitted with a self-closing device and staff required to ensure that it is not propped open. A member of staff shall be made responsible to ensure the door is opened for as brief a period as possible. Entry to the premises will be restricted to front entrance door on St Anns Road, N15, only, whilst the premises is being used for regulated entertainment licensed activity

Entrance/exit from the premises whilst regulated entertainment licensable activities are ongoing shall be via a lobbied door to minimise noise breakout.

The regulated entertainment licensable activity shall conclude 30 minutes before the premises is due to close to prevent excessive noise breakout as the premises empties

#### Other doors e.g. fire doors

The doors that separate the kitchen and the external seating areas will remain closed while regulated entertainment is being operated.

#### Structure borne noise

All speakers are mounted on anti-vibration mountings to prevent vibration transmission of sound energy to adjoining properties

#### **Sound limits**

The licensee shall ensure that no music played in the licensed premises is audible at or within the site boundary of any residential property

All regulated entertainment amplified activity will utilise the in-house amplification system, the maximum output of which is controlled by the duty manager

The level of amplified regulated entertainment shall be controlled by means of limiting device set at a level which upon request may be agreed with the licensing authority

#### **Outside Areas**

No music other than background music will be played in external or annexed seating areas of the premises. Any music played in external areas shall cease at 22:30 every day.

No form of loudspeaker or sound amplification equipment is to be sited on or near the exterior premises or in or near any foyer, doorway, window or opening to the premises. The applicant has agreed not to play music in the external seating areas.

Signs shall be displayed in the external areas/on the frontage requesting patrons to recognise the residential nature of the area and conduct their behaviour accordingly. The management must reserve the right to ask patrons to move inside the premises or leave if it is felt that they could be disturbing neighbours

Only patrons seated at tables will be permitted in the beer garden or the side/external seating areas.

The beer garden/external/side seating area will be closed and patrons requested to come inside the main structure of the premises at 22:30 every day of the week.

#### Deliveries and collections.

Deliveries and collections associated with the premises will be arranged between the hours 08:00 and 19:00, Monday –Friday, so as to minimise the disturbance caused to the neighbours

Glasses will be collected from the beer garden area at the beginning of the day rather than at closing time when neighbours in close proximity might be unduly disturbed

Empty bottles and non-degradable refuse will remain in the premises at the end of trading hours and taken out to the refuse point at the start of the working day rather than at the end of trading when neighbours might be unduly disturbed

#### Plant and machinery

All plant and machinery is correctly maintained and regularly serviced to ensure that it is operating efficiently and with minimal disturbance to neighbours arising from noise

#### Dealing with complaints

A complaints book will be held on the premises to record details of any complaints received from neighbours. The information is to include, where disclosed, the complainant's name, location, date time and subsequent remedial action undertaken. This record must be made available at all times for inspection by council officers

#### Patrons entering/exiting premises.

There will be no queuing outside the premises.

Where people queue to enter the premises a licensed door supervisor shall supervise and ensure the potential patrons behave in an acceptable manner

All ventilation and extraction systems shall be correctly maintained and regularly serviced to ensure that it is operating efficiently and with minimal disturbance to neighbours arising from odour

#### Prevention of nuisance from light

Illuminated external signage shall be switched off when the premises is closed

Security lights will be positioned to minimise light intrusion to nearby residential premises

I understand the Sandero Restaurant has applied for a licence for:

Provision of regulated entertainment: Live Music and Recorded Music Monday to Sunday 10am to 11pm Provision of late night refreshment Monday to Sunday 11pm to 11.30pm Supply of Alcohol Monday to Sunday 10am to 11pm Opening Hours Monday to Sunday 7am to 11.30pm

I wish to object to the granting of this licence for reasons of the Prevention of Public Nuiscance.

The Sandero Restaurant is at the junction of St Ann's Road and Glenwood Road. The outdoor seating area to the rear of the restaurant extends well into Glenwood Road, which is entirely residential. I believe the granting of a licence to permit opening hours Monday to Sunday till 11:30pm, the playing of live and recorded music till 11pm, and the sale of alcohol till 11:00pm, would result in serious and regular disturbances to the peace and quiet that local residents are reasonably allowed to expect:

1. The restaurant has erected (without planning permission) outdoor seating areas to the front and rear of the premises. Taken together, these outdoor seating areas will have a total seating capacity of a significant size, very probably greater than the inside of the restaurant. The potential for excessive noise from customers - not just when arriving and leaving but during the entire course of their stay - is very great.

2. Sound is carried easily across this neighbourhood. I live in the road next to Glenwood, and we can hear late night music from neighbouring streets very clearly, particularly in the summer.

3. The record of the Sandero Restaurant's respect for community interests does not bode well. Given that they have allegedly developed the restaurant (and open areas) without planning permission, or proper observation of planning constraints, and that there are reports of their selling alcohol without a licence, I believe there is a strong likelihood that they will not prove to be responsible licencees, resulting in regular complaints of excessive noise after lipm.

The above restaurant has applied for a licence to serve alcohol and play live and recorded music. I object on the grounds that the granting of such a licence would constitute a public nuisance in the following ways:

1: Outdoor music.

Most of the business at the restaurant is conducted in a large outdoor area to the rear. Although the restaurant's address is listed as St. Ann's Road, the open-air bar area actually extends around 30 meters down Glenwood road which is a quiet, 100% residential street. Granting the restaurant licence to play music in this area means granting licence to play music on the street right outside the houses of many local residents. The outdoor bar obviously has absolutely no sound insulation and often does play music now. This can be heard in every room in my own house and the same must be true of all neighbouring properties. Live music would be louder and would thereby constitute even more of a public nuisance. However, even quiet music in this outdoor area means that the houses near the restaurant can never be sure of peace and quiet. Music, even of a low level, all day every day, outside, on a quiet residential street is most certainly a public nuisance.

2: Outdoor noise from a bar.

The granting of an alcohol licence to the restaurant would mean that the outdoor area would be used as an open-air bar, rather than purely a restaurant. This means excessive noise and again, since it is on a quiet residential street without any sound insulation, this would severely diminish the ability of local residents to enjoy peace and quiet in their homes. The restaurant currently serves alcohol and on hot evenings, the outdoor area has been very loud and crowded with people who are clearly not eating (they are standing and drinking).

3: Live/loud music in the restaurant proper.

Notwithstanding points 1 and 2, the indoor section of the restaurant on the corner of St Ann's and Glenwood roads is still surrounded by residential properties. The restaurant has had live music in this room on a couple of occasions thus far and it has been clearly audible from all rooms in my house. Again, the same must be true for many nearby houses. Allowing a licence for live music even in the restaurant proper still, therefore, constitutes a public nuisance.

#### 4: Opening hours.

The proximity to residential properties means that extending the opening hours of the restaurant would also impede the right of local residents to enjoy peace and quiet in their homes. The planning officer, in the appeal he granted (ref. APP/Y5420/A/09/2107975) said:

"It seems to me that both in the early morning and late evening the coming and going of customers could be the source of unacceptably noisy activity which may impinge on the peace and quiet that occupiers of nearby residential properties on St Ann's Road and in Glenwood Road could reasonably expect to enjoy, particularly on Sundays and Bank Holidays but also on weekdays and Saturdays in the early morning."

He therefore stipulated in the planning consent that the restaurant's closing times must be no later than 23:00 Mon-Sat and 22:30 Sun. I see no reason why the licensing of the property should contradict the planning officer on this point and the extension of opening hours to 23:30 should not be licensed. The planning officer did not consider the large outdoor area at all since this was built without any planning consent. Had he done so, I'm sure that his concerns for the peace and quiet of the two residential streets would have been heightened. Since the licensing committee does have the benefit of considering the outdoor bar, I hope they will agree that extended opening hours would certainly impinge on public peace and quiet and would constitute a public nuisance.

Another outdoor area has now been built to the front of the property on St. Ann's Road and this, I believe, should also be taken into consideration when licensing the premises.

I would be happy to see a licence granted with the attached conditions:

1: No service (even of non-alcoholic beverages) after 23:00 Mon-Sat and 22:30 Sun and public holidays.

2: No music (live or recorded) to be played outside the confines of the front, indoor part of the restaurant.

3: No music (live or recorded) which is of a level that is audible in the surrounding residential properties to be played inside the restaurant after 19:00.

4: No alcohol to be served to customers who are not also purchasing food.

I believe these conditions allow for the successful running of a restaurant and are, in fact, the standards that restaurants in residential areas uphold as a matter of course. Since this restaurant has clearly demonstrated that it will not follow such reasonable standards, I hope that the licensing committee will make them mandatory.

I repeat that I do not want my details to be passed on to any party without my express consent. I would be grateful if you could acknowledge receipt by return email and also that you have taken note of my request for anonymity.

I write to you regarding Sandero's application to play. Firstly, I did not realise they did not have a current license, as music is played loudly from speakers in the restaurant and alcohol is served freely causing a considerable noise nuisance for myself and my family every night of the week.

Having already experienced the noise, which often continues late into the evening/night as late as midnight on a weeknight and sometimes much later on weekends (1.40 am on one occasion), I must strongly object to a license being offered for the supply of alcohol or for live and recorded music to be played at the restaurant either inside the main building or in the covered seating area or garden at the rear.

I have lived here for over four years with my husband and have a three-year old toddler and six-month old baby. I am very concerned about the effect any live or recorded music playing in Sandero Restaurant would have on my family life. My children are young and go to bed at 7pm in the evening and my husband leaves for work early in the morning, around 5 or 6am and therefore, it is vital they are able to sleep in the evenings. The very nature of living in a flat means that they are sometimes woken by noises by the occupants of neighbouring flats but I believe issuing a License permitting live / recorded music at 434 St Ann's Road would be most detrimental to my home life and cause them major disturbance. I believe granting the License would cause a public nuisance in this residential area.

I am worried that the level of noise will be similar to that experienced earlier this year, some months ago, when a wedding celebration appeared to be taking place at Sandero Restaurant. I was not able to hear my television at normal volume, my children awoke and my husband had tried and failed to go to sleep during the evening. We believed it to be a 'one-off' at the time so thought we would bear it just this once. My family experiencing disturbed nights would be have a knock-on effect on our days. I am sure I do not need to point out this would mean my children are unhappy when they are tired during the day and my husband would not be able to function efficiently at work.

I would be grateful if you could kindly note I wish to remain anonymous. I <u>do not</u> wish my name, address or contact details to be made public or passed on to the applicants but I should be grateful if you would kindly contact me should you need any further information or if I am required to respond to any further appeal / application from Sandero restaurant of a similar nature.

While acknowledging that this licensing application has no direct link to planning matters, we would like to point out that in allowing the planning appeal Ref: APP/Y5420/A/09/2107975, the Inspector made the following planning condition:

"No customers shall be on the premises of the use hereby permitted outside the following times:- 0630 - 2300 Mondays to Saturdays; 0700 - 2230 Sundays and bank and other public holidays."

You will see that the proposed licensing hours fall outside the hours allowed in the plannng appeal.

	(NORTHUMBERLAND PARK WARD) Gillian Crew, representing the Metropolitan Police, reported that the application for a review was being brought by the police following the closure notice, mainly on the grounds of crime and disorder. Ms Crew noted the opening hours of the premises, which operated both as a restaurant and a nightclub, and reported that approved door supervisors were a condition of the existing licence. It was reported that the premises had been a centre for gang-related activity, and that firearms had both been carried and discharged inside and outside the premises. It was reported that conditions relating to door supervisors and trading hours were not being adhered to.	
	Ms Crew called Inspector Hembury as a witness in respect of the serving of the closure order on 12 June 2010. Inspector Hembury confirmed the statement submitted as part of the report pack and summarised the concerns which had led to the serving of the closure order. Inspector Hembury reported that there had been an accumulation of incidents, and that the police were aware of an event planned for 12 June 2010 and had information relating to one particular DJ who was due to attend. Inspector Hembury indicated that he had contacted Mr Ekuban on several previous occasions regarding concerns relating to violence at events publicised at the premises, which had led to these events being cancelled voluntarily.	
	Mr Ekuban questioned Inspector Hembury regarding the intelligence held on a particular DJ, and asked why the police had not advised him of their concerns when he had previously performed at the premises. Inspector Hembury reported that the police had not been aware of the individual in question on previous occasions.	
	Ms Crew called DCI Shanks as a witness, and DCI Shanks confirmed the content of his submitted statement. In

response to the statement of DCI Shanks, Mr Ekuban denied that he had willingly made a statement that he was aware of firearms being carried on the premises but had not reported this.

Ms Crew called Detective Perry as a witness. Detective Perry confirmed that he had been involved in a search of the premises on 25 May 2010 and investigating an incident on 5 April 2010. Detective Perry confirmed that the search had taken place as a result of intelligence received regarding the doormen at the premises being unlicensed and of a number of incidents involving firearms. Mr Ekuban claimed that he was unaware of the concerns raised in respect of the principal doorman at the premises, and asked why this had not been brought to his attention sooner by the police, in response to which Ms Crew advised Mr Ekuban that as licence holder it was his responsibility to ensure that he was complying with the requirements of the licence.

The Committee were shown a recording of CCTV footage from outside the premises on the night of 5 April 2010, when firearms had been discharged. The Committee was asked to note that patrons were still exiting the premises at 4.20am, and that some persons were able to re-enter the club after that time. The Committee was also shown a large number of patrons leaving the premises in a hurry, as the result of a disturbance inside the premises.

Mr Ekuban and Ms Coleman addressed the Committee. Ms Coleman reported that the premises operated as restaurant and wine bar, and had been licensed since 2005. Restaurant customers had usually left by 2am, and there were no problems when the premises operated just as a restaurant. Ms Coleman advised that the premises was also hired out for parties, and that people came to these events between 2-4am; she reported that she was not always present for these late events. Ms Coleman reported that they were law-abiding people, but they did not necessarily know the people who hired the premises for events. Mr Ekuban reported that he would have acted on any concerns from the police regarding customers at the premises. When the police had raised concerns previously regarding some of the events booked, these had been cancelled voluntarily to avoid trouble.

Ms Coleman and Mr Ekuban reported that following the decision of the Magistrates on 14 June 2010, they had decided not to hire the premises out for events any more. Since the premises had been operating in this way, there had been no further problems. They reported that they were sorry for the problems that had arisen as a result of the

private functions, none of which had been intended, and that they proposed to operate only as a restaurant from now on.

In response to questions from the police regarding previous incidents at the premises, Ms Coleman confirmed that these had all occurred in relation to hired events, and not when the restaurant was operating as a restaurant. It was reported that they were not always aware of incidents that occurred outside the premises. In response to a question regarding why the police were not called regarding a suspected firearms discharge on 5 May 2010, Mr Ekuban reported that he had heard a noise, but that no marks or shell had been found to indicate that a weapon had been discharged and that he had not seen a firearm anywhere. It was reported that CCTV footage had been supplied to the police for examination.

Ms Crew asked Mr Ekuban about the night of 25 May 2010, and why police had seen patrons on the premises at 4.30am, customers apparently using drugs openly and a purchase of alcohol being made after 4am. Mr Ekuban confirmed that the premises ceased trading at 4am, and that no alcohol would have been sold after this time. It was reported that security would ask anybody lighting up on the premises to stop, and the music would also be stopped until this had been complied with. Mr Ekuban confirmed that it took some time for all the customers to leave once the premises closed at 4am, and that customers would still be coming through from the back and waiting for taxis. Mr Ekuban reported that his own internal footage would show door supervisors doing their job. In response to a question from the police regarding how firearms got onto the premises, Mr Ekuban reported that he had never seen a firearm in the club and that, if he saw a door supervisor carry out a search he was not satisfied with, he would request that that person not work at the premises again. Mr Ekuban denied that he was not in control during hired events, and reported that he would always be present and monitoring the premises. Mr Ekuban confirmed that some of the hired events were publicised and open to members of the public.

In response to questions from the Committee, Mr Ekuban confirmed that he was aware that he should not have signed any statement if he did not agree with its contents, and that he was aware that the premises ought to be closed by the time specified on the license.

In response to a question from Tony Michael, Legal Officer, regarding why the police were seeking revocation and not modification of the licence, Ms Crew reported that this was because of concerns in relation to the licence holders

	themselves, who had lost control of the premises. It was reported that there had been no regulation in place at the premises, and there were concerns relating to every aspect of the premises' operation. It was noted that the concerns related to very serious crimes, and the police were concerned that if the licence were not revoked, this could lead to loss of life at the premises. It was noted that if the Committee were not to revoke the licence, they must be satisfied that there would be genuine change in the circumstances of how the premises was run.	
	The Committee decided to allow summing up to take place in public and gave a specific warning to all parties that summing up should not include the disclosure of any information relating to an individual or information likely to reveal the identity of an individual.
