Cllr McNamara addressed the Committee in objection to the application. Cllr McNamara made it clear that he did not object to the principle of a restaurant operating on the site but, based of conversations with local residents, it was felt that the hours applied for should be reduced as the premises was in a residential area.  The applicants addressed the Committee and stated that, in the discussions with local residents, people had been in favour of restaurant at this location, and did not foresee the opening hour applied for being an issue. The applicants clarified that the reason that an application had been made to operate until 5am on Christmas Eve was to enable their church group to use the premises after late prayers on Christmas Eve. It was reported that the applicants knew the area, and did not anticipate any problems, although they would monitor carefully to identify any issues and address them if the arose.	e e e e e e e e e e e e e e e e e e e
	In response to questions from the Committee, the applicants advise that it was intended that the restaurant would be a family restaurant was reported that any live music would be in the form of singing such as church choirs, and that it was not intended to his professional musicians to perform at the premises. The application for performances of dance was only made to cover the eventuality.	t. g e on

that customers might wish to get up and dance at their seats, and that their was no space set aside for dancing. It was confirmed that there would be no amplified music at all. The Committee asked about parking, in response to which the applicants advised that they would recommend their customers to use the nearby community centre car park. It was proposed that the takeaway facility would close at around 11pm to midnight.

In response to questions from Cllr McNamara, the applicants advised that they understood the concerns regarding noise, but that the premises had been refurbished such that noise would not be audible from the flats above or from outside. Although 2am had been applied for every night, it was not anticipated that the premises would always be open and busy up until 2am, it was just so that any customers who did arrive late did not have to be rushed out. Cllr McNamara asked about security at the premises, particularly on match days, in response to which the applicants advised that staff would be monitoring the door, but that there was no proposal to hire full time security staff.

In conclusion, the applicants advised that they understood their responsibilities to prevent crime and disorder and ensure the safety of all, protect local residents and businesses from nuisance and protect children from harm. The applicants were aware of the impact that management of a licensed premises could have on the local area, and would do all they could to ensure the premises was well-managed and that the licensing objectives were upheld at all times.

Concluding the objections, Cllr McNamara stated that the restaurant was a positive development in principle, but that such late hours would have an impact on local residents as noise inevitably travels. Cllr McNamara recommended that shorter hours should be granted and that the applicant could reapply for an extension of hours after proving for a time that the premises would be well-run and would not cause any disturbance.

The Committee adjourned to deliberate.

#### **RESOLVED**

The Committee carefully considered the application for a premises licence in respect of Mighty Rock restaurant, and took into account Haringey's Licensing Policy and amended guidance, issued under Section 182 of the Licensing Act 2003, and it was the Committee's decision to grant the application on the following terms:

#### LICENSING SUB-COMMITTEE HEARINGS PROCEDURE SUMMARY INTRODUCTION The Chair introduces himself and invites other Members, Council officers, Police, Applicant and Objectors to do the same. 2. The Chair invites Members to disclose any prior contacts (before the hearing) with the parties or representations received by them The Chair explains the procedure to be followed by reference to this summary which will 3. be distributed. **NON-ATTENDANCE BY PARTY OR PARTIES** 4. If one or both of the parties fails to attend, the Chair decides whether to: grant an adjournment to another date, or (ii) proceed in the absence of the non-attending party. Normally, an absent party will be given one further chance to attend. **TOPIC HEADINGS** 5. The Chair suggests the "topic headings" for the hearing. In the case of the majority of applications for variation of hours, or other terms and conditions, the main topic is: Whether the extensions of hours etc. applied for would conflict with the four licensing objectives i.e. (i) the prevention of crime and disorder, (ii) public safety, (iii) the prevention of public nuisance, and the protection of children from harm. 



I would like to confirm that I have considered the above proposal with regard to the prevention of public nuisance on behalf of the Enforcement Response (Noise) Team & would like to make representations to the Application

The operating schedule does not address the prevention of public nuisance from:

- airborne entertainment noise
- Noise generated by patrons in external areas of the premises
- Noise from patrons exiting the premises
- Noise generated from deliveries
- Noise generated from refuse collections
- Noise from plant and machinery
- Cooking odour

No history of any complaints according to our records

If the sub-committee were to grant this application then we would recommend the following alterations/conditions to the operating schedule:

#### Prevention of nuisance from noise / vibration

All doors and windows will remain closed during the licensed regulated entertainment activities or in any event after 11pm. The entrance door will be fitted with a self-closing device and staff required to ensure that it is not propped open. A member of staff shall be made responsible to ensure the door is opened for as brief a period as possible. Where necessary adequate and suitable mechanical ventilation should be provided to public areas

Entry to the premises will be restricted to Broad Lane entrance whilst the premises is being used for regulated entertainment licensed activity.

The regulated entertainment licensable activity shall conclude 30 minutes before the premises is due to close to prevent excessive noise breakout as the premises empties

#### Sound limits

The licensee shall ensure that no music played in the licensed premises is audible at or within the site boundary of any residential property

All regulated entertainment amplified activity will utilise the in-house amplification system, the maximum output of which is controlled by the duty manager

#### **Outside Areas**

Customers prohibited from using the rear yard.

#### Deliveries and collections.

Deliveries and collections associated with the premises will be arranged between the hours 0800 and 1800 hrs Monday to Saturday and not on Sundays or Bank Holidays so as to minimise the disturbance caused to the neighbours

Empty bottles and non-degradable refuse will remain in the premises at the end of trading hours and taken out to the refuse point at the start of the working day rather than at the end of trading when neighbours might be unduly disturbed

#### Plant and machinery

All plant and machinery is correctly maintained and regularly serviced to ensure that it is operating efficiently and with minimal disturbance to neighbours arising from noise

#### Patrons entering/exiting premises.

Signs should be displayed requesting patrons to respect the neighbours and behave in a courteous manner

#### Prevention of Nuisance from Odour

All ventilation and extraction systems shall be correctly maintained and regularly serviced to ensure that it is operating efficiently and with minimal disturbance to neighbours arising from odour

I write on behalf of my Mother, Mrs B Stuart, who is 86 years old and lives in the Ground Floor Flat 110 Antill Road N15 4BA, with reference to the above planning application.

She has asked me to forward her comments as it is easier for me to do it for her.

The below comments also concern Paul Dutton who lives upstairs to her at First Floor Flat 110 Antill Road. He has already emailed you on 11 May 2011 23-21 - pauldut@gmail.com - but received a reply to say that his wording wasn't correct. Unfortunately, just as he was reading your email, his machine crashed and when he rebooted his computer he couldn't retrieve your email - and so has no idea why his wording was not suitable as he didn't get to finish reading your reply. He is on holiday at the moment and has asked me to include him in my correspondence to you. Should you wish to have his comments separately, he will do this upon his return next week. I can forward you a copy of his email if you so wish, but will have to do it tomorrow.

However, I now state below objections to the proposed application for licensing to sell alcohol and application to play live or recorded music, and will begin by using your suggested wording:-

I object to this application. I live close by and am worried about an increase in crime and disorder and issues of public safety and public nuisance.

Although these premises are on the corner of a busy main road, they are also at the top of a residential road and residential surrounding area. The selling of alcohol from midday until the early hours, combined with live or recorded music, is totally unsuitable for a premises in this location.

This will surely attract trouble, and also some undesirable people who would be a threat to public safety.

There is also the question of noise and nuisance. Live music is loud and there are houses a few yards up from the premises. Dear Madam,

I am writing to you to express my point of view and my disagreement with the comments made by Mrs. Nadine Fraser who lives at number 116 Antill Road.

I would like to emphasize the following:

First of all, Mrs. Fraser should only make comments when there are sufficient grounds and reasons for her to make them. She should not speak for other people whom as you probably know, do not share the same opinion as hers, let alone speak for other people who **possibly may come and live in places that have not even been built.** I totally disagree with the fact that she has been knocking door to door with her exaggerated arguments, trying to make people oppose to our application. This is why and due to her own suggestion, the notice had to be extended for another 28 days so the whole neighbourhood could see it which we have no objection even though this has delayed the Council on making a decision on our application.

We would like to make it quite clear that we are **NOT** making an application to open a Bar or a Discotheque. We are making an application to the Council to be able to sell alcoholic drinks in a **restaurant.** We would not obviously be open every day until 3 am. Should this be the case, we have already been instructed by the authorities concerned with controlling the noise after midnight and they have suggested to us to keep the door and shutter that leads to Antill Road closed and to use the entrance on Broad Lane.

Mrs. Fraser is totally mistaken in her assumptions. Our purpose is by no means to create problems to our neighbours, let alone to make a restaurant that is heaven for delinquency. We are law abiding citizens as the different authorities that have worked with us relating to the Off License application can confirm.

Mrs. Fraser's arguments against our application are that because there will be so many thieves and drunken people outside the restaurant at three in the morning, they will be a threat to her one (1) and three (3) year old children and also to the elderly people that come out at this time. If a real danger would be possible, we ask ourselves....... how many elderly people would come out of their houses after midnight? In which way could the welfare of her one and three year old children be in jeopardy? They are suppose to be in bed and sleeping at this time of the day and the noise (if there was ever one loud) would never wake them up anyway as Mrs. Fraser's home is 34 meters exactly from the restaurant, not 20 meters as she has claimed. This can be corroborated if needed. In fact,

some of our neighbours have expressed to us that they would feel much safer with us opened until late at night as the road is usually very lonely and they feel scared for this reason.

Another point is at what degree would the air be polluted by our smokers when the maximum average we could have of them would be 5 people at one time? Our restaurant has a maximum capacity of forty (40-50) people and **not everyone smokes**.

We can also assure you that our customers will not have the need to go out and throw the rubbish or urinate outside the restaurant as we have made sure there are enough bins provided and impeccable toilets for the exclusive use of our customers. This will by no means be our case as Mrs. Fraser suggests.

The restaurant has been opened for over a year now and during this period we have had many parties and celebrations and there has not been a single complaint on the part of the neighbours or anyone else. Not for the noise nor for anyone taking their parking spaces as we have as a policy to advise our customers that come by car, to completely avoid this road to park their cars. We intend to continue with our policy for as long as we remain here.

Besides, the only person that can be affected if so, by the smell or noise coming out of the extractor fan in the kitchen is Mrs. Sumpson from 122 Antill Road (next door). She can confirm if we have caused her any problems during this nearly two (2) years since we opened. Mrs Sumpson was one of the main opponents for us to obtain the License when we applied at the time we opened the restaurant.

I am sure you are aware that it is discriminating and unfair that we are assumed and branded as **criminals** just because we want to provide our customers (as you know, some of them are our own neighbours that are backing our application), with a glass of wine or a beer for them to enjoy together with their meal. Attached is the list of the names and addresses of the people that are supporting our application in case you would need to get in touch with them. I am also attaching a copy of the letter we have sent to Mrs. Fraser.

Mrs. Barrett I really hope that you take into consideration all the things that I have mentioned in this letter which shows that Mrs. Frasers arguments are totally contradictory and make no sense whatsoever to the reality. Her arguments are not sufficient and we would like you to please review our case and see that there are not grounds for you to reject our application.

I write to you not making use of my right to respond to your point of view regarding our application for a premises licence for el MEZON RESTAURANT. Instead I'm responding to you because I realise of the extreme preoccupation of yours, in fact if you are convinced that the security of the area, your family and the local residents will degrade I completely understand you.

Therefore I would like to briefly explain to you the reason and the intention of our application for premises licence.

Firstly, for us (EL MEZON RESTAURANT) is extremely important to be in complete harmony with all our neighbours, as we have done for more than a year. As you might be aware two years ago many of our neighbours were against the idea that this site was opened, arguing stronger reason than yours but until today they haven't had any reason at all to complain about our site, on the contrary many of the local residents are quite please to have a shop and a restaurant near by. Perhaps some of the local residents are supporting our request.

In many occasions our clients have asked for a beer or a glass of wine to accompany the meals. We would really like to be able to have the authorization to please our customers in that aspect. Also to be able to allow customers to have occasional meetings and celebrations, everything with in familiar atmosphere.

This is the main reason why we have asked for the licence to operate until late in the night because any occasional celebration or social meeting could possibly be prolonged to later than our current schedule time to operate and we would not want to break the law. This does not mean that we will be operating until 1.am/3am every night and weekends, in comparison to BONGO BAR VENUE in broad lane WE WILL NOT BE A NIGHT CLUB OR PUB In any occasion that a late celebration or meetings take place at the EL MEZON RESTAURANT we have been instructed by competent authorities that guard the well-being of the community, (please see copies attached) for example: if music is played at high volume the doors including the chatter that gives access to the restaurant by Antill road would be closed at all time, only giving access to the customers by the front door by Broad Lane.

Our regular customer who has been visiting us for the last year and the customer who will be visiting us in future are dissent and pleasant people like you and as many local residents that have been visiting the premises and not delinquents as you are imaging.

I can ensure you that if the licence is granted, this will not be any reason for insecurity to you, your family or any local resident.

All I wish is to let you know that we have no intention whatsoever in transforming our restaurant into a bar or discotheque. Our only aim is to obtain an off license to be able to offer alcohol to the customers that come to enjoy lunch or dinner.

I suppose you are aware that the laws for restaurants are different than those for discotheques.

In pubs and discotheques, you are able to sell only alcohol, therefore these places are often visited by certain kind of people that can go there only to drink if they want to, they get drunk and this obviously comes together with a change of behaviour in a person that can affect other people.

This very rarely occurs in a restaurant because as far as I know, we can only sell alcohol to those customers that are having a meal and who normally have it together with wine or beer.

We do not believe that a dangerous situation will arise that would affect the neighbourhood or people passing by our restaurant. Given the case that our off licence would be approved, our prime concern would be not to affect the neighbours in any way. Should it happen, please do not hesitate to let us know immediately. Perhaps you can also advise me as the whether I ought to also reply directly to any or all of those who have voiced opposition to an extension or variation to EL MEZON'S present licence as it applies to this application at this time please.

However, **Firstly** and foremost I wish to express my gratitude and full appreciation to you and your colleagues at the council who have advised and offered assistance so kindly and professionally without any prejudice in any circumstances I also take this opportunity to thank all of the relevant departments and authorities involved especially the Police and their recommendations.

The noise and the enforcement Officers

The fire department/health and safety

And the entire environmental control services for their input collectively.

Secondly: and just as importantly, I write to address those who have voiced their opposition with as much logic, courtesy, respect and sincerity as it is possible to convey herewith.

I'm now advised to make all responses to letters of abjections from members of the public, directly to you, <u>and not to the objectors</u>, so may I draw your attention to my letter of

- (B) To apply to any, and all other objectors which fall into the same category and points raised thus far; as whatever these objections, the demographics of EL MEZON will remain constant and law abiding within the letter and spirit of the laws of the land and the remit of our licence.

Thirdly: I fully apologise for any misunderstanding caused by my part, in having earlier replied to members of the public who raised their concerns as you have informed me by way of the letters to you, with regard to this application; instead of having sent all correspondences directly to you at your Offices. I value your later advice and direction to send all other such responses only to you, as this is my reply to that set of circumstances.

- Never-the-less, I do need to emphatically reiterate the points I raised in my letter of the 23-05-11 (which was then addressed to Mrs Nadine Fraser – 116 Atill Road) that we at EL MEZON will not violate the remit of our licence or good standing within the community in any of the ways feared in those scenarios. Of that we can very firmly promise.
- As far as we are aware bearing in mind that we are a very small restaurant, we will
  only be able to serve alcohol to those customers that are having a meal and who
  normally would prefer to have it together with wine or beer for example.
- We do not have the size, capacity, or intention to encourage dancing; because we
  are not a discotheque or night club. Again the space could not allow this kind of
  activity, and we certainly do not intend to try to cater to that in any way, shape of
  form.
- Again our only aim is to obtain a proper licence to be able to offer alcohol to those customers who come to enjoy lunch or dinner as a meal. We also of course serve hot beverages such, coffee, tea etc.
- This is a family and culturally orientated facility, and although we are open to the public at large, and encourage and entertain members of the local community, we are essentially family orientated, with the majority of our custom coming from within the Latin American and Ibro American community which may also include people from the Caribbean, continental Spain, and Portugal essentially. Our cuisine and menus reflect this clearly. Furthermore as we understand it, EL MEZON reserve the right to refuse service to any one who appears to be getting drunk or is in any way exhibiting an undesirable behaviour at any time. Please rest assured that this policy will be firmly exercised by this management at all times at EL MEZON

- We need to make it perfectly clear that we will not be operating as an off licence, and therefore we will not attract people passing by who are only interested in buying drinks. Please bear in mind that there is a shopping mall on the opposite site of the street in the Tottenham Hale Retail Park where people can do such purchases; and also I believe there are such outlets along Broad Lane, some distance away from our location, as well at the local BP Petrol station. There are also some operational pubs in fairly close proximity to EL MEZON'S location.
- We are open to helpful suggestions from neighbourhood organisations, or individuals from the immediate community who may have any suggestion as to how we may help to live in better harmony and be of greater service to all the people in this vicinity.

Fourthly: many residents along Antill Road and Broad Lane have come forward in support of the services they have been receiving from EL MEZON since we opened for business more than a year ago; and are committed to being supportive of us in this application. Perhaps you may wish to have their identities and addresses in support of this, and in that case a list is available, although I'm not sure that they would like to have their identities made public at this time. Please advice.

- There shall be clear written sings on display to all who come within the premises;
   that our policies state as follow;
  - 1. No offensive weapons of any kind will be tolerated on this premises
  - 2. No anti-social behaviour including the use of profane language will be tolerated
  - 3. No drugs of any kind which is illegal will be tolerated on this premises
- any one not abiding by this regulation will be told to leave the premises and the
  police will be notified immediately, and asked to assist us in making sure these rules
  and conditions are met and enforced rigorously
- And also very importantly to all patrons entering/exiting the premises clear signs shall be displayed inside and outside our entrances, (and at other appropriate places inside) requesting all patrons to respect the neighbours, and behave in a courteous manner.
- We EL MEZON will monitor that cleanliness within the confines of our pavement/street front area is highly maintained; and with receptacles/bins provided with the direction of Haringey council's guidance

Finally we are aware and greatfull for your guidance from Mr George Roberts the Officer preparing representation of the 9<sup>th</sup> of May 2011; and can tell you that we are more than happy to commit to all seven points raised by his correspondence, and have indeed already put in place all of these recommendation as a matter of course.

I hope that this answers all of the points of objections which have been raised as far as I'm aware through your letters to me on this matter; but I have to say that as a responsible small business operator who would like dearly to continue in business and to be of service to the communities within the law, we have paid full attention over the past year as is evident for your records and we only wish to continue to operate and offer this improvement and upgrade to the service we offer at EL MEZON.

With kindest regards and hoping that all fears shall by now be laid to rest regarding objections to this application; we hope that the community will decide to authorize this request please, through your good Officers and Councillors
