<b>1.</b>	<p><b><u>Apologies/Previous Minutes</u></b></p> <p>Minutes</p> <ul style="list-style-type: none"> <li>• With reference to naming Green Lanes, this will not form part of the formal consultation, but will be undertaken informally. Harringay Green Lanes will be the default name. Short meeting to be set up to discuss this matter.</li> <li>• IS noted that there would have to be a good case for changing it as this would involve changing maps etc.</li> <li>• The seating option has been taken out of the Burgoyne Road option.</li> <li>• In regards to the bus lane, TfL have informed the department that a decision will take approx 18 weeks. The bus lane will be included within the designs and will be included in the consultation with a caveat.</li> </ul>

<b>2.</b>	<p><b><u>Consultation design</u></b></p> <p>Example consultation documents were provided. It was noted that residents would be able to download a copy of the detailed booklet and leaflet. General comments form would be included in the pack posted to households.</p> <p>AN noted that it was unfair that the detailed questionnaire isn't posted to households but only available online. AN Also noted that there isn't enough information on the different options.</p> <p>TK informed the group that this information is available online and there is too much information to be included. NC pointed out that this advocates people attending the drop in sessions. These are advertised in the accompanying letter signed by NC.</p> <p>Blog is available for residents to post comments. KH confirmed that this could be included on David Lammy's twitter feed.</p> <p>Full page advert will be in Haringey Independent on Green Lanes and West Green Projects.</p> <p>Display will be in Paul Simon shop. In regards to advertising Paul Simon, TK noted that the logo only needed to be on the static board. Group noted it could be online and more detailed documents when printed. AN noted that it should be on anything that hasn't gone to print.</p>	TK

	MH from Railway Fields joined the group. Noted that in regard to the bridge options they could offer advice and training. Group noted that Pockets Park funding could be explored.	
3.	<p><b><u>Future of KfH premises</u></b></p> <p>RC informed the group that it is agreed in principle to have premises for December. Liability insurance would have to taken out.</p> <p>RC confirmed that the Christmas lights would be switched on 7<sup>th</sup> December.</p> <p>NC noted that if the group have the KfH premises, an indoor market could be arranged for that evening. RC to liaise with Jessica.</p> <p>KH noted that she is in liaison with UCL Advances re a scheme focused on providing retail spaces for food, trade and craft businesses i.e. market stalls/ gallery space and community hubs.</p> <p>Deputy Director of UCL Advances, Paul Stalk and IS will meet to discuss further.</p> <p>IS commented that the group needs to be clear as to how long they would be willing to commit.</p> <p>KH to liaise with NC in regards to a way forward. 3.	<p><b><u>Bridge income from advertisements</u></b></p> <p>It was noted that the group had not received any income from Bay Media and this has not been paid to the council. Traders were promised 21% (£2730). NC to progress further.</p> <p>In regards to the bridge options currently no advertising space is planned into the options. However, one side of the bridge could be used for advertising. Traders could get a contract with another company for this purpose.</p> <p>SM noted that he supports that one side should be used to generate income.</p> <p>AN noted that any income would need to be reinvested in the area on e.g. flowers and hanging baskets.</p> <p>ZB comments that traders could sponsor any future planting. ED to find out how much was spent in Tottenham and who is the contractor.</p>	<p>NC</p> <p>ED</p>
4.	<p><b><u>Arena Development</u></b></p> <p>ZB confirmed that she is awaiting a response to a letter sent on the matter.</p> <p>NC noted that she had been informed that TK Maxx is to occupy the site. However, there is inconsistency in the information provided to different parties. The group noted that David Lammy be made aware and meet with management. ZB to email David Lammy.</p>	ZB

<p>5.</p>	<p><b><u>Crime statistics</u></b>  ZB noted that there is no response or intelligence information provided from the St Ann's team.</p> <p>IS noted that there was a spike of incidences in the wards during the Olympic period. Vast amount of burglaries are opportunist. From the most recent figures 5 entered through an open window.</p> <p>IS informed the group that the LCSP has good links with the Harringay Team.</p> <p>NC noted that whilst there are crime statistics on the web, this information is not as detailed as the information provided to IS.</p> <p>NC to invite Morris Hutchinson and Mark Hembury to a future meeting. ZB noted that the next area forum meeting could focus on local policing (11<sup>th</sup> February).</p> <p>AN noted that the sergeants must provide up to date figures and should regularly attend meetings.</p>	<p>ZB</p>
