Schools in Haringey

Primary – 65 schools

47 primary schools, 9 infant and 9 junior

- 9 academies and 3 free schools
- 38 community schools
- 1 voluntary-controlled
- 14 voluntary-aided

- 6 academies
- 1 foundation
- 5 community (one of which is a single sex girls school)
- UTC 14-19

How the need for additional places is identified

- Place planning school rolls and projections are published in the yearly Haringey School Place Planning Report
- This includes birth and population data and information relating to new housing developments.
- Specific schools are indentified for delivering additional places by applying the School Place Planning Principles relating to – popularity, school standards, space and value for money

Admissions processes

The Admission arrangements and criteria for Community schools are agreed by Cabinet each year (following public consultation)

- Parents can list up to 6 schools
- The admissions criteria are applied to each preference
- The highest possible preference is offered
- If we cannot offer any school, the nearest school with an available place is offered

Application deadline - 15 January 2015

Offer date - 16 April 2015

Secondary transfer (Haringey residents)

Application deadline – 31 October 2014

Offer date - 31 October 2014

In Year admissions (applications made to the borough where the school is located)

Children moving in to the borough or moving schools
