1. Describe the issue under consideration

1.1 To approve a request to award a contract for the above project as allowed under CSO 9.06.1.c and 7.01.b which allows the selection of one or more contractors from a Framework or similar arrangement (including approved lists), established by a public sector body for the urgent need to appoint and assign a In-situ External Property and Construction Related Project Manager Resource for the Delivery of the Future Haringey programme.

#### 2. Recommendations

- 2.1 To appoint MACE limited in the sum value of £57,109.00 based on 1Nr Lead Programme Manager full time equivalent resources at 8 hours per day, 3 days per week for 12 weeks plus 19 hours (307 total hours) at £87.00 per hour and 1Nr Senior Programme Manager at 8 hours per day, 3 days per week for 15 weeks plus 20 hours (380 total hours) at £80.00 per hour for the Delivery of the Future Haringey programme.

- 3.1 Do Nothing the Council is committed to undertaking the programme delivery.



# 4. Background information

The Property and Major Projects business unit presently do not have sufficient programme management resources team to fully service the urgent need for programme manager resources. Haringey are now commencing the next stage of what was the Future Haringey Accommodation Strategy.

The Wood Green Investment Programme has achieved outline Cabinet Approval for Option 4 of the regeneration, this option looks to create a new council office within the Clarendon Road area incorporating Library, Customer Service Centre and Democratic Space.

In order to consolidate the existing office portfolio further and release key sites for the Development Vehicle, The Cheif Operationg officer has acknowledged that the FOAS programme needs to be merged with New Ways of Working, Shared Business Services and the Workforce Planning Programmes. This concept has been approved at the Resources Priority Board.
