## 2. Summary of the proposal

The council is considering the use some of its vacant permanent council housing stock to provide temporary accommodation ("TA") to homeless households, instead of using this stock to provide housing on a permanent basis.

The stock to be used will be one bedroom properties and will house "two bedroom" families while they wait for permanent rehousing. This will mean that a higher number of families can be housed in the borough, but lead to longer waiting times for one bedroom households.

# Outline the key findings of your data analysis.

The tables below show the demographic breakdown of the one and two bedroom homeless households living in Haringey's temporary accommodation as at 20 December 2016.

This data was used to compare the characteristics of those who would benefit from the policy (two bedroom households) with those who may face longer waiting times (one bedroom households).

# 4. a) How will consultation and/or engagement inform your assessment of the impact of the proposal on protected groups of residents, service users and/or staff?

Consultation on this paper has not been undertaken directly, as we have recently concluded consultation the Homelessness Strategy on 29 January 2017, and specifically, the consultation a new Temporary Accommodation Placement Policy. This 8 week consultation ended on 7<sup>th</sup> September 2016 and received 369 responses or around 12% of all households in TA. The exceptionally high response rate demonstrates that the location of temporary accommodation is extremely important, and there was very strong support for giving priority for local placements to those who are working (70%) or have children taking exams (64%).

## 4. b) Outline the key findings of your consultation

The TA Placement Policy (see 4a) set out the priorities given for households to be placed in the borough, and placed within London. Respondents were asked to rank proposed criteria and suggest their own for in-borough and in-London placements. After "length of local connection", the most common additional criteria was for "families with children in school" and "single parents". Both these groups will benefit from the increased in-borough placement available from the use of permanent stock as TA.

# 5. What is the likely impact of the proposal on groups of service users and/or staff that share the protected characteristics?

#### 1. Sex

80% of two bedroom households are female headed compared with only 58% of one-bedroom households. As 72% of two bedroom households are single parents, this policy will have a positive impact on such households due to the support they will receive from family and friends in their Haringey support networks by remaining in the borough.

# 2. Gender reassignment

Transgender people aged 16 – 25 are more likely to be homeless compared to non-transgender people and maybe more likely to constitute a household with a one bed need. Data on gender reassignment is not collected as part of the application process and so there is no information available to confirm the size of accommodation required by this group. Also, it should be noted that there is an LGBT pathway in place which helps households find suitable accommodation which would help mitigate any potential impact on this group. Overall however, there is insufficient information to fully assess the impact and so impact is consequently unknown.

# 3. Age

There will be beneficial effect for households headed by 21-40 year olds who make up 71% of two bedroom households, but with increased waiting times for those aged 21-30 who make up 44% of one bedroom households. However, it is also noted that there would be a significant increase in the number of children placed in the borough.

# 4. Disability

Physical and mental disabilities are collated when this is an applicant's Priority Need – mostly single applicants. This is not collated for households have Priority Need such as having dependant children under 18. As at 20 December 2016, 14% of one bedroom households in TA had a mental health disability and 15% had a physical disability. Although disability rates in two bedroom households are unknown, it is likely that these will be higher than Haringey's general population (13% and 6% respectively).

Households who require two bedrooms to allow a carer to reside with them, or an additional room for medical reasons will not be required to move into smaller, one bedroom properties.

The impact of waiting times will have a larger effect on these groups. The impact will be larger for those households requiring an accessible property if these are used for TA instead. This can be mitigated by ensuring that adapted properties are not used for TA.

# 5. Race and ethnicity

There are similar ethnic profiles among one and two bedroom households and the effect of longer waiting times is not expected to have an undue affect on these groups.

Sexual orientation is not collected as part of a homeless application, but LGBT people maybe more likely to constitute a household with a one bed need. However, data on sexual orientation is not collected as part of the application process and so there is no information available to confirm the size of accommodation required by this group. Also, it should be noted that there is an LGBT pathway in place which helps households find suitable accommodation which would help mitigate any potential impact on this group. Overall however, there is insufficient information to fully assess the impact and so impact is consequently unknown.

As at 20 December 2016, there were only 2 one bedroom households and 4 two bedroom households containing a pregnant woman. However, the benefits of additional TA placements in the borough will be greater for women who are pregnant and with babies aged less than 6 months as this will help maintain local support networks and access to already existing health care packages.

Marital/ Civil Partnership status is not collected as part of a homeless application, but it is not anticipated that this policy would be detrimental or that this group would be disproportionately affected.

## 10. Groups that cross two or more equality strands e.g. young black women

This policy will be beneficial to two bedroom households who are placed locally instead of out of the borough, and this is beneficial to many households with protected characteristics. These benefits are concentrated further when these characteristics are combined, and in particularly, young black women who are over-represented among homeless households.

# Outline the overall impact of the policy for the Public Sector Equality Duty:

Although the policy will affect the same number of two bedroom households as the number of households with greater waiting times, there will be a significantly higher number of individuals who benefit.

The largest impact on those with protected characteristics is on those with disabilities who form a higher percentage of one bedroom households. However, the impact will be minimal where the households are already placed in suitable TA before and during the extended waiting time. There will though be a detrimental affect on this group if the current accommodation is not adapted to their needs.
