

## **Summons to Attend Council Meeting**

A meeting of the Council of the London Borough of Haringey will be held at the Civic Centre, High Road, Wood Green, London N22 8LE on MONDAY 3 FEBRUARY 2003 at 19.30 HRS, to transact the following business:

1. To receive apologies for absence.
2. To approve as a correct record the minutes of the meeting of the Council held on 13 January 2003 (circulated separately).
3. To ask the Mayor to consider the admission of any late items of business in accordance with Section 100B of the Local Government Act 1972.
4. To receive such communications as the Mayor may lay before the Council.
5. To ask Members to consider whether they need to make a declaration in accordance with Section 106 of the Local Government Finance Act 1992 in relation to unpaid community charge or council tax liability which is two months or more outstanding. Members to whom this applies must make a declaration if they are present at any part of the meeting and must not vote on any matter relating to the budget. It is not sufficient for such members to refrain from voting or to absent themselves from the chamber for particular parts of the meeting.
6. To consider a report of the Director of Finance on the Council budget for 2003/2004.
7. To receive the report of the Chief Executive.
8. To receive the report of the Monitoring Officer (to follow).
9. To make appointments to outside bodies (to follow).
10. To consider requests to receive deputations and/or petitions and, if approved, to receive them.

11. To receive reports from and adopt the minutes of Council Committees as follows: -

- (a) The Executive – 14 January 2003.
- (b) Overview and Scrutiny Committee – 20 January 2003 (to follow)
- (c) Standards Committee – 7 January 2003

(a) & (c) were circulated with the Council minute book.


