

UPDATE ON SACRE MEMBERSHIP

Report of Clerk to the Committee – December 2004

A chart showing the current membership status is attached and summarised below:

- Miss Campbell (Group A) of the United Reformed Church has tendered her resignation. She will speak to the Rev Ackroyd about a replacement.
- Mrs Kennard of the Board of British Jews (Group A) has tendered her resignation. The Clerk has contacted the Board of British Jews for a replacement.
- Hannah Eisemann-Renyard has tendered her resignation as a Quaker Representative. The Clerk has written to request a replacement nomination.
- Cllr Fabian has resigned as a Councillor from Haringey and Cllr Gail Engert will act as her replacement in the interim.
