SC25. APOLOGIES: Apologies for absence were received on behalf of Councillor Reynolds an Mr R.Celaire

SC26. MINUTES

RESOLVED:

That the minutes of the meeting held on 4 November 2002 be confirmed and signed.

SC27. MATTERS ARISING:

The Chair confirmed that an article on the Standards Committee had appeared in the December edition of 'Haringey People'. The Chair would approach the Editor of 'Insight' for a similar article to published.

The Chair confirmed that the letter to all members of the Council and relevant co-optees, advising the intention to place on the Council website general information about the code of conduct, regist of interests, the Standards Committee etc, had been sent on 24 December 2002. The Liberal Democrat Group had discussed this at their recent meeting and had agreed that the details of all members be included on the website. The Labour Group would discuss same at their meeting, to be held on 9 January 2003.

SC28. ANNUAL REPORT ON COUNCIL'S COMPLAINTS PROCEDURE: 2001/

Highlights of the Report were presented, which had been approved by The Executive in November 2 It was agreed that the 'oversight responsibilities' of the Committee required defining as a broader func to be looked at further in a review of the Constitution. It was considered that the Committee shoul involved at an earlier stage during the development of such procedures and not just at the final stage approval alone. The Chair agreed to write to the Head of Local Democracy, setting out the Commit view, regarding its relationship with other Council Bodies. The Committee requested regular update progress of implementation of the Complaints Procedure every six months and the Chair agree investigate the same protocol for the 'accounting procedure'.

It was confirmed that neither a 'review' nor 'appeals' procedure in relation to complaints, was consid to be necessary.
