WRITTEN QUESTION 1 – TO THE CABINET MEMBER FOR COMMUNITIES FROM COUNCILLOR ALLISON:

What actions has the cabinet member or Leader of the Council taken to lobby the Borough Commander to take action to combat the current spate of burglaries in Highgate?

ANSWER

The Cabinet Member is in constant liaison with the Borough Commander on policing matters concerning the Borough.

Specifically on burglary the MPS is undertaking Operation Aled which is operating in the Highgate area in direct response to the recent spate of burglaries, many of which are using mopeds. This includes:

- Use of all partnership cameras to gather evidence
- Use of automatic number plate recognition (ANPR)
- Work with local garages to locate mopeds
- Increased police resources and patrols
- Plain clothes police operations
- Assessment of how to use traffic operations to disrupt activity
- Enhanced press notifications (attached)

WRITTEN QUESTION 2 – TO THE CABINET MEMBER FOR THE ENVIRONMENT FROM COUNCILLOR BEACHAM:

WRITTEN QUESTION 3 – TO THE CABINET MEMBER FOR ECONOMIC DEVELOPMENT AND SOCIAL INCLUSION FROM COUNCILLOR BLOCH:

Are all mobile phone masts installed under permitted development rights, without consultation with local residents surrounding the proposed site?

ANSWER

No.

Mobile Phone Mast (MPM) applications fall into three categories as set out and prescribed in Government Regulations:

- Prior notification applications MPMs with total permitted development rights.
 The Council is simply informed it will happen, therefore no local public consultation is undertaken.
- Prior approval application MPMs with partial permitted development rights. The Council is informed and is given an agreed number of days to comment on location and design with certain constraints. The Planning Service undertakes public consultation on this type
- Planning applications The Planning Service undertakes public consultation on this type.

MPM applicants must always get approval/permission of the land owner.

WRITTEN QUESTION 4 – TO THE CABINET MEMBER FOR FINANCE AND CARBON REDUCTION FROM COUNCILLOR BUTCHER:

How much did the new microphone system in the Civic Centre cost to buy and install?

ANSWER

The cost was £17,500.

WRITTEN QUESTION 5 – TO THE CABINET MEMBER FOR THE ENVIRONMENT FROM COUNCILLOR ENGERT:

What is the criterion for determining where the Council installs new street lighting and how are incidents of crime included in this evaluation?

ANSWER

When determining the installation of street lighting the main priority is the structural integrity of the borough's old lighting columns. The condition of columns is assessed by inspections which are carried out by engineers to determine a programme of those which will require replacing. This list is then referenced against information or requests received from the Police.

We also have a reactive lighting maintenance programme, which includes a rolling programme to clean and re-lamp existing columns.

WRITTEN QUESTION 6 - TO THE CABINET MEMBER FOR ECONOMIC DEVELOPMENT AND SOCIAL INCLUSION FROM COUNCILLOR ERSKINE:

In what areas in Haringey do mobile phone companies or their subsidiary companies have permitted development rights to install new masts without consultation with local people?

ANSWER

There is no specific area or areas which apply, the whole Borough is the subject of the regulations regarding this matter. The spread of mast installations relates to the coverage required to maintain good reception throughout the area by the providers.

<u>WRITTEN QUESTION 8 – TO THE CABINET MEMBER FOR ENVIRONMENT FROM</u> COUNCILLOR HARE:

Since fortnightly collections were introduced how many requests have been made by residents for alternative size wheelie bins and how many have been provided?

ANSWER:

Veolia receives on a daily basis requests for all types of containers including 120 litre wheeled bins. To date Veolia has delivered 350 of these smaller bins.

WRITTEN QUESTION 9 – TO THE CABINET MEMBER FOR ENVIRONMENT FROM COUNCILLOR JENKS:

From information recorded at recycling depots please provide a breakdown of recycling rates for domestic rubbish in areas within Haringey for the years 2009, 2010 and 2011. This request is on the understanding that recycling rates are not available by ward boundary which would be preferred information.

ANSWER

It is not possible to provide a breakdown of recycling rates by ward or by specific area boundaries. The refuse and recycling kerbside and blocks collection rounds are designed to be as operationally efficient as possible and do not follow ward or specific area boundaries.

Rounds are subject to amendment over time and so it is not possible to compare recycling rates for rounds over 2009, 2010 and 2011.

WRITTEN QUESTION 10 – TO THE CABINET MEMBER FOR COMMUNITIES FROM COUNCILLOR NEWTON:

Please provide a current list of the vacancies in all Safer Neighbourhood Teams and whether the Council and the local Police have set a deadline as to when these positions will be filled.

ANSWER

This issue of staffing of the Safer Neighbourhood Teams is a concern for the Cabinet Member for Communities and is the subject of discussions with the Borough Commander.

Vacancies in the SNTs have mainly been caused by the recruitment of PCSOs as Constables. The Metropolitan Police lead their recruitment centrally, and a PCSO recruitment campaign began on 24 February. As recruitment is centralised, it is not possible to confirm when all the posts will be filled.

From 16 April, there will be an additional 80 police officers to support the Safer Neighbourhood Teams, and members should start to notice greater support to neighbourhood policing.

WRITTEN QUESTION 11 – TO THE DEPUTY LEADER AND CABINET MEMBER FOR CHILDREN FROM COUNCILLOR REECE:

Please provide the percentage of 16-19 year olds not in education, employment or training (NEETs) for each of the last three years and the percentage of 16-19 year olds that the Council was not aware of their status in each of the last three years.

ANSWER

All %s are for the three month averages between Nov and Jan, which is how the DfE measures performance. In 2009/10, we were required to collect data for 16-18 year olds.

Figures for NEETs

2009–2010 % of 16-18s who were NEET = 6.8%

2010–2011 % of 16-19s who were NEET = 6%

2011–2012 % of 16-19s who were NEET = 4.3%

Figures for Not Knowns

2009–2010 % of 16-18s whose situation was Not Known = 5.0%

2010–2011 % of 16-19s whose situation was Not Known = 5.5%

2011–2012 % of 16-19s whose situation was Not Known = 34.2%*

The higher Not Known average for 2011/12 is due to the change in cohort rules from April 2011. 19 year olds are now included in the target cohort and the NEET cohort is now calculated by borough of residency as opposed to educational establishment. This has contributed to the rise in Not Knowns, due to issues in establishing the destinations of borough residents being educated outside of North London. This is mirrored in the performance figures of other boroughs.

We are actively seeking to make contact with these young people, and I am pleased to report that the figure for 16-19 year olds without known destinations at 16 March 2012 now stands at 32.9%. This is a reduction from the 34.2% average recorded in January 2012 - evidence that our tracking activities are beginning to take effect.

WRITTEN QUESTION 12 – TO THE CABINET MEMBER FOR ENVIRONMENT FROM COUNCILLOR REID:

What is the average time taken in each ward from when a pothole is reported to it being filled and what is the Council's performance target?

ANSWER

We have three performance measures:

It is our understanding that the OFT has launched an extensive review of the payday lending sector, prompted by concerns that some payday lenders may be taking advantage of people in financial difficulty.

AMENDMENT TO **MOTION E** (2011/12)

(Deletions have been struck through and additions are in bold)

This Council believes:

- That women in Haringey are sadly paying the price of the last Labour Government's disastrous failure to regulate the banks and keep public spending under control, and that responsibility for this country's severe economic problems, increased unemployment and the crippling public sector spending deficit lie squarely with the Labour Party
- The Coalition Government's changes to taxation, benefits and pensions are unfairly targeting women which includes the recent announcement of an increase in the basic tax threshold to £9,205 in 2013, help low-paid workers, the majority of which are women
- The changes to working tax credits in April 2012 will make life harder for many low paid women in part time work in Haringey Since May 2010 the government's changes to the lowest tax thresholds has reduced the tax burden on many local families and women
- The Government's equalities Minister has failed to recognise the impact of their damaging deficit reduction strategy on the economic security of many women continued to champion the rights of women. The government has extended the right to request flexible working, will set up scheme to recruit and train 5,000 mentor specifically to provide support for women to set up or grow their business, help women into work through individual plans in the work programme and ensure women are not penalised for working.

This council notes:

- The recent IPPR analysis that showed how 33,000 more women were out of work between October and December 2011 compared to 16,000 more men but notes that the overall rate of unemployed men (9%) is higher than that of women (7.7%)
- More than one million women are now unemployed, the highest number in 23 years and that this is a one of the consequences of one of the worst financial crashes in the last 70 years made worse by the last Labour government

- Around 8,500 women in Haringey will be adversely affected by the accelerated state pension age The delay in reforms to increase the state pension age to 66 due to concerns about the impact on women
- In Haringey, around 1880 families are likely to lose all of their working tax credits this April. Since 2010, 3,660 families in Haringey have been taken out of paying any income tax at all. By April 2013 this is set to increase to 5,830 and, in total, 80,000 families will have their tax burden decreased
- Around 1900 families in Haringey will be losing help with childcare costs. The
 government has provided £300 million for childcare support under the
 Universal Credit, on top of the £2bn already spent under the current
 system. The will allow around 80,000 additional families to benefit from
 childcare support.
- Labour's decision to reduce funding to Children's centres in Highgate,
 North Bank and Rokesley which provide childcare and which will severely impact on local women

- To write to the chancellor **and the cabinet member for finance** asking he that they looks into the disproportionate affect the Government's tax and benefits changes **and the Council's budget spending decisions** are having on women
