Title:	Philip Lane Walkabout
Purpose of briefing:	To provide information on the range of issues identified during the Philip Lane Walkabout and implications arising.
Lead Officer(s):	Ann Cunningham, Head of Traffic Management

1. Introduction

- 1.1. The following report outlines the issues / problems identified during a walkabout in Philip Lane, which was attended by officers from the Traffic Management, Neighbourhood Services and Ward Councillors. Those issues ranged from general maintenance of the existing infrastructure, to design and enforcement issues.
- 1.2. Philip Lane is a classified road, serving as a route for a number of buses travelling between Tottenham High Rd / Seven Sisters to St Ann's Rd and West Green Road towards Wood Green High Road. It experiences high level of traffic at particular times of day. Traffic levels have increased since the implementation of the traffic scheme implemented in May 2006 in the Bruce Grove area. This will at times result in high levels of congestion. Appendix A sets of the issues identified and potential solutions.
- 1.3. A number of the maintenance issues highlighted will be addressed as part of our maintenance schedule. Officers have also committed to trialling additional footway enforcement, especially at locations where vehicles are crossing the pavements to access parking on private property.

2. Financial Implications

- 2.1. The total costs of the solutions identified are £46 651.00 if addressed as individual projects. These costs could be reduced by £25k if programmed as a complete scheme. This reduction relates to the consultation and legal order aspects of the work. The breakdown of those costs is available in Appendix B.
- 2.2. The cost of those works needs to be weighted up against the budget available and prioritised against other essential works that may need to be carried out elsewhere in the borough. This budget is set for 2013/2014 and is £60K for Parking infrastructure maintenance and £550k for reactive maintenance (which is proportionate use from the planned carriageway and footway maintenance additional investment).



Appendix A

Location 1:

Philip Lane Outside school entrance, existing single yellow lines operate Mon- Sat.
 8:30 am – 6 pm.





Possible Solutions: introduction of loading restriction Mon- Sat, 8:30 am - 6 pm to mitigate waiting in this location.

Location 2:

- New raised table at same level of footway encourages drivers to park on footpath.
- This design could causes problems during wet periods as storm water could run onto the footpath.



Possible Solutions:

Implement parking bay to prevent footway parking.

• Subsequence investigations indicated flat flooding is not an issue at this location, there may be issues of surface water during extreme inclement weather, but this is not at a level which requires intervention.

Location 3: Opposite 243 Philip Lane.

Double yellow lines required on the northern side of the carriageway adjacent to the refuse.



Possible Solutions:

- Extend double yellow lines from the junction of Keston Road to a point 5 metres east of the refuse.
- Add at any time loading restriction (double kerb marking) to the existing restriction on the southern side of Philip Lane and to the proposed double yellow lines on the northern side.
- Add at any time restriction to existing double yellow lines on the junction of Keston Road and Bourn Avenue.
- Hatching and centre line needs remarking.

Location 4: Philip lane from its junction of Mansfield Avenue eastwards toward the junction of Downhills Park Road.



Possible Solutions:

- Waiting and loading restriction required alternative side to facilitate the free flow of traffic.
- Centre line needs remarking.

Location 5: Approach to junction of Downhills Park Road






Possible Solutions:

- General maintenance of all restriction at this location.
- Waiting and Loading Restriction on the junction of Downhills Park Road need to prevent loading at any time.
- Loading restriction on the northern side need remarking/maintenance
- All signage needs to be checked and reinstalled where necessary.

Location 6: Crossing facility on Downhills Park Road



Location 7: Bus stop outside 270 Philip Lane



Possible Solutions: Bus stop badly faded, needs remarking.

Location 8: outside and opposite 264 Philip Lane

- Concerns were raised with the footway parking on the northern side of Philip lane due to construction of footway.





Is Haringey over the limit?



The rise in alcohol-related harm











Drinking: too much of a good thing?

Since 1970 the amount of alcohol consumed per person has risen by 50% in the UK. During this time alcohol has become relatively cheaper and more readily available. Alcohol is aggressively and expertly marketed and drinking has become a normal feature of everyday life.

Alcohol can play a positive social and economic role - and the large majority of people enjoy alcohol without harm. However, excessive alcohol use can have a harmful effect on individuals, their families and our community.

There are huge costs to the UK economy, the cost of inpatient admissions in Haringey is estimated to be at least £7.5 million.

Alcohol was named as the most dangerous drug in the UK in 2009. It has become ever-present in our lives and those of our children: recognising when we go over the limit is not always obvious. There are currently 884 licensed premises in Haringey, a rise of 41% or 255 new premises since 2005-6. These premises, along with larger supermarkets and on-line shopping facilities, often encourage bulk buying through considerable discounts.

Alcohol consumption is higher in men, in white English and Irish populations and lower in many Black and minority ethnic communities, though this may be changing in second generation communities.

Around 1 in 10 people in Haringey are binge drinking and over 10,000 people across the borough are higher risk drinkers, regularly going well above their daily recommended limits. More hidden are the 57,000 residents (around a quarter of people in the borough) putting their health at increased risk with less dramatic consumption - i.e. between 15 and 35 units a week for women and 22 and 50 for men.

Why is drinking over the limit bad for you? Health harm

Alcohol-related harms are broad ranging and associated with even moderate levels of drinking. Health-related problems include: hypertension, cardiovascular disease, cancer, liver disease, mental illness, accidents in the home and on the road, violence and premature death. In most cases the relationship between alcohol and illness is simple: the more you drink the greater the risk of harm.

Men in Haringey have the highest death rate specifically due to alcohol in London. Around 6% of all hospital admissions in the borough are related to alcohol consumption – an increase of 224% between 2002 and 2012. Compared to England, men in Haringey are much more likely to be admitted to hospital and people living in the most deprived areas of Haringey have a quarter more admissions than the Haringey average. Reduced consumption would improve health inequalities as lower income groups suffer greater health harms.

Social harm

Alcohol misuse and dependency can affect work productivity, which can result in additional financial pressure on families.

Children and young people can often do little to protect themselves from the effects of parental drinking and can suffer emotional distress, neglect or violence. In Haringey, over one in ten (13%) people who seek alcohol treatment are parents living with their own children and nearly one in five (18%) have parental responsibility.

Nationally in around half of all violent crimes, victims believed their attackers had been drinking. Alcohol is also a common feature of domestic and sexual violence.

High levels of alcohol consumption are associated with increased risk taking particularly among young people, including unsafe sex and drink driving.

What are we doing to reduce alcohol-related harm?

Tackling alcohol-related harm is a complex issue. In Haringey, the council, the NHS, police, fire, probation services and the voluntary sector are:

- Raising awareness of sensible drinking as well as the impact of alcohol misuse through campaigns, both national and local such as alcohol awareness week (November every year) and Haringey's online alcohol screening and advice tool Don't Bottle It Up (www. dontbottleitup.org.uk)
- Preventing alcohol-related harm to children and young people by working with schools and other frontline services
- Strengthening enforcement to control access and reduce alcohol-related crime and anti-social behavior
- Increasing early help by training frontline staff to ask the right questions and provide basic advice and signposting to services
- Encouraging self help by promoting self help groups such as Alcoholics Anonymous (www. alcoholics-anonymous.org.uk) and Al-Anon (family and friends, www.al-anonuk.org.uk)
- Providing effective treatment by continuously improving our services for people with alcohol issues and the families and children affected by alcohol misuse. Haringey's local alcohol advice and treatment services is Haringey Advisory Group on Alcohol (HAGA) (www.haga.co.uk)



Dear all,

Public health is now at the heart of your local authority.

After a successful transition from the NHS to the local authority, I am delighted to present my second annual Public Health report focusing on alcohol. These reports are important ways for me to bring to your attention key health concerns in Haringey. They highlight the way in which public health is everyone's business.

Last year we focused on the dramatic rise in childhood obesity, a crisis in our community requiring collective and individual action. The publicity and interest generated by the report helped us focus on tackling the proliferation of fast-food outlets in the borough. We're working with academics and young people to

do on-the-ground research on the role fast food plays in their diets and ways we could tackle excess. We have strengthened our approach through good connections between public health, planning and environmental health to take this work forward, in particular linking to schools and local businesses.

Tackling alcohol-related harm

In this year's report, we focus on the rapid increase in alcohol-related harm in our borough, an issue that similarly needs our urgent individual and collective attention. Tackling alcohol misuse is key to achieving the outcomes in Haringey's Health and Wellbeing Strategy: giving every child the best start in life, reducing the gap in life expectancy between the east and west of the borough and improving mental health and well being.

Alcohol can affect people negatively, this impact is generally greater in people experiencing a whole range of challenges linked to poverty. Alcohol-related harm drives health inequalities.

Everyone should have the right to enjoy the best possible health outcomes and tackling alcohol-related harm is one of the ways we can achieve this. We need to create community spaces that are alcohol free or where alcohol can be enjoyed but in moderation. We need to give people the tools to understand when they are drinking too much and what they can do to cut down. Ideally we want to create a culture that prevents problem drinking from starting and provides help for people early on should they be struggling.

Some of the ways we might do this are: ensuring health considerations are taken into account in any licensing decisions, through community safety efforts to tackle alcohol crime and anti-social behaviour and just as importantly by making sure that the right services are in place for people who need help.

I am proud too of the emphasis Haringey places on recovery – helping people who have misused drugs or alcohol gain control over their lives and the services they receive. We have a network of Recovery Champions across the borough; we actively challenge stigma through initiatives such as Recovery Pride week, peer advocacy programmes and ensure our services facilitate access to education, training and employment skills for people recovering from alcohol or drug problems.

Of course while local action is important, we also need to advocate for tough action at a national level to limit the sale and promotion of alcohol, including setting a 50p per unit minimum price of alcohol.

What can you do?

The issue of alcohol use should be a concern to us all. I would like to hear your stories, thoughts or ideas about how as a community we can build a healthy approach to alcohol and tackle alcohol-related harm. 





1. Describe the issue under consideration

To provide feedback on requested agenda items explain how they have been taken forward.

To further provide an update on previous issues discussed at the forum meetings, this was requested in the feedback questionnaire issued at the last meeting in June.

2. Background

At the first Area Forum and Committee ward members talked about the aims of the Forum and committee which included working with local people to improve the neighbourhood for all residents.

The area committees have additional powers to shape aspects of local services in response to local conditions and residents' concerns. A local area plan for the West Green and Bruce Grove has now been completed and will be guiding future council activities, local budgets and planning decisions in



the area. The plan will now also help shape the agenda for forthcoming Forum and committee meetings.

Meetings start with an open public forum followed by a decision-making session of the Committee that is open to the public.

The Forum is also about shaping aspects of local services in response to local conditions and residents concerns allows opportunities for local residents to ask questions of local councillors and council officials, to make suggestions and raise issues of concern, as well as to network with other local residents, traders and activists.

Suggestions for topics at this meeting were sought from local residents and community groups to enable the agenda to be driven as far as possible by local people.

Joe Cullen – local resident raised the following concerns which have been responded to below.

- Lack of diversity of the shops along Bruce Grove, offering the same products,
- The shop fronts can the store keepers be incentivised to keep their shop fronts tidy/ new lick of paint?

The Tottenham Traders in partnership with the Council and the Police have recently launched the Tottenham High Street Charter which set out a list of priorities to improve of High Streets. One of the trader's objectives is to improve their shop fronts and their window displays. A number of clean up events and workshops will be happening over 2013 to support the traders with this.

One of the Council's key objectives for town centres is to ensure that people have access to a full range and quality of goods and services. The way town centres look is an important factor in their character and the way they are perceived. Through planning policy in particular, the Council seeks to support and promote all of its town centres as existing successful and vibrant town centres and places that will attract new businesses, jobs and homes.

The predominant use in our town centres is A1 (shops). However, in order to encourage a more mix of uses and vibrancy, we will also encourage other appropriate non A1 uses. These include banks, estate agents (A2), restaurants (A3) pubs (A4) and take always (A5) or



community facilities. are also appropriate uses within town centres, and are encouraged.

We recognise that some uses within town centres can have negative impacts on vitality and vibrancy, for example, the clustering of betting shops and hot food take away. The Council is actively working to promote a wide range of retail uses as well as leisure and community uses. The Council is in the process of updating its planning policy on retail and town centres and will be consulting on the document in March. New retail development that will have a negative impact on existing town centres will be resisted where possible. We will encourage proposals that add to the vibrancy and choice of shops in the existing centres

There is ongoing dialogue with Transport for London and Network Rail about their investment plans for Bruce Grove and there are significant projects proposed in the next 2 years that could see all pavements from Monument Way to Bruce Grove re-paved and for the railway bridge to be repainted. We are working with both organisations to confirm and expedite plans.

• Anti social/intimidating behaviour outside numerous betting shops on the High Road. Wondering what the council/police intend to do.

Update on issues discussed at previous forum meetings

Bruce Grove Youth Centre

Five young people who are users at Bruce Grove have been involved in the formation of an Area Youth Forum. There will be a formal launch in February half term with an immediate focus on recruitment and fundraising. The young people want to make a short film of what life is live for them in the Tottenham area and use this mechanism to identify key issues for consideration.

Bruce Grove Youth Centre is currently used four evenings per week and is used by a Training Provider, First Rung, and two days per week to work with young people who are at risk of disengaging from employment or training. It is also used during the day time by students at the Tuition Service (an alternative provision for students with medical needs or who are school phobic or who have additional educational needs) for recreational activities in their break time. The Centre provides a safe meeting space for our work with young people who need individualised targeted support. Unity Radio, an internet based radio station is based at Bruce Grove. On average 25 young people attend and they have successfully interviewed a number of high profile people including: the US



Haringey Council

Secretary of State's Special Envoy, Hannah Rosenthal at the Hours Against Hate walk at Bruce Castle Park, KC, a DJ at Choice FM, David Lammy MP, and Labrinth, a chart topping performer at the Spirit of London Awards 2012.

We are working in partnership with the Harington Scheme to provide work experience and accredited horticultural training to a group of young people with LDD. The young people will work to reclaim the land at the back of Bruce Grove and transform it into a wildlife garden with the prospect of incorporating natural play and growing fruits and vegetables.

Broadwater Farm Facilities and Amenities

Higham Road

In response to the suggestion to have convex mirrors along the public highway, the Highways team have advised that the glare from the mirror can often increase the potential for accidents

Bullying in Schools - raised by the Broadwater Farm Resident's Association on April 23 2012.

There was a presentation at the last meeting on the 28.02.2013 about role and influence of the council on this matter . The presentation contained some good information for parents and was published on the council website as part of the west green and Bruce Grove agenda for 28.02.13 . Links to the education welfare service website which can provide guidance to parents about how to take forward a concern with the school if their child is being bullied and the support they can also provide in terms of mediation. The Chair agreed that this subject is returned to in 18 months time.

The roles and ways to expand performing arts and positive benefits it has in our local area especially as children, younger and older people can be involved promoting creativity, health, friendship and positive activities. Notes of the presentation and discussion were passed to Regeneration and Children's services.

Council Tax Benefit Changes

Previously the Area Forum had been advised that Council tax benefit was being abolished and local authorities were being required to develop their own schemes by 31 January 2013, for 2013/14. The government was transferring the support to councils in 2013/14, with a reduction in funding of 10% and a requirement that the council's own scheme must maintain the support to



pensioners. Cabinet had considered various options for the scheme at its meeting on 10th July 2012 and agreed to consult on the following 4 proposals

- To reduce payments to all working age claimants by an equal proportion in line with the reduction in government funding estimated to be 20%.
- Reduce savings and investment allowed to £10,000
- Remove entitlement if less than £1
- Amend the maximum backdating period.

Subsequently, consultation responses from residents in November 2012 indicated a desire that some groups to be protected – in particular pensioners and the disabled. In response, the scheme recommended, protected claimants in receipt of particular benefits and recognised significant disability,

Full Council agreed on the 17th January to a reduced council tax support to working age claimants (excluding those in receipt of certain disability related benefits) by 19.8% overall, and also agreed the following technical changes to exemptions and discounts.

- a) Reduction of discount on Class D empty properties undergoing major repair (previously known as Exemption Class A) to 50% for one year and 0% discount thereafter. This was previously agreed at a flat 0% discount;
- b) Payment of an Empty Homes Premium on properties that have been empty and unfurnished for more than two years of 50%. Unoccupied annexes and properties belonging to a member of the armed forces currently absent as a result of this are excluded from this premium;
- c) One-off 100% discount for the first calendar month for Class C properties (Empty properties) and 0% discount thereafter. Occupation periods of less than six weeks will be disregarded in administering this discount:
