1. Describe the issue under consideration

Black History Month: The Panel requested details of the Black History Month programme in libraries as they may wish to feed in suggestions for next year. BHM events in the libraries are mainly publicised in the monthly **What's On**, which is available both in hard copy and online. This year we have produced a BHM brochure alongside the October edition of **What's On** (which will only list events). This is for ease of use and to avoid **What's On** becoming too large. The publications are distributed in various locations across the Council along with the use of social media, library plasma screens and posters. Details of individual events taking place in each library also appear on the Council website and the library webpage.

Libraries and Bruce Castle Museum have been organising Black History Month for some years. Staff in libraries and the museum have always embraced Black History Month with enthusiasm and all have helped deliver a huge variety of thought-provoking and entertaining events. There is no funding for activities and no staff allocated specifically to organise the BHM programme (apart from a Senior Librarian who has volunteered to act as a coordinator).

Despite this, libraries are generally able to tap into local partnerships and offer an extensive range of activities. The local community are always willing to deliver events and activities for free to the libraries. Last year's highlight was the Venture Smith exhibition and launch at Marcus Garvey Library. This year the programme features lectures, film showings, book launches, exhibitions and cultural and art activities. The libraries also arrange activities for children, including special events for invited classes of children from local schools.
