

Trends in national police recorded crime and Crime Survey in England & Wales(CSEW) 2002/03 to 2012/13 (thousands)


Trends in Haringey recorded crime and Crime Survey in England & Wales (CSEW) 2002/03 to 2012/13 (thousands)



 With the exception of 2011/12, crime in Haringey has fallen consecutively every year since 2002/03, an overall reduction of over 40% www.haringey.gov.uk




Overall level of crime (Haringey) FY 2010/11 - FY2012/13



- 10% reduction in FY2012/13 compared to the previous year
- Greater reduction than either London or MSG
- Haringey's rate is below London and in line with MSG





- 12% reduction for Apr-Sep 2013 compared to the same period last year
- Haringey's reduction higher than either London (8%) or MSG (4%)
- Haringey's rate of 41.4 per thousand pop. is below London (42.8) and in line with MSG (41.0)







MOPAC 7 offences: Apr-Sep 2013 v 2012



- 14% reduction for Apr-Sep 2013 compared to the same period last year
- Haringey had a higher reduction than London (7%) and MSG increased by 5%
- Haringey's rate (23.8 per thousand pop.) is above London (21.6) but below it's neighbouring CSPs (24.2)





- 18% reduction for Apr-Sep 2013 compared to the same period last year
- Haringey's reduction was three times higher than London (6%) and significantly higher than MSG (1%)
- Haringey's rate (3.9 per thousand pop.) is above London (3.5) and in line with MSG (3.8)







Rape offences: Apr-Sep 2013 v 2012




- 8% increase for Apr-Sep 2013 compared to the same period last year
- Haringey's reduction is a quarter less than London increase (33%) and significantly less than it's MSG (23%)
- Haringey's rate (0.28 per thousand pop.) is above both London (0.24) and MSG (0.23)
- Haringey's SD rate of 27.5% is above London rate of 19.6% (for the period 01/04/13 17/10/13)




- 32% reduction for Apr-Sep 2013 compared to the same period last year
- Both London and MSG recorded increases of 8% and 5% respectively
- Haringey's rate (0.34 per thousand pop.) is below both London (0.43) and it's MSG (0.44)
- Haringey's latest SD rate is 29.9% is above the London rate of 22% (1/4/13-17/10/13






- There were 159 reported sexual offences in Apr-Sep 13
- This is equivalent to 0.62 per 1,000 population, less than both London and MSG with 0.67 and 0.69 respectively
- Sexual offences decreased by 19% (37 fewer) in Haringey compared to increases in both London and MSG of 16% and 10% respectively




- 12% reduction for Apr-Sep 2013 compared to the same period last year
- Haringey's reduction was higher than London (8%) and MSG increased by 5%
- Haringey's rate (0.36 per thousand pop.) is below both the London (0.49) and MSG rate of 0.54
- Haringey's latest SD rate is 41.5% in line with London rate of 41.2% (1/4/13-17/10/13)



Youth Offending



- The rate of first time entrants to the Youth Justice System aged 10-17 has reduced by over half (55.5%), from 1352 (228 youths) to 601 (143 youths) per 100,000 of 10-17 population
- 3rd lowest rate in comparator group



- 49.5% of offenders in the Oct 10 to Sep 11 cohort have reoffended, joint highest in London
- Triage has artificially increased the percentage
- Currently conducting data matching exercise with Police to verify levels (local data shows a lower percentage)
- Dealing with a much smaller but offending-entrenched caseload with more complex issues issues



Overall Assessment

- Overall crime in Haringey reduced by 16%
- Major reductions seen in robbery (23.6%), burglary (24.1%) and violence with injury (20.6%)
- Sexual offences have reduced by a fifth (19%) bucking the London trend
- Racially/religious aggravated crime has fallen by 12% more than London and bucking the MSG trend
- With the exception of robbery SD rates for key crimes are off-target. The partnership should continue to monitor these
- The rate of first time entrants to the Youth Justice System aged 10-17 has reduced by over half
- The youth re-offending rate continued to increase, with almost half of the cohort reoffending
- Reducing reoffending among young people continues to be a key priority for the coming year
