6. I have also provided licensing register extract at **page 8** for Seven Foods Limited. They are again licensed to sell alcohol 24 hours a day 7 days a week. You can see the details of my test purchase at **page 9**.
7. My application is not for sale of alcohol 24 hours a day, 7 days a week. I am asking very reasonable times compare to my competitors.
