## FIRST WITNESS STATEMENT OF HUSEYIN SESEN

1. I, HUSEYIN SESEN, am the director of MEVSIM LTD. T/A 4 MEVSIM. I make this statement from facts within my own knowledge save as appears to the contrary. Where the information is not within my own knowledge, I state the source of it and believe it to be true. Any exhibit attached to this witness statement is verified and identified by me.

#### Application - 4 MEVSIM - No.640-642 Lordship Lane, N22 5JH

- 2. The shop is owned by myself and I am the director of the premises. I took a lease of the shop on 2019 for 15 years. It was a huge commitment and has involved a lot of money in set up and running costs. We are very proud of the shop and the benefit it brings to the local community.
- 3. We signed the lease in 2019 and I aim to spend over £80,000 in set up costs converting it from an off licence. The existing premises has been on the site (642 Lordship lane) over 12 years. I attach a number of photographs showing the shop inside and out today paginated [1-2].
- 4. The shop will open in as soon as the new licence is approved
- 5. We pay total of £36,000 for both shops plus the business rate.

- 7. We will employ 7 people in total.
- 8. I can confirm that we have never had any licensing issues with any clients and have never had a single complaint from any section of the public. We are not aware of any ASB issues related to the shop. I confirm, Mr DURAN SESEN still the designated premises supervisor. He has no previous convictions.
- 10. The current licence and proposed licencing times that we seek are set out below:

- 11. The shop at 642 Lordship Lane currently open 24h and after the current licensing times, we seek same condition at 640-642 Lordship Lane.
- 12. I HUSEYIN SESEN I am the current director of the premises, Mr DURAN SESEN is the designated premises supervisor and the personal licence holder.

#### Objections to the Application

#### Haringey Public Health, London Borough of Haringey

- 13. I strongly urge upon this committee that there will be no increase a crime and Disorder, Public Nuisance or reduction of protection Children from Harm, nor the negative cumulative impact on one or more of the licensing objectives. This is because the alcohol will sell in the same location of the previous premises at 642 Lordship Lane, also with the same volume of alcohol. The only change will be to increase the shelves for food and dairy products at 640 Lordship Lane, merging two shops into one shop. Therefore, there is not any change in any matter of sell of alcohol.
- 14. There is always a member of staff at the counter next to the entrance door controlling who is permitted into the premises at any time. It is also has the affect of ensuring that anyone objectionable or seriously under the influence of alcohol is not permitted entry. I confirm that there have been no incidents of violence or ASB although this risk is firmly recognised.
- 15. I am concerned other businesses in the same street might affect my business as they are been in Lordship Lane, these premises has already have 24h licence that may or may not be the case, but I am advised that every application would be considered with the same opportunities. I simply ask that the same arrangements we have in place, recently another premises licence has been approved in the same street with in the las 12 months
- 16. I would like also to point out, if the premises is granted, I would like to apply most of the recommendation suggested by the Public Health. I don't want to restrict my current condition on ABV, also I do not wish to reduce hours of the premises.

#### Other Objections

- 17. <u>Ward Councillors</u> | would repeat the points made below.
- 18. The ward Councillor pointed that is irrelevant the condition "will be accepted that sales of alcohol will not be carried out at any other time than the permitted opening hours" if sales are permitted on a 24/7 basis. I would like to apply this condition in case the premises granted with the different hours then applied.
- 19. I am happy to help to the Council and Local Police to reduce the crime in the area and I will advise people to leave quietly the shop and the vicinity area.

#### CONCLUSION

- 20. The alcohol will not sell in 640 Lordship Lane, it will be restricted to 642 Lordship Lane like in the previous Licence. Therefore, this shop would not have any further issue in the area.
- 20. The premises is not in cumulative impact zone.
- 21. There is no any objection from the Police licence team and we assume they are happy with the application.
- 22. The premises has no crime history to associate any of the local issue.
- 23. There are currently shops opening 24h in immediate vicinity. This particular shop had 24h licence and due to the expansion of the area for %50 or more we require to apply a new licence for 24h. I am totally agreed with Licensing Policies, however, it would not be a fair trading for me to compete with other premises since they open 24h, I also want to point out that my main reason to extend my shop is mainly is due to have a more grocery and I will not increase the amount of alcohol premises already selling therefore my existing 24/7 hours of the alcohol licence should carry on as usual with the extended shop.

- 24. I accept there are issues around street drinking in the area but that the application must be dealt with on its own merits. Despite the wider issues of street drinking, this does not mean that the application should be refused because of the issues in the area.
- 25. In last 8-9 months, another shop made similar application to extend their premises 24h licence to other adjoining shops and simply I want the same opportunity.
- 26. In the last instance I am even happy if I reduce the closing time until 05:00am.
- 27. The Metropolitan Police and Haringey Council had to take responsibility for the wider issues and it was not fair or proportionate for the premises, which had operated lawfully for period of years without a review.
- 28. I hope this statement, which has been drafted by Counsel with my authority following a lengthy meeting sets out our position in a helpful manner in readiness for the hearing on 27/08/2019.
- 29. If the application is refused, I would like to continue with the old licence at 642 Lordship Lane with 24h without merging the shop with 640-642 Lordship Lane.
- 30. I have attached my existing licence for the premises 642 Lordship lane.

## Annex 1 – Mandatory Conditions

Section 19 – Supply of Alcohol

- (2) No supply of alcohol may be made under the premises licence-
- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (3) The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.





## Annex 2 – Conditions consistent with the perating Schedule

This licence has been granted upon the conversion, under Schedule 8 to the Licensing Act 2003, of the existing justices' license and such rights and restrictions that applied thereto are hereby incorporated into this license, subject to any terms herein to the contrary and / or any limitation or restriction imposed by the Licensing Act 2003 or any subsequent amendment thereto.

All fire escapes/escape routes will be clearly marked and kept free from obstruction at all times.

## THE PREVENTION OF PUBLIC NUISANCE

All customers are asked to respect the surroundings and behave in an orderly manner.

Signs will be installed to remind customers to respect neighbours and leave quietly.

Patrons will be discouraged from congregating outside the premises.

All waste generated by the premises will be dealt with appropriately.

### THE PROTECTION OF CHILDREN


Alcohol may only be sold to individuals over the age of 18 with valid proof of identification with one of the following:

- A citizen card, supported by the Home Office






Annex 3 - Conditions attached after a ring by the licensing authority






