## Introduction to JTAI

- JTAIs inspect the multi-agency response to children affected by particular issue in a local authority area in England.
- Inspectors from: Ofsted, CQC, His Majesty's Inspectorate of Constabulary and Fire and Rescue Services (HMICFRS), His Majesty's Inspectorate of Probation (HMIP)
- ➤ Carried out under s20 of the Children Act 2004
- The agencies within the scope of a JTAI are the police, children's social care, education, youth offending services and relevant health services.

#### Thematic Focus: Serious Youth Violence

Inspections will focus on how the police, children's social care, education, youth offending services and relevant health services in local areas work together to address and prevent serious youth violence. The inspectorates will consider interventions with individual and groups of children to see how well agencies help them and reduce the risk of serious youth violence

When referring to serious youth violence inspections will include specific types of crime committed by and affecting children outside of the home. The Serious Violence Duty has superseded the Serious Violence Strategy,<u>https://www.gov.uk/government/publications</u> /serious-violence-duty In addition the JTAIS will also consider multi-agency interventions in places such as parks, streets and shopping malls, where individual or groups of children are at risk, to improve safety for children and for communities. In addition to individual local area reports, an overview summary of the thematic will be published

Guidance refers to 'children affected by serious youth violence'. We use this to cover: children who are victims of violence, children who cause harm to others through violence, and children who are both victims and perpetrators of violence



After the inspection	Findings are published as a letter, setting out strengths and weaknesses, area for improvement, and if relevant priority action areas.





#### Annex A

#### Information request (Annex A)

- <u>Annex A</u> sets out the information that inspectors will request and the timeline for the local agencies to share it. The information includes:
- child-level data, which inspectors will use to select the children whose experiences they will evaluate. (Inspectors will ask the local agencies to audit the experiences of some of these children)
- case records of the children whose experiences the local agencies have audited
- performance and management information that sets out how the local partnership works together

In exceptional circumstances, inspectors may ask for additional information not set out in Annex A and may agree to look at additional information provided by the local partnership. The inspector/local agency must demonstrate that the additional information is:

- necessary for an accurate understanding of children's experiences and the effectiveness of the local partnership in relation to the scope of the inspection
- > not already available through the request in Annex A
