6. Background

- 6.1 The Annual Meeting appoints Committees of the Council. Wherever possible bodies have been constituted in accordance with the provisions of the Local Government and Housing Act 1989 in terms of political balance. Labour Councillors constitute 59.65% of the available seats on the Council; the Liberal Democrats occupy 38.6% of the seats and an Independent Member occupies the remaining 1.75%. Where practicable the allocation of seats on Committees should be in line with the proportion of seats on the Council held by the political groups. The rule about proportionate allocation of seats on bodies overall takes precedence over the rule about proportionate allocation on any individual body.
- 6.2 There is no requirement to offer a seat to a single member as they do not constitute a "political group" under the definition in the Local Government (Committees and Political Groups) Regulations 1990 (S.I. 1553) Regulation 8.
- 6.3 In calculating the allocation of seats on Committees, the following bodies were excluded because they are excluded from the statutory rules on political balance:
 - the Cabinet and its subordinate bodies
 - the disciplinary pool
 - the Standards Committee and
 - other Committees where membership is determined on the basis of electoral ward represented (eg. Area Assemblies)

On this basis a total of 57 seats were available on Committees and Sub-Committees, 33 or 57.89% were allocated to the Labour Group and 24 or 42.11% to the Liberal Democrat Group. In view of the volume of appointments to be made it is expedient to approve the appointments on a "slate" basis rather than on an individual basis.

- 6.4 Changes to appointments can be made at any stage during the Municipal Year with the changes being reported to the Council as appropriate.
- 6.5 The proposed appointments to Committees and Sub Committees and appointments of Chairs are as detailed in the attached Appendix and reflect the changes proposed by the Governance Review Delivery Group.

Non-executive Scheme of Delegation

6.6 The Council's Constitution at Part 4, Section A paragraph 1.1 requires that the Annual Meeting confirms the non-executive scheme of delegation to officers.

7. Financial Implications

All positions attracting a special responsibility allowance are listed in Part 6 of the Council's Constitution.

The Annual Meeting of the Council is required to appoint Committees and subordinate bodies for the ensuing Municipal Year.



- 6.1 The Council Meeting on 22 March 2010 approved a scheme for the payment of members' allowances for 2010/11. The scheme was originally based on the findings of an Independent Panel commissioned by the ALG.
- 6.2 The scheme is made in accordance with the Local Authorities (Members Allowances) Regulations. The regulations indicate that agreement and adoption of the scheme is the responsibility of full Council and will continue to be so within any new arrangements set out in the Constitution which the Council is required to adopt under the Local Government Act 2000.
- 6.3 This report indicates the amounts paid to Members in 2010/11, as detailed at Appendix 1.
- 6.4 The allowances that can be paid include:
 - basic allowance
 - special responsibility allowance
 - childcare and dependent carers' allowance
 - travel (outside M25 area only)
- 6.5 Arrangements must be made for publication of the total amount paid to each member, including basic, special responsibility and childcare/dependent carers' allowance, after the end of the year to which the scheme relates. These are set out for 2010/11 in Appendix 1.
