Addendum Report for Confirmation of New Tree Preservation Order at 65 Mount View Road, N4

In response to objections by Lancaster Solicitors on behalf of Flat A & Flat C 9 Dashwood Road N8, I can make the following comments:

- An inspection of the tree was carried out on 7 June 2011 and assessed to be in a good condition.
- The tree was damaged 1-2 years ago when the main central stem was broken in high winds but this has not adversely affected the overall condition of the tree.
- Whilst no tree can be classed as 'safe' the tree can be managed in future with regular inspections and pruning if required and any reasonable requests to prune the tree in future would be permitted by the council.
- The council's consent is not required for cutting down or carrying out work on trees which are dead, dying or have become dangerous.

Addendum Report for Confirmation of New Tree Preservation Order at 95 Mayfield Road, N8

In response to objections from 95 Mayfield Road and Ground Floor Flat, Inderwick Road N8, I can make the following comments:

- Whilst the trees are only visible from a public place with difficulty, they are visible from approximately 90 surrounding properties on Mayfield and Inderwick Road, providing significant amenity value to local residents.
- The trees are approximately 18 metres (60 feet) tall and are located approximately 12 metres (40 feet) away from the property.
- According to data collected for the Kew Tree Root Survey* the maximum recorded distance for damage by Lime tree roots is 20 meters. However this is the extreme for the data and only occurs in a very small proportion of cases. The average distance recorded for damage by Lime tree is 6 meters.
- Lime trees tolerate regular pollarding which reduces water uptake and the risk of subsidence.
- The application process for works to protected trees is free of charge and can be completed by the tree owner.
