1. **Describe the issue under consideration**

1.1 This report relates to an application for a new premises licence at 272 Muswell Hill Broadway by Mr M Suttcliffe.

1.2 The application seeks the following:

Regulated Entertainment: Live Music, Recorded Music, Performance of Dance

Monday to Sunday 1200 to 0200 hours

Late Night Refreshment

Monday to Sunday 2300 to 0200 hours

Supply of Alcohol

Monday to Sunday 1200 to 0200 hours

Supply of alcohol **ON** the premises.

Hours open to Public

Monday to Sunday 1000 to 0200 hours

1.3 The application can be found at **Appendix A.**

1.4 Representations have been received from:

Responsible Authorities - Metropolitan Police/Licensing Authority /Enforcement Response.

There are over 50 representations received from residents and the local MP against this application.

1.5 Recommendation

In considering the representations received and what is appropriate for the promotion of the licensing objectives, the steps the Sub-Committee can take are:

- Grant the application as requested
- Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
- Exclude any licensable activities to which the application relates
- Reject the whole or part of the application

Members of the licensing sub committee are asked to note that they may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must be appropriate in order to promote the licensing objectives.

2 Background

- 2.1 The premises held a previous licence as Socialite Bar under Mr B John the leaseholder for the premises. The new applicant Ms Sev we understand is sub leasing the premises from Mr John in order to provide licensable activity at the premises. The previous licence was subject to a Review brought by the Metropolitan Police due to serious crime and disorder issues emanating from the premises the licence was revoked by the LSC in December 2016 but the then licence holder opted to appeal the decision. The appeal was later withdrawn in May 2017 by Mr John.
- 2.2 The premises has operated as a venue offering milkshakes for the past 18 months. The applicant has also hired out the premises for events some of which were held under a Temporary Event Notice and on at least one occasion no permissions were applied for.
- 2.3 The Planning Authority has informed the Licensing Authority that the premises has permission to operate until 2am each day except Sunday and Bank Holidays. There has further application to Planning to allow for a Sunday application as applied for under the Licensing process.

3 Licensing Policy

- 3.1 The committee will also wish to be aware of the guidance issued under section 182 of the Licensing Act 2003. Licensing is about regulating the provision of licensable activities on licensed premises, by qualifying clubs and at temporary events within the terms of the Licensing Act 2003. The terms and conditions attached to various permissions are focused on matters which are within the control of individual licensees and others granted relevant permissions. Accordingly, these matters will centre on the premises and places being used for licensable activities and the vicinity of those premises and places.
- 3.2 The objective of the licensing process is to allow for the carrying on of retail sales of alcohol and the prevention of public nuisance, prevention of crime and disorder, public safety and protection of children from harm. It is the Licensing

Authority's wish to facilitate well run and managed premises with licence holders displaying sensitivity to the impact of the premises on local residents.

- 3.3 In considering licence applications, where relevant representations are made, this Licensing Authority will consider the adequacy of measures proposed to deal with the potential for public nuisance and/or public disorder having regard to all the circumstances of the case.
- 3.4 Where relevant representations are made, this authority will demand stricter conditions with regard to noise control in areas that have denser residential accommodation, but this will not limit opening hours without regard for the individual merits of any application. This authority will consider each application and work with the parties concerned to ensure that adequate noise control measures are in place. Any action taken to promote the licensing objectives will be appropriate and proportionate.
- 3.5 This Licensing Authority in determining what action to take will seek to establish the cause of concern and any action taken will be directed at these causes. Any action taken to promote the licensing objectives will be appropriate and proportionate.
- 3.6 Where relevant representations are made, this authority will demand stricter conditions with regard to noise control in areas that have denser residential accommodation, but this will not limit opening hours without regard for the individual merits of any application. This authority will consider each application and work with the parties concerned to ensure that adequate noise control measures are in place
- 3.7 Also The Licensing Authority may not impose conditions unless its discretion has been exercised following receipt of relevant representations and it is satisfied as a result of the hearing that it is appropriate to impose conditions to promote one or more of the four licensing objectives. Therefore conditions may not be imposed for the purpose other than promoting the licensing objectives and in some cases no additional conditions will be required.
- 3.8 In cases Members should make their decisions on the civil burden of proof, that is the balance of probability.
- 3.9 Members should consider in all cases whether or not primary legislation is the appropriate method of regulation and should only consider licence conditions when the circumstances in their view are not already adequately covered elsewhere.
- 3.10 The Government has advised that conditions must be tailored to the individual type, location and characteristics of the premises and events concerned. Conditions cannot seek to manage the behaviour of customers once they are beyond the direct management of the licence holder and their staff. The Councils Licensing policy generally expects applicants to address the licensing objectives and discuss how to do this with the relevant responsible authorities.

4 Licensing hours

4.2 Where relevant representations are made, the Council will consider the proposed hours on their individual merits. Notwithstanding this, the Council may require stricter conditions in areas that have denser residential accommodation to prevent public nuisance. The Council will endeavour to work with all parties concerned in such instances to ensure that adequate conditions are in place. The Council may restrict the hours that certain premises can offer alcohol for sale for consumption off the premises for preventing crime, disorder and nuisance.

5 Powers of a Licensing Authority

5.1 The decision should be made with regard to the Secretary of the State's guidance and the Council's Statement of Licensing Policy under the Licensing Act 2003. Where the decision departs from either the Guidance or the Policy clear and cogent reasons must be given. Members should be aware that if such a departure is made the risk of appeal / challenge is increased.

5.2 The licensing authority's determination of this application is subject to a 21 day appeal period or if the decision is appealed the date of the appeal is determined and /or disposed of.

6. Other considerations

Section 17 of the Crime and Disorder Act 1998 states:

"Without prejudice to any other obligation imposed on it, it shall be the duty of each authority to which this section applies to exercise its various functions with due regard to the likely effect of the exercise of those function on, and the need to do all that it reasonably can to prevent crime and disorder in its area".

6.1 Human Rights

While all Convention Rights must be considered, those which are of particular relevance to the application are:

- Article 8 – Right to respect for private and family life.
- Article 1 of the First Protocol – Protection of Property
- Article 6(1) – Right to a fair hearing.
- Article 10 – Freedom of Expression

M Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

Staff will be trained to adhere to the measures specified under each licensing objective below. In addition, the license holder will liaise with the responsible authorities and residents to ensure the business continues to meet the licensing objectives.

b) The prevention of crime and disorder

1. Appropriate digital CCTV equipment and the sufficient number of cameras shall be installed and maintained at the premises to record colour images that are clear enough to allow the Police to use to investigate any crimes that are committed on the premises. The areas covered by the cameras will cover all areas within the premise that are open to the public. A camera will be positioned to obtain images of persons entering the building by the main entrance.
2. No persons other than the Police, the Licensing Authority, the Premises Holder, the manager or authorised persons shall have access to the CCTV recording equipment or the recordings made from such equipment. The CCTV system will be in operation, and recording whenever the premises are open to the public.
3. Recordings made on the CCTV system shall be retained for a period of at least 30 days of recording.
4. A minimum of two notices stating that CCTV is in operation shall be displayed throughout the premises where the public have access. The notices shall be at least A4 size.
5. The license holder will carry out a risk assessment in relation to any events and take appropriate security measures including hiring SIA qualified security staff for the event in question. (The risk assessment will enable the license holder to determine the number of security staff required, their hours of work and any other relevant requirements).

c) Public safety

1. The license holder must ensure that all staff are aware of their social and legal obligations, and their responsibilities regarding the sale of alcohol.
2. Training shall be given to all staff to ensure compliance with the four licensing objectives. Training records will be kept on the premises, and the training records will show the date of training. The training record is to be signed by the staff member receiving the training and then countersigned by the Designated Premises Supervisor (DPS).
3. The fire safety measure which the premises are providing must be maintained in good working order, and their adequacy will be determined on a regular basis, by the carrying out of a fire risk assessment as required by, and in accordance with the regulatory reform (fire safety) order 2005.

4. An adequate and appropriate supply of first aid equipment and materials must be available on the premises.

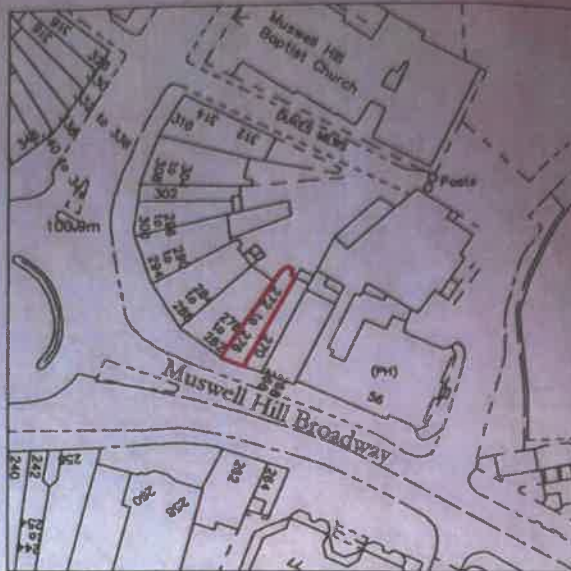

Lease Plan of 272 Muswell Hill, London, N10 2QR

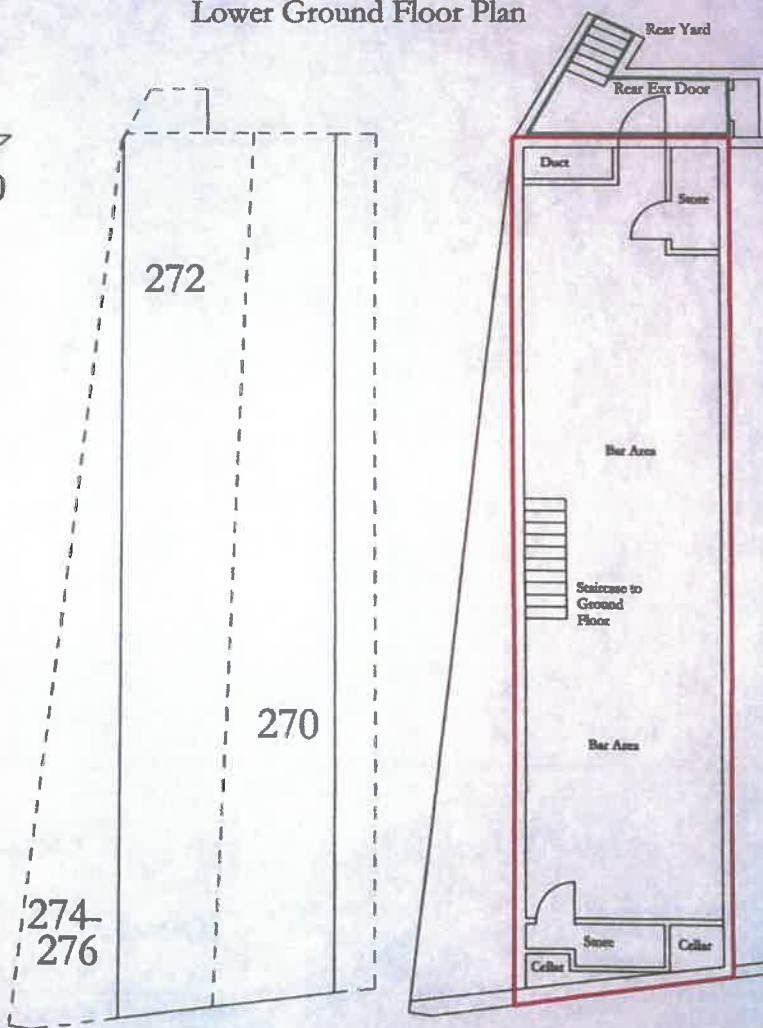
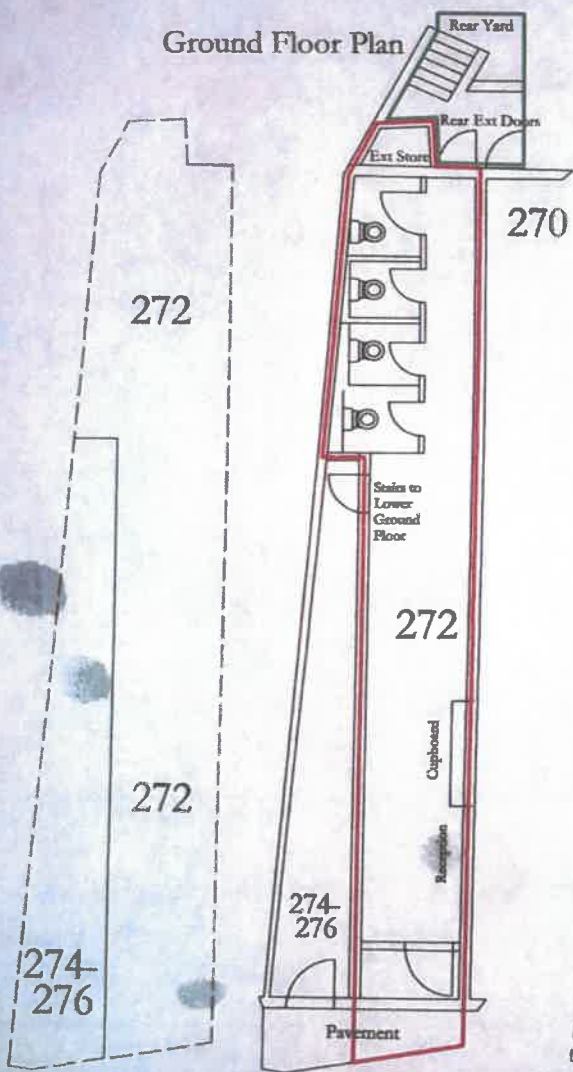
Scale 1:150

I provide my Representation, as Responsible Authority under the Licensing Act 2003, with regard to the licensing objective promoting the prevention of public nuisance.

The provisions for addressing public nuisance they have outlined in their application are inadequate.

In the last 6 months we have received 2 complaints of noise nuisance associated with the premises as:

Date/ Time	Noise Reported
27/06/2021, 17:31	Booming bass and loud music emanating from The Venue N10 in Muswell Hill Broadway. The venue has conditions on its licence and is breaching the terms of its licence.
31/07/2021, 03:02	Drunken people leaving The Venue N10 (operating illegally without a licence) screaming/shouting on street, then drinking & eating on the road where cars are parked with music blaring from 2.15am to 2.55am

Both reports were made outside our service operating times so are unsubstantiated.

There is however a significant history of complaints associated with the premises and we would seek to ensure that the applicant confirm measures they will take to eliminate the potential for noise and/ or vibration emanating from the premises. We would also require then to verify that the sound insulation of the premises is such that the potential from transmission of sound and /or vibration to residents above and adjacent has been eliminated.

All doors and windows should be kept closed at all times and entry/ exit to the premises restricted to those on Muswell Hill Broadway while the premise is in use. To comply the applicant may also need to consider the installation of suitable mechanical ventilation and door self-closing devices.

I recommend the following conditions are added to the Licence:

Control Noise from Patrons

- Notices will be prominently displayed at the exit requesting patrons respect local residents and leave the area quietly.
- Staff and Door Supervisors shall actively monitor and control patrons queuing, leaving and entering the premises to ensure they leave the area quickly and quietly. Staff and Door Supervisors shall actively discourage loitering or waiting outside the premises after closing.
- The Licence Holder shall conduct regular assessments (externally and around the full perimeter) of the noise coming from the premises whilst it opens for business and shall take

steps to reduce the level of noise where it is likely to cause a disturbance to local residents. A written record shall be made of those assessments in a logbook kept for that purpose and shall include, the time and date of the checks, the person making them and the results including any remedial action. This record must be made available at all times for inspection by council officers. Regular liaison meetings will be held where specifically requested by residents to enable neighbours to raise concerns about any aspect of the licensed activities.

Controlling Noise Emissions

- The Licence Holder shall devise and implement fully a Noise Management Plan to be agreed in writing by the ASB Enforcement Team. The Plan should detail all noise control measures to be implemented. This should be informed or devised by an expert in acoustics and provided no later than 28 days after the issues of the licence.
- Music played at the premises shall be limited to background level only until the approved noise control measures as outlined in the Noise Management Plan are implemented.
- All external doors and windows shall be kept closed at any time when regulated entertainment is taking place.
- No nuisance shall be caused by noise coming from the premises or by vibration transmitted through the structure of the premises.
- All speakers should be mounted on anti-vibration mountings to prevent vibration transmission of sound energy to adjoining properties.
- The regulated entertainment licensable activity shall conclude 30 minutes before the premises is due to close to prevent excessive noise breakout as the premises empties.
- No form of loudspeaker or sound amplification equipment is to be sited on or near the exterior premises or in or near any foyer, doorway, window or opening to the premises.

Conclusion:

I have no objections to the application on the proviso that the above conditions are applied to any Licence issued.

REPRESENTATION LETTER

Dear Sir/Madam,

LICENSING ACT 2003 – Application for a Premises Licence - The Venue N10, 272 Muswell Hill Broadway, London N10 2QR

The Licensing Authority wish to make representation against this application under the need to promote to the licensing objections.

The premises initially operated as a wine bar and but ended up becoming a night club until the licence was revoked in 2017. The revocation was due to the crime and disorder and public nuisance taking place on the premises.

Whilst this application is from a new operator the concerns remain relating to the potential for noise nuisance to be generated through the fabric of the building. The application states the capacity is 130, there is no evidence to support or show how this figure was arrived at we do not consider 130 capacity a credible figure for a basement venue.

The venue has been closed for some time and when it did start to operate again it did so as a 'ice cream /milkshake's type parlour. The premises did however have some booked event which they permitted without having a Temporary Event Notice. The Council became aware of these events from residents complaints or sending through copies of flyers advertising events.

The general area/ location has undergone some major changes in recent years since the nightclub operation ceased to operate from this location and there is now a range of new residential properties to the rear of the venue. It is important that consideration is given to the 'likely effect' upon residents if the premises is able to operate until 2am. The premises we feel should not operate as a nightclub but as a bar with music until 11pm Sunday – Thursday. Midnight Friday & Saturday.

The venue should not be hired out for DJ promoted events at any time.

Management/staff shall proactively monitor the conduct and behaviour of patrons on the public highway to ensure no noisy, rowdy or anti-social behaviour (this includes loud talking/shouting and people congregating in large groups on pavement obstructing the public highway).

Those patrons deemed to be engaging in such behaviour shall be asked to cease this activity and/or disperse from the premises quietly.

No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance

All exit routes and public areas shall be kept unobstructed, shall have non-slippery and even surfaces, shall be free of trip hazards and shall be clearly signed.

A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram. An incident log shall be kept at the premises, and made available on request to an authorised officer of the Haringey Council or the Police. It must be completed within 24 hours of the incident and will record the following:

- a) all crimes reported to the venue
- b) all ejections of patrons
- c) any complaints received concerning crime and disorder
- d) any incidents of disorder
- e) all seizures of drugs or offensive weapons
- f) any faults in the CCTV system, searching equipment or scanning equipment
- g) any refusal of the sale of alcohol including date, time and name of staff member
- h) any visit by a relevant authority or emergency service.

A direct telephone number for the Licence Holder/DPS/manager of the premises shall be publicly available at all times that the premises is open. The number is to be made available to residents and businesses in the vicinity. Any complaints shall be remedied within 48 hours and details to be recorded in the incident book including the action taken by the Licence Holder/DPS/manager.

A staff member from the premises who is conversant with the operation of the CCTV system shall be in the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested and within a maximum of 24 hours of the initial request.

A minimum of 2 SIA licensed door supervisors shall be on duty at the premises from 20:00 until the premises closes and until 30 minutes after the premises closes on Friday and Saturday nights.

The premises shall operate a zero tolerance policy to the supply and use of drugs.

I wish to make representation on the following:

We the Police wish to make representation against this application on the following grounds which undermine the licensing objectives .We note that these premises historically operated as a wine bar and developed into a night club operating into the small hours of the morning with the premises becoming poorly managed leading to revocation of the licence in 2017 due to failing to uphold the licensing objectives on the grounds of crime and disorder along with public nuisance which took place upon the premises .

Whilst we acknowledge that this is a new application it is a basement venue with a large potential for noise to be generated which in turn would impact greatly upon the surrounding community, which has increased its residential properties with new buildings having been built in the very near vicinity.

Several complaints from residents have been received by the Local authority when a temporary event notice was granted and an event was ran from the property that was running as a patisserie /Ice cream type venue when the business tried to diversify its hours .Clearly having an impact .

It is therefore proportionate we feel that consideration be given to limiting not only the operating hours of any likely new venue but to also limit the Type of premises allowed to operate within this what is now a predominantly residential area so as to limit the likely effect upon the community. A 0200 hours closing time we feel would negatively impact residential neighbours.

More appropriately for the geographic location in agreement with the local authority we feel it appropriate that the hours of the premises should be limited as follows:

Regulated entertainment i.e. music with an end time of 11pm Sunday – Thursday and Midnight Friday & Saturday.

If this application were granted in full or part, we would recommend the following alterations be made to the licence conditions. We also suggest that additional conditions be attached to the licence, as set out below, to further promote the licensing objectives

PREVENTION OF CRIME AND DISORDER

The premises will operate a zero tolerance policy towards illegal drugs.

Digital CCTV system to be installed in the premises.

Cameras must be sited to observe the entrance doors from inside.

Cameras on the entrances must capture full frame shots of the heads and shoulders of all people entering the premises i.e. capable of identification.

Cameras must be sited to cover all areas to which the public have access including any smoking areas.

Cameras must provide a linked record of the date, time of any image.

Cameras must provide good quality images - colour during opening times.

Images and recording quality must be reviewed and monitored regularly.

Cameras must be regularly maintained to ensure continuous quality of image capture and retention.

Member of staff trained in operating CCTV at venue during times open to the public.

Digital images must be kept for 31 days. The equipment must have a suitable export method, e.g. CD/DVD writer so that Police can make an evidential copy of the data they require. Copies must be available within a reasonable time to Police on request.

A minimum of 2 SIA licensed door supervisors shall be on duty at the premises from 20:00 until the premises closes and until 30 minutes after the premises closes on Friday and Saturday nights.

A premises daily register will be set up and kept for a minimum of six months and door supervisors will record their names, times of attendance and SIA licence number on it.

If these conditions were accepted in full I would withdraw my representation.

Re: 272 Muswell Hill N10 –The Venue licence application.

I am a resident who lives near by this venue and am writing to oppose this request for the licence to serve alcohol and open until 2am.

I, like many others, live close by this venue and whenever they hold an event, we are regularly disturbed by the crowds who hang around at night and in the small court yard at the back.

I will speak of the "likely impact" that the authorisation of this licence will have on me as a resident:

The prevention of public nuisance: At the moment, the venue is limited to a certain time of closure and those who hire it out are required to bring their own alcohol. When this venue is hired out, the customers can be found congregating at the back of the club in a small residential court yard that is a densely-populated residential area, drinking and urinating in public. Similarly with recorded music in the evenings and early morning the rear doors of the bar is often left open and music can be heard, wakening us and our children up. As residents, we can also hear the drunken customers who hire out the venue and believe If the Venue is granted it will have a significantly detrimental effect on our physical and mental health. We had the same problem when this venue was called The Socialite - where there was repeated noise disturbance and crime. We will be facing the same level of disturbance if this is allowed. As residents, we will all be disturbed by this change in the licence.

The Prevention of crime and disorder: Where you have large groups drinking alcohol, there is the increased risk of crime and public disorder. The other venues in the immediate environment regularly has the police in attendance and some boy was stabbed recently. It is very concerning that Haringey Council will add another venue to the mix.

Public safety: There is no permitted parking place for customers to be dropped off or collected. When this venue's licence was revoked, it was done so because of the level of crime and violence that the club attracted and jeopardised our safety as residents.

I trust and sincerely hope that this application for a licence to open late and serve alcohol is not granted.

As a resident of a nearby estate, I recall the many problems with anti-social behaviour that occurred when a late night alcohol license was previously granted for these premises.

The applicant's venue frontage is small, therefore people queuing for admission create an pavement obstruction and hazard for motorists and many people leaving at 2AM seven days a week is also a nuisance for nearby residents, especially those in the residential conversion of the office block at the top of the hill. As a motorist and cyclist I frequently encounter drunken people at the crossing near to the Mossy Well, perhaps it would not be a good idea to increase the chances of that.

The close proximity of Parkland Walk also provides cover for illicit activity by those looking for custom from the patrons of such venues. I have frequently witnessed late-night drug dealing in that area. Muswell Hill Broadway is only served by buses so many of the applicant's clientele will travel here by car, putting parking pressure on local roads, many of which are unadopted.

There has in the last few years been a marked increase in litter along Muswell Hill and in the surrounding roads of alcohol containers, NO2 canisters and condoms, as well as anti-social behaviour and an increase of vehicle break-ins that has to be linked to the increased popularity and number of venues in the Broadway for late-night entertainment. Local residents have no desire for this area to become another Shoreditch or other 'trendy' place for late night entertainment.

Dear Licensing Team,

Me and my wife object to the license application for Venue 10 which is planned as a night club or discotheque open until 2AM.

Our main concern is that the conditions of this location exacerbate the incentives and negative effects of criminal activity for reasons I will detail.

We already had two stabbings in front of our entrance and one street fight involving roughly twenty individuals all caught on camera. The videos were inspected by the judge deciding in relation to the previous night club application. The victim of the first stabbing, a guard of a different establishment, had severe but not life threatening injuries. The second victim, a young man, was in a very critical condition and I am not certain if he survived.

I have witnessed both assaults on camera and due to the conditions of the location, it was very easy for the aggressors to disappear without even the need to rush it. This area has a lot of nature with dense vegetation and backyard streets with little illumination on those sides of the buildings where the bedrooms are located.

Everyone's sleep in the neighborhood was routinely disturbed on Fridays and Saturdays late in the night when the previous night clubs were open. Even worse, in those times it was a common sight for children to see individuals in dark corners or behind bushes consuming drugs. Our area is very densely populated with children and they should not grow up thinking such behaviour is normal or even cool.

Going back ten or eleven years, we had a further establishment in the same place and a person was shot. Another individual leaving that place was injured in a fight two hundred yards further down in Grosvenor Gardens and he was brought to hospital with an ambulance. When we heard the scream of the victim, we woke up immediately and we knew it was the scream of someone in extreme pain and fearing for his life.

By all measures and proven by past experience, this is the wrong location for an establishment of this kind.

To the Haringey Licencing Team,

I am writing to object to the application to provide a late night alcohol and live music licence to The Venue N10, 272, Muswell Hill Broadway N10 2QR. This is for the following reasons.

1) The immediate neighbourhood consists of parades of shops and businesses with two or three floors of flats above them. Each floor mainly consists of at least two flats, usually overlooking the main street, Muswell Hill Broadway. I am a resident in one of those flats. Currently the noise level from the street from traffic, passers-by and people coming out of the nearby Mossy Well pub and other restaurants and bars is high, but just about tolerable: normally the neighbourhood becomes quiet at around midnight or earlier most nights. However, I understand The Venue intends to operate as a night club 7 days a week from midday until 02.00 in the morning. In terms of sleep disruption this is clearly unacceptable, as inevitably loud inebriated groups of people will be coming and going through half the night causing a public nuisance to local residents. Furthermore there will be noise pollution leaking from the premises as well from loud music. It should be noted that given the age of our flats, sound insulation is almost non-existent.

2) This will particularly impact the particular demographic of local flat dwellers including myself: I am surrounded by either Key Workers who may well be starting early shifts, single parent mothers with young children whose lives are already affected by night noise from The Mossy Well pub, or the elderly, many of whom have long-term infirmities. Sleep disruption for any of us indisputedly leads to stress, tiredness and a deterioration in the quality of our lives.

3) The absence of frequent late night public transport in the middle of the night will inevitably slow down the dispersal of crowds leaving The Venue, causing extended periods of aggravation and disruption, and will lead to more opportunities for, for example urinating on doorsteps, fighting and littering.

4) The Venue already has a reputation for attracting criminal behaviour. It was closed down by the police relatively recently following a shooting incident, a knife attack and numerous brawls and punch-ups in the street late at night. It is hard to see how re-opening The Venue will lead to anything else but a deterioration of public order and potential criminality in Muswell Hill.

5) In terms of public safety, the gathering of crowds entering the premises will be occurring on a relatively narrow pavement which borders a steep hill frequently used by buses, heavy goods vehicles and rubbish disposal trucks. The pavement area is already relatively congested, which means pedestrians passing The Venue will often have to step into the road in order to get past if it attracts large numbers of customers through the day and night. Given that the pavement is used frequently by parents taking children to and from school or nursery, often in prams, the potential for an accident waiting to happen is all too evident.

I hope the Licencing Team will take these objections seriously: I fear that this proposal will make living in central Muswell Hill intolerable.

As a local resident I note with concern the application for a late licence application in respect of the business at this address. This appears to be 'Sundays to Saturdays' although it's unclear whether this means two nights per week or seven.

Our home backs onto the railway viaduct that now forms part of the Parkland Walk - a popular amenity by day but subject to much anti-social behavior at night - and especially after closing time of

local bars/pubs, when groups assemble for very noisy parties that can continue until dawn, and not only at weekends. The noise and litter are both serious problems, as is the potential danger of objects being dropped or thrown from the bridge into gardens or onto the roadway leading from St. James's Lane.

These late-night revellers are customers of two 'club' venues at the top of Muswell Hill and the Weatherspion's pub opposite.

I suffer from a neurological condition for which I am under a treating consultant. When I unable to sleep it impact my ability to work and directly impacts my ability to be able to go to work the next day due to illness.

I wish to object most strongly to this new application for a licence for "The Venue N10" at 272 Muswell Hill Broadway.

The area already suffers a great deal of late night public nuisance and disorder from clubbers and late night drinkers. I live in Ashmount Lodge (which is a neighbouring building) and there is a lot of disturbance regularly at night in our car park at the entrance to Pinnacle Close. Our bin area and car park is used as a toilet and a meeting place, with illegal parking and drug dealing going on. We frequently witness drunkenness, unruly behaviour and cars gathering and a lot of noise.

This is a residential area and I know that residents in nearby streets experience the same. The noise and disturbance created by late night venues is unacceptable around here where families are trying to get their children to sleep, and residents have to be up for work in the mornings. There is a school nearby and increasing the number of licensed premises in the area is inappropriate and will cause even more distress.

In addition, the pavement outside this venue is quite narrow, and is positioned at a busy junction at the top of Muswell Hill. Vehicles regularly accelerate at ridiculous speeds away from the roundabout down the hill for the thrill of it. I have returned home on Saturday evenings and found the pavement completely blocked by people from the neighbouring licensed venue, and have needed to step into the road in order to reach the door of Ashmount Lodge. We certainly do not want another late night venue opening along this narrow stretch of pavement.

I am writing to express my dismay at news that The Venue (272 Muswell Hill Broadway, N10 2QR) is attempting to win back a late drinking licence revoked in 2017 when trading as The Socialite.

As you know, 272 Muswell Hill Broadway has experienced some of the worst violence seen in N10 - a shooting, stabbings, Tasers and multiple instances of fights, altercations and the like. A man was shot in the face for goodness sake. This heinous act led to the revocation of its late licence which has been a godsend for residents who have not had to put up with threatening behaviour on the Broadway and suffer from noisy, drunk people leaving the premises after 2am.

I appreciate that the venue may now be under different ownership, but so what? The basement bar / club has proven time and again to be a magnet for undesirable people from outside of the area who break the law and make life miserable for local residents.

In addition, since the licence was revoked, there have been new residential developments immediately opposite the venue (77 Muswell Hill) and Dukes Mews / Pinnacle Close. As a result, the Broadway is even more residential than it was in 2017. These new residents should not have to suffer a late night drinking venue with 2am hours seven nights a week.

I also note that the area already has a late-night drinking option at The Broadway at 266 Muswell Hill Broadway which enjoys a 2am licence at the weekend and has none of the history of violence associated with the basement club.

The cheek of the new owner of the Venue is incredible. They must know the history

associated with their premises and yet they think that after just 4 years residents and Haringey Council have forgotten what this club has done to the area in the past.

As a local resident who has lived on Springfield Avenue for more than 20 years, I am writing to strongly object to the granting of a late night licence to The Venue at 272 Muswell Hill Broadway (N10) as it would inevitably lead to public disorder and a deterioration of public safety, as has been clearly shown in the recent past culminating with stabbings and a shooting. The granting of this licence would certainly not uphold three of the four objectives of the Licensing Act 2003, namely the prevention of crime and disorder, public safety and the prevention of public nuisance both in the premises and in the surrounding area.

My strongest objection is as a local woman and mother of young women. For years, after around 11pm, my daughters and I were unable to safely walk home from Muswell Hill, past the venue concerned and the late-night bar (currently the Broadway). This was due to the significant number of intimidating young men

hanging around outside the venues, blocking the pavements and obviously intoxicated by various substances. I think our fear and caution proved to be justified as stabbings and a shooting did take place. Additionally, as residents of Springfield Avenue, we also had to put up with very menacing cars parked on our road dealing drugs in until the early hours, clearly servicing the clientele of these two night-time venues. Until the revoking of the licences (post 2017), I had to always drive home in the evenings or pick up my daughters from the Broadway to ensure safety. The situation greatly improved since 2017, but is once more deteriorating since this July 2021, as customers of The Broadway spill onto the pavements once more intimidating the local residents and creating a public nuisance. If The Venue licence were granted, this problem would obviously become worse and, as a woman, I would feel unsafe and unable to walk home at night on my own. Therefore, the granting of this licence would go against the London Mayor's objective of making the city safe for women. Muswell Hill has no night time police presence and therefore these night venues create unsafe spaces, especially for women who are reduced to having to be accompanied or rely on driving or taxis. Why should I and my daughters feel unsafe in our own neighbourhood?

I believe that the granting of this late night licence would take Muswell Hill backwards, returning to residents being afraid to walk their own streets, to increased violence and drug dealing and to antisocial behaviour common in the past (littering, noise pollution, damage to people's property and urinating). I strongly believe that the granting of a late licence to The Venue will make matters significantly worse regarding public safety. As a young female, why should I be made to feel even more unsafe in my own neighbourhood?

Additionally, this would be like going back in time and reversing recent improvements in safety in this area. I remember my sister always having to be picked up by car at night because it was considered too dangerous for her to walk past the top of Muswell Hill, which was proved right by stabbings and a shooting. I can't believe I am having to do this again as the outcry from the police and local residents was so damning in 2016 when the previous licence for this venue (then known as the Socialite Bar) was revoked. I thought that would be the last time we'd have to protest. Clearly this is not the case.

The Prevention of Crime and Disorder: Granting this licence would inevitably lead to increased public disorder and a deterioration of public safety - one of the many reasons why the Metropolitan Police pushed for the revocation of the licence of the Socialite Bar when it operated at this site. Nothing has changed in the intervening years, except that we seem now to have an even smaller police presence, especially at night.

Public Safety:

- I feared for my own safety and that of my teenage daughter walking home at night past the late opening venue at 272 Muswell Hill Broadway. There was always a significant number of intimidating young men hanging around outside, blocking the pavements, clearly drunk or on drugs, who would make misogynistic comments and, on several occasions, actually followed my daughter and terrified her. I would go out to meet her on Muswell Hill in order to protect her. Stabbings and a shooting took place in 2016 - but there were multiple fights and stabbings in the years preceding 2016. The venue has been notorious for years: we keep telling you this but every few years we have to fight to make you listen. Why should we have to feel unsafe in our own neighbourhood?

- The granting of this licence would go against the London Mayor's objective of making the city safe for women. Muswell Hill has no night time police presence and therefore these night venues create unsafe spaces, especially for women who are forced to having to be accompanied or rely on driving or taxis.

The Prevention of Public Nuisance. Granting this licence will lead to:

- drunk young men, blocking the footpaths, thereby forcing pedestrians out onto Muswell Hill which is a very busy and fast road
- Drunk young men intimidating female pedestrians with lewd comments and stalking. This happened to my daughter. It is unmonitored and very frightening.
- Drunk young people vomiting, urinating and dropping litter in the neighbouring streets.
- Drunk young people shouting and singing in the neighbouring streets after 11pm when families are trying to get to sleep
- Drunk young people looking for drug suppliers - who park their cars in local roads. The dealers park on our road and tell the punters to come here to collect the goods. All exceedingly intimidating.

The granting of this licence would certainly not uphold three of the four objectives of the Licensing Act 2003, namely the prevention of crime and disorder, public safety and the prevention of public nuisance both in the premises and in the surrounding area.

In the public meeting of December 2016 the police noted that 'This area was known for serious crime and disorder and the police had been working with the venues at this location to try and prevent further incidents.' We are writing to oppose this application for live music, recorded music, alcohol sales and late refreshments.

We well remember the noise, disruption and not infrequently fighting that occurred previously when there was a late night establishment at the top of Muswell Hill : pub closing times inevitably led to an exodus of already "happy" people into the club at about 11pm.

That establishment was closed down and another sprung up in it's place and applied for a license similar to this one. In the end a much more acceptable solution was proposed by Haringey, but for whatever reason the club closed down.

Now with the worst of covid behind us this application has appeared. But covid is not fully over by any means and this sort of establishment - closed in , crowded - is just the sort of environment in which a delta spike could occur, especially as the likely clientele's youth demographic is far from fully vaccinated at the moment.

Besides fears of covid we oppose the application anyway. The prospect of a "night club" open till 2 am every day of the week with music and alcohol as well as late refreshments from 11pm to 2am fills us with dread. Our lives will be seriously affected by these plans : our sleep, security and safety will be at risk.

We ask that, at the least, the plans are scaled back to have a late licence [ie after the pubs have closed] on Friday and Saturday nights only and that the premises are properly patrolled and have surveillance cameras fitted to suppress the risk of drug dealing and anti-social behaviour spilling out into the nearby streets.

I would like to object to the above application. Given the historic gun crime at the exact site, and the identical use plans, it is pretty clear the sort of anti-social behaviour that will be brought back into the heart of a residential area densely populated by young families. I don't know how late-night partygoers are expected to disperse at 2am without disrupting the entire neighbourhood when there is nowhere to park other than outside nearby residences. Given a number of front doors in the area are only accessible by passing through the immediate vicinity of where people historically loitered outside the site, and the history of knife and gun crime, the granting of the licence would pose a real threat to public safety.

I would also add that the notice about the application is well hidden on a door set back from the street, which when then the venue is open, is totally invisible. I dare say that has been done deliberately - perhaps that has already been noted by the licensing team. I am a little concerned that not all interested parties have been made aware in a timely manner.

Notice of Application for a Premises Licence for The Venue N10, 272 Muswell Hill Broadway, London, N10 2QR (the "Premises")

I write in relation to the above premises licence application.

I am writing to strongly oppose this application for live music, recorded music, alcohol sales and late refreshments for the Premises, or if it is to be granted, at least, significant altered, to prevent crime, disorder and allowing/maintaining public safety based on the context set out below. For the avoidance of doubt, I whole-heartedly favour the total rejection of this application for a licence.

My reasons for opposing this application are as follows:

- 1) Previously, the venue was operated as the Socialite Bar as a nightclub that was open until 2am and I am sure that Haringey Licencing has the file related to the anti-social behaviour, noise, disruption, violence (including well-publicised stabbings and shootings) and the repeated drain on authority and police resources (but if not, I would recommend that this file be reviewed, including the statements provided by the police opposing the Licence for this venue). There was significant outrage from local residents and the police, which resulted in the licence for the Premises being revoked. This being the case, I fail to see why the reopening of the Premises on the same/similar basis would result in a different result than that which had afflicted the Premises and the surrounding areas previously. As such, this representation is based on the three Licensing Objectives of prevention of crime and disorder, public safety and the prevention of public nuisance.
- 2) The Premises is located in a residential area rather than a big, commercial site or setting. As such, the acceptance of any Licence should place a higher burden on the Premises to uphold the Licensing Objectives than say a nightclub in Soho. Accordingly, there is clearly a significant risk of creating a public nuisance and an increase in the risk of crime and disorder by providing the Premises with a Licence. I refer you to the points set out below referring to the current increase in public nuisance and crime and disorder, even before this Licence has been allowed.
- 3) The Venue N10 has been open and operating as a nightclub even prior to the submission of this application for a Licence. This highlights the disregard the owners/operators of the Premises have for compliance with Haringey's licencing requirements and complying with the Licencing Objectives. I make this statement based on screenshots from The Venue N10's own social media channels, which I not have since been removed, but which I have been provided with and I can share with Haringey Licencing if required. As such, it is clear that the owners/operators of the Premises will not try to adhere to the Licencing Objectives and this in itself should be sufficient reason to reject this application.

- 4) As the Premises is set in a residential area, a large proportion of the patrons who frequent it (based on what used to happen previously for the Socialite Bar and on what has happened when the Premises have operated without any licence) drive to the venue and park on the side streets.
- 5) I have first hand, repeated experience and knowledge of the patrons parking their vehicles, as historically and when the Premises has opened without a licence, every Friday and Saturday, there are tens of cars that drive along Dukes Avenue and adjacent streets (I assume that there are other streets on the other side of the Premises that are similarly affected) , causing congestion and parking difficulties for residents in this area.
- 6) This usually happens every Friday and Saturday from 10pm all the way until approximately 2.30-3am (although it is busiest around midnight-2.30am).
- 7) This is usually accompanied with (and I have regularly witnessed based on what happened historically, when the Premises has opened without a licence and also what happens presently based on the licence of the other venue (the Broadway) that has a licence until 2am) the patrons of the Premises causing issues of crime, disorder and threatening public safety in the following ways:
 - a. playing loud music from their vehicles (including blasting the music loudly, leaving doors and boots open and then dancing and shouting in the street);
 - b. shouting as they exit their vehicles and walk to and from the Premises ;
 - c. drinking and taking drugs in their vehicles parked up on Dukes Avenue and on the street (generally on their way to and from the Premises);
 - d. sitting around the Church (at the top of Dukes Avenue) and drinking and shouting;
 - e. urinating on the street - generally, by the electricity box outside number 6 Dukes Avenue, around the Church at the top of Dukes Avenue and in Dukes Mews;
 - f. usually after approximately 2am (based on what happened historically, when the Premises opened without a licence and currently, with the Broadway venue), patrons walking back to their vehicles on Dukes Avenue and:
 - i. shouting aggressively, threatening other patrons of the Premises and other members of the public (including residents who are awoken and ask these patrons to keep the noise down);
 - ii. violence on Dukes Avenue with other members of the public or patrons from the Premises. This is usually accompanied with loud shouting and damage to street furniture and vehicles. This can involve just two patrons from the Premises or groups of individuals and has involved dangerous weapons;
 - iii. Vehicles and street furniture being destroyed by patrons smashing these items, including an incident when a black vehicle was smashed by a number of patrons from the Premises; and
 - iv. Litter and food wrapping left on Dukes Avenue.
 - g. Worryingly for the drivers and also other road users, patrons of the Premises and the Broadway venue, who are visibly intoxicated, getting into their vehicles on Dukes Avenue and driving their vehicles away. This is a real worry and a commission of a number of crimes, but my main concern is for the safety and welfare of the occupants of the vehicles, who could end up killing themselves and other road users; and
 - h. Obviously, the most significant event was the shooting involving the patrons from the Premises when it was previously licenced. Needless to say, it is extremely scary and distressing to think that the provision of this licence could result in the residential area of Muswell Hill having to live with the fear of patrons from the Premises carrying guns and other weapons that could impact me and my family (alongside hundreds of other residents who live close by to the Muswell Hill Broadway). Previously, any stray bullets could easily have resulted in the injury or death of a resident (and there are a lot of young families in the area, so potentially affecting children). This is a recent incident and still remains a truly a significant concern.
- 8) I have contacted the police and the noise disturbance team at Haringey Council on numerous occasions in the past few years. There have also been a number of occasions where I have not contacted the police due to my perception of the police being unable to attend to an incident in time.

- 9) I would add that since the licence to the Socialite Bar was revoked, there has been a reduction in the level of incidents highlighted above at paragraph 6 (although, they do continue to happen due to the Broadway continuing to open until 2am) and permitting a Licence to the venue once more will clearer increase the frequency, number and risk of such incidents in the future.
- 10) I would also highlight that whilst there has been a reduction in the number and frequency of the events highlighted above, they still do happen on a regular basis due to the fact that the Broadway venue opens until 2am every Friday and Saturday. Accordingly, it is clear that allowing any bar or nightclub to be open at this location until 2am will result in issues of crime, disorder and threatening public safety and this should not be allowed.
- 11) Please note that all of the instances of crime, disorder and risk to public safety above have had a direct effect on me and my family (I have an eight year old and a five year old child) through disturbed sleep, feelings of anxiety and fear. I am fearful for my family's public safety as a result of the historic actions of the patrons of the Premises and the Premises clear disregard for the safety of the public and their failure to do anything about it.
- 12) As highlighted above, I consider that it is preposterous that the Premises should be permitted to operate a Licence that runs until 2am seven days a week in a residential area and either denying the licence application or certainly, restricting this to an earlier time on a Friday and Saturday only would significantly reduce (if not cease) the instances of crime, disorder and significantly help to maintain public safety.
- 13) I expect Haringey Council, the Police and the management of the Premises to be aware of these events already, as I am aware of a number of residents having made reports for offences, public disorder and noise to these departments historically.
- 14) Finally, I would highlight that at no time in the past year (or historically, when the Premises was licenced) have I seen anyone from any of the licenced venues visibly managing patrons whatsoever on Dukes Avenue. The management of the Premises will have no powers to force patrons of the Premises to keep quiet, leave the area or manage them in any way. Accordingly, there will be an increase in public nuisance and risk of crime and disorder should a licence be granted.
- 15) I consider that there to have been a number of crimes and disorder offences and failure to maintain public safety resulting directly due to the Licence and a failure to uphold these by the Premises previously. As such, I consider that only by refusing this licence would it be ensured that such incidents do not occur, but in the event that a licence is granted, I would contend that reducing the hours of operation of the Premises to only Friday and Saturday and earlier (say 11pm) would also reduce crime and disorder and maintain public safety.

Dear Licensing Team at the Haringey Council!

I am writing to register my objection to the application for a premises licence by Venue N10 located at 272 Muswell Hill Broadway, N10 2QR .

The basis for this opposition is that granting a licence for these premises will not promote the licensing objectives, particularly the prevention of crime, disorder, public nuisance, public safety, the protection of children from harm.

I strongly believe that enabling the premises a 7 days a week late night licence and to sell alcohol would be totally detrimental to its aims and objectives. The application proposes that Live music, recorded music, performance of dance, late night refreshment, supply of alcohol to be offered at premises from 10am/12pm until 2am – 7 days a week. Granting a licence to Venue N10 would be potential risk to crime, disorder and public nuisance that in the past years with previous venue already reached problem levels for residents where local police/council had taken some serious actions.

As a resident I have suffered with noise nuisance and been a witness of antisocial behaviour/violence from/between people that were visiting previous late venue at 272 Muswell Hill Broadway at all hours of the night - especially on the weekends. Furthermore as previous patrons were letting their guest to overcrowd pavement outside of the premises at the nights was simply giving a permission for all of the above issues caused to us residents. Often guest of the clubs were staying outside of the premises long hours after closing time. These were making a noise that caused unbearable/sleepless nights to locals.

In the past few months Venue N10 had some activities (during the lockdown) which was already a breach of their permits and national lockdown/restriction rules. This has been reported to the council. I have witnessed guests of this venue gathering outside blocking an entry to residential parts of the business. Crowds taking over pavements just outside that without stepping on the road itself is impossible to pass over. I have never seen visible security unless "private event" was taking a place.

I, as a resident of near by property already been experiencing increased antisocial behaviour from the guests visiting next door venue The Broadway (266 Muswell Hill Broadway). Both premises can accommodate more or less 100 people at the time, I have to ask.. what does that mean for residents when party is over? I, as one of many residents of Muswell Hill, invite you on Friday/Saturday night for a little taster of what we experience already which with second venue with same concept the quality of neighbourhood will dramatically change and affect majority residents and their families, visiting guests.

Additionally, litter outside of the premises, flats/houses were often left after the party. I have concerns about the New License and their opening and closing times especially that venue is located in residential area. It's a massive issue for residents, as this is when the premises' customers will be passing through the neighbourhood causing nuisance caused and by customers when they are arriving at or leaving the premises for all neighbours that live next to the premises, disturbance goes on for hours at late night hours. Guests leaving premises are often intoxicated and ending with vomiting and using nearby areas as a public toilet. Obviously urination and bottles being left around make my neighbourhood look unpleasant, and makes it less pleasant to live here. Public Safety – is under a question as over-crowded pavement outside of the clubs force pedestrians to walk in the road, previously cars taking an extra care and often waited to roads being cleared to be able to pass over the crowd. Additionally crowd awaiting for an entry to the club often is loud and/or tipsy already starting arguments.

In the past played music at the previous club at the above stated premises was that loud that was exceeding premises of the club and were bass were felt and music was heard in the flat. Number of visits from the Noise respond team were rather adding stress to my life than resolving ongoing issue. Seems that previous venue had no sound-proofing and after few private events (at current Venue N10) in the past I can admit nothing changed in this subject. As the previous and potential new late night venue is located in an old building I believe that is not designed to contain modern levels of sound and vibration, that is why the noise was and will inevitably escape from the premises and affect me, my partner and other residents

The landlord already invested in double glazing windows but wearing earplugs, turning television up or sleepless night are something that I do not wish to experience again.

Pandemic affected us all and like myself made my job fully remote I cannot stress enough in addition to anxiety, stress I have already experience by needing to adjust to a new lifestyle I cannot imagine to face another stress, related/caused by potential club reopening. I have already had to find a way to work / life balance by spending a lot of time at my property that I have been leaving at for the past 6 years. It's not only my home but also a work place.

Generally any activity involving increased numbers of people, vehicles, music and alcohol after 11:30 at night is not appropriate for a residential area and it increases the possibility of becoming a public nuisance and significantly raises the risk of criminal and disorderly behaviour.

I would also urge the Committee to consider the previous horrifying incidents like stabbing, shootings, number of violent fights that are all related to previous venues - socialite bar, metropolitan bar in which evidence of the negative effects of the flexible licensing hours was put forward by local residents, local authorities with a request of closing the above. Please Prevent us - locals of Crime and Disorder – fighting, drug problems, robberies, thefts, disorder etc. The problems occur when the late night venues are in operations. In the past the police were involved on most of nights during venue operation hours. That's said late night venues at 272 Muswell Hill Broadway are bringing to the area ongoing problems only.

While the owner of the club may assure us/residents that he will prevent from any trouble, it's very clear that while he may be able to control the crowd at the premisses, it will be out of his control how his visitors will be acting outside as this will be no longer be his responsibility.

In view of the above, I would urge the Licensing Authority to refuse the application to protect residents and neighbourhood.

Regardless of the good intentions those leaving late licensed venues have always created a large amount of noise pollution which impacts those houses within about 0.5miles of the venue and this would occur on a nightly basis which will create significant distress for the families in the area who will have their sleep disturbed on a regular basis.

Hello,

We have been recently made aware that a late licence for 7 days a week has been submitted for 272 Muswell Hill Broadway...

I would like to put forth my strong objection...

A place open until 2 am EVERY DAY would be a massive massive disruption to what is an otherwise nice local community where some places are open occasionally until later, usually a couple of days at the weekend. This area is mostly residential and most people will be working most days early on, so having a venue open until late will allow the clients to be noisy until early hours of the morning when normally people are asleep, with their families and so on. There will be extra noise, and drinking and arguing in the streets, as is occasionally the case with places that sell alcohol.

Moreover, the clients will be afterwards spilling into the side streets (some already do when going to or coming from the other couple of pubs locally), continuing to drink and talk very loudly. That already happens especially with groups of young people who seem to have those arguments and bottle smashing occasions long after midnight when returning from the local pubs. If this venue is to be open THAT late, 7 days a week, well that would definitely ensure that no good sleep comes to those of us who live nearby on the adjacent streets. I don't even what to think of the people who live right by the roundabout!

Moreover, a lot of cars already seem to be doing suspicious very short stops/deliveries most weekend nights on Duke's Avenue, Wellfield Avenue or Muswell Road, then disappearing into the night again after brief encounters with youngsters in the area. Now why expensive, flashy cars stop briefly round here, you might be able to guess yourselves, as obviously young people in the area and maybe not only, need to purchase something that will help them have fun that night. This is now the case at the weekend usually, I dread to think that this will become a regular habit EVERY NIGHT if that place will get its daily late licence. We won't be able to get any sleep with the nighttime engine starting and stopping and the noisy party goes.

On top of that, we also need to take into consideration the local situation re safety, most people coming back home late will face noise, disruption and quite possibly aggression. The main bus stops are at the roundabout, so anyone working late shifts, coming or going, will have to face the crowds of people coming or going to the venue. When the punters are leaving, they will most definitely be inebriated and endangering the safety of neighbours in the area.. Women more than anything will be definitely feeling more unsafe and the roundabout will be a place to be avoided..

Last, but not least, this area is and always been residential, not commercial. It is not a nexus point for tubes/buses/overground etc, that would enable venue goers to disperse rapidly and get onto public transport to go home or continue further. Muswell Hill is not that well connected and generally the police presence to ensure calm and order is very very low... I'm not sure how exactly the venue thinks they can reassure anyone that their clients will respect the peace of the local neighbourhood and their safe and quiet leaving the premises..

Most likely, all their clients will carry on partying and drinking on the little alleyways and side streets, leaning on people's front fences (they're already doing that sometimes at the weekend), making it a very unpleasant, unclean, unnecessary and unsafe environment for everyone around this residential neighbourhood.

This is not a central area where places can be opened daily this late, as they are surrounded by similar locations and venues... This is just a normal neighbourhood!

I hope you will make the right and safe decision.

I am writing to object to the latest licensing application from the above venue, which requests a license permitting the sale of alcohol, live music and to remain open until 2am Monday-Sunday.

As Member of Parliament for Hornsey & Wood Green, I am extremely concerned about the impact this application would have on local residents, who have already contacted me to express their strong opposition. Under the venue's previous name, The Socialite, concerns were repeatedly raised with me of noise disturbance and rowdy behaviour from people leaving the premises. A serious violent incident outside the bar involving firearms caused considerable alarm and distress in the local community and at the time I called for an urgent license review. There is serious and understandable public concern that if this license was approved, the previous issues would return.

My concerns fall into two categories:

The prevention of public nuisance: this is a residential, family area. Residents tell me that when the venue is hired out, they experience increased anti-social behaviour including public urination and noise nuisance and I am extremely concerned that permitting this application would significantly increase the problems experienced by residents. It is unclear what steps have been taken to improve the management of the premises and the local impact.

The Prevention of crime and disorder: as set out above, under the venue's previous name I requested a licensing review following a concerning incident outside the venue involving a firearm. More recently, residents have shared their concerns about a stabbing in the local area and an increased Police presence in the evenings due to crime and disorder concerns around neighbouring venues. I am particularly worried that adding another late-night venue to the mix in this small, densely populated residential area will increase the risk of crime and disorder.

I hope these objections will be taken into account and this application, in its current form, will be rejected.
