## **2. DECLARATIONS OF INTEREST**

## **3. DISABLED RESIDENTIAL PARKING PERMIT (PAGES 1 - 12)**

*The Chair of Overview and Scrutiny has agreed that the decision is both reasonable in all the circumstances and that it should be treated as a matter of urgency. This is in order to restore, as quickly as possible, the ability for vehicles to be registered to anyone in the same household as the resident that holds the Blue Badge. This will allow those Blue Badge holders to access the wider borough more fully than at present, particularly so that they can take full advantage of what Haringey has to offer before and during the Christmas and New Year period.*

*Please be advised that the Chair of Overview and Scrutiny has further agreed that the call-in procedure shall not apply to this urgent decision. This is because the decision is urgent and any delay in implementation caused by the call-in procedure would seriously prejudice the Council's or the public's*

*interests due to the fact that this decision relates to extending the concessions of the (free) disabled residential parking permit, aligning it more to the original companion badge scheme, and will restore, as quickly as possible, the ability for vehicles to be registered to anyone in the same household as the resident that holds the Blue Badge. This will allow those Blue Badge holders to access the wider borough more fully than at present, particularly so that they can take full advantage of what Haringey has to offer before and during the Christmas and New Year period and this can be communicated to Disabled Badge Holders in December. Accordingly, the Chair of Overview and Scrutiny Committee has agreed that the decision is both reasonable in all circumstances, and that it should be treated as a matter of urgency. This is in accordance with Part 4, Section H, and Paragraph 18 (a) and (b) of the Council Constitution.*

## **1 Describe the issue under consideration**

- 1.1 To report on the feedback of statutory consultation which commenced on 13 October 2021 for 21 days, closing on 3 November 2021, on the proposal to extend the concessions of the disabled (virtual) residential parking permit as detailed in paragraph 6.4.
- 1.2 To request approval to proceed to implementation of these concessions, having taken objections into consideration.

## **2 Cabinet Member Introduction**

- 2.1 I am pleased that we can extend the concessions of the disabled virtual residential parking permit. We understand the importance of this concession and benefit arising for our disabled motorists.

## **3 Recommendations**

The Cabinet Member is asked:

- 3.1 To approve the proposal to extend the concessions of the disabled virtual residential parking permit, as detailed in Table 1 in paragraph 6.4 of the report.

## **4 Reasons for decisions**

- 4.1 The Blue Badge parking scheme is a lifeline that allows millions of disabled people to park their vehicle close to their destination, either as a passenger or driver. The badge can only be used lawfully if the disabled person is either driving the vehicle or being carried as a passenger and being dropped-off or picked-up at that location.
- 4.2 The scheme is designed to support the most vulnerable people in society, but is subject to fraud and abuse, ranging from misuse of the badge by family members, to criminals and gangs stealing badges to sell on the black market.
- 4.3 Following approval granted under Delegated Authority in October 2021, statutory consultation was undertaken on extending the concessions of the disabled residential parking permit. The Council is required to consider the

feedback to this consultation prior to deciding whether or not to implement the proposed changes.

- 4.4 A total of 4 submissions were received to the statutory consultation - 3 objections and 1 in favour. Of the objections received, none could be considered as a 'substantial objection' for example, relating to the consultation process not following required legal process or statutory documents containing fundamental errors. A summary of objections received are detailed in Table 2, paragraph 6.10 of this report.

### **5 Alternative options considered**

- 5.1 An alternative was to not introduce proposed changes to extend the concessions of the disabled (virtual) residential parking permit borough wide. This is not recommended as the changes proposed are to ensure the Council meets its obligations under the Equality Act 2010.

### **6 Background Information**

- 6.1 The Council has offered a Blue Badge substitute scheme to help reduce the theft of Blue Badges. The original scheme, known as the Companion Badge, incorporated the vehicle registration number so that it could not be used on any other vehicle and was therefore of no value to anyone other than the legitimate holder. It did not replace the Blue Badge but could be used 24 hours a day in Haringey. Take-up of the scheme was relatively low, with 15% of Blue Badge holders choosing to purchase a Companion Badge.
- 6.2 This scheme was recently replaced with a free (disabled) virtual residential parking permit, for the badge holder's home Controlled Parking Zone (CPZ). This mirrored arrangements in two neighbouring boroughs (Islington and Hackney). Being free of charge, this was expected to appeal to a wider cohort of badge holders. This would, in turn, reduce the numbers of Blue Badges being displayed, and therefore at risk of being stolen. This scheme requires the vehicle to be registered in the Blue Badge holder's name at the address within the CPZ. Those residents could already purchase a residential parking permit. The new scheme therefore did not, by default, increase any opportunity for misuse of the scheme.
- 6.3 However, on implementation of the new scheme, existing Companion Badge holders report that they find the new scheme too restrictive. They feel that being limited to their home CPZ fails to provide the protections required. Concerns were also raised regarding the requirement that the vehicle be registered to the Blue Badge holder. There are situations where a Blue Badge is issued to a minor and, in some situations, the vehicle is registered to the badge holder's partner or spouse. Consideration has therefore been given to extending the concessions to address those concerns, but with some checks and balances introduced to manage risk of the virtual permit being used to avail of free parking when the Blue Badge holder is not present.
- 6.4 The proposed extended concessions to the disabled virtual residential parking permit include the following:

### **Table 1**

Item	Description
(a)	Extend eligibility for the disabled virtual residential parking permit to allow the vehicle to be registered to anyone in the same household as the Blue Badge holder.
(b)	The disabled virtual residential parking permit be extended borough-wide, allowing holders to park in non-dedicated disabled parking bays, residential permit parking bays, permit holders parking place, pay by phone bays, shared use residential permit parking place/pay by phone bays and shared use permit holder parking place/pay by phone bays.
(c)	Those permit holders would be prohibited from parking on single or double yellow lines
(d)	When using the disabled virtual residential parking permit, the Blue Badge must be available for inspection when requested by an Enforcement Officer.
(e)	When using the disabled virtual residential parking permit, the Blue Badge holder must be present either as the driver or passenger of the vehicle and therefore personally making use of the concession, unless parked outside the home of the Blue Badge holder.
(f)	The disabled virtual residential parking permit would remain free of charge.

- 6.5 The disabled virtual residential parking permit will currently have to be renewed annually. However, the Council will update its systems as soon as possible to provide a 3-year permit which mirrors the start and expiry dates of the 3-year Blue Badge.

### **Statutory Consultation**

- 6.6 Statutory notifications were undertaken on the proposals detailed in Table 1 section 6.5, on 13 October 2021 for a period of 21 days. This adheres to the legal requirements set out in section 9 of this report.
- 6.7 As part of the statutory process, a Notice of Proposal was published in the London Gazette, Enfield and Haringey Independent. In addition, the documents were uploaded to the Haringey TMO webpage and hard copies printed and held on deposit as indicated by the instructions in the Notice of Proposal. A copy of the statutory notice of proposal that was advertised is attached as Appendix 1.
- 6.8 As part of the statutory process, the views of the following statutory bodies were also sought:
- AA
  - London Transport
  - Police (local)
  - Fire brigade
  - London Ambulance Service

- Freight Transport Association
- Road Haulage Association
- RAC
- Metropolitan Police (traffic)
- London Travel Watch
- Haringey Cycling Campaign

6.9 A copy of e-mail sent to the above statutory bodies is attached as **Appendix 2**.

### Statutory Notification Feedback

6.10 3 objections and 1 general comment were received to the proposal. An overview of these objections and comment, with officer recommendations, can be found in Table 2 below. Full detail of the objections received, and officer comments, can be found in **Appendix 3**.

**Table 2**

Reference	Objection/Comment	Officer Recommendation
Comment 1	To introduce a virtual permit to allow disabled badge holders to park anywhere within the Borough.	The proposal will satisfy this resident as the concessions will be extended to allow anyone with a valid disabled virtual residential parking permit to park anywhere within the Borough rather than limiting parking to the CPZ in which they reside in.
Objector 1, 2 & 3	Carer of disabled family member would not qualify for a disabled virtual residential parking permit under the extended concessions as they do not reside in the property which the disabled person lives. Can this be extended?	As this is a (disabled) residential parking permit, it needs to be limited to Blue Badge holders or those who reside with them as part of the household. The Blue Badge may be used by carers when transporting the badge holder.

6.11 After considering the statutory consultation results and noting that there were 3 objections to the consultation as detailed above, it is concluded that no alterations should be made to the proposals detailed in Table 1 of section 6.5 of this report.

## 7 Contribution to strategic outcomes

7.1 The introduction and management of disabled parking places aligns with the Council's current [Borough Plan](#) and [Transport Strategy](#) section 3.2 with respect to the management of on-street parking and its prioritisation to those with disabilities and who live locally.

- 7.2 The eligibility for introduction of disabled and dedicated disabled parking places is clearly defined by the current [disabled-parking-place-policy.pdf \(haringey.gov.uk\)](#).
- 7.3 The use of disabled parking and dedicated parking places contributes to the Council meeting its obligations for disabled parking set out in section 149 of the Equality Act 2010 (the Public Sector Equality Duty ('PSED')). This duty includes having due regard to the need to advance equality of opportunity between persons who share a relevant protected characteristic (including people with a disability) and persons who do not share it.

## **Statutory Officers' comments**

### **8 Finance**

- 8.1 This report seeks Cabinet Member approval for the implementation of the proposal to formalise and extend the concessions of the disabled virtual residential parking permit as detailed in Table 1 of section 6.5. Blue Badge holders are entitled to park free of charge and therefore they the disabled permit is currently issued free of charge.
- 8.2 The cost of the consultation is estimated to be between £2-3k; there are no other requirements such as changed signage etc. The cost for running the scheme will be funded from existing revenue resources.

### **9 Legal**

- 9.1 The Council has a general duty under the Disability Discrimination Act 2005 and the Council has to have regard in the provision of its services (including car parking services) to take steps to take account of a disabled person's disabilities, even where that involves treating disabled persons more favorably than other persons by, for example, offering concessionary parking fees.
- 9.2 The Council has a statutory obligation to provide disabled parking facilities and to effectively manage the delivery of the national Blue Badge scheme. As long as due consideration is given to representations made, the decisions within this report are in accordance with the law, and the Council would be entitled to carry out those proposals. There is no legal reason why the proposals set out in this report cannot be implemented.
- 9.3 Before reaching a decision to make the necessary traffic management order to extend the concessions of the disabled virtual residential parking permit, the Council must follow the statutory consultation procedures pursuant to the Road Traffic Regulation Act 1984 ("RTRA") (as amended) and the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 (as amended). In carrying out the notification, the Council must comply with the principles ("Sedley Principles") set out also by the courts which are: that notification must be at a time when proposals are still at a formative stage; that the proposer must give sufficient reasons for any proposal to permit of intelligent consideration and response; that adequate time must be given for consideration and response; and that the product of notification must be conscientiously taken into account in finalising any statutory proposals. All objections received must

be properly considered in the light of administrative law principles, Human Rights law and the relevant statutory powers.

- 9.4 The Council's powers to make traffic management orders arise mainly under sections 6, 9, 45, 46, 122 and 124 and schedules 1 paragraph 8 and 9 of the RTRA.
- 9.5 By virtue of section 122, the Council must exercise its powers under the RTRA 1984 so as to secure the expeditious, convenient and safe movement of vehicular and other traffic including pedestrians, and the provision of suitable and adequate parking facilities on and off the highway. These powers must be exercised so far as practicable having regard to the following matters: -
- The desirability of securing and maintaining reasonable access to premises.
  - The effect on the amenities of any locality affected including the regulation and restriction of heavy commercial traffic so as to preserve or improve amenity.
  - The national air quality strategy.
  - Facilitating the passage of public service vehicles and securing the safety and convenience of their passengers.
  - Any other matters appearing to the council to be relevant
- 9.6 The legal position in relation to traffic management orders and the statutory requirements in respect of consultation are set out in section 9.1 through 9.5 of this report. Public consultation has been undertaken and due consideration given to representations by the public. As long as the statutory consultation is undertaken and due consideration similarly given to representations made, the Council should be acting in accordance with the law were it to proceed with the proposals set out in this report.

## 10 Equalities

- 10.1 The Council has a Public Sector Equality Duty under the Equality Act (2010) to have due regard to the need to:
- Eliminate discrimination, harassment and victimisation and any other conduct prohibited under the Act
  - Advance equality of opportunity between people who share those protected characteristics and people who do not
  - Foster good relations between people who share those characteristics and people who do not.
- 10.2 The three parts of the duty applies to the following protected characteristics: age, disability, gender reassignment, pregnancy/maternity, race, religion/faith, sex and sexual orientation. Marriage and civil partnership status apply to the first part of the duty.
- 10.3 Proposals in this report offers Blue Badge holders protections from the theft of their badges. Those proposals include measures to prevent misuse of the concession. This will, in particular, satisfy the requirement to advance equality of opportunity between people who share those characteristics and people who do not. The abuse and misuse of disabled parking concessions impacts on disabled and non-disabled residents, preventing access to parking spaces by those legitimately entitled to use them. Preserving access to parking spaces for



disabled people will allow for fuller participation in public life for those reliant on a vehicle for mobility,

Notice is hereby given that the Council of the London Borough of Haringey proposes to make the above mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

The general effect of the Orders would be to ~~formalise~~ and extend the concessions of the disabled virtual residential parking permit as detailed below:

1. Extend eligibility for the disabled virtual residential parking permit to allow the vehicle to be registered to anyone in the same household.
2. The disabled virtual residential parking permit be extended borough-wide, allowing holders to park in non-dedicated disabled parking bays, residential permit parking bays, permit holders parking place, pay by phone bays, shared use residential permit parking place/pay by phone bays and shared use permit holder parking place/pay by phone bays.
3. Those permit holders would be prohibited from parking on single or double yellow lines (However Disabled Badge holders may park for up to 3 hours on single or double yellow lines where loading restrictions do not apply, providing the badge and associated clock is displayed correctly).
4. When using the disabled virtual residential parking permit, the Blue Badge must be available for inspection when requested by an Enforcement Officer.
5. When using the disabled virtual residential parking permit, the blue badge holder must be present either as the driver or passenger of the vehicle and therefore personally making use of the concession, unless parked outside the home of the blue badge holder.
6. The disabled virtual residential parking permit would remain free of charge.
