1. Describe the issue under consideration

1.1 This report relates to an application for a new premises licence by Cornelia Cotlogut

1.2 The application seeks the following:

Late Night Refreshment

Monday to Saturday 2300 to 0200 hours

Sunday 2300 to 0000 hours

Supply of Alcohol

Monday to Saturday 1100 to 0130 hours

Sunday 1100 to 0000 hours

Hours open to Public

Monday to Saturday 0800 to 0200 hours

Sunday 0800 to 0000 hours

1.5 Recommendation

In considering the representations received and what is appropriate for the promotion of the licensing objectives, the steps the Sub-Committee can take are:

- Grant the aspplication as requested
- Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
- Exclude any licensable activities to which the application relates
- Reject the whole or part of the application



Members of the licensing sub committee are asked to note that they may not modify the conditions or reject the whole or part of the application merely becaus it considers it desirable to do so. It must be appropriate in order to promote the licensing objectives.

2 Background

- 2.1 The premises is situated along Westbury Avenue with residential properties above it, next door to it and behind it. The premises operates as a café and shisha premises, it has an outdoor front area as well as an external area to the rear.

 The front pavement area is also the point of access for the residents who live above the premises.
- 2.2 The premises has come to the attention of the Council and Police due to various complaints relating to public nuisance. A summary of the complaints received is at Appendix C.
- 2.3 The licence holder has addressed the requirement to vary the DPS once it was established the previous named DPS was no longer involved at the business.

3 Licensing Policy

- 3.1 The committee will also wish to be aware of the guidance issued under section 182 of the Licensing Act 2003. Licensing is about regulating the provision of licensable activities on licensed premises, by qualifying clubs and at temporary events within the terms of the Licensing Act 2003. The terms and conditions attached to various permissions are focused on matters which are within the control of individual licensees and others granted relevant permissions. Accordingly, these matters will centre on the premises and places being used for licensable activities and the vicinity of those premises and places.
- 3.2 The objective of the licensing process is to allow for the carrying on of retail sales of alcohol and the prevention of public nuisance, prevention of crime and disorder, public safety and protection of children from harm. It is the Licensing Authority's wish to facilitate well run and managed premises with licence holders displaying sensitivity to the impact of the premises on local residents.
- 3.3 In considering licence applications, where relevant representations are made, this Licensing Authority will consider the adequacy of measures proposed to deal with the potential for public nuisance and/or public disorder having regard to all the circumstances of the case.
- 3.4 Where relevant representations are made, this authority will demand stricter conditions with regard to noise control in areas that have denser residential accommodation, but this will not limit opening hours without regard for the individual merits of any application. This authority will consider each application and work with the parties concerned to ensure that adequate noise control measures are in place. Any action taken to promote the licensing objectives will be appropriate and proportionate.
- 3.5 This Licensing Authority in determining what action to take will seek to establish the cause of concern and any action taken will be directed at these causes. Any action taken to promote the licensing objectives will be appropriate and proportionate.



- 3.6 Where relevant representations are made, this authority will demand stricter conditions with regard to noise control in areas that have denser residential accommodation, but this will not limit opening hours without regard for the individual merits of any application. This authority will consider each application and work with the parties concerned to ensure that adequate noise control measures are in place
- 3.7 Also The Licensing Authority may not impose conditions unless its discretion has been exercised following receipt of relevant representations and it is satisfied as a result of the hearing that it is appropriate to impose conditions to promote one or more of the four licensing objectives. Therefore conditions may not be imposed for the purpose other than promoting the licensing objectives and in some cases no additional conditions will be required.
- 3.8 In cases Members should make their decisions on the civil burden of proof, that is the balance of probability.
- 3.9 Members should consider in all cases whether or not primary legislation is the appropriate method of regulation and should only consider licence conditions when the circumstances in their view are not already adequately covered elsewhere.
- 3.10 The Government has advised that conditions must be tailored to the individual type, location and characteristics of the premises and events concerned. Conditions cannot seek to manage the behaviour of customers once they are beyond the direct management of the licence holder and their staff.
 The Councils Licensing policy generally expects applicants to address the licensing objectives and discuss how to do this with the relavant responsible authorities.

4 Licensing hours

- 4.2 Where relevant representations are made, the Council will consider the proposed hours on their individual merits. Notwithstanding this, the Council may require stricter conditions in areas that have denser residential accommodation to prevent public nuisance. The Council will endeavour to work with all parties concerned in such instances to ensure that adequate conditions are in place. The Council may restrict the hours that certain premises can offer alcohol for sale for consumption off the premises for preventing crime, disorder and nuisance.
- 5 Powers of a Licensing Authority
- 5.1 The decision should be made with regard to the Secretary of the State's guidance and the Council's Statement of Licensing Policy under the Licensing Act 2003. Where the decision departs from either the Guidance or the Policy clear and cogent reasons must be given. Members should be aware that if such a departure is made the risk of appeal / challenge is increased.
- 5.2 The licensing authority's determination of this application is subject to a 21 day appeal period or if the decision is appealed the date of the appeal is determined and /or disposed of.

6. Other considerations

Section 17 of the Crime and Disorder Act 1998 states:

"Without prejudice to any other obligation imposed on it, it shall be the duty of each



authority to which this section applies to exercise its various functions with due regard to the likely effect of the exercise of those function on, and the need to do all that it reasonably can to prevent crime and disorder in its area".

6.1 Human Rights

While all Convention Rights must be considered, those which are of particular relevance to the application are:

- o Article 8 Right to respect for private and family life.
- o Article 1 of the First Protocol Protection of Property
- Article 6(1) Right to a fair hearing.
- Article 10 Freedom of Expression





The Licensee will install comprehensive CCTV coverage at the premises and it is operated and maintained at the premises.

The CCTV system shall conform to the following:

- 1. Cameras will be sited to observe the entrance and exit doors both inside and outside.
- 2. Cameras on the entrances will capture full frame shots of the heads and shoulders of all people entering the premises i.e. capable of identification.
- 3. Cameras viewing till areas will capture frames not less than 50% of screen.
- 4. Cameras overlooking floor areas will be wide angled to give an overview of the premises.
- 5. Be capable of visually confirming the nature of the crime committed.
- 6. Provide a linked record of the date, time and place of any image.
- 7. Provide good quality images -colour during opening times.
- 8. Operate under existing light levels within and outside the premises.
- 9. Have the recording device located in a secure area or locked cabinet.
- 10. Have a monitor to review images and recorded picture quality.
- 11. Be regularly maintained to ensure continuous quality of image capture retention.
- 12. Have signage displayed in the customer area to advise that CCTV is in operation.
- 13. Digital images will be kept for 31 days.
- 14. Police will have access to images at any reasonable time.
- 15. The equipment will have a suitable export method, e.g. CD/DVD writer so that the Police can make an evidential copy of the data they require. This data will be in the native file format, to ensure that no image quality is lost when making the copy, if this format is non-standard (i.e. manufacturer proprietary). Copies will be made available to Police on request.

A member of staff trained in operating CCTV will be at venue during times open to the public.

An incident log shall be kept at the premises and made available on request to the Police, which will record the following:

- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) seizures of drugs or offensive weapons
- (f) any faults in the CCTV system or searching equipment or scanning equipment
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

Annex 2 - Conditions consistent with the Operating Schedule

PUBLIC SAFETY

Appropriate fire safety procedures shall be in place including fire extinguishers, internally illuminated fire exit signs, numerous smoke detectors and emergency lighting

All appliances will be inspected annually.

All emergency exits shall be kept free from obstruction at all times.

THE PREVENTION OF PUBLIC NUISANCE

All customers will be asked to leave quietly.

Clear and legible notices will be prominently displayed to remind customers to leave quietly and have regard to our neighbours.

No live and recorded music will take place in the premises.

THE PROTECTION OF CHILDREN

The licensee and staff will ask persons who appear to be under the age of 25 for photographic ID such as proof of age cards, the Connexions Card and Citizen Card, photographic driving licence or passport, an official identity card issued by HM Forces or by an EU country, bearing the photograph and date of birth of bearer.


All staff will be trained for UNDERAGE SALES PREVENTION regularly.

Hi there,


My wife and I live at [redacted], just by Turnpike Lane underground station and above JANI restaurant and bar. We have lived there for several years and enjoy being a part of the community here very much. We did have a good relationship with Mirjan Gradica until around September 2021, when he started playing music very loudly in his bar at night and we regularly needed to send him messages asking him to turn down the music. I do understand that it's a bar in the evenings, but we also should be allowed a certain amount of peace in our own home. At the time, Mirjan was pleasant enough and would turn the music down. Then earlier this year the music was being played until 3am most weekends and people were out the back of the building smoking shisha pipes just as late or later. This has been going on since then and when I've tried to speak to him about it, he says that he now has a late license, which he has displayed in the window. It was only last week when I looked at the notice in the window that I saw it is not actually a license to sell alcohol until 2am, but the application to do so. This means that he has been breaking licensing laws by staying open later than his current license allows, though I believe he probably has misunderstood the situation after applying for the license and getting the paper through in the post so must think that this is the license he applied for, rather than the notice of application. Also, the chairs and tables they have for customers now are often put out right in front of the door to our building making it very hard to get in and out plus I think they have to many chair on the public pavement I saw oldest, disable and mams with kids struggle to pass through due too many chairs and tables. It now feels as though they think they can do what they like, but we're not sleeping until 1am most weekdays and until 3am or later at the weekend. The lack of sleep and confrontations we have to deal with now has become too much and I want to put in a representation to ask that the license remains for the earlier time and that this is enforced to make sure he sticks to the times that he legally should be opening and closing at. I don't wish for him to lose his business of course, I do want him to be able to run a successful restaurant and bar that provides a safe space for members of the Albanian community in the area. However, I just want to be able to sleep at night and do not wake up 6am every morning with the noise off the waitress drugging chairs and talking very loudly with customers and not be tired at work every day. It has been very stressful over the last few months and so I felt that I had to act, not only




