Purpose:

- 2. Seek a decision on the 3 & 4 Early Year funding formula for 2023-24.

3. To use the funding formula detailed in option 1 Universal approach, to provide deprivation funding for ALL 3- & 4-year-olds see 7.1

1. Introduction

1.1. The purpose of this paper is to provide Schools Forum members with an overview of the options for paying the deprivation funding and the resulting funding for 3 & 4 year olds for 2023-24.

5. <u>3 & 4 year old Early Years DSG Block Funding</u>

5.1. Funding for this provision is broken down along the following lines:

Funding stream	2023-24 Funding allocation (£m)
3- & 4-Year-Old Funding	£16,733,467

Deduction of 5% retained funding from 3- & 4-year funding block	£819,016
Deduction of Quality Supplement from 3- & 4-year funding block	£76,000
Actual funding available for 3- & 4-year-old settings after deductions	£15,485,310

6. Deprivation supplement - options

6.1. DfE have confirmed that Local Authorities must have a deprivation supplement and that local authorities have the freedom to choose the appropriate metric for allocating funding but should be transparent about the metric chosen.

- **6.2.** Detailed discussions were had with the Early Years working group to review the two options for paying deprivation. These included looking at full financial information and funding models to enable the Early Years working group to make the most informed decision.
- **6.3.** The two options for the use of the deprivation supplement are below:

Option 1 Universal funding

This option would provide deprivation funding for **ALL** 3- & 4-year-olds - as is the case in 2022-23.

Funding is comprised of two elements	A base rate and a deprivation supplement
Base rate element p/h	£5.33
Deprivation supplement p/h	£0.37
Total universal funding rate p/h	£5.70

- Following consultation with representatives of the Early Years Working Group, Option 1 has been revised.
- The contingency funding of £62,000 has been reallocated to the base rate.
- $\circ~$ This results in an increase of £0.02 p/h in the base rate, and thereby increases the universal funding rate to £5.70 p/h

Option 2 – Targeted approach for funding of deprivation

This option would only provide deprivation funding for 3- & 4-year-olds that **are eligible for EYPP.**

Deprivation rate without contingency for mitigating impact.	0.40p p/h	0.20p p/h	0.10p p/h	0.05p p/h
Funding for 3 & 4 year olds not eligible for EYPP	£5.64	£5.67	£5.69	£5.69
Funding for 3 & 4 year olds eligible for EYPP	£6.04	£5.87	£5.79	£5.74

- This option includes contingency to mitigate uptake in provision increases only
- 7. Recommendation for the allocation deprivation supplement
 - 7.1. The Early Years working group have recommended the 3 & 4 year old funding formula for 2023-24 of Option 1 Universal funding, is used for the allocation of the deprivation supplement.
 - **7.2.** This will ensure equitable distribution of deprivation funding for all early year's settings in Haringey.

Proposed options for deprivation?

Option 1- Universal approach

 Maximise the hourly rate for all settings by paying every 3 & 4 year old deprivation funding

Options 2- Targeted approach

 To only pay 3 & 4 year olds eligible for EYPP deprivation funding

Option 1- Universal funding

Funding is comprised of two elements	A base rate and a deprivation supplement
Base rate element p/h	£5.33
Deprivation supplement p/h	£0.37
Total universal funding rate p/h	£5.70

- Following consultation with representatives of the Early Years Working Group, Option 1 has been revised.
- The contingency funding of £62,000 has been reallocated to the base rate.
- This results in an increase of £0.02 p/h in the base rate, and thereby increases the universal funding rate to £5.70 p/h

Recommendation from the Early Years working group to go with Option 1 – Universal funding

DEPRIVATION FUNDING OF £0.37 P/H FOR EVERY 3 & 4 YEAR OLD

Deprivation rate p/h	£0.37p p/h
Base rate p/h	£5.33 p/h
Universal funding rate p/h	£5.70 p/h

- This will ensure the most equitable distribution of deprivation funding for all early years settings in Haringey
- This no longer includes a £62,000 contingency fund.
- The hourly rate for all settings for 3- and 4-yearolds would be £5.70.
- For financial year 2024-25 we will review the early years funding formula and how it is best used to target children in deprivation.
