Residents have raised concerns about the anti social behaviour that is currently being caused in the location. Some medication has been seent to the residents but their concerns still remain.

1.5 **Recommendation**

In considering the representations received and what is appropriate for the promotion of the licensing objectives, the steps the Sub-Committee can take are:



- Grant the aspplication as requested
- Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
- Exclude any licensable activities to which the application relates
- Reject the whole or part of the application

Members of the licensing sub committee are asked to note that they may not modify the conditions or reject the whole or part of the application merely becaus it considers it desirable to do so. It must be appropriate in order to promote the licensing objectives.

2 Background

- 2.1 The premises is situated along the parade of commercial business with residential above and is on the cormer of a residential road. The premises has operated as a rretail/tyre shop in the past. The applicant now wishes to offer a restaurant style operation.
- 2.2 The new owner is seeking to operate a late night venue and also add a shisha lounge area to the rear of the venue where he intends to provide licensable activity also. No specific plans or Planning permission is in place for a proposed shisha lounge to the rear. The agent acting for the applicant has since stated there iare no plans for shisha activity.
- 2.3 The applicant has been advised of the need for Planning permission, if a shisha lounge is being proposed.

3 Licensing Policy

- 3.1 The committee will also wish to be aware of the guidance issued under section 182 of the Licensing Act 2003. Licensing is about regulating the provision of licensable activities on licensed premises, by qualifying clubs and at temporary events within the terms of the Licensing Act 2003. The terms and conditions attached to various permissions are focused on matters which are within the control of individual licensees and others granted relevant permissions. Accordingly, these matters will centre on the premises and places being used for licensable activities and the vicinity of those premises and places.
- 3.2 The objective of the licensing process is to allow for the carrying on of retail sales of alcohol and the prevention of public nuisance, prevention of crime and disorder, public safety and protection of children from harm. It is the Licensing Authority's wish to facilitate well run and managed premises with licence holders displaying sensitivity to the impact of the premises on local residents.
- 3.3 In considering licence applications, where relevant representations are made, this Licensing Authority will consider the adequacy of measures proposed to deal with the potential for public nuisance and/or public disorder having regard to all the circumstances of the case.
- 3.4 Where relevant representations are made, this authority will demand stricter conditions with regard to noise control in areas that have denser residential accommodation, but this will not limit opening hours without regard for the individual merits of any application. This authority will consider each application and work with the parties concerned to ensure that adequate noise control measures are in place. Any action taken to promote the licensing objectives will be appropriate and proportionate.



- 3.5 This Licensing Authority in determining what action to take will seek to establish the cause of concern and any action taken will be directed at these causes. Any action taken to promote the licensing objectives will be appropriate and proportionate.
- 3.6 Where relevant representations are made, this authority will demand stricter conditions with regard to noise control in areas that have denser residential accommodation, but this will not limit opening hours without regard for the individual merits of any application. This authority will consider each application and work with the parties concerned to ensure that adequate noise control measures are in place
- 3.7 Also The Licensing Authority may not impose conditions unless its discretion has been exercised following receipt of relevant representations and it is satisfied as a result of the hearing that it is appropriate to impose conditions to promote one or more of the four licensing objectives. Therefore conditions may not be imposed for the purpose other than promoting the licensing objectives and in some cases no additional conditions will be required.
- 3.8 In cases Members should make their decisions on the civil burden of proof, that is the balance of probability.
- 3.9 Members should consider in all cases whether or not primary legislation is the appropriate method of regulation and should only consider licence conditions when the circumstances in their view are not already adequately covered elsewhere.
- 3.10 The Government has advised that conditions must be tailored to the individual type, location and characteristics of the premises and events concerned. Conditions cannot seek to manage the behaviour of customers once they are beyond the direct management of the licence holder and their staff. The Councils Licensing policy generally expects applicants to address the licensing objectives and discuss how to do this with the relavant responsible authorities.

4 Licensing hours

4.2 Where relevant representations are made, the Council will consider the proposed hours on their individual merits. Notwithstanding this, the Council may require stricter conditions in areas that have denser residential accommodation to prevent public nuisance. The Council will endeavour to work with all parties concerned in such instances to ensure that adequate conditions are in place. The Council may restrict the hours that certain premises can offer alcohol for sale for consumption off the premises for preventing crime, disorder and nuisance.

5 Powers of a Licensing Authority

- 5.1 The decision should be made with regard to the Secretary of the State's guidance and the Council's Statement of Licensing Policy under the Licensing Act 2003. Where the decision departs from either the Guidance or the Policy clear and cogent reasons must be given. Members should be aware that if such a departure is made the risk of appeal / challenge is increased.
- 5.2 The licensing authority's determination of this application is subject to a 21 day appeal period or if the decision is appealed the date of the appeal is determined and /or disposed of.



6. Other considerations

Section 17 of the Crime and Disorder Act 1998 states:

"Without prejudice to any other obligation imposed on it, it shall be the duty of each authority to which this section applies to exercise its various functions with due regard to the likely effect of the exercise of those function on, and the need to do all that it reasonably can to prevent crime and disorder in its area".

6.1 Human Rights

While all Convention Rights must be considered, those which are of particular relevance to the application are:

- Article 8 Right to respect for private and family life.
- Article 1 of the First Protocol Protection of Property
- \circ Article 6(1) Right to a fair hearing.
- Article 10 Freedom of Expression



a) **General – all four licensing objectives (b,c,d,e)**: The premises will have fully installed with high definition CCTV system.

All staff will be provided with training in relation to the licensing objectives that are related with their duties. This will include the individual's responsibilities, age verification and licensing offences, as appropriate. Details of the training will be recorded in a log book and will be refreshed at regular intervals.

We will take all the necessary measures and implement any strategies safety strategies given to us by the council licensing authority and the police.

We will implement any strategies safety strategies given to us by the council licensing authority and the police to keep our customers and our staff safe.

We will have a strict age verification policy (Challenge 25) for both entrance and sale at the same time adopt a strict NO ID, NO SALE policy.

We make sure CCTV recording is in continuance consistent operation and this will be communicated to all the premises users by way of clear visible signs is strategic positions inside and outside the premises.

We will also display warning signs that warn of other possible breaches to the licensing objective i.e we will have signs prohibiting any antisocial or threatening behaviour, signs warning of public disorder, signs warning about and prohibiting controlled/ illegal drugs at the premises. Appropriate signage shall be displayed in prominent positions, both inside and outside the

premises, informing customers they are being recorded on CCTV.

We will have close liaison with the Metropolitan Police to seek advice and adopt their recommendations.

This staff member will be able to show police or authorised officers of the Licensing Authority recent data footage with the minimum of delay when requested. This data or footage reproduction shall be almost instantaneous.

All staff responsible for selling alcohol shall receive regular training in the Licensing Act 2003 in terms of the licensing objectives.

Staff shall be trained on conflict management to have the knowledge on safe conflict resolution and management.

The premises shall operate a 'Challenge 25' age-restricted sales policy and promote it through the prominent display of posters. The licence holder shall require staff to note any refusals in a refusals log. The refusals log shall record the date and time of the refusal; the name of the staff member refusing; and the reason for refusal. It must be checked and signed monthly by the designated premises supervisor.

The refusals log shall be made available for inspection upon request by the Licensing Team, Police or Trading Standards.

Any alcohol sold for consumption off the premises shall be sold in a sealed container.

c) **Public safety**: To keep our customers and our staffs safe we will have the following in place. Have warning sign that warn of drugs, violence, antisocial behaviour or any other crimes. Make sure the venue is well light both inside and outside.

We will implement any strategies safety strategies given to us by the council licensing authority and the police.

Politely but firmly ask any customer that is drunk to leave the venue and further to this we will make sure that any customer asked to leave the venue will be ejected safely and responsibly by calling a family member or a close friend to collect the and where this is not possible call a licensed taxi for them to take them home safely.

We will prevent and prohibit any over consumption of alcohol beyond the recommended drinking guide lines.

We will not allow and adopt a zero tolerance to any form of over consumption of alcohol and/or any drinking games.

e) **The protection of children from harm**: We will have close liaison with the Metropolitan Police to seek advice and adopt their recommendations on how to run the premises safely to keep children in and around this community safe.

We will join and/or work with the Community Safety Unit in line with the Community Safety Partnership Plan to make sure we are up to date with current affairs and that we up to standard with community safety and promptly implement any recommendations given to us in line with keeping children safe.

Regularly seek advice from the Metropolitan Police and the Community Safety Unit and regularly attend meetings called by them to keep up to date with children safety issues.

Have a strict age verification policy (Challenge 25) for both entrance and sale at the same time adopt a strict NO ID, NO SALE policy. Make sure that all staff are trained of how to effectively check IDs (Passport, EU Driving License, EU ID card or PASS card) to prevent any underage entry or sale of alcohol. Children will only be allowed accompanied by their parents and/or guardians and on such occasions they shall strictly not be allowed to purchase alcohol and they shall strictly not be allowed to remain in the premises after Midnight.

We have valued your concerns that you have raised and we are more than happy to minimize/avoid them in line with the licensing Act 2003. Taking you concerns and points seriously, we have changed our opening hours.

Public Nuisance

We totally understand the concerned that you have raised in regarding the existing problems.

The Restaurant is going to be Full service restaurant offer sit-down table service where people pay to sit and eat hot meals that are cooked on our kitchen. In the morning we serve English and Continental breakfast.

We would like our restaurant to be a quite where our customers can enjoy their food without any problems peacefully.

We have put in place the following measures to minimize/control public Nuisance from our restaurant to mention few of them are:

- 1. All music and amplified sound shall be kept to background levels
- 2. Notices shall be prominently displayed requesting customers to leave the area quietly.
- 3. Alcohol only be consumed on the premises while being seated at a table.

4. The outside frontage shall be swept and cleared of any rubbish and smoking litter associated with the business towards the end of trade each evening

5. The collection of refuse shall be restricted to the hours between 07:00 and 23:00 Monday-Saturday. No waste collections shall be made on a Sunday or Bank Holiday.

6. Customers will not be permitted to take drinks outside of the premises onto the steps or the pavement .

7. No more than 5 patrons, at any one time, shall use the frontage of the premises to smoke after 21:00hrs until closing. Signage shall be displayed to advise customers of this.

8. Exterior lighting shall be directed away from residential properties so as not to cause a nuisance.

9. There will be No Vertical drinking and we only serve drink with table hot meal.

Crime and Disorder

Again we have valued your concerns and in line with the licensing objectives under licensing Act 2003, we communicated with the local Police and we agreed with their condition given to us to avoid/minimized Crime and Disorder in the area.

We are not a drink establishment or a bar where serve alcoholic beverages only.

Having discussion with local Police officer we have removed off sales of alcohol to avoid intoxicated people coming to our restaurant.

Also we have the following list protective measures in place to minimize your concerns in line with the licensing objectives.

1. Clear and prominent signage will be displayed at the entrance/exit highlighting:

(a) CCTV in operation.

(b) Challenge 25 Proof of Age Scheme in operation.

(c) Residential Area: Please be respectful of our neighbours and leave quietly.

(d) Islington is a Controlled Drinking Zone. Drinking in the street is not permitted.

(e) Co-operation with the premises' search policy is an absolute condition of entry.

(f) Maximum venue capacity will be maintained at the level dictated by said risk assessment, as

(a) any and all persons who appear to be drunk and/or disorderly

(b) any and all persons displaying signs of other substance abuse.

7. The management shall monitor the CCTV regularly through

8. The premises licence holder shall ensure that any patrons smoking outside of the premises do so in an orderly manner and are regularly monitored by staff so as to ensure that there is no public nuisance or obstruction on the public highway.

As the Responsible Authority the Noise and Nuisance Team have reviewed the application. The applicant proposes to open a café and restaurant at 95 West Green Road, N15 which comprises a café/ bar dining area and dining room as well as an rear external garden. The premises was formerly a tyre and car repair shop and backs onto a public car park and is bounded by residential properties.

The licensable activities proposed are;

- 1) Sale by retail of Alcohol (On and Off the premises).
- 2) Provision of late-night refreshment.
- 3) Provision of regulated entertainment.

The application lacks detail and further information is required to confirm how they will uphold the 4 licensing objectives as outlined below:

Public Nuisance

The proposed plan does not include a lobby area to prevent noise breakout from the front dining space. The rear area is near the flats next door and directly above and control of people noise from the rear garden area is likely to be challenging even with the 50% enclosure they will install.

The operating schedule is replicated from guidance and non-specific, it does not propose conditions specific to application. We would expect the Schedule to include details about management controls for the garden area, particularly how many patrons will be permitted to use the space.

The application is contradictory in that it states recorded music will be provided but that this will not be amplified. They have installed speakers inside the premises as part of the fit-out, so we have surmised this is an error.

Residents are located directly above and adjacent to the premises. Residents have contacted the council to raise concerns about noise and nuisance from the potential use of the indoor back room and/ or rear area for shisha smoking which they have been advised is planned for this space. They also raised concerns about the impacts of carbon monoxide from burning indoors and described a recent visit to the premises by the Fire Brigade in response to concerns about carbon monoxide who found that those occupying the premises were burning coals indoors. They raised concerns about people noise and people gathering.

The hours specified in the application are excessive considering the proximity of residents. A reduction in the hours as outlined below is recommended to limit the potential impact on residents, particularly in the early hours of the morning.

They have stated that in dealing with drunken customers they will "Politely but firmly ask any customer that is drunk to leave the venue and further to this we will make sure that any customer asked to leave the venue will be ejected safely and responsibly by calling a family member or a close friend to collect the and where this is not possible call a licensed taxi for them to take them home safely". This is likely to be unsustainable.

The applicant should be specific about the wording of their signage and prompts to customers about drugs, violence and antisocial behaviour.

Conclusion

We have no objections to the application on the proviso the following conditions are added to the Licence granted and the recommended operating times applied.

Recommended Conditions:

- 1. The premises shall not make use of the proposed rear garden area until planning permission has been granted.
- 2. The proposed garden area must close to all parties no later than 21:00hours each day to ensure residents are not subjected to public nuisance from this area.
- 3. No live or recorded music shall be played in the proposed rear garden area at any time This does not include **low level background** music. The area shall be monitored by staff throughout its use to control the number and behaviour of patrons so that noise nuisance does not arise. The number of patrons permitted to use the rear area at any one time shall be limited to 8 people.
- 4. No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.
- 5. Patrons permitted to temporarily leave and then re-enter the premises to smoke shall be restricted to a designated smoking area.

- 6. No fumes, steam or odours shall be emitted from the licensed premises so as to cause a nuisance to any persons living or carrying on business in the area where the premises are situated.
- 7. All doors and windows shall remain closed during any licensable activity and where a door is used for patrons to enter or leave the premises the door shall be lobbied and fitted with a self-closing device.
- 8. All speakers shall be mounted on anti-vibration mountings to prevent transmission of sound energy to adjoining properties.
- 9. All regulated entertainment shall conclude 30 minutes before the premises are due to close each day.
- 10. All entertainments shall utilise the in-house amplification system and the output shall be controlled by the duty manager.
- 11. All staff involved in the sale of alcohol shall receive induction and refresher training (at least every three months) relating to the sale of alcohol and the conditions of the premises licence.
- 12. All training relating to the sale of alcohol and the conditions of the premises licence shall be documented and records kept at the premises. These records shall be made available to the Police and/or Local Authority upon request and shall be kept for at least one year.
- 13. A 'Think 25' proof of age scheme shall be operated and relevant material shall be displayed prominently within the Premises –including in a visible location:
- 14. At the entrance to the Premises;
- 15. Behind the bar;
- 16. In any other area where alcohol can be purchased by a customer.
- 17. A written record of refused sales shall be kept on the premises and completed when necessary. This record shall be made available to Police and/or the Local Authority upon request and shall be kept for at least one year from the date of the last entry.
- 18. Loudspeakers shall not be located in the entrance lobby or any outside/external area of the premises building, this includes the proposed garden area.
- 19. All windows and external doors shall be kept closed but not locked during regulated entertainment, except for the immediate access and egress of persons.
- 20. The management shall make subjective assessments of noise levels outside at the perimeter of the premises approximately hourly, to ensure that noise from the premises does not cause a disturbance to local residents/businesses. Records shall be kept of the times, dates and any issues discovered. These records shall be kept for six months and must be made available to an authorised officer of the Council or police, upon request. Where monitoring by staff identifies that noise from the premises is audible at the perimeter, measures shall be taken to reduce this i.e. turning volume down.
- 21. No alcoholic drinks or glass containers shall be taken out onto the public highway.
- 22. The premises licence holder shall ensure that the area immediately outside the premises is kept clean and free from smoking related litter at all material times to the satisfaction of the Licensing Authority.

- 23. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of residents and businesses and leave the area quietly.
- 24. The Premises shall install and maintain a comprehensive CCTV system which shall comply with minimum requirements agreed between the Licensee and the Metropolitan Police Service Licensing Officer.
- 25. The CCTV shall cover all entry and exist points (including the 'smoking area') enabling identification of every person entering the Premises at any time of day and irrespective of lighting conditions. The positioning of the CCTV cameras shall be agreed between the Licensee and a Metropolitan Police Service Licensing Officer prior to the opening of the Premises.
- 26. 16 The CCTV system shall continually record whilst the Premises are open for licensable activities and during all times when customers remain on the Premises. All recordings shall be stored for a minimum of 31 days with date and time stamping on the footage.
- 27. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times the premises are open to the public. This staff member must be able to provide a Police Officer or an authorised officer of the council with copies of recent CCTV images or data with the minimum of delay when reasonably requested.

Informative

- The applicant must apply for and be granted planning permission for the erection of any structures in the rear garden area and its use as ancillary to the proposed café/ restaurant. Planning permission is also required for the operation of a shisha lounge. The applicant has been advised of this and advised to contact the Planning Department. The applicant must not assume that the conditions above form an agreement or confirmation planning permission is not required. The applicant has been advised of this and advised to contact the Planning Department.
- 2. The applicant will be required to apply for planning permission if they intend to install kitchen extract equipment which terminates externally (either at 1st storey level or 1m above the roof ridge).
- 3. The applicant must confirm by provision of the lease plan the extent of the demise of the rear garden area so that we can confirm the status of this communal space and who has access.

Dear Sir/Madam,

We are the tenants above 95 West Green Road (we are the maisonette at 95A.) We have some serious concerns regarding their intentions with the business relating to their application for a late night music/alcohol license, as detailed below.

- Shisha:

On Wednesday 17th May, Tewodros (the tenant) spoke to my flatmate Tabitha and showed her inside the property, where he pointed out speakers in the ceilings and shisha pipes lined up. He was eager to exchange numbers so that we would contact him directly with any complaints. He mentioned that he was going to have "parties" and that there might be noise issues. He stated his aim to open a shisha bar. Two days later, our carbon monoxide alarm went off at approx 11pm, so my other flatmate Lulu called the emergency gas services. He identified the source as burning downstairs, which confirms both a) the hot, sweet smell and b) Lulu's research that burning shisha indoors raises carbon monoxide levels. Our carbon monoxide levels were four times above the level for evacuation, so the gas man was taken aback when he went downstairs and saw then burning coals inside, causing a smoky room and blatant fire hazard (picture attached.)

We have researched this and found opening a shisha bar on this premises is illegal - unless he knocks down 50% of the walls. The property's leaseholder and sub-landlord Peter Myers (copied into this email) swiftly informed us and him that that is a direct breach of his tenancy. Despite the business owners knowing that this is illegal, Lulu and I smelt the same strong smell yesterday evening. When I went to investigate, a man who looked intoxicated (not Tewodros) refused to let me in to see if anything was burning. Another man congregating outside said that "this was going to be a shisha place."

Clearly, the message hasn't got through that opening a shisha bar below us is both illegal and highly unsafe. I know that this isn't directly what they have applied for, but if you grant them a late night music and alcohol license (which is also against the terms of their tenancy, for reasons I will detail) then I strongly suspect that they will use their back room to smoke shisha. Lulu has severe asthma, so this business is illegally continuing to put her directly at risk.

Late night music/alcohol license:

Upon seeing their application stuck to the outside wall two weeks ago, we contacted Peter. He informed us that Tewodros' trading hours are between 8am and 10:30pm - all days of the week. Any trading outside of these hours is direct breach of his tenancy. He also reminded Tewodros of this, upon which he took his application down - only for it to be stuck back up earlier this week, which is why I am writing to you.

Their application for this license is a direct breach of their tenancy. If granted, we strongly suspect they will also use the premises for illegal and unsafe shisha smoking.

Please take this email and our safety into consideration. If there is anything else you need, please let me know.



I too have such concerns in the main regarding alcohol sales, music volume and closing down timing, and with staff overseeing it all, especially making sure customers are not hanging around outside, which goes on from the licensed premises opposite 95 West Green Road as it is.

Because I tend to believe that any staff may find it difficult talking to some members of the public/customers who do/will probably hang around outside, as in the past very sadly and perhaps even now Traffic enforcement officers have had to deal with abuse from those that do the hanging around when giving out parking tickets, fortunately there has been less illegal parking since Haringey kindly managed to get the double yellow lines put down we have less of the illegal parking but it still goes on mainly from around early to late evenings.

We do not agree to the requested timings as we feel that the licensing objective of, prevention of crime and disorder & Prevention of public nuisance, would be undermined by the nature of the late sale of alcohol and opening times for the following reasons.

The location of this venue situated on a side road (Anchor) the rear of the premises backs on to Brunswick Park car park. This is the likely location where punters to this premises is likely to park their cars when attending the premises. ASB is already present in the location in which complaints have been made by local residents. I am concerned that the terminal hours suggested would give a sufficient rise of complaints from residents within the locality.

There is also what appears to be retirement properties also behind the venue (next to car park) Anchor - Holly Court

200 Brunswick Rd, London N15 5DB

I am concerned that the terminal hours provided could cause disturbance to these properties. As the plan shows the rear outside seating of the venue only has a 50% covered roof, therefore I have concerns on how the venue is going to minimise the noise in the warmer months.

In relation to the licencing objective, **prevention of crime and disorder**, I am concerned that introducing another venue to the location could cause an increase in calls to the police. Due to the geographical area and other local licenced premises I am concerned with the Footfall and dispersal within these times and already intoxicated people attempting to enter the venue.

We therefore suggest the following timings that we feel would be more appropriate, this also gives a 30minute window of the sale of alcohol stopping, this will allow a wind down time for soft drinks and water sales to reduce risk of alcohol fueled crime / disorder both at venue and when clients disperse.

Furthermore, under the licensing objective of **prevention of crime and disorder**, I request the following to be added to the operating schedule.

A digital CCTV system to be installed in the premises.

- 1. Cameras must be sited to observe the entrance doors from both inside and outside.
- 2. Cameras on the entrances must capture full frame shots of the heads and shoulders of all people entering the premises i.e. capable of identification.
- 3. Cameras must be sited to cover all areas to which the public have access including any outside smoking areas.
- 4. Provide a linked record of the date, time of any image.
- 5. Provide good quality images colour during opening times.
- 6. Have a monitor to review images and recorded quality.
- 7. Be regularly maintained to ensure continuous quality of image capture and retention.
- 8. Member of staff trained in operating CCTV at venue during times open to the public.

Digital images must be kept for 31 days. The equipment must have a suitable export method,

e.g. CD/DVD writer so that Police can make an evidential copy of the data they require.

Copies must be available within a reasonable time to Police on request

No vertical drinking, drink ancillary to a table meal

Entry cut off point to be ONE(1) hour prior to closing time.

Booking system, no walk ins after the hours of 2200hours.

At least 4 prominent, clear and legible notices shall be displayed throughout the premises, including all toilets warning customers that drug use will not be tolerated.

Toilets at the premises shall be checked for any sign of drug use on average of every hour / two hours between 2100 hours and closing time. A record shall be kept of the times, dates and any issues discovered. These records shall be kept for six months. Records must be made available to an authorised officer of the Council or police upon request.

An incident log shall be kept at the premises, and made available on request to an authorised officer of the Council or the Police, which will record the following:

- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) any faults in the CCTV system
- (f) any visit by a relevant authority or emergency service

It is noted that no SIA security has been mentioned in the operating schedule I would request that the DPS and or manager of the premises carry out a dynamic risk assessment in order to determine whether any SIA security is required.

If agreed by the applicant we would **withdraw** our representations contingent upon that agreement.
