1. Describe the issue under consideration

- 1.1 This report relates to an application for a new premises licence by Mr Michael Lambrou.
- 1.2 The application seeks the following:

Sale of Alcohol

Monday to Sunday 1000 to 2300 hours

Supply of alcohol **ON** the premises.

Hours open to Public

Monday to Sunday 0900 to 2359 hours

- 1.3 The application can be found at Appendix A.
- 1.4 Representations have been received from:

Met Police- accepted- now withdrawn. App B
Licensing Authority RA – accepted - now withdrawn – App C.
Planning Authority – accepted – now withdrawn- App D
There are representations from residents and Cllr Arkell at App E.

The applicant has accepted all the representation submitted by the Responsible Authoritities.

1.5 Recommendation

In considering the representations received and what is appropriate for the promotion of the licensing objectives, the steps the Sub-Committee can take are:

- Grant the aspplication as requested
- Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
- Exclude any licensable activities to which the application relates
- Reject the whole or part of the application

Members of the licensing sub committee are asked to note that they may not modify the conditions or reject the whole or part of the application merely



becaus it considers it desirable to do so. It must be appropriate in order to promote the licensing objectives.

2 Background

2.1 The premises is situated in a terrace of shop units with residential above. The Planning Officers representation is important to the application as Mr Lambrous intent was to operate a social club for men only. The Planning representation and intervention from the officer has made clear that would be contrary to the planning permission and the premoses must operate as café that is open to all and does not have any membership requirements.

3 Licensing Policy

- 3.1 The committee will also wish to be aware of the guidance issued under section 182 of the Licensing Act 2003. Licensing is about regulating the provision of licensable activities on licensed premises, by qualifying clubs and at temporary events within the terms of the Licensing Act 2003. The terms and conditions attached to various permissions are focused on matters which are within the control of individual licensees and others granted relevant permissions. Accordingly, these matters will centre on the premises and places being used for licensable activities and the vicinity of those premises and places.
- 3.2 The objective of the licensing process is to allow for the carrying on of retail sales of alcohol and the prevention of public nuisance, prevention of crime and disorder, public safety and protection of children from harm. It is the Licensing Authority's wish to facilitate well run and managed premises with licence holders displaying sensitivity to the impact of the premises on local residents.
- 3.3 In considering licence applications, where relevant representations are made, this Licensing Authority will consider the adequacy of measures proposed to deal with the potential for public nuisance and/or public disorder having regard to all the circumstances of the case.
- 3.4 Where relevant representations are made, this authority will demand stricter conditions with regard to noise control in areas that have denser residential accommodation, but this will not limit opening hours without regard for the individual merits of any application. This authority will consider each application and work with the parties concerned to ensure that adequate noise control measures are in place. Any action taken to promote the licensing objectives will be appropriate and proportionate.
- 3.5 This Licensing Authority in determining what action to take will seek to establish the cause of concern and any action taken will be directed at these causes. Any action taken to promote the licensing objectives will be appropriate and proportionate.
- 3.6 Where relevant representations are made, this authority will demand stricter conditions with regard to noise control in areas that have denser residential accommodation, but this will not limit opening hours without regard for the individual merits of any application. This authority will consider each application and work with the parties concerned to ensure that adequate noise control measures are in place
- 3.7 Also The Licensing Authority may not impose conditions unless its discretion has been exercised following receipt of relevant representations and it is satisfied as a result of



the hearing that it is appropriate to impose conditions to promote one or more of the four licensing objectives. Therefore conditions may not be imposed for the purpose other than promoting the licensing objectives and in some cases no additional conditions will be required.

- 3.8 In cases Members should make their decisions on the civil burden of proof, that is the balance of probability.
- 3.9 Members should consider in all cases whether or not primary legislation is the appropriate method of regulation and should only consider licence conditions when the circumstances in their view are not already adequately covered elsewhere.
- 3.10 The Government has advised that conditions must be tailored to the individual type, location and characteristics of the premises and events concerned. Conditions cannot seek to manage the behaviour of customers once they are beyond the direct management of the licence holder and their staff.
 - The Councils Licensing policy generally expects applicants to address the licensing objectives and discuss how to do this with the relavant responsible authorities.

4 Licensing hours

- 4.2 Where relevant representations are made, the Council will consider the proposed hours on their individual merits. Notwithstanding this, the Council may require stricter conditions in areas that have denser residential accommodation to prevent public nuisance. The Council will endeavour to work with all parties concerned in such instances to ensure that adequate conditions are in place. The Council may restrict the hours that certain premises can offer alcohol for sale for consumption off the premises for preventing crime, disorder and nuisance.
- 5 Powers of a Licensing Authority
- 5.1 The decision should be made with regard to the Secretary of the State's guidance and the Council's Statement of Licensing Policy under the Licensing Act 2003. Where the decision departs from either the Guidance or the Policy clear and cogent reasons must be given. Members should be aware that if such a departure is made the risk of appeal / challenge is increased.
- 5.2 The licensing authority's determination of this application is subject to a 21 day appeal period or if the decision is appealed the date of the appeal is determined and /or disposed of.

6. Other considerations

Section 17 of the Crime and Disorder Act 1998 states:

"Without prejudice to any other obligation imposed on it, it shall be the duty of each authority to which this section applies to exercise its various functions with due regard to the likely effect of the exercise of those function on, and the need to do all that it reasonably can to prevent crime and disorder in its area".

6.1 Human Rights

While all Convention Rights must be considered, those which are of particular relevance to the application are:

- o Article 8 Right to respect for private and family life.
- o Article 1 of the First Protocol Protection of Property
- o Article 6(1) Right to a fair hearing.



o Article 10 – Freedom of Expression

The standard practices listed below will be maintained at all times. All reasonable steps will be taken to ensure that the premises will have a positive impact upon the local environment and its residents at all times.

b) The prevention of crime and disorder

CCTV shall be installed, operated and maintained in agreement with the Police. The system will enable a frontal head and shoulders image of every person entering the premises. 

I write on behalf of the Commissioner of the Metropolitan Police. I would like to make representations to the recently submitted application for a new premises licence for the premises of Traditional Cafe and Tea House (Greek), 78 Myddleton Road, Wood Green, London N22 8NQ

I wish to make representation on the following objective:

Prevention of public nuisance

The applicant is asking for the following licensable activities and timings:

Supply of alcohol **ON** the premises.

Hours open to Public

0900 to 2359 hours

We are uncomfortable with the requested timings given that the premises are embedded within a residential area with properties above the location, adjacent and both sides' therefore terminal times of 2300 hours weekdays and weekends would negatively impact the resident's guiet enjoyment of their homes which is their right.

We therefore propose the following Timings: which are in agreement with those submitted by the local authority

The times the Licence authorises the carrying out of licensable activities:

Sale of alcohol:
Monday to Sunday, 1000hrs to 2200hrs
Supply of alcohol ON the premises.
Hours open to the public: Monday to Sunday-0900hrs to 2230hrs

In addition we are of the opinion that the submitted operating schedule in regards to the measures that will be taken to uphold the four licensing objectives are sparse in content and generic and lack specificity and we would request the following be added to the operating schedule to be included on the final licence.

Proposed conditions:

- 1. All staff involved in the sale of alcohol shall receive induction and refresher training relating to the sale of alcohol and the times and conditions of the premises licence.
- 2. All training relating to the sale of alcohol and the times and conditions of the premises licence shall be documented and records kept at the premises. These records shall be made available to the Police and/or Local Authority upon request and shall be kept for at least one year.
- 3. A 'Think 25' proof of age scheme shall be operated and relevant material shall be displayed prominently within the Premises including in a visible location:
 - (a) At the entrance to the Premises;
 - (b) Behind the bar;
 - (c) In any other area where alcohol can be purchased by a customer.
- 4. A written record of refused sales shall be kept on the premises and completed

When necessary. This record shall be made available to Police and/or the Local Authority upon request and shall be kept for at least one year from the date of the last entry.

- 5 . No alcoholic drinks or glass containers shall be taken out onto the public highway.
- 6. The premises licence holder shall ensure that the area immediately outside the premises is kept clean and free from smoking related litter at all material times to the satisfaction of the Licensing Authority.
- 7. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and businesses and leave the area quietly.
- 8. Patrons permitted to temporarily leave and then re-enter the premises, e.g. to smoke, shall not be permitted to take drinks or glass containers with them.
- 9. A digital CCTV system to be installed in the premises.
- A. Cameras must be sited to observe the entrance doors from both inside and outside.
- B. Cameras on the entrances must capture full frame shots of the heads and shoulders of all people entering the premises i.e. capable of identification.
- C .Cameras must be sited to cover all areas to which the public have access including any outside smoking areas.
- D .Provide a linked record of the date, time of any image.
- E. good quality images colour during opening times.
- F. Have a monitor to review images and recorded quality.
- G. Be regularly maintained to ensure continuous quality of image capture and retention.
- H. Member of staff trained in operating CCTV at venue during times open to the public.
- I .Digital images must be kept for 31 days. The equipment must have a suitable export method, e.g. CD/DVD writer so that Police can make an evidential copy of the data they require. Copies must be available within a reasonable time to Police on request
- 10. An incident logbook shall be kept at the Premises and made available on request to a police officer or authorised officer of the Licensing Authority. The logbook shall record the following: (a) all crimes reported to the venue;
 - (b) All ejections of patrons;
 - (c) Any complaints received;
 - (d) Any incidents of disorder at or associated with the premises.
 - (e) All seizures of drugs and offensive weapons;
 - (f) Any faults in the CCTV system

If the above listed proposal and conditions were accepted in full by the applicant, I would withdraw my representation.

LICENSING ACT 2003 – Application for a New Premises Licence – 78 MYDDLETON ROAD LONDON N22.

The Licensing Authority are making representation on this application as the premises has come to the attention of the Authority for operating as a social club for men only and providing illegal gaming machines and gambling.

We also note that the premises does not have Planning permission to be used as a social club and note that these matters have been made clear to the operator.

The hours being sought are considered very late for the premises which has residential property directly above it and also that back onto it. The prevention of public nuisance has not been properly thought through with the late hours being requested.

The Licensing Authority consider that a reduction in hours is required in order to address the need to prevent public nuisance.

It is also unclear if there is a rear garden at this location but in any event it is not included in the plans submitted.

The Licensing Authority wish to propose the following conditions and amendments:

Traditional Cafe and Tea House

78 Myddleton Road, Wood Green, London N22 8NQ

Sale of alcohol: Monday to Sunday, 10am to 2200pm

Supply of alcohol ON the premises.

Hours open to the public: Monday to Sunday, 9am to 2230pm

The premises cannot be operated a s social club for mem only.

The premises shall open to the general public at the hours shown above.

Alcohol shall only be sold ancillary to patrons consuming a meal and seated at tables.

No gambling will be permitted onsite.

No gaming machines permitted onsite.

The windows of the premises will be clear to enable a view from the street into the premises.

- 1. All staff involved in the sale of alcohol shall receive induction and refresher training (at least every three months) relating to the sale of alcohol and the times and conditions of the premises licence.
- All training relating to the sale of alcohol and the times and conditions of the premises licence shall be documented and records kept at the premises. These records shall be made available to the Police and/or Local Authority upon request and shall be kept for at least one year.
- 3. A 'Think 25' proof of age scheme shall be operated and relevant material shall be displayed prominently within the Premises including in a visible location.
- 4 A written record of refused sales shall be kept on the premises and completed when necessary. This record shall be made available to Police and/or the Local Authority upon

request and shall be kept for at least one year from the date of the last entry.

- 5 alcoholic drinks or glass containers shall be taken out onto the public highway.
- The premises licence holder shall ensure that the area immediately outside the premises is kept clean and free from smoking related litter at all material times to the satisfaction of the Licensing Authority.
- 8 Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and businesses and leave the area quietly.
- 9 The Premises shall install and maintain a comprehensive CCTV system which shall comply with minimum requirements agreed between the Licensee and the Metropolitan Police Service Licensing Officer.
- 10 The CCTV shall cover all entry and exist points (including the 'smoking area') enabling identification of every person entering the Premises at any time of day and irrespective of lighting conditions. The positioning of the CCTV cameras shall be agreed between the Licensee and a Metropolitan Police Service Licensing Officer prior to the opening of the Premises.
- 11 The CCTV system shall continually record whilst the Premises are open for licensable activities and during all times when customers remain on the Premises. All recordings shall be stored for a minimum of 31 days with date and time stamping on the footage.
- 12 A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times the premises are open to the public. This staff member must be able to provide a Police Officer or an authorised officer of the Licensing Authority with copies of recent CCTV images or data with the minimum of delay when reasonably requested.

We are unclear at this time if there is a rear garden area. Please provide clarification on this matter.

The licensing process is NOT an alternative to Planning and does not override Planning law.

Dear Licensing Dept,

I write as a local resident, someone who regularly uses Myddleton Road and who has known it for over two decades.

The application calls this a "Traditional café and tea house". I dare to suggest that this is not actually what is intended, but that it will be another men's drinking establishment. There are other cafes on the street where men (as well as women) can go.

Any new licence must "not be detrimental to the viability of Myddleton Road as a local shopping centre." There are already two Men's Drinking Clubs on the shopping part of the road, and a number of other establishments where men gather outside and make it difficult and often worrying for women to walk along the pavement. A third exclusively male drinking establishment is indeed detrimental to the road as a local general shopping centre. We are lucky that a few new shops have recently opened, and this must be encouraged.

It can also be argued that groups of men who have been drinking, either gathered outside or coming out in groups can also be a public nuisance and even lead to crime and disorder.. Some of the women who work on the road are indeed worried by these groups. It is also not at all ideal for it to be next door to a nursery school and staff are already worried.

I strongly object to this application and hope that Haringey supports the viability of this local shopping centre that the community – and the Council – has spent many years and much money improving.

We Love Myddleton Road would like to strongly object to the alcohol licence application for "Traditional Cafe and Tea House (Greek)" at 78 Myddleton Road, Wood Green, London N22 8NQ on the grounds of:

- the prevention of crime and disorder
- the prevention of public nuisance
- public safety

The proposal for another licensed members only club on Myddleton Road would add to the two existing members only clubs - Bar Nicosia and New Salamis on the street and the recently closed clubs at 94 and 75 Myddleton Road. The presence of these de facto male clubs has created an intimating atmosphere for women on the street, so much so that this was one of the main reasons that Women's' Safety was selected as the number one priority for the next few months for the Bounds Green Ward at the recent Bounds Green Safer Neighbourhood Team Ward Panel Open Meeting on Monday 22 January.

In addition, the opening of the club at No.78 has coincided with the neighbouring premises at No. 80 covering the majority of its frontage with opaque film, reportedly because of concerns about the clientele from No.78.

We also have concerns about the record of the owner of No.78 "pushing the envelope" repeatedly with regards to the use of these premises and whether this would be repeated should they obtain an alcohol license. The most recent planning application to Haringey for No.78 (HGY/2023/1772) was for a single one bedroom flat with additional office accommodation, plus the retail unit to be used as a public cafe. In fact, the public cafe has been acting as a private members club since that time despite assurances to the Haringey Planning Department that it was actually a public cafe. This alcohol license application seems to confirm that the applicant is at the very least looking to use it as a private club in the future if they are not doing so at the present.

Closer examination of HGY/2023/1772 would we believe reveal to a more sceptical viewer that what are labelled as a one bedroom flat and office accommodation may well be used as a two bedroom flat and a further single bedroom flat. When the front of the premises was not curtained off domestic appliances could indeed be seen in the "office accommodation".

Finally, there is unease in the local community about objecting to this application because the details of objectors are made publicly available. We believe that this demonstrates deep-seated concerns about the premises and should be grounds for concern in and of itself.

We believe that there is sufficient evidence available to demonstrate that the granting of an alcohol license to these premises could increase public nuisance and crime & disorder and endanger public safety so the license should be refused.

1. Describe the issue under consideration

- 1.1 This report relates to an application for a new premises licence by Mr Michael Lambrou.
- 1.2 The application seeks the following:

Regulated Entertainment: Recorded Music

Friday 1000 to 0100 hours

Late Night Refreshment

Friday 1000 to 0100 hours

Sale of Alcohol

Friday 1000 to 0100 hours

Supply of alcohol **ON** the premises.

Hours open to Public

Friday 1000 to 0130 hours

- 1.3 The application can be found at Appendix A.
- 1.4 Representations have been received from:

Noise Team RA – accepted - now withdrawn – App B. There are representations from residents in support of the variation. – App C Representations against the variation – App D.

1.5 Recommendation

In considering the representations received and what is appropriate for the promotion of the licensing objectives, the steps the Sub-Committee can take are:

- Grant the aspplication as requested
- Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
- Exclude any licensable activities to which the application relates
- Reject the whole or part of the application



Members of the licensing sub committee are asked to note that they may not modify the conditions or reject the whole or part of the application merely becaus it considers it desirable to do so. It must be appropriate in order to promote the licensing objectives.

2 Background

- 2.1 The premises is situated in the Scotland Green cul-de-sac. There are residential properties surrounding the premises. There is another pub a few metres away called the Two Brewers but this pub only operates on Spurs home match days. The area also has another pub called The Bluecoats that is a late night venue.
- 2.2 The Planning Officer has advised that the current planning permission are as follows and that any increase in those hours will require an application to Planning for a change in the conditions:

'See condition 3 attached to HGY/1991/0554 in regards to sound from the site:

No music, live concerts or other amplified sound shall emanate from the site which, in the opinion of the Environmental Health Service acting on behalf of the Local Planning Authority, cause nuisance to any adjacent occupier after 2300 on any day. Reason To ensure the proposed development does not impinge on the amenities of adjacent occupiers.

Any proposal to play music, live concerts or amplified sound after 2300 on any day requires planning permission as per the above"

2.3 The LSC is remided that it is the variation being sougt that is under consideration.

3 Licensing Policy

- 3.1 The committee will also wish to be aware of the guidance issued under section 182 of the Licensing Act 2003. Licensing is about regulating the provision of licensable activities on licensed premises, by qualifying clubs and at temporary events within the terms of the Licensing Act 2003. The terms and conditions attached to various permissions are focused on matters which are within the control of individual licensees and others granted relevant permissions. Accordingly, these matters will centre on the premises and places being used for licensable activities and the vicinity of those premises and places.
- 3.2 The objective of the licensing process is to allow for the carrying on of retail sales of alcohol and the prevention of public nuisance, prevention of crime and disorder, public safety and protection of children from harm. It is the Licensing Authority's wish to facilitate well run and managed premises with licence holders displaying sensitivity to the impact of the premises on local residents.
- 3.3 Cumulative impact has been used as a term to describe the stree that a number of licensed premises can have on crime and disorder, nuisance and the impact on nearby residents. It is often not that licensed premises on their own are operating in a way that is detrimental to the licensing objectives, but it is the accumulation of the premises and the people attending them creates the increased problems and demands on services. Cumulative impact can occur either in the area where the premises are located or some distance away from them. The issue of cumulative impact occurs due the the number of



people in the area frequenting the licensed premises.

- 3.4 In considering licence applications, where relevant representations are made, this Licensing Authority will consider the adequacy of measures proposed to deal with the potential for public nuisance and/or public disorder having regard to all the circumstances of the case.
- 3.5 Where relevant representations are made, this authority will demand stricter conditions with regard to noise control in areas that have denser residential accommodation, but this will not limit opening hours without regard for the individual merits of any application. This authority will consider each application and work with the parties concerned to ensure that adequate noise control measures are in place. Any action taken to promote the licensing objectives will be appropriate and proportionate.
- 3.6 This Licensing Authority in determining what action to take will seek to establish the cause of concern and any action taken will be directed at these causes. Any action taken to promote the licensing objectives will be appropriate and proportionate.
- 3.7 Where relevant representations are made, this authority will demand stricter conditions with regard to noise control in areas that have denser residential accommodation, but this will not limit opening hours without regard for the individual merits of any application. This authority will consider each application and work with the parties concerned to ensure that adequate noise control measures are in place
- 3.8 Also The Licensing Authority may not impose conditions unless its discretion has been exercised following receipt of relevant representations and it is satisfied as a result of the hearing that it is appropriate to impose conditions to promote one or more of the four licensing objectives. Therefore conditions may not be imposed for the purpose other than promoting the licensing objectives and in some cases no additional conditions will be required.
- 3.9 In cases Members should make their decisions on the civil burden of proof, that is the balance of probability.
- 3.10 Members should consider in all cases whether or not primary legislation is the appropriate method of regulation and should only consider licence conditions when the circumstances in their view are not already adequately covered elsewhere.
- 3.11The Government has advised that conditions must be tailored to the individual type, location and characteristics of the premises and events concerned. Conditions cannot seek to manage the behaviour of customers once they are beyond the direct management of the licence holder and their staff.
 The Councils Licensing policy generally expects applicants to address the licensing objectives and discuss how to do this with the relavant responsible authorities.

4 Licensing hours

4.2 Where relevant representations are made, the Council will consider the proposed hours on their individual merits. Notwithstanding this, the Council may require stricter conditions in areas that have denser residential accommodation to prevent public nuisance. The Council will endeavour to work with all parties concerned in such instances to ensure that adequate conditions are in place. The Council may restrict the hours that certain premises can offer alcohol for



sale for consumption off the premises for preventing crime, disorder and nuisance.

- 5 Powers of a Licensing Authority
- 5.1 The decision should be made with regard to the Secretary of the State's guidance and the Council's Statement of Licensing Policy under the Licensing Act 2003. Where the decision departs from either the Guidance or the Policy clear and cogent reasons must be given. Members should be aware that if such a departure is made the risk of appeal / challenge is increased.
- 5.2 The licensing authority's determination of this application is subject to a 21 day appeal period or if the decision is appealed the date of the appeal is determined and /or disposed of.

6. Other considerations

Section 17 of the Crime and Disorder Act 1998 states:

"Without prejudice to any other obligation imposed on it, it shall be the duty of each authority to which this section applies to exercise its various functions with due regard to the likely effect of the exercise of those function on, and the need to do all that it reasonably can to prevent crime and disorder in its area".

6.1 Human Rights

While all Convention Rights must be considered, those which are of particular relevance to the application are:

- Article 8 Right to respect for private and family life.
- Article 1 of the First Protocol Protection of Property
- o Article 6(1) Right to a fair hearing.
- Article 10 Freedom of Expression

 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.

- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise antisocial behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 4. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 5. (1) The premises licence holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 6. The responsible person must ensure that—
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
- (i) beer or cider: ½ pint;
- (ii)gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii)still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

7. Prohibition on Sale of Alcohol below Cost of Duty plus VAT

- (4) (a) Sub-paragraph (b) below applies where the permitted price given by Paragraph (b) of paragraph (2) on a day (—the first dayll) would be different from the permitted price on the next day (—the second dayll) as a result of a change to the rate of duty or value added tax.
- (b) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Exhibition of films.

- 1. Admission of children to the exhibition of any film is to be restricted in accordance with the recommendations made by the specified film classification body.
- 2. Where -
- (a) the film classification body is not specified in the licence, or
- (b) the relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question,

admission of children must be restricted in accordance with any recommendation made by that licensing authority.

Annex 1 – Mandatory Conditions

3. In this section -

—children means persons aged under 18; and —film classification body means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

Door supervision.

1. Any person(s) required to be on the premises to carry out a security activity must be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001 or be entitled to carry out that activity by virtue of Section 4 of that Act.

Annex 2 - Conditions consistent with the Operating Schedule

THE PREVENTION OF CRIME AND DISORDER

A minimum of three members of staff will be present between 2100 and the closing of the premises on Saturdays, St Patrick's Day and Christmas Eve.

Anti-drugs signs will be displayed on the premises.

The designated premises supervisor will be a member of Pubwatch and a 'ring round' system will be in operation.

On Tottenham Hotspur Match Days:

- 1. Premises not to open for the sale of alcohol before 1100 on Saturday and Sunday.
- 2. All drinks dispensed from the bar are poured into plastic containers—4 hours before the scheduled kick off time until 1 hour after the end of the match.
- 3. No glass bottles are sold over the bar—4 hours before the scheduled kick ff time until 1 hour after the end of the match.
- 4. A minimum of one Door Staff who has been approved by the Security Industry Authority to be employed on the premises to control the entry and exit of customers—4 hours before the scheduled kick off time until 2 hours after the end of the match.

PUBLIC SAFETY

Fire safety equipment will be checked regularly and any requirements made by the Fire Safety Officer will be complied with.

THE PREVENTION OF PUBLIC NUISANCE

Signs will be displayed at the exit reminding customers to leave quietly and respect the neighbours.

Staff will call Taxis/Mini cabs to the premises for the use of customers leaving the premises when requested to do so.

THE PROTECTION OF CHILDREN

All staff will be trained that alcohol will only be sold to persons who can produce photographic identification where there is any doubt that they are over the age of 18.

Persons under the age of 18 will not be permitted to use Gaming machines.

Alcohol may only be sold to individuals over the age of 18 with valid proof of identification with one of the following:

- A valid passport
- A photo driving license issued in a European Union Country
- A proof of age standard card system
- · A citizen card, supported by the Home Office

If any licensed doorman or member of staff of the premises has any doubt as to the age of any potential patron, then that person will be refused entry.

Having reviewed the application, I don't foresee any issues with the variation application for the extension of hours on a Friday but we have had previous complaints regarding loud music and people noise from patrons from the premises, whilst these have not been sustained and given that the premises is situated in a heavily residential area, I recommend the following conditions be added to the licence to cover the four licensing objectives which have been agreed by the applicant. (see attached email)

Prevention of crime & disorder

- A digital CCTV system to be installed in the premises and cameras must be sited to observe the entrance doors from both inside and outside.
- Cameras on the entrances must capture full frame shots of the heads and shoulders of all people entering the premises i.e. capable of identification.
- Cameras must be sited to cover all areas to which the public have access including any outside smoking areas.
- Provide a linked record of the date, time of any image.
- good quality images colour during opening times.
- Have a monitor to review images and recorded quality.
- Be regularly maintained to ensure continuous quality of image capture and retention.
- Member of staff trained in operating CCTV at venue during times open to the public.
- Digital images must be kept for 31 days. The equipment must have a suitable export method, e.g. CD/DVD writer so that Police can make an evidential copy of the data they require. Copies must be available within a reasonable time to Police on request
- An incident logbook shall be kept at the Premises and made available on request to a
 police officer or authorised officer of the Licensing Authority. The logbook shall record
 the following and should be completed within 24 hours of the incident:
- (a) all crimes reported to the IN
- (b) All ejections of patrons;
- (c) Any complaints received;
- (d) Any incidents of disorder at or associated with the premises.
- (e) All seizures of drugs and offensive weapons;
- (f) Any faults in the CCTV system.
- (g) Any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

Prevention of public nuisance

 Amplified music and bass shall not be played at a level that will cause unreasonable disturbance to the occupants of any properties in the vicinity.

- No music will be played in, or for the benefit of patrons in any external areas of the premises, including the rear garden.
- The use of the rear garden area shall terminate at 2230 hrs on days when regulated entertainment is being provided.
- All windows and external doors shall be kept closed after 22:30 hours, or at any time when regulated entertainment takes place, except for the immediate access and egress of persons.
- Regulated entertainment shall cease at 00:30 on Fridays.

The Protection of Children from harm

- A 'Think 25' proof of age scheme shall be operated and relevant material shall be displayed prominently within the Premises including in a visible location: (a) At the entrance to the Premises; (b) Behind the bar; (c) In any other area where alcohol can be purchased by a customer.
- A written record of refused sales shall be kept on the premises and completed when necessary. This record shall be made available to Police and/or the Local Authority upon request and shall be kept for at least one year from the date of the last entry.

I was recently made aware that the Victoria pub has applied for an extended license to be able to play music and serve alcohol until 1am Friday night/Saturday morning.

As a resident of the flats opposite the Victoria pub on Scotland Green, I would like to register my objection to this extension on the grounds of the anticipated disruption/nuisance that it would cause to local residents.

The close proximity of the premises means that any later opening/serving of alcohol presents an immediate threat to the way of life of the residents of nearby properties on Scotland Green, which house a number of families with young children. In addition to noise concerns, we have a very real and present issue with intoxicated persons regularly choosing to use the entrance ways to the flats as a place they can urinate due to it being out of sight from the high road.

This undesirable behaviour is vastly increased during match and event days at the Tottenham stadium, for which we have raised multiple complaints to local councillors. With Scotland Green serving as a regular route for event goers walking to Tottenham Hale station, and the increase now in matches and events that take place on a Friday evening, a later opening of the pub would undoubtedly attract and result in an increased level of this undesirable behaviour.#

Please note this is not attributing all the current issues to the Victoria. Rather, this is a general issue in the area, but one that would only be exacerbated by extended opening times.

On a related note, please can you advise as to the current licensing arrangements for the Bluecoats pub (614 High Rd, London N17 9TA)? I have been incredibly surprised to see them serving beer and cocktails recently in open containers to passers by on the high road before and after matches/events. Aside from the increased noise, littering, and other undesirable public behaviour, last weekend the crowd of people stood outside the pub drinking and waiting to be served was circa 30-40 people, completely blocking the pedestrian route on that side of the street and forcing passers-by to walk in the high road which is highly unsafe.
