1. Describe the issue under consideration.

The Council's current cycle training contract is due to expire on 6th February 2024. However, due to increased demand and associated costs for cycle training, the cost of which is covered by increased funding from TfL ring fenced for this service, the current provider (Cycle Confident) has exhausted its expected funding envelope.

The original contract threshold was set at £0.450m (2018-2021) however to address funding and deliverability this contract was extended in the COVID period by an extra £0.160m and 3 years ending in February 2024. This funding was expected to cover until the end of the contract extension. However, the budget limit has now been reached. Therefore, to cover this new spend and deliver the works within the contract period. The Council needs to increase the approved budget for Cycle Confident by £0.065m to cover this service provision until the end of February 2024.

This report seeks approval for the variation to the Cycle Training Contract to Cycle Confident Limited (the current provider) to increase the contract value by £0.065m to cover the rest of the contract fulfilment.

3. Recommendations

For the Cabinet Member for Cllr Hakata to approve the modification of the contract by additional funds of $\mathfrak{L}0.065m$ to cover the remaining costs of the Cycle Confident Contract. Making the contract total $\mathfrak{L}0.675m$ with no additional time.

4. Reasons for decision

This additional funding is required to pay the contractor (Cycle Confident) for the works they plan to, and have delivered with the community, up until the end of their contract.

5. Alternative options considered

To not pay them

Cycle Confident have delivered the training to our community in advance of payments to ensure that cycle training has been delivered to our schools, and community groups. Transport for London (TfL) has ring fenced funding for cycle training within the Local Implementation Plan (LIP) and the Council has received this funding. Therefore, not paying for works undertaken or immediately planned has been rejected.

6. Background information

In March 2018, Cycle Confident Limited was chosen from a shortlist of 5 companies to provide cycle training for those who live, work and study in Haringey. The contract was initially for three years (2018-2021) and was valued at £0.450m. This funding was allocated from the LIP and covered school cycle training, one to one cycle training and Dr Bike maintenance sessions.

Over the length of this contract, funding has varied for cycle training alongside demand. And specifically, the Council had to manage the impact of COVID on this service and the inability for the Council to go to the market during this time. As such a contract extension was put in place to give suppliers and users confidence. This was for an increased value of $\mathfrak{L}0.160$ m and covered the period 2021 to February 2024. However, in the last two years there has been a significant uptake in demand and funding from TfL. As such the expected contract value of $\mathfrak{L}0.610$ m (of both the original award and extension) was reached earlier than was planned.

Cycle Confident though have continued to liaise, book, and deliver cycling services directly with the schools and community. This has meant that they have delivered some work outside of funding agreements. This award will cover the costs of this work and future works before the end of the contract.

7. Contribution to the Corporate Delivery Plan 2022-2024 High level Strategic outcomes'?

The Cycle Training Contract falls within the Corporate Delivery Plan under the theme of "Responding to the Climate Emergency" and specifically the action of "Improved access to alternative means of transport to private motor vehicle" which includes metrics/measurables "Number of cycle training sessions delivered" and an outcome of "Community focused cycle training provision".

8. Carbon and Climate Change

The current cycling contract delivers education and advice to our community on cycling safety and confidence. Active Travel is a key requirement if we are to deliver the borough climate goals.

Increasing cycling means less air pollution including carbon is put out to our atmosphere with the hope it replaces private vehicles as the number one mode of transport. Cycling helps increase our physical health and wellbeing and reduce road congestion encouraging more outside use and less time sitting in traffic polluting our communities.

9. Statutory Officers comments (Director of Finance (procurement), Head of Legal and Governance, Equalities)

Finance

This report is for the Cabinet Member for Cllr Hakata to approve the recommendations as set out in para 3 of this report. The additional contract extensions costs £0.065m are fully funded from LIP grant funding from TFL and therefore will have no financial implications for the Council.

Our current Cycling Training contract has softer measures designed to get more people, including children cycling, and make Haringey a more cycling friendly borough.

In addition to this, the worst air quality tends to be in the east of the borough, which has a younger and more diverse community. By increasing cycling, this will be promoting equality of opportunity by reducing health inequalities on these groups.
