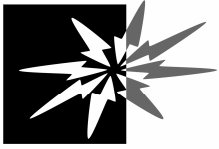

1. Purpose To approve fees and charges for the 2008/2009 for Bereavement Services	
2. Introduction by Cabinet Member 2.1 The proposed charges set out in this report are in line with decisions made during the 2008/9 – 2010/11 Budget Setting process, particularly in relation to achieving efficiency gains in this service area.

4. Chief Financial Officer Comments 4.1 The proposed cremation price increase will address the Pre-business Review efficiency savings of £115k related to cremation income.	

5. Head of Legal Services Comments

5.1 The Head of Legal Services has been consulted and comments that there is discretion to charge for the services listed. The discretion must be exercised reasonably, and in the case of bereavement services the authority may charge such fees as it thinks proper. Accordingly no legal issues arise in relation to the proposed charges.

7. Strategic Implications

- 7.1 Council's charging policy for commercial services states that prices for such services should aim to recover costs fully and price setting be guided by the market. Cremation is a commercial service and accordingly, the proposed cremation prices are comparable with the market (see comparison in appendix 1) and will result in a surplus.
- 7.2 Burial prices are raised to ensure that business demands stay at current levels without unduly increasing the uptake of burials and thus draining the limited burial capacity .

8. Financial Implications

- 8.1 The 2008/9 forecast/budgeted cremation income is £1,081k including the PBPR efficiency savings of £115k.
- 8.2 The proposed price increase of cremation to £495 (12.5% increase over 2007/8 prices £440) and the number of cremations at 2,200 (in line with current demand) will deliver this income target.
- 8.3 Prices of burials will be increased by 6% and will deliver the 2008/9 burial income target of £583k.
- 8.4 Cremation prices will now be close to the top end of the local market (being the 3rd highest) and thus the ability to increase prices further to fund future expenditure in compliance with mercury emission will be substantially reduced.
- 8.5 Other avenues including commercial disposal of property within the Enfield site would need to be pursued to fund such expenditure.

9. Legal Implications

10. Equalities Implications

10.1 The fees and charges apply to all users who use the services and are structured to provide equal access by all citizens and reflect the full diversity of the community. Discount burial prices apply to parishioners.

10.2 We are committed to eliminating discrimination on grounds of age; disability; colour, ethnic origin, national origin or race; gender; HIV status; marital status; religious belief; responsibility for dependants; sexuality, and unrelated criminal conviction. We offer Muslim burials at Wood Green cemetery.

11. Consultation

11.1 Not applicable.

12. Background

12.1 As in previous years, the Council review cremation and burial prices in comparison with neighbouring boroughs and update prices in order to optimise income whilst meeting current demands and remaining competitive.

12.2 Cremation price increases will also deliver the approved 2008/9 PBPR efficiency saving targets of £115k on cremations.

12.3 The council capacity in burials is limited and it is important that the current demand is maintained without causing accelerated uptake of burial spaces.

13. Conclusion

13.1 The proposed increase in bereavement prices are comparable with the neighbouring operators and deliver the income budget without increasing accelerated reduction of burial capacity or undue demands on its capital resources.
