LICENSING SUB-COMMITTEE HEARINGS PROCEDURE SUMMARY INTRODUCTION The Chair introduces himself and invites other Members, Council officers, Police, Applicant and Objectors to do the same. 2. The Chair invites Members to disclose any prior contacts (before the hearing) with the parties or representations received by them The Chair explains the procedure to be followed by reference to this summary which will 3. be distributed. **NON-ATTENDANCE BY PARTY OR PARTIES** 4. If one or both of the parties fails to attend, the Chair decides whether to: grant an adjournment to another date, or (ii) proceed in the absence of the non-attending party. Normally, an absent party will be given one further chance to attend. **TOPIC HEADINGS** 5. The Chair suggests the "topic headings" for the hearing. In the case of the majority of applications for variation of hours, or other terms and conditions, the main topic is: Whether the extensions of hours etc. applied for would conflict with the four licensing objectives i.e. (i) the prevention of crime and disorder, (ii) public safety, (iii) the prevention of public nuisance, and the protection of children from harm. (iv) 6. The Chair invites comments from the parties on the suggested topic headings and decides whether to confirm or vary them. WITNESSES 7. The Chair asks whether there are any requests by a party to call a witness and decides any such request. 8. Only if a witness is to be called, the Chair then asks if there is a request by an opposing party to "cross-examine" the witness. The Chair then decides any such request. **DOCUMENTARY EVIDENCE** The Chair asks whether there are any requests by any party to introduce late documentary evidence. 10. If so, the Chair will ask the other party if they object to the admission of the late documents. 11. If the other party do object to the admission of documents which have only been produced by the first party at the hearing, then the documents shall not be admitted.

NB. Members should note that this application was a straight conversion from the 1964 Act so it had no separate conditions under the 4 Licensing objectives to carry over save the statutory conditions under the 1964 Act, these were:

Not to sell alcohol to a policeman on duty in uniform

Not to sell alcohol to anyone under 18

Not to sell to anyone who is drunk

Not to sell to a known prostitute



I would like to confirm that I have considered the above proposal with regard to the prevention of public nuisance on behalf of the Enforcement Response (Noise) Team & would like to:

Make representations to the Variation on the following grounds:

The operating schedule does not address the prevention of public nuisance from:

- airborne entertainment noise
- Structure borne noise or vibrations from entertainment
- Noise generated by patrons in external areas of the premises e.g. beer garden
- Noise generated from patrons queuing to enter
- Noise from patrons exiting the premises

<u>Informative</u>

I would recommend the following alterations/conditions to the operating schedule:

Operating hours

[That the premises closes no later than 01:30 hrs.

[That regulated entertainment ceases at 01:00 hrs.

International Events

[The premises shall have no more than 12 extensions per premises per year (excluding applications made under TENS).

- 1. An operating plan covering public nuisance should be completed prior to the event.
- 2. A minimum of 7 days notice shall be given to the licensing authority.

The licensing authority may prohibit the extension if there is reason to believe that one of the four licensing objectives has not been adequately considered.

Prevention of nuisance from noise/vibration Airborne

All doors and windows will remain closed during the licensed activities. Where a door is used for patrons to enter or leave the premises the door will be fitted with a self-closing device and staff told to ensure that it is not propped open. If necessary a member of staff shall be positioned at the door to ensure it is opened for as brief a period as possible.

The licensable activity shall conclude 30 minutes before the premises is due to close to prevent excessive noise breakout as the premises empties.

Entrance/exit from the premises whilst licensable activities are ongoing shall be via a lobbied door to minimise noise breakout. Where necessary adequate and suitable mechanical ventilation should be provided to public areas.

Structure borne

All speakers are mounted on anti-vibration mountings to prevent vibration transmission of sound energy to adjoining properties.

Sound limits

The licensee shall ensure that no music played in the licensed premises is audible at or within the site boundary of any residential property.

All entertainments will utilise the in-house amplification system, the maximum output of which is controlled by the duty manager.

Outside Areas

No music will be played in, or for the benefit of patrons in the external areas of the premises.

No form of loudspeaker or sound amplification equipment is to be sited on or near the exterior premises or in or near any foyer, doorway, window or opening to the premises.

Signs shall be displayed on the frontage instructing patrons to recognise the residential nature of the area and conduct their behaviour accordingly – The management reserve the right to ask patrons to move inside the premises or leave if it is felt that they could be disturbing neighbours.

The number of persons permitted to utilise the external areas will be restricted to six persons.

The external area will be closed and patrons requested to come inside the main structure of the premises at 00:30hrs.

Deliveries and collections.

Deliveries and collections associated with the premises will be arranged between the hours of 22:00hrs and 08:00hrs so as to minimise the disturbance caused to the neighbours.

Empty bottles and non-degradable refuse will remain in the premises at the end of trading hours and taken out to the refuse point at the start of the working day rather than at the end of trading when neighbours might be unduly disturbed.

Plant and machinery

All plant and machinery is correctly maintained and regularly serviced to ensure that it is operating efficiently and with minimal disturbance to neighbours arising from noise.

Dealing with complaints

A complaints book will be held on the premises to record details of any complaints received from neighbours. The information is to include where disclosed, the complainants name, location, date time and subsequent remedial action undertaken. This record must be made available at all times for inspection by council officers.

Patrons entering/exiting premises.

Where people queue to enter the premises a licensed door supervisor shall supervise and ensure the potential patrons behave in an acceptable manor.

When the premises turn out a licensed door supervisor shall supervise patrons and ensure the leave in a prompt and courteous manor, respecting the neighbours.

Signs should be displayed instructing patrons to respect the neighbours and behave in a courteous manor.

A licensed door supervisor will be positioned on the exit door to ensure, as far as reasonably practical, that patrons do not leave with drinks.

A person directed by the licensee or designated premises supervisor will patrol the curtilage of the premises to prevent patrons urinating in public areas in the vicinity of the premises.

Prevention of nuisance from light

Illuminated external signage shall be switched off when the premises is closed.

Security lights will be positioned to minimise light intrusion to nearby residential premises.

As I understand it, Punch Taverns Plc., have applied to vary the premises licence under the Licensing Act 2003 for the above named premises.

I wish to register my concerns as a resident at 83 Burgoyne Road, 8 houses away from the Old Ale Emporium.

Under Haringey Council's Statement of Licensing Policy, January 2008, the third licensing objective is to prevent a public nuisance. My concern is that if the application is granted without amendment, it will be in contravention of the third licensing objective on the grounds of noise and anti social behaviour.

I consider that if the Old Ale Emporium is permitted to sell alcohol after 11.30pm from Sunday to Thursday it will increase the likelihood of noise and anti social behaviour in the bottom half of Burgoyne Road and lead to loss of sleep for anybody sleeping in a room facing on to the street in my house, at that time of night. Ambient noise is generally less at this time and therefore any increase from customers walking home or driving away could result in their sleep being disrupted unreasonably if the sale of alcohol is permitted beyond 11.30pm. I object to any increase in these hours after 11.30pm.

I have no objection to the application to extend the hours of sale on Friday and Saturday nights to 1.00 am the following morning.

I would also like to register my concerns regarding the application to permit an additional hour for the sale of alcohol on the Monday for each May Bank Holiday, Spring/Whitsun Bank Holiday and August Bank Holiday and any other Bank Holiday that might be granted at any other time, for the same reasons of increased noise and anti social behaviour.

In respect of the application to vary the license to permit films, indoor sporting events, live music, performance of dance, provision of facilities for dancing and karaoke from Sunday to Thursday, until 1.00am the following day, I

object on the same grounds as previously stated but particularly in relation to the creation of noise.

I also object to an extra hour being applied to permit films, indoor sporting events, live music, performance of dance, provision of facilities for dancing and karaoke for the Monday for each May Bank Holiday, Spring/Whitsun Bank Holiday and August Bank Holiday and any other Bank Holiday that might be granted at any other time. With the exception of films and indoor sporting events I consider that 11.30pm on the day in question might be an acceptable compromise, and that films and indoor sporting events cease when the premises closes. In respect of Friday and Saturday I consider 1.00am the following day being reasonable. In respect of recorded music, I consider that when the sale of alcohol ceases, so also does the playing of recorded music.

The Old Ale Emporium is situated on the corner of Green Lanes and Burgoyne Road, and I am concerned that the application to permit films, karaoke, performance of dance, provision of facilities for dancing and recorded music both indoors and outdoors could lead to the creation of noise outside the Old Ale Emporium in Burgoyne Road.

I understand that the premises has applied for planning permission to create a smoking area facing onto Green Lanes, and by definition this must be classed as being outdoors and that the application to vary the licence in respect of the above activities is such that they may be permitted in this designated smoking area. As long as that is the case and provision is made to exclude these activities taking place outdoors on Burgoyne Road at any time, then I would have no objection.

In respect of opening and serving alcohol 30 minutes before and after any major sporting event, outside permitted hours, I have serious reservations that this could contravene Haringey Council's Statement of Licensing Policy, January 2008, with regard to objective number 3. There is no definition as to what constitutes a major sporting event. Whilst it could be limited to mean for instance the Football and Rugby World Cups, such limit is not clear in the application. I think that such events could be better controlled through application for a temporary licence as and when necessary.

The current landlord, David Smith and his wife have reassured me that they fully understand my concerns, and were they applying for this variation to cover their tenancy, my grounds for concern would be diminished; however I note that this application is being made by Punch Taverns PIc, and there is no guarantee that these variations as applied might not be used in full under the management of another landlord.

I ask the licensing team to reject this application for variation as applied for and impose a regime that whilst not discriminating on commercial grounds, shows a greater appreciation of social responsibility.

Late-night premises licence variation: Old Ale Emporium, 405 Green Lanes, N4 1EU Applying for Mon-Sunday 1.30, plus 2.30am on public holiday periods, plus a wide range of licensable activities both indoors and outdoors

1 INTRODUCTION

The Ladder Community Safety Partnership (LCSP) contains representatives of Neighbourhood Watches and Residents' Associations both from the 'Ladder' roads, and in Green Lanes itself. We are an independent group, although working in partnership with Haringey Council and the Metropolitan Police where appropriate.

We are writing to you as members of the LCSP to oppose this application.

We believe that in the context of the well known problems in the area, granting a licence for the activities and hours requested would be against the general principles of Haringey's Licencing Policy and specifically under the following headings:

- The Prevention of Crime and Disorder
- Public Safety
- Prevention of Public Nuisance

We are concerned, in particular, at the issues surrounding the prevention of public nuisance, in the light of the applicant's request for

- very late hours (1.30am daily) and even longer for periods around public holidays (2.30am)
- live music, dancing, karaoke, indoor sporting events and films daily until 1am
- recorded music daily until 1.30am
- films, recorded music, dancing both indoors and outdoors
- opening for major international sporting events at any time of the night (although we understand that this will now need Police consultation before the event)



More information on why we believe the Committee should reject this application is provided under appropriate headings below.

2 REASONS FOR OBJECTING

(a) Relevant sections of the Borough's Licensing Policy/Objectives

We believe the following statements in the Borough's Licensing Policy 2008 support our objections:

- 'the Council considers that licensing law plays a key role in both preventing and controlling ... anti-social behaviour ... by regulating and applying conditions to affect the number, location and hours of premises' [2.7]
- 'this licensing policy statement is intended to support the Antisocial Behaviour Strategy by reducing the impact of drink related antisocial behaviour and the environmental crimes and nuisance that can be associated with licensed premises' [7.12]
- 'the council will have special regard to the local impact of licensing on related crime and disorder ... particularly when concerning location, impact, operation and management of all proposed licenses, applications, renewals and variations of conditions' [8.6]
- 'licensed premises, especially those operating late at night and in the early hours of the morning, can cause a wide range of nuisances that can impact on the people living, working or sleeping in the vicinity of the licensed premises. **The Council is committed to protecting the residents** in the vicinity of these licensed premises.' [14.1]
- 'in particular, late night activities cause much of this nuisance. Late night cafes ... can have a number of adverse effects on the residents in the vicinity of these premises.

 Nuisance such as noise, litter, anti-social behaviour, lights and odour all contribute to the loss of amenity to the general public' [14.2]
- 'noise nuisance is of particular concern' [14.3]
- 'the potential for additional crime and disorder and/or public nuisance is increased with longer hours.' [19.1]
- 'operating hours between 23.00 and 07.00 are considered to give greater potential for noise nuisance' [19.3]

(b) Licensing Hours

In the light of the above statements and of the licensing objectives in general, we believe that a daily closing time of 1.30am is very late for ordinary weekday evenings, after which most residents will have to get up early to go to work. However, our major concerns are with the issues of live music and other activities daily until 1.00am and the wide range of indoor and outdoor activities until 1.00am daily (1.30am in the case of recorded music).

We believe that these are unreasonable propositions, given the location of the premises in the heart of one of the most densely populated residential areas in the borough.

- (c) The Prevention of Crime and Disorder
- (d) Public Safety
- (e) Prevention of Public Nuisance

We have seen the application form submitted by Punch Taverns, which states that the steps taken to promote these licensing objectives are 'as per current licence'. Unfortunately, that document simply refers to the 'conditions and restrictions inherent in the Licensing Act 1984' - which has, of course, been superseded by the Licensing Act 2003.

This means that , at the time of writing, we have seen no comments whatsoever relating to compliance with these key objectives. This, in turn, makes it very difficult for residents to be able to assemble any informed opinion about the manner in which crime, disorder, public safety and public nuisance will be dealt with.

There is therefore a wide range of questions which need to be asked, and answered, as specified and recommended in the Appendix (pp30-33) of the Borough's Licensing Policy Statement..

3. CONCLUSION

We believe that the above points need to be clarified by the Licensing Committee and clearly specified in any licence granted.

Our comments and objections obviously make clear that residents are very concerned at the likely implications of very late hours, coupled with a very wide range of licensable and noisy activities, both indoors and outdoors. Activities such as live music and karaoke are inherently noisy. The pub currently has no outside area beyond a tiny stretch of curtilage along the Green Lanes frontage. There is an application with LBH Planning for a small smoking area to be created at the corner of the property, but it would (if granted) obviously be totally inappropriate to carry out any film, music or dance activity in such a small open space. We would therefore urge the Licensing Sub Committee to support a balanced decision, bearing in mind both the concerns of local residents and the needs of the present applicant to continue to operate a successful business.

In the light of these concerns, we would urge the Licensing Sub-Committee to consider limiting the hours and activities to 11.30pm or 12 midnight (Sun-Thurs) and to 1.00am (Fri-Sat and specified holidays). No activities - beyond smoking and drinking, strictly within any permitted outdoor smoking area - should take place outdoors. We believe that these proposals are a workable way forward for residents and applicant alike





I would like to confirm that I have considered the above proposal with regard to the prevention of public nuisance on behalf of the Enforcement Response (Noise) Team & would like to:

Make representations to the Variation.

On the following grounds:

That the proposed operating hours are inappropriate due to the close proximity of residential dwellings.

The operating schedule does not address the prevention of public nuisance from:

- airborne entertainment noise
- Structure borne noise or vibrations from entertainment
- Noise generated by patrons in external areas of the premises e.g. beer garden

Supporting Information

The only noise complaint reported to us on 10/5/07, relates to an alarm allegedly sounding 2 to 3 times a week in the early hours of the morning. The complainant made no further reports of any problems.

Informative

Should the licensing committee grant this variation we would recommend the following alterations/conditions to the operating schedule:

Prevention of nuisance from noise/vibration

Airborne

All doors and windows will remain closed during the licensed entertainment activities. Where a door is used for patrons to enter or leave the premises the door will be fitted with a self-closing device and staff told to ensure that it is not propped open. [if necessary] A member of staff shall be positioned near the door to ensure it is opened for as brief a period as possible.

The licensable entertainment activity shall conclude 30 minutes before the premises is due to close to prevent excessive noise breakout as the premises empties.

Entrance/exit from the premises whilst licensable entertainment activities are ongoing shall be via a lobbied door to minimise noise breakout.

Where necessary adequate and suitable mechanical ventilation should be provided to public areas.

Structure borne

All speakers are mounted on anti-vibration mountings to prevent vibration transmission of sound energy to adjoining properties.

A report to be provided detailing the current level of sound insulation between the restaurant and the flats above.

Sound limits

The licensee shall ensure that no music played in the licensed premises is audible at or within the site boundary of any residential property.

Outside Areas

No music will be played in, or for the benefit of patrons in the external areas of the premises.

No form of loudspeaker or sound amplification equipment is to be sited on or near the exterior premises or in or near any foyer, doorway, window or opening to the premises.

Signs shall be displayed on the frontage instructing patrons to recognise the residential nature of the area and conduct their behaviour accordingly – The management reserve the right to ask patrons to move inside the premises or leave if it is felt that they could be disturbing neighbours.

The number of persons permitted to utilise the frontage will be restricted to 16 persons.

Only patrons seated at tables will be permitted to utilise the frontage.

The frontage will be closed and patrons requested to come inside the main structure of the premises at 2200 hours.

Deliveries and collections.

Empty bottles and non-degradable refuse will remain in the premises at the end of trading hours and taken out to the refuse point at the start of the working day rather than at the end of trading when neighbours might be unduly disturbed.

Plant and machinery

All plant and machinery is correctly maintained and regularly serviced to ensure that it is operating efficiently and with minimal disturbance to neighbours arising from noise.

Dealing with complaints

A complaints book will be held on the premises to record details of any complaints received from neighbours. The information is to include where disclosed, the complainants name, location, date time and subsequent remedial action undertaken. This record must be made available at all times for inspection by council officers.

Patrons entering/exiting premises.

Where people queue to enter the premises a licensed door supervisor shall supervise and ensure the potential patrons behave in an acceptable manor.

Signs should be displayed instructing patrons to respect the neighbours and behave in a courteous manor.

Prevention of Nuisance from Odour

All ventilation and extraction systems shall be correctly maintained and regularly serviced to ensure that it is operating efficiently and with minimal disturbance to neighbours arising from odour.

Prevention of nuisance from light

Illuminated external signage shall be switched off when the premises is closed.

Security lights will be positioned to minimise light intrusion to nearby residential premises.
