13. PLAYGROUND SITE, ADJOINING STAINBY ROAD, MONUMENT WAY N15 (PAGES 141 - 162)

Residential redevelopment of playground site adjoining Stainby Road comprising 15 units: 6 x four bed houses and a block of 9 flats comprising 4 x one bed and 5 x three bed flats (forming part of previously approved scheme, reference HGY/2005/1257.

RECOMMENDATION: Grant permission subject to conditions and/or a Section 106 Legal Agreement.

Retention and rebuilding of existing fire damaged building, including two storey extension to rear to provide 6 x 1 bed flats, 2 x 2 bed flats and 2 x 3 bed flats. RECOMMENDATION: Grant permission subject to conditions and a Section 106 Legal Agreement.

15. 44~50 COLERIDGE ROAD N8 (PAGES 167 - 180)

Erection of two storey residential building at first floor level over existing single storey commercial premises and additional storey above existing residential to provide 9 residential units with 5 parking spaces at ground floor level. RECOMMENDATION: Grant permission subject to conditions and a Section 106 Legal Agreement.
