6. Licensing Committee

6.1 The full Council appoints the membership of the Licensing Committee including its Chair and Vice-Chair. By law there must be at least 10 but no more than 15 appointed Members. The Committee can still meet and undertake its business with a quorum of 4 Members.

6.2 The Council can determine the terms of reference of the Committee. These are currently set out in Part 3 C of the Council's Constitution and remain unchanged.

7. Establishing the Licensing Sub-Committees

7.1 The Licensing Committee established its 3 Sub-Committees (A, B and C) on 22 May 2008 (see appendix 1) following the appointment of Members of the Licensing Committee by Full Council on 19 May 2008.

7.2.1 Following the recent resignation of Councillor Demirci from the Liberal Democrat Group there is a resultant vacancy on the Licensing Committee which will be appointed to by Full Council on 14 July 2008. The resultant vacancy means that there is a subsequent vacancy on the Licensing Sub-Committee 'B' and therefore it is for the Licensing Committee to appoint to that vacancy.

7.2.2 The Member to be appointed to the Licensing Committee will be confirmed by Full Council on 14 July 2008 and the Committee will be advised of the appointed member at the meeting on 16 July 2008.
