Report Title: The review of parking services fees and charges 2008/9

1.1 To authorise officers to proceed to statutory consultation on the proposed increase to parking services fees and charges.

2.2 That the Lead Member agrees to implement those charges if no major objections are received following the statutory consultation.

3. Policy Summary

3.1 The parking services fees and charges generated income of £2.994m for 2007/8 (summary attached Appendix B) which partly offsets parking account expenditure costs by around 30% for the Council, other costs are off-set by parking fines. The Council budget setting process for 2008/9 assumed parking services fees and charges will increase by 2.5% above RPI resulting in annual increase of 6.5% for other parking services fees and charges. The price increases proposed in this report will at least meet this requirement as set out in the pre business plan review for 2008/9.

3.2 The Council's external income policy has two fundamental principals that; services should raise income wherever there is the power or duty to do so; and the income should (at least) cover the full cost, including all overheads of the service.

5 Report

- 5.1 The Cabinet agreed that following the review of parking fees and charges undertaken in 2007, that parking service fees and charges would be increased annually where appropriate, in line with inflation.
- 5.2 The Council's Budget Setting Process for 2008/09 assumed that parking service fees and charges would increase by 2.5% above RPI (4%) resulting in an annual increase of 6.5% for other parking fees and charges.
- 5.3 It is proposed that those increases apply from 1 September 2008, if no major objections are received following the statutory consultation that will be required in most cases.
- 5.5 Parking fees and charges are inclusive of VAT where applicable.

6. Comments of the Head of Legal Services

- 6.1 The Head of Legal Services has been consulted and has no comments to make.

7. Comments of the Chief Financial Officer

- 7.1 The Council's budget setting process for 2008/09 assumed that some parking service fees and charges would increase by 2.5% above RPI (4%) resulting in an annual increase of 6.5% for other parking fees and charges. The increases proposed in this report will be sufficient to meet the parking services income budget target assumptions in respect of other parking fees and charges.
- 7.2 The Council budget setting process for 2008/9 assumed annual increases in parking fees and charges to be implemented from 1st July 2008. If the proposals in this report are not implemented ASAP there may be an adverse affect on achieving assumed income targets.
- 7.4 Generally fees and charges should be set in line with the Council's external income policy agreed by Members. The policy requires budget holders to review fees and charges against corporately set criteria as well as other factors that may be relevant. The proposed increases to parking fees and charges being considered in this report have been reviewed in line with this policy.
