5.3 Crime and Disorder

- An updated digital Closed Circuit Television System will be installed and maintained at the premises.
- The CCTV will be recorded at all times when the premises are open and the recordings shall be available to the police and council in request.

 A minimum of three members of staff will be present between 2100 hours and the closing of the premises.

5.4 Public Safety





- Noise generated from patrons who may be queuing to enter

Where a door is used for patrons to enter or leave the premises the door will be fitted with a self-closing device and staff told to ensure that it is not propped open. A member of staff shall be positioned at the door to ensure it is opened for as brief a period as possible

The regulated entertainment licensable activity shall conclude 30 minutes before the premises is due to close to prevent excessive noise breakout as the premises empties

Entrance/exit from the premises whilst regulated entertainment licensable activities are ongoing shall be via a lobbied door to minimise noise breakout. Where necessary adequate and suitable mechanical ventilation should be provided to public areas

Structure borne

All speakers are mounted on anti-vibration mountings to prevent vibration transmission of sound energy to adjoining properties

The licensee shall ensure that no music played in the licensed premises is audible at or within the site boundary of any residential property

All regulated entertainment amplified activity will utilise the in-house amplification system, the maximum output of which is controlled by the duty manager

The level of amplified regulated entertainment shall be controlled by means of limiting device set at a level agreed with the licensing authority

Outside Areas

No music will be played in, or for the benefit of patrons in the garden or other external areas of the premises

No form of loudspeaker or sound amplification equipment is to be sited on or near the exterior premises or in or near any foyer, doorway, window or opening to the premises

Plant and machinery

A complaints book will be held on the premises to record details of any complaints received from neighbours. The information is to include where disclosed, the complainants name, location, date time and subsequent remedial action undertaken. I live at 47 Palace Road which is 75 metres from the Princess Alexandra and not much further from Bar Apogee. Since the licensing laws have been changed, we have noticed a marked rise in late night noise. For the last few months, there has been an improvement due to the closure of the Princess Alexandra.

I have now been informed that our local pub is set to become a late night bar, restaurant and night club and that it will never close before 2pm. Prior to the building work taking place on the Princess Alexandra, we had major noise issues with people leaving the pub, smashing of glasses, car alarms going off, people hooting and music from cars, shouting and singing etc etc. I presume that the owners of the new night club want it to be busy, so I imagine that this will only make matters worse. Palace Road is a quiet residential street that is being spoilt by these bars.

Last year our car was driven in to late at night causing £6000 of damage. We suspect that this was done by a customer of Bar Apogee who broke in to a car, lost control and hit 3 cars in Palace Road. I realise that this is an exception, however, you will never stop people from drinking too much, and putting up polite signs, asking customers to respect the local residents just doesn't work. There are a lot of people who think they are the worlds greatest singers after a few drinks at 1 in the morning.

There are already massive parking problems in Palace Road, due to the garage and van rental company in Park Road and the additional housing that is just being completed. This will only get worse when the 'proposed' CPZ scheme comes in to operation. For some very strange reason, the CPZ is only going to cover half of Palace Road and will allow the garage and both bars to continue to use the Park Road end as there customer storage parking area.

I cannot believe that allowing a quiet local pub to become a night club with the hours that are being suggested, is a good idea for the community. It may be a good idea for a very small number of people who want to be in a club at 3am on a Sunday night, but I think you will find that the majority of the local population would prefer some peace and some sensible laws.

I would like to register my objection to the licence application for The Princess Alexandra (to be Villiers Terrace) at 120 Park Road.

It seems from the application that the licensees intend to have music and dancing until late at night, both inside and outside the premises (outside till 11pm). This is a residential area, and I think that the usage they are intending is totally inappropriate to the area. The business has always traded as a local pub, which has benefit as a meeting place for the local community, whereas with the changed use, it seems that the owners intend instead to try to attract a whole new audience to the area - as I said a residential area.

I am also concerned by the ongoing building works, which seem to indicate that at least some of the activity will be outside the building on an area previously paved and accessible, on the corner of Palace Road and Park Road. It think it is totally innappropriate for people to be outside on this corner so close to residential premises.

There seems to be little provision in the licence application to prevent public nuisance - even under the previous licensee's tenure, people had started to congregate to smoke on the pavement outside the pub late at night, which was daunting when returning home at night as well as noisy.

It with heavy heart that I received the news that, after having battled with others for Bar Apogee to curtail it's proposed licensed activities last year, we are now being faced with another front of opposition with The Princess Alexandra. *WHY?* All the objections the residents put forward with regard to the Bar Apogee application still apply and yet another similar application is actually being considered again. It flies in the face of public reason!

To reiterate last year's concerns, I have lived here with my family for over 21 years now and I choose to continue to live here because it's a place that always felt like home. I am starting to have my doubts and I am wondering if this is where I want to bring my kids up. To have a nightclub/late night bar/pub so close to where we live and sleep is both ludicrous and absurd! My car is parked across the road and it has been broken into on several occasions at night and recently yet another audio set and other items have been stolen. I have gone down to it in the morning only to find it had been 'keyed' in the night and has had drink thrown all over it on several occasions. I report it to the Police, but they can't do much to stop it happening again. Discarded glasses and bottles are often strewn along our garden wall or in the garden itself, not to mention vomit on the pavements outside.

Nocturnal brawling and fighting at weekends no longer surprises me, and while I concede that this may not always necessarily originate from the premises in question, to extend opening hours and further licensed activity into the wee small hours means increased opportunity for this kind of behaviour and more reason for drunk, disruptive people to loiter in the area well into the night and more opportunity for the kind of crime my car has been subject to. No more, please!?

I have a 13 year old boy with ADD, who needs his sleep in order to cope with life in general and his mother needs it no less. I have had to make him close his window in the summer, when fresh air would have been a relief to him, and had to buy an electric fan so that the noise from the cars/customers in the Bar Apogee car park doesn't keep him up, as it bounces around his room through an open window. I also keep my own window closed to reduce the probability of being woken by the sound of abusive yelling, car door slamming/engine revving and breaking glass as people go home at closing time. I shouldn't need to.

This is something that has only happened over the last several years when licensing was first granted to O's Bar, as it was then, but the activity has become gradually more and more disruptive/ongoing with each successive ownership. This is my home. This is where I live. I have rights too, but they don't seem to matter

The Licensing Committee last year agreed to keep things as they were, but I am completely behind the current proposal to have these matters reverted those that existed pre-O's Bar. The decision last year has not made life any easier and the bar in question has not consistently fulfilled the conditions that were agreed upon.

Modern life in the city has so many additional stresses nowadays that the right to a decent night's sleep and the right of my 21 year old daughter to come home safely after seeing her friends without being propositioned by men hanging around in the area outside Bar Apogee are just two of the most basic, surely? We all find it hard to concentrate at work when we am tired and the weekends mean a great deal to us to recharge our batteries, but how to do it when there is an adjacent bar/club open late into the early hours of the morning?

Please act on the concerns of the residents in this area and show us that making money isn't always life's first priority. Quality of life supercedes that, surely?

We have personally had to call the police on several occasions and my husband has already intervened to break up disturbances outside our house; this both makes me proud of him yet terrified for his personal safety.

Crouch End is a family area. These two venues are surrounded by residents, many of whom have lived here for many many years. Please do not make Park Road a clubbing destination.

As local residents, we consider that the proposal for a late-night music venue is completely inappropriate for this area which is entirely residential. Our specific objections are as follows

Prevention of Crime and Disorder It is extremely likely that people leaving the premises after drinking until well after midnight will commit acts of vandalism in local streets, and that local residents will find that they cannot walk safely in their own streets.

Prevention of Public Nuisance Residents in the immediate area around the premises will suffer serious noise nuisance from within the premises. Residents in a wider area will undoubtedly suffer noise nuisance when customers leave in the 'small hours' of the morning. 

I am writing as I would like to make a representation <u>against</u> the application for a new premises license for Villiers Terrace at 120 Park Road, London N8.

I have lived at my current address (55 Palace Road N8) for 12 years and when the 'Princess Alexandra' changed hands a couple of years ago the local vacinity changed dramatically and my concern is this will continue if this license is granted. My reasons for concern are as follows:

- 1. Disturbance during the night especially weekday nights when everyone in my household has to get up for work/school the following morning. Disturbances include cars pulling up at all hours and upon closing of the pub people talking loudly and arguing in the street after drinking alcohol.
- 2. Music (although supposed to be regulated) so loud that you can hear it until it stops. This is especially so in the summer when windows are open and the pub garden is being used.

We are writing to express our concern at the proposed application for changing the former Princess Alexandra pub into a nightclub. Not only are the premises in a residential area, but just across the road there is sheltered accommodation for elderly people. We ourselves are frequently subjected to excessive noise at the week-ends from the licenced Cricket Ground premises at the end of our road, as well as from over-exuberant (read intoxicated) members of the public on Park Road who enjoy the many pubs and bars in the central Crouch End area.

The proposal to change the Princess Alexandra will also encourage large numbers of people from outside CE to come to this area, increasing the probability of yet more excessive noise and aggravation to the locals. Moreover, Park Road, despite being a main road with regular double decker buses, has no current parking restrictions on the Princess Alexandra side, bringing traffic chaos to the area almost every day. I write to register my objection to the application for a new premises licence made by Sonrisa Limited.

I live across the road from Villiers Terrace which as the Princess Alexandra has been a traditional pub for many years, until more recently. The surrounding area is firmly residential and to a large extent is populated by families with children.

Although in the application the premises are described as a "Restaurant and Bar Area" the activities and hours applied for are clearly more consistent with those of a nightclub, ie

music and dancing to 2am Friday to Sunday, and until 1 am for the rest of the week.

Over the past 18 months or so this residential area has been regularly disturbed late at night by loud music and rowdy customers from both the Princess Alexandra and Bar Apogee across the road. These problems have led to a number of Park Road residents, myself included, to seek a review of Bar Apogee's premises licence which is currently in progress. Since the Princess Alexandra has been closed for refurbishment the problem of noise in the surrounding area has reduced.

In this context the operator of Villiers Terrace is now applying for a licence with extended hours in excess of those previously granted to the Princess Alexandra. I believe it is inevitable that if the hours applied for are granted without significant amendment the problems of noise disturbance are only likely to increase.

The smoking ban in July last year has clearly exacerbated the problem of noise nuisance with customers coming in and out of the premises, and with a constant presence of customers smoking outside in the early hours of the morning. This issue in itself makes the late night opening of Villiers Terrace particularly sensitive given its proximity to residential housing.

It seems perverse that as you move away from the centre of Crouch End along Park Road into an increasingly residential area the licensable hours sought/granted actually increase. For instance, on Friday and Saturday nights the Maynard Arms which is nearer to the centre is licensed to play music until only 23.00pm and must close by 00.40am.

I hope you will take the above comments into consideration.



Re Licensing Applications of Princess Alexandra Pub of Park Road and Bar Apogee (opposite to Princess Alexandra) also in Park Road.

I am writing with concern about the proposal to turn the Princess Alexandra to a late night club type venue with a 3.a.m. licence and for The Bar Apogee situated opposite Princess Alexandra and currently subject to licence review, similarly to extend its licence to 3.a.m.

This would create a larger longer noise nuisance in a residential area which would cover both sides of the road and be unavoidable for any pedestrians as drinkers move outside to pavement to drink. I've seen this development in "Kiss the Sky" further down Park Road towards Crouch End village.

Crouch End village has plenty of places to drink and eat. There's no need for additional licensing hours extensions in the residential roads away from the village itself.

Neighbouring Muswell Hill already has a number of late night clubs and we sometimes suffer from their late night spillage of drinkers roaring their way home down Park road, and now we would have them from the opposite direction also. This is a residential area known for its pleasant aspect and family friendly amenities. It has a relaxed feel but these developments would tend to create a more urban stress feel. I believe any decisions to extend licensing hours would increase the number of "clubs" in Park Road from 2 (at the village end) to 4 (with the additional 2 in the residential part). It's not clear to me how residents around the additionally licence extended venues (should this be permitted by the licensing authority) would be able to sleep at night from the noise disturbance.

I believe there is a loss of family type venues as a result of the changing nature to venues that goes with extended licensing hours. There were only a couple of family friendly pubs in the area with gardens and the Princess Alexandra was one of those. It was one of the few nice old style pubs with open fires in the Winter and is our local (currently not in use pending renovations). I fear it will now become yet another late night only club venue aimed at young drinkers.

How would this fit with the Department of Health's Alcohol Strategy which I believe is a cross-government strategy in which local authorities can play a part and alcohol targets are among targets include in the national local authority set I believe?

I fear an increase in extended hours venues will lead to more social pressure on young people to drink excessively. Crouch End and Haringey as a whole are not areas where youngsters drink because there's nothing to do (unlike some other areas in the country). These are vibrant lively communities with lots of amenities for young people and they don't need to go down the road of pressures to make drinking one the main social activities in the area and the borough. I've nothing against drinking or pubs and clubs in themselves, but it's the extension of drinking venues designed to attract young drinkers that concerns me with all the risks of underage drinking and peer pressures that entails.

Past editions of local papers reveal that Bar Apogee and its predecessor O's Bar suffered from a considerable number of violent incidents on the street from its customers. I would not be happy to see its drinking hours extended.

Crouch End is a sought after area to live in because it's a nice green family friendly place to live and a bit of an oasis from the urban stress of more central areas of London. It would be easy to lose that through any licensing decisions that would create a permanent detriment to the area that would not easily be reversed because they would set a precedent for others.

I believe that the environmental and residential interests are most important and residents need to be able to sleep at night and feel safe in the evenings.

We the undersigned wish to collectively make a representation **against** the application for a new premises licence for "Villiers Terrace" 120 Park Road, London, N8.

We are the residents of **Truro Court**, a block of council flats adjacent to "Villiers Terrace."

Thankfully, we have been able to sleep very well since the beginning of September 2008, when work started at the above mentioned site and the pub ceased trading. We want to continue sleeping well.

"Villiers Terrace" was formerly known as the Princess Alexandra Public House. Since it was taken over by the last owner we have all noticed a significant rise in noise levels, drunk and disorderly conduct, littering and rubbish dumping not to mention an increase in violence, crime and drug use. This was clearly coupled with, and directly related to, the marked increase, under this new ownership, of the playing of loud live and recorded music.

We had hoped that the new establishment was going to be a more laid back; less party oriented type of pub, but this new application for a licence does not bode well for us as long-suffering neighbours. "Villiers Terrace" is clearly aiming to be a loud, late night drinking "bar/club." This exactly what we have to avoid in order to protect our children, ourselves and our neighbourhood from the above stated problems.

Our concern is that the unsavoury crowd that the former pub attracted, due to its loud music, late night drinking and lack of ability or willingness to curtail drug use on the premises, will return. Granting an even later licence to serve alcohol throughout the week will certainly ensure that the problems, which have plagued this area of Park Road for many months, are bound to return with increased intensity.

There has been at least one (probably more) serious incident – prompting a yellow police board being erected directly outside the pub with a request for information. It was common (before September) to hear couples fighting loudly and violent behaviour of men towards women or other men. One night, for example, it sounded as though one woman customer of the pub narrowly escaped an indecent assault. On the weekends it was fairly common to have the police and or ambulance attend to violent, drunken people who felt the need to hurt each other and shout obscenities at the tops of their voices. We have had to put up with customers from the pub smoking, snorting cocaine and having sex in our front and back private communal gardens. Since the Princess Alexandra turned from a quiet drinking establishment to a late night party venue we have seen it all...

The residents living in the flats on the side nearest to the pubs (there are two teenaged girls and one seven year old girl) were frequently woken up by shouting, fighting, drunkenness and violent and abusive behaviour. Please, if you are able to - ask the police about this particular area. Because of the late night bar and petrol station (with cash point) across the road, the area became a meeting point for overly drunk people at 3am in the morning. If food is made available late into the night too... it will become a mecca for late night drinkers in search of food, money and drugs. It will also mean that the rubbish dumping (on the behalf of the pub) will become even more of a problem. We have just been informed by Haringey Pest Control that our recent mouse problem (my partner has lived in this block for nearly 20 years and has never known of a mouse problem before) was most likely due to the disturbing of rubbish piles accumulating at the pub. Late night food is sure to add to the problem of rodents.

We see ourselves as a tolerant lot (perhaps too tolerant) and don't really complain that much. Many of us do our fair share of partying too, a bit of music is ok if it ends by midnight and isn't too loud. It's even ok if it's a one off party and goes on until 2 or 3am. But 2 - 3am every night is way too much to expect us to cope with. This late night licence will not only affect our sleep, it will also have long term adverse effects on our neighbourhood. We must draw the line somewhere. This is a residential area, with children and families trying to get a decent night's sleep so they can go to work or school in the morning. We don't deserve to have to listen to alcohol-fuelled ranting and fighting throughout the night.

We hope you share our aim to ensure that "Villiers Terrace," doesn't attract the same sort of problems as the Princess Alexander did (without a 3am licence!). We feel that we must all work together to make sure that these

licences are not granted by the Council, and <u>furthermore</u>, <u>that a close</u> <u>eye is kept on the effect that "Villiers Terrace" has on crime, disorder and noise levels in our area.</u>

1. Bar Apogee Park Road N8: Licence Review

This bar already has a reputation for being excessively noisy and although not living immediately opposite it, its clients often disturb the peace of residents when leaving the bar and making their way homewards along Park Road or gathering at the bus stop. Our experiences of the nuisance generated by Bar Apogee should be taken into consideration when reviewing its licence.

2. Villiers Terrace Park Road : Licence Application

Re the above (absurdly- named - no desire to continue a tradition - and this alone has upset many residents even those not clients of the former public house), the fact that it is opposite the troublesome Bar Apogee, and that its assurances that it will not 'cause misery' to residents cannot be guaranteed as although basically a gastropub its request for opening hours to be extended to include other services including a DJ does not reassure residents that they will not be subjected to additional late-night noise from the premises. It may be soundproofed but Park Road and our homes are not! Therefore I suggest that the opening hours until 1.a.m during the week and 2.am.at weekends should be reduced to an earlier and more accceptable closure time.

We write to voice our concerns regarding the licensing proposal for Villiers Terrace, 120 Park Road, London N8. The objection relates primarily to the prevention of public nuisance and crime and disorder, which we believe will increase markedly if this application is approved in its current form.

Our primary objection is the proposed opening hours, which were already problematic when the previous establishment – The Princess Alexandra – was trading. We note that Villiers Terrace is seeking extended opening hours and is proposing to provide live entertainment until 1am Monday – Thursday and until 2am Friday – Sunday. As you will appreciate, the pub sits within a quiet residential family area and the proposal to cite what will invariably be a noisy club in the heart of it, does not sit comfortably with local residents.

Under the current proposals, we anticipate that we will be disturbed by noise late into the night throughout the week and that crowd dispersal will exacerbate that. The problems with The Princess Alexandra were significant and led to our writing to the landlord as advised by the council on 22 May to complain about noise, anti-social behaviour, litter and poor crowd dispersal (see attached copy.) We were also forced to call the council on one occasion when the level of music on a Friday night was so loud at 12pm that we were unable to sleep despite our windows being closed and our house being situated 150 metres from the pub.

We therefore suggest that an extension of the previous licensed hours is unacceptable. Moreover, given our experience with The Princess Alexandra, we suggest that the licensed hours need to be reduced beyond what was previously set and certainly beyond what is currently sought. We suggest that live music should be no later than 10:30 Sunday to Thursday and 11:30 on a Friday and Saturday. Further, we consider that the premises should close by 12:00 Sunday to Thursday and by 01:00 on a Friday and Saturday. We note that pubs in the non-residential parts of central Crouch End (Kiss the Sky and the Kings Head) close at 01:00 at the latest and cannot see why a live music venue in a residential area should be granted a later license.

Aside from our concerns with regard to opening hours, we must stress the need for stringent operational guidelines to be attached to any license. As you will see from our letter to the landlord of The Princess Alexandra, we experienced a range of problems that impinged on the quality of our lives. Notably, crowds of people were allowed to gather outside the pub to smoke and drink until late into the night causing significant noise. On leaving the premises, people were not managed out quietly and were instead allowed to leave noisily, to congregate at the bench at the end of the road and to sit playing loud music in cars parked on Palace Road. This went on well beyond the licensed hours and often resulted in screaming drunken arguments and fighting and created a very intimidating atmosphere for anyone walking to their home alone. On several occasions, we have felt threatened and intimidated.

The effect of the poor management was also felt in the mornings, when several hundred cigarette butts and countless broken glasses would litter the pavement around the pub. This was unpleasant to walk through and unsafe, particularly for young children.

We are not opposed to the licensing of a pub at the end of Palace Road. On the contrary, it's important for local businesses to establish themselves in the area and to provide a resource for the local community, as The Princess Alexandra did in the past (under the previous management.) However, we really question the acceptability of the late licensing of a live music venue in the middle of a residential area and, given our recent experience, rightly so.

We therefore ask that you consider the thoughts expressed here seriously and move to bring the licensing of this establishment into line with what is acceptable for its location and that whatever license is granted, has strict operational conditions attached to it.

For our privacy, we ask that our names and addresses are treated confidentially when dealing with this application.

Anti-social behaviour

We write as residents of Palace Road to complain about the anti-social behaviour caused as a direct result of The Princess Alexandra public house.

Anti-social behaviour, namely unacceptably high levels of noise both in and out of licensed hours, littler and poor crowd dispersal have been an ongoing issue for the past 18 months. The good weather has exacerbated this problem and on the evening of Saturday 10 May, we experienced unacceptably high levels of music until at least 2am on Sunday 11 May.

The following Monday morning (12 May) and various occasions thereafter, the pavement outside the pub where the benches are located has been covered in broken glass and several hundred cigarette butts. As you'll appreciate, residents (particularly those with children) do not wish to walk through this sort of debris on route to work or school.

Further, the behaviour of some of the clientele leaving the pub at closing time is unacceptable. We are often kept awake by people screaming, aggressive shouting or fighting between 1-3am; a problem that has been exacerbated without bouncers to control the dispersal. On the morning of Saturday 10 May we were also forced to clean vomit from the pavement outside our house and that of our neighbour.

We have spoken to the council to report the problem and they have advised writing to you as a first step and asking that you respond within a two-week period of the above date by:

- Controlling crowd dispersal at closing time:
- Cleaning the outside areas each night to ensure clean pavements in the morning;
- Keeping noise to the levels stipulated in your license and ensuring that all people are indoors and windows/doors closed by 11pm.

If there is no noticeable improvement in your running of the pub within that period we will have to pursue the matter with the council and police. I should also say that we are aware of the free availability of drugs in the pub and will have no hesitation in also bringing this to the relevant authority's attention.

We very much hope that you will respond in the manner suggested and return the pub and the area to the peace and quiet we have experienced in previous years.

LICENSING ACT 2003 – NOTIFICATION OF AN APPLICATION FOR A NEW PREMISES LICENSE FOR VILLIERS TERRACE, 120 PARK ROAD, LONDON N8

Having suffered a great deal of noise disturbance when 120 Park Road obtained a music licence under previous management I am most concerned about the new management requesting a music licence, especially since they have applied for music to be played until 2 a.m. and Sunday afternoons from 1200 till 0200.

Under previous management the music even used to be played in the pub garden or - when inside the pub - with opened doors during the Summer which was terribly invasive for us noise-wise. Even with closed doors we could hear live bands and I had to call the council until the bands were moved to the opposite end of the pub and the volume turned down. My neighbours also complained about sleepless nights.

I have really enjoyed the peace and quiet since the pub has been closed for refurbishment, however Park Road is a residential area I believe it is unfair that we should be relentlessly subjected to unwanted, repetitive music in our own homes where we simply **cannot escape it** and should be resting after a hard day/week **at work**.

When I purchased the property in 2005 the Princess Alexandra was a traditional pub, not a live music venue and I experienced no problems.

Hello.

I am a new resident to the area of Park Road and I would like to express my concerns with regard to the late licence Villiers Terrace have applied for.

This is predominantly a residential street, we have moved here with a young family from the very centre of Crouch End with the expectation that this area will be quieter and we will be less disturbed during the night by instances of drunkenness or anti-social behaviour.

There is already a late bar in the area which is subject to a license review because of their impact on our community, having a second bar can only magnify this for us.

There will always be an impact when a large number of people come out onto the street at 3am in the morning, whatever the license conditions and it will be the surrounding area and residents who will suffer. In addition I am concerned about the increased traffic and noise caused during the night by taxis or cars taking people home.

The smoking ban has had a huge impact on the noise level generally coming from pubs as people congregate outside the establishment and continue their conversation and drinking without consideration of the noise they are creating and the effect on the neighbours. This increase in noise and complaints has been confirmed by the Haringey Noise Team but there seems very little that can be done besides controlling licensing hours to minimise the impact on local residents late at night

I currently live near to another pub in the area, the Queens Pub on Broadway Parade and we are badly affected by the behaviour of people in the pub, particularly due to their late license. This pub operates until midnight so people who drink in other pubs migrate here when other locations close so there is a greater tendency for drunkenness, anti-social behaviour and recently drug-dealing. I am concerned that the late licence here will disproportionately draw these people and this behaviour to this area.

The style and tone of this pub is not aimed at the local residents or community but is to draw in people from further away who do not respect this area, this type of bar would surely be better suited to an area which is not so residential.

I hope that you will consider these concerns and reject the application for a late license.

I am sending this email as I am strongly against the possibility of a Nightclub opening in Crouch End which plans to have a closing time of 3.00 am. The premises in question is the "Alexandra Pub" on Park Road N8 currently rebranded as the "Villiers Terrace".

My views and those of my fellow residents opposing it are as follows:-

Firstly, the 3.00 am closing will have a great impact on this close knit Crouch End community, which consists of many young families and the older generation. The streets will become noisy into the early hours of the morning which is not very pleasant for the residents living in close proximity to the Nightclub who are trying to sleep.

There will be extra litter on the streets. We are already subjected to vast amounts of broken glass bottles and rubbish littering our streets which can cause injury in particular to young children and the older generation. Our streets are also covered with vomit on the pavements mainly at weekends and people urinating in the street which is not pleasant.

This may have impact on Crime within Crouch End. There will be large groups of people wondering the streets late at night, consumed with drunk and drugs, causing damage to property and cars. I myself have been a victim of car crime five times in the last two years. I live on Crouch Hall Road in Crouch End N8 8HH. These incidents have caused me considerable distress not to mention over a £1200 in expenses and a considerable rise in my car motor insurance premium. I have had to contact Hornsey Police Station several times to report large groups of youths damaging cars by jumping on car bonnets, lighting small fires to peoples front garden hedges, throwing bricks through peoples car windows, breaking car wing mirrors etc, shouting and screaming, and hurling abuse into the early hours of the morning.

Residents would not feel safe returning home late at night with large groups of people hanging around in the streets.

This will effect the house prices within the area.

There will be an increase in congestion in the area. As we are already suffering from a lack of parking for people living in the area and this will not help the situation but deteriorate it further.

This will put a burden on the local police and neighbourhood watch services.

Crouch End has a close knit village atmosphere which it has maintained over the years and is renowned for and we do not want it destroyed and for Crouch End to become a "Clubbing Destination" as the local papers are suggesting with the arrival of a Nightclub.

Lastly, I would like to mention that I would also like to oppose "Bar Apogee's' on Park Road which is currently undergoing a licence review and already has a 3.00 am closing time.

It has been bought to my attention that the building formally The Princess Alexandra pub, 120 Park road, has applied for a new license to operate as a night club with extended hours during the week and weekends. I would like to give my very strong objection to this on the following grounds.

The prevention of public nuisance

The building itself was built as a public house, there is no sound proofing, indeed there is even a conservatory, and there's a lot of outside space. It isn't appropriate for any kind of loud dance music, especially into the early hours of the morning, plus customers standing/sitting in the beer garden until the early hours, talking, laughing, usual drunken antics.

The premises (as with Bar Apogee across the road) is surrounded on all sides by residential housing. Most of the residents are young, working families, with children of school age. We have been and are, disturbed into the early hours on Friday and Saturday nights by Bar Apogee, to have this on Sunday, and through the week from another premises would be intolerable. This area is not the right place for a night club.

From past experience of Bar Apogee (and the Princess Alexandra), people often come by car, which means a lot of engine revving, car door slamming, screeching tyres, when people leave.

Even when the premises was a pub, there were a number of complaints against it for noise and disturbances - the police have also had to be called on a number of occasions, as have the noise team. This will only get worse if it becomes a night club operating until lam Mon-Thur and 3am Fri- Sun.

The prevention of crime and disorder

There have been a number of fights outside The Princess Alexandra in the past and we can't see this getting any better if it becomes a nightclub.

Local residents have had to break up fights late at night at these premises, putting their own safety at risk.

Beyond the above, in February the council rejected a license extension application from Bar Apogee (115 Park Road), and instead offered a license with hours of 1.00 Mon-Fri and 2am Fri-Sat, Sun 12am - with a number of strict conditions such as not allowing any more customers in after midnight, 2 security personnel at all times on the door, sound proofing of the premises, ensuring people leave quietly, limited number of people smoking outside at one time etc. Therefore how could 120 Park road be

allowed anything different? In fact, we have requested a review of the license hours for Bar Apogee as late clubbing licenses 300 aren't appropriate here.

It this goes ahead, it will make our lives a misery 7 days a week. I'm sure the Licensing Act 2004 wasn't bought in so pubs could become night clubs. Please don't let Park road become a night club destination.

With reference to the review of the premises licence for Bar Apogee, 115 Park Road, N8 8JN

The operation of Bar Apogee has continued to be a public nuisance and a cause for concern to the local residents because of the following points.

Many patrons of the bar still gather outside the doors, using the chairs and tables provided.

The doors are often left open, using door catches, for long periods.

Noise made by these patrons and music from inside the premises become very intrusive and disturbing, often well into the early hours of the morning.

Vehicles are frequently parked in front of and around the premises, often half on the pavement. Park Road is narrow at this point and the obstructions persistently cause traffic to be reduced to one lane operation and the consequent noise of standing traffic and the stopping and starting of traffic, including night buses. This also creates an additional obstacle for emergency vehicles; it should be noted that Park Road is a standard route from Hornsey Fire Station.

The parking is also leading to the break up and subsidence of the public footpath in front of the bar.

On leaving the bar, patrons frequently behave in a noisy and anti-social manner as they walk up Park Road.

The non-opening of this bar, usually on Monday nights, is a very welcome respite to this on-going situation.

The pending application by the Princess Alexandra, opposite to the Bar Apogee, for a similar early morning hours music and dance licence will, if granted, only lead to a further deterioration to the present situation in the area.

At the last license hearing for the Bar Apogee, I recall there was an attempt to blame the Princess Alexandra for a lot of the nuisance late at night in the area. The Princess Alexandra has been closed for refurbishments for around 4 months, this has not led to any improvement in the late night problems.

Finally I list three infringements of the licensing conditions, as laid out in the current licence for the Bar Apogee.

Item 4 - The outer doors are often held open with door hooks.

Item 10 -More than 10 patrons are often outside.

Item 12 -No external CCTV has been in installed around the premises.

Finally I continue to be concerned about the influence and attraction of such a bar to the many young people in this heavily residential area.

I am writing to lodge my strong objection to the proposed changes to the operation and licence of the Princess Alexandra, 120 Park Road, N8 (Villiers Terrace).

The premises are immediately adjacent to four blocks of flats and also close to many houses in Palace Road and Park Road, a high density residential area. These homes would be directly disturbed by patrons arriving and especially leaving, parking, smoking outside, loud music from and the general disturbance caused by such activities late into the night eg 3-4am.

Parking in the area is currently difficult. It can only be made worse by extra vehicles bringing patrons into the area. Palace Road is closed off with a barrier midway. Park Road is a very busy main road congested with both through traffic, including emergency vehicles and buses, and many parked cars. These conditions will be made extensively more difficult with extra traffic both moving and parked and cause further public nuisance.

The Princess Alexandra has in recent times been the location for public disturbance and violent disorder. Police notices appealing for witnesses have been displayed in the vicinity of the pub. This coupled with the on-going difficulties caused by the Bar Apogee located opposite at 115 Park Road, do not fit in with the residential nature of the area.

Many young people from the local secondary school frequently pass through the vicinity. Families living in the area have children aged from small babies to impressionable teenagers. Many elderley people also live close by.

After many years of living in this area with little disturbance from what used to be community pubs I object to the quality of my neighbourhood being changed in this totally inappropriate way.

I am writing as I would like to make a representation <u>against</u> the application for a new premises license for Villiers Terrace at 120 Park Road, London N8.

I have lived at my current address (55 Palace Road N8) for 12 years and when the 'Princess Alexandra' changed hands a couple of years ago the local vacinity changed dramatically and my concern is this will continue if this license is granted. My reasons for concern are as follows:

- 1. Disturbance during the night especially weekday nights when everyone in my household has to get up for work/school the following morning. Disturbances include cars pulling up at all hours and upon closing of the pub people talking loudly and arguing in the street after drinking alcohol.
- 2. Music (although supposed to be regulated) so loud that you can hear it until it stops. This is especially so in the summer when windows are open and the pub garden is being used.
- 3. Drop of property value I am currently trying to sell my property and some detrimental feedback has already been regarding the pub as it is not now known to be the quiet pub of old but a nightclub style venue.

It has recently come to our attention of the proposals of the establishments **Apogee and Villiers**Terrace who are bidding for opening hours as late as 3am on Friday and Sunday nights and 2am at other times as a music venue.

As a resident of the area, I would like to voice my **objections** about this before it goes to the licensing committee:

- This area is a quiet, residential area with many young families. There is already disturbance on occasion with drunken people leaving Apogee at or soon after 1.00am.
- We live outside the centre of Crouch End Broadway we do not expect to put up with the high noise level disruptions. Neither from the music from the bar nor from customers leaving the venues.
- Parking problems often come with this kind of late opening hours. This can already be seen when numerous cars park on either side of the street and half on the pavement along Park Road making it a hazard for pedestrians as well as for other drivers and buses passing.
- Groups of people are already congregating outside Apogee after 1am, whilst the noise level is certainly a nuisance to residents close by, it can be quite intimidating and worrying to listen to.

As a resident of Park Road, Crouch End I am dismayed to discover that the owners of the refurbished Princess Alexandra pub are seeking a late license to open until 2am Monday to Thursday and until 3am Friday to Sunday.

Having lived with the disruption caused by the late opening of Bar Apogee over the last year or so it is hugely concerning to learn that another establishment only yards away may also be eligible for a late license.

Over the past year I have been woken from my sleep by people leaving Bar Apogee in the early hours of the morning which is some feat given that my bedroom is at the back of my home and does not overlook the road. On numerous occasions fights have broken out between people leaving the bar. The most recent, a couple of months ago, almost caused me to call the police as those involved were fighting in the street and creating an obstacle for passing motorists.

I no longer park my car on the road across from Bar Apogee at the weekends as on numerous occasions during the past 2-3 months I have found my wing mirrors completely detached from my car and thrown to one side on the pavement.

I have been unhappy with the noise levels from Bar Apogee for some time and have considered writing to the council before now but unfortunately I have dragged my feet on the issue. The prospect of another establishment having the same rights has compelled me to do so now.

As a professional I frequently leave my home at 6am in the morning to begin my working day and to have my sleep disturbed any time after midnight is not only a great inconvenience it represents a significant detriment to my quality of life. When this happens at speed even below 30 mph this becomes a very dangerous situation. The road is clearly marked with white and yellow lines and in the evening and early mornings these are completely ignored.

Public nuisance

The car parking brings a nuisance level for residents. The revving engines and playing loud music whilst smoking in their cars is a problem. Cars honking to their friends whilst passing by the pub.

Smokers talking and shouting whilst standing around in the street.

Buses having to wait whilst oncoming traffic gets past them and because the bus is starting off in first gear this become extra noise.

Harm to children

I have no experience of outcomes or problems arising from this other than when my daughter and her friends were 17 years old they had no problem getting served alcohol there.

- 1. This is a residential area and we live directly opposite this proposed 'night club'. Residents have already experienced noise nuisance from the previous licence holder, particularly during the warmer months, when you want to have your windows open and you are prevented from doing so, because of the noise levels from the entertainment and the patrons.
- 2. As a resident of Park Road, Crouch End I am dismayed to discover that the owners of the refurbished Princess Alexandra pub are seeking a late license to open until 2am Monday to Thursday and until 3am Friday to Sunday.

Having lived with the disruption caused by the late opening of Bar Apogee over the last year or so it is hugely concerning to learn that another establishment only yards away may also be eligible for a late license.

Over the past year I have been woken from my sleep by people leaving Bar Apogee in the early hours of the morning which is some feat given that my bedroom is at the back of my home and does not overlook the road. On numerous occasions fights have broken out between people leaving the bar. The most recent, a couple of months ago, almost caused me to call the police as those involved were fighting in the street and creating an obstacle for passing motorists.

I no longer park my car on the road across from Bar Apogee at the weekends as on numerous occasions during the past 2-3 months I have found my wing mirrors completely detached from my car and thrown to one side on the pavement.

I have been unhappy with the noise levels from Bar Apogee for some time and have considered writing to the council before now but unfortunately I have dragged my feet on the issue. The prospect of another establishment having the same rights has compelled me to do so now.

As a professional I frequently leave my home at 6am in the morning to begin my working day and to have my sleep disturbed any time after midnight is not only a great inconvenience it represents a significant detriment to my quality of life. I am writing to you with reference to the proposed new premises licence for Villiers Terrace, 120 Park Road, London N8 which I totally oppose on all grounds.

Numerous residents including both leaseholders like myself and council tenants from Veryan Court contacted the Council's noise control team on various occasions in 2007 due to excessive loud music -both live and recorded being played to gone 3am at the Princess Alexandra Pub (former name of new proposed pub) on Friday, Saturday and Sunday nights in particular, screaming and shouting both outside and behind our block of flats, people going to and from the car park (illegally as it supposed to be for residents only) making vast amounts of noise and fighting, leaving rubbish, urinating at the back and front of the block etc

The noise control team issued a warning to the landlord as they witnessed the unacceptable volume themselves via Flat No 9's complaint.

I have learnt that the landlord of this new terrace is planning on applying for planning permission for 2 floors of outside space -to maximise capacity.

I find it incredulous that the landlord has the nerve to request such anti sociable hours in a totally residential area, surrounded on all sides by residents, most of which are council run buildings without double glazing. Noise carries a great deal and it is very distressing trying to get to sleep with such disturbances, having to call up the noise team, wait for them to call back etc.

I have to pay a staggering £131 a month in council taxes, along with a excessive service charge and I should, along with everybody else, be entitled to a decent night sleep without feeling in fear of a noisy night ahead.

It is not acceptable in such a densely populated area where there are a mixture of families, old people and people who work throughout Mon-Sunday to have to put up with an venue being open till 2am Mon-Thurs and then till 3pm Fri -Sunday.

The previous landlord's bouncers made no attempt to control the behaviour or noise of people leaving the pub nor would the landlord ever turn the music down -even with the door shut, the bass sound was pounding in on the 4th floor where I am situated. This is totally unacceptable.

Annex 1 - Mandatory Conditions

Section 19 - Supply of alcohol

- (2) No supply of alcohol may be made under the premises licence-
- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (3) The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Section 21 - Door supervision

At specified times one or more individuals must be at the premises to carry out a security activity and each of these individuals must be licensed by the Security Industry Authority.

Annex 2 - Conditions consistent with the Operating Schedule

THE PREVENTION OF CRIME AND DISORDER

A digital Closed Circuit Television System will be installed and maintained on the premises.

The CCTV system will be recording at all times when the premises are open and the recordings shall be made available to the police and the council on request.

A minimum of three members of staff will be present between 21.00 and the closing of the premises.

PUBLIC SAFETY

Fire safety equipment will be checked regularly and any requirements made by the Fire Safety Officer will be complied with.

The total number of persons accommodated at any one time within the premises shall not exceed 140.

The doors or gates in the following locations shall be locked back in the open position whilst the premises are occupied and notices shall be exhibited adjacent thereto worded: "THIS DOOR TO BE KEPT LOCKED BACK OPEN WHILST THE PREMISES ARE OCCUPIED"

- The outer front door lobby to the main entrance.
- The rear yard door onto Park Road.

All Certificates required by the Council to be submitted promptly when they become due.

THE PREVENTION OF PUBLIC NUISANCE

Signs will be displayed at the exit reminding customers to leave quietly and respect the neighbours.

Staff will call Taxis/mini cabs for the use of customers leaving the premises when requested to do so.

THE PROTECTION OF CHILDREN

All staff will be trained that alcohol will only be sold to persons who can produce photographic identification where there is any doubt that they are over the age of 18.

Persons under the age of 18 will not be permitted to use Gaming machines.

Alcohol may only be sold to individuals over the age of 18 with valid proof of identification with one of the following:

- A valid passport
- A photo driving license issued in a European Union Country
- A proof of age standard card system
- A citizen card, supported by the Home Office

If any licensed doorman or member of staff of the premises has any doubt as to the age of any potential patron, then that person will be refused entry.

Annex 3 - Conditions attached after a hearing by the licensing authority

- (i) That the standard mandatory conditions are enforced.
- (ii) That the recommendations of the Child Protection Agency are enforced.
- (iii) That front and back outside areas be closed to use by the public everyday at 23:00.
- (iv) That on Friday and Saturday nights from 22:00 there be a minimum of two SIA approved door staff until the close of the premises to control the entry and exit of customers.
- (v) That a noise management plan be submitted by the applicant to the Council Noise Team and approved by the Council prior to the coming into force of this licence.
- (vi) That the reference to opening at 07:00 on the occasion of live televised sporting events as set out at boxes M and O of the operating schedule be completely deleted.
