2 Executive Summary

6. Licensing Committee

- 6.1 The full Council appoints the membership of the Licensing Committee including its Chair and Vice-Chair. By law there must be at least 10 but no more than 15 appointed Members. The Committee can still meet and undertake its business with a quorum of 4 Members.
- 6.2 The Council can determine the terms of reference of the Committee. These are currently set out in Part 3 C of the Council's Constitution and remain unchanged.

7. Establishing the Licensing Sub-Committees

- 7.1 The Licensing Committee established its 3 Sub-Committees (A, B and C) on 22 May 2008 (see appendix 1) following the appointment of Members of the Licensing Committee by Full Council on 19 May 2008.
- 7.2.1 Following the recent change of Membership of the Licensing Committee from the Liberal Democrat Group – Councillor Scott replacing Councillor Baker as Member, and as confirmed by Full Council on 24 November 2008, there is a subsequent vacancy on the Licensing Sub-Committee 'C' and therefore it is for the Licensing Committee to appoint to that vacancy.

8 Recommendations

- 8.1 That the Committee note the appointment of Councillor Scott to the vacant position as a result of the resignation of Councillor Baker from the Licensing Committee as confirmed by Full Council at its meeting on 24 November 2008;
- 8.2 That the Committee consider and appoint to the current vacancy on its Licensing Sub-Committee C.
