<b>1. Purpose of the report</b>	
1.1 To review business permit charges to ensure that they are proportionate and to support businesses in the current economic climate.

3.1 Recommendations in this report link to priorities in Haringey's Community Strategy ('economic vitality and prosperity shared for all ') which commits the Council to support local businesses.	
<b>4. Recommendations</b>	
<ul style="list-style-type: none"> <li>▪ That the Cabinet Member for Environment and Conservation agree to reduce the business permit charge to a standard £200. This charge also to apply to second and subsequent permits.</li> <li>▪ To authorise officers to make the necessary changes to traffic management orders</li> </ul>	

- That the Cabinet Member for Environment and Conservation agree that a further review of Business charges be undertaken in October 2010 to evaluate the impact of this reduction in charges.

#### **5. Reason for recommendation(s)**

5.1 The take up of business permits across the borough is relatively low, however in a very small number of locations demand currently exceeds capacity. Businesses feel that in general take up is low due to the charges that apply to those permits. They asked that the Council reduce those charges to assist them in the current economic climate.

#### **6. Other options considered**

6.1 The other option considered was to continue with existing charges as they have not been increased over the past 3 years and compare reasonably well with other boroughs. However the council is committed to introducing measures to support businesses through the current economic difficulties.

#### **7. Summary**

7.1 The Council's business permit scheme applies to all commercial businesses located in the borough's existing CPZ's. Those permits are issued to businesses who

- require regular and unavoidable use of a vehicle to run their business
- transport bulky and, or high value goods on a regular and unavoidable basis
- work unsociable hours (when public transport is not readily available)

7.4 Permits are not issued just for employees travelling to work (unless these journeys need to be made at unsociable hours). Business permit holders are not allocated a specific bay, but may use any of the business bays provided within that CPZ.

7.5 The current charges of the Business Permits are as detailed below:

- Green/Electric Vehicles - £ Free of charge
- First Permit: Wood Green & Green Lane Zones - £300
- Second & Subsequent Permits - £400
- First Permit: All Other Zones - £225
- Second & Subsequent Permits - £300

7.6 Business permit charges in neighbouring boroughs are detailed in appendix 1.

7.7 The below table provides full details of the number of business bays (including shared business / residents bays) available across the borough and the number of permits currently in issue by the Council.

7.8 It is proposed that all business permit charges are reduced to £200 per annum.

## 8 Chief Financial Officer Comments

8.1 Although it is proposed to reduce all business permit charges to £200 per annum, the service estimates that annual income will remain at £44k as take up is expected to increase. This will be monitored through the budget management process.

## 9 Head of Legal Services Comments

9.1 The Road Traffic Regulation Act (1984) makes provision for local authorities to charge for parking and vary those charges. Amendments to the relevant traffic orders will be required when changes to the existing parking scheme are made.

## 10 Equalities & Community Cohesion Comments

10.1 Proposals in this report will support businesses during the current economic climate.

## 11 Consultation

11.4 Statutory Consultation will be undertaken before changing charges, which requires the Council to notify its intentions in the London gazette, local press and on site where changes to charges are proposed.

## 12 Service Financial Comments

12.4 The business permit scheme currently generates £44k annually. It is expected that the reduction in charge will be revenue neutral as take up of business permits increases.

12.5 There are currently 127 permits in issue, which give an average permit charge of £346. In order to maintain the existing level of revenue the Council would need to issue an additional 93 permits annually.
