7. Summary

7.1 The Committee has previously agreed to commission a scrutiny review on improving the sexual health of teenagers chaired by Councillor Bull. Following consideration by panel members and consultation with relevant stakeholders, a scope, terms of reference and a work plan have been developed.

7.2 The review will focus on prevention and the promotion of good sexual health and will aim to contribute to the development of the new sexual health strategy for the Borough. It will obtain its evidence by considering relevant documentation, including statistics and interviewing a range of stakeholders. In addition, it will aim to obtain the views of young people and service users, both potential and actual.

8. Chief Financial Officer Comments

16. Report

Aims/Objectives of Review

- 16.1 It is proposed that the review will focus on what the Council and its partners currently do to promote and improve the sexual health of teenagers with the Borough. This will include what is done to reduce the levels of sexually transmitted infections (STIs) and conceptions. Rather than focus on what happens to young people when, for example, they become infected with a STI or pregnant, it is proposed that the review concentrates instead on the issue of prevention and the promotion of good sexual health.
- 16.2 A scrutiny review on teenage pregnancy took place on in 2005/6 and this covered several issues relating to conceptions that will be directly relevant to this review. In 2006, NHS Haringey made changes to the Family Planning Service in response to budgetary pressures. These proposals were considered in detail by the Overview and Scrutiny Committee. It is suggested that both of these areas be revisited to see what changes have taken place since the previous review and their outcomes and impact.
- 16.3 There are two targets within the Local Area Agreement (LAA) that are directly relevant to the areas to be covered by the review:
- NI112; Rate of under-18 conceptions (per 1000 girls aged 15-17 as compared with the 1998 baseline rate). The target is - 5%, Current performance shows an increase of 14.4%.
 - NI113: Prevalence of Chlamydia in under 20 year olds. This target relates to the percentage of young people being screened. The target is 15%. Current performance is 15.7%.
- 16.4 NHS Haringey will be revising and updating the sexual health strategy and this process has started with the development of an updated needs assessment.
- 16.5 The Chlamydia positivity rate for young people under 25 who were screened as part of the National Chlamydia Screening Programme (NCSP) was 8.9% in Haringey in 2007/8, which is the 23rd. highest rate in London. This gives a general indication of the possible prevalence of the disease amongst those tested. Current figures – quarter 4, 2008/9 - for the number of under 20s being screened are 15.7% against a Department of Health target of 15%.
- 16.6 The most recent (2007) under 18 conception rate is currently 70.0 per 1000 female population which represents an increase of 12.4% against the 1998 baseline. This compares against a London wide rate of 45.6 per 1000. Haringey is the only borough classified as inner London to have shown an increase in rates since 1998 but both Lambeth (74.4) and Lewisham (70.6) still have higher overall rates of

conception despite a reduction since 1998. Some boroughs, such as Hackney and Hammersmith and Fulham, have seen particularly large reductions – 25.9% and 26.5% respectively.

- 16.7 The picture for outer London boroughs is different from that of inner London, with 8 boroughs showing increases since 1998, with some of these as high as 23.0% (Barnet) and 19.6% (Redbridge). These nevertheless have to be viewed in the context of, with a few exceptions, generally lower overall conception rates. There is a clear link between deprivation and teenage pregnancy figures which appears to be mirrored within conception rates but not the changes in rates that have taken place since 1998.
- 16.8 There are 4 community contraceptive clinics within Haringey. Each has two weekly sessions of which approximately half are held in the evening. The 4YP service is aimed at young people under the age of 18 and provides information on sexual health and contraception, free condoms and pregnancy testing. All community contraceptive clinics and 4YP drop-ins offer pregnancy testing. There is a condom distribution scheme targeted to reduce HIV transmission operated through the voluntary sector and NHS Haringey provider services. The scheme is to be extended with the introduction of a scheme for young people. There is an Emergency Hormonal Contraception (EHC) scheme within the Borough which operates with participating pharmacies.
- 16.9 Sex and Relationship Education (SRE) is undertaken in schools. The biological element of this is part of the national curriculum for science and parents cannot withdraw their children from this. However, SRE outside of science is discretionary. Teachers cannot be compelled to teach it and parents have the right to withdraw their children.
- 16.10 There is a Haringey Teenage Pregnancy Prevention Strategy and Action Plan. This is delivered through a number of different agencies and services from the Children's Trust including:
- NHS Haringey
 - The Children's Service
 - Connexions
 - 4YP
 - Schools
 - Colleges of further education
- 16.11 A joint three year sexual health strategy was published by NHS Haringey and the Council in 2005 which set out a vision, principles, a framework for sexual health services delivery and a model for an integrated sexual health network. The strategy is now due to be revised and the timing of this provides an opportunity for the scrutiny review to influence it.
- 16.12 The process is being initiated through a needs assessment for the Borough. This will:
1. Assess need and develop a baseline picture of sexual health and service provision in Haringey.
 2. Assess service capacity and capability, including mapping of services.
 3. Engagement with the local community

As one of the 21 boroughs identified as having high and or increasing numbers of teenage conceptions you were focused on to develop an evidence based, focused work plan. Beverley Hughes Minister for Children, Young People and Families and Dawn Primarolo minister for Public Health wrote to your chief executive and the Teenage Pregnancy Strategy Board on the 2nd April 2008 and invited you to a meeting to help you strengthen the implementation of your local strategy and share the learning from high performing areas and the Department of Health Teenage Pregnancy National Support Team. The meeting focused on three key issues:

- i) The ten key factors for effective teenage pregnancy strategies – and their links to other programmes aimed at young people;
- ii) Maintaining the priority of teenage pregnancy within Children’s Trust arrangements and an integrated youth support service;
- iii) The use of local data to improve the targeting of young people most at risk and to collect more timely data on conceptions through local abortion and maternity services.

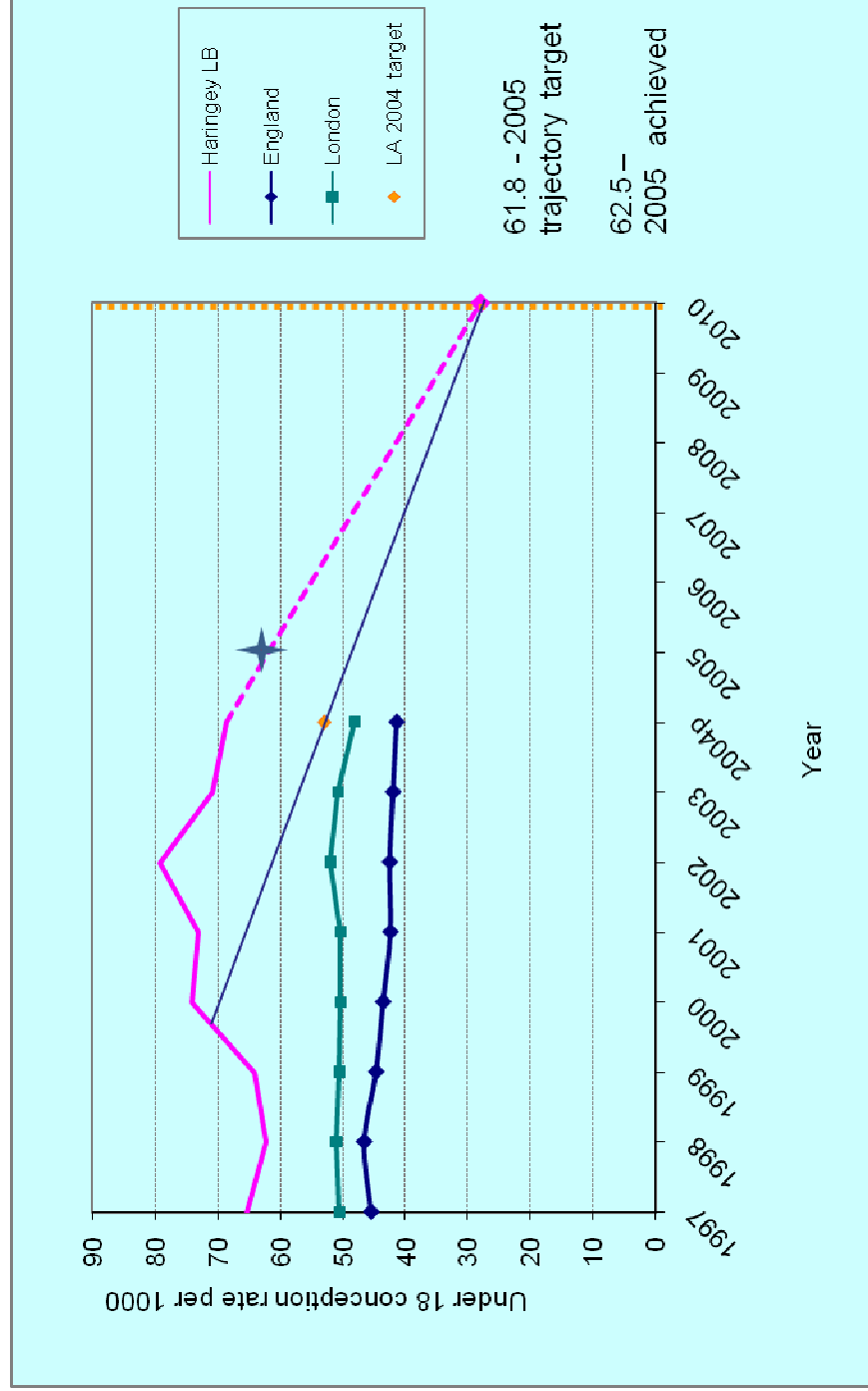

Under-18 Conceptions – 5 year trend summary

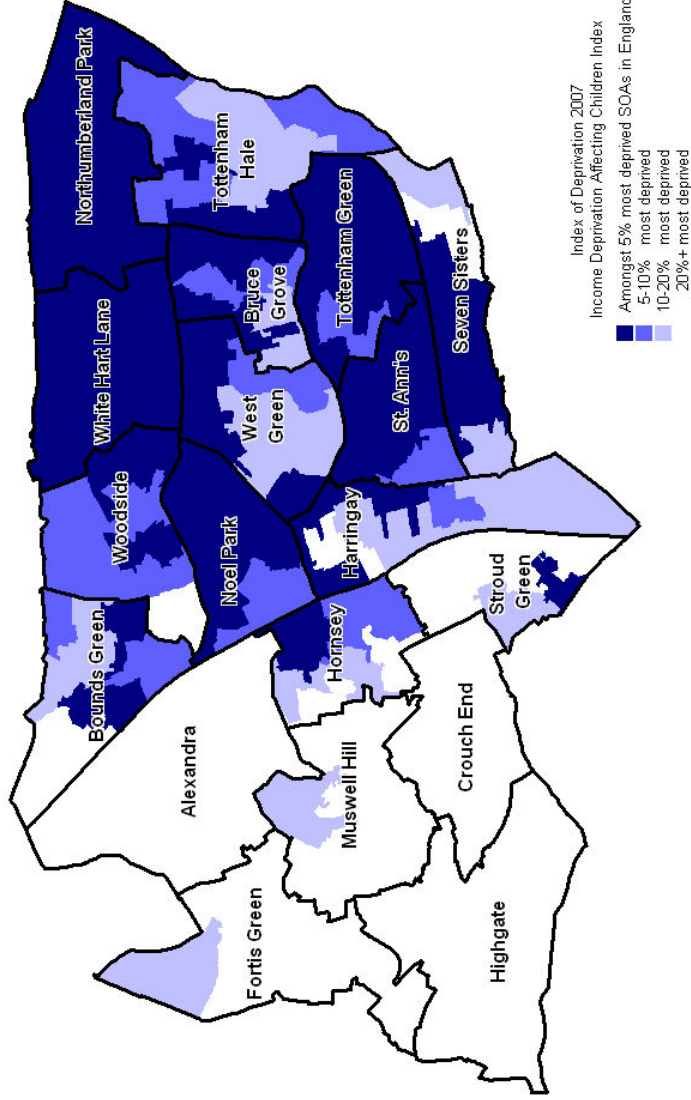

Income Deprivation Affecting Children Index (IDACI) IMD 2007

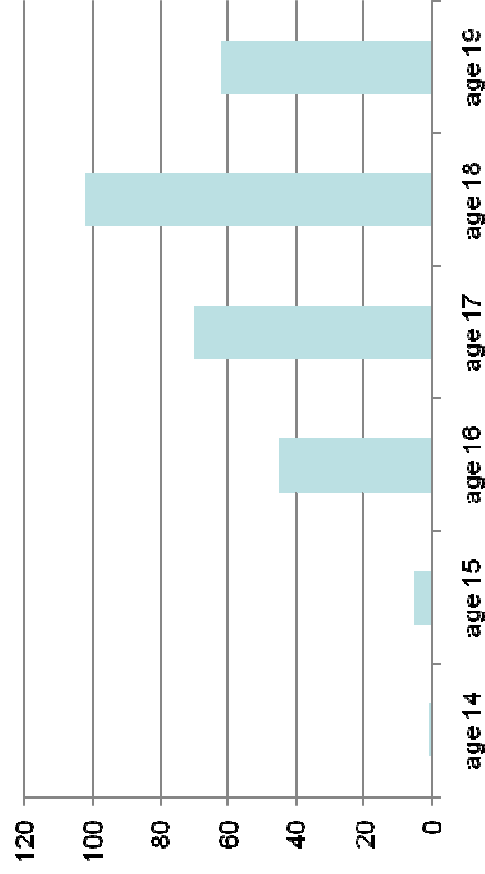
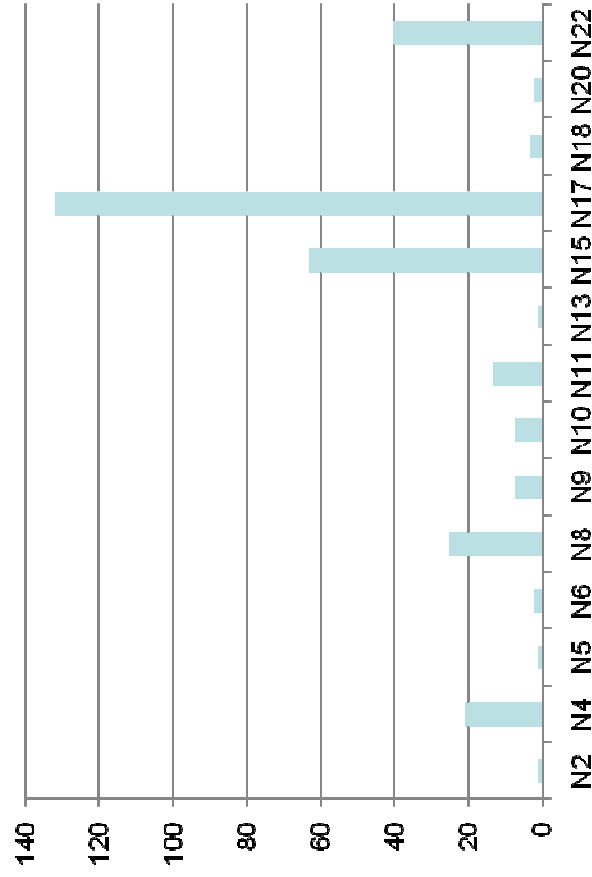

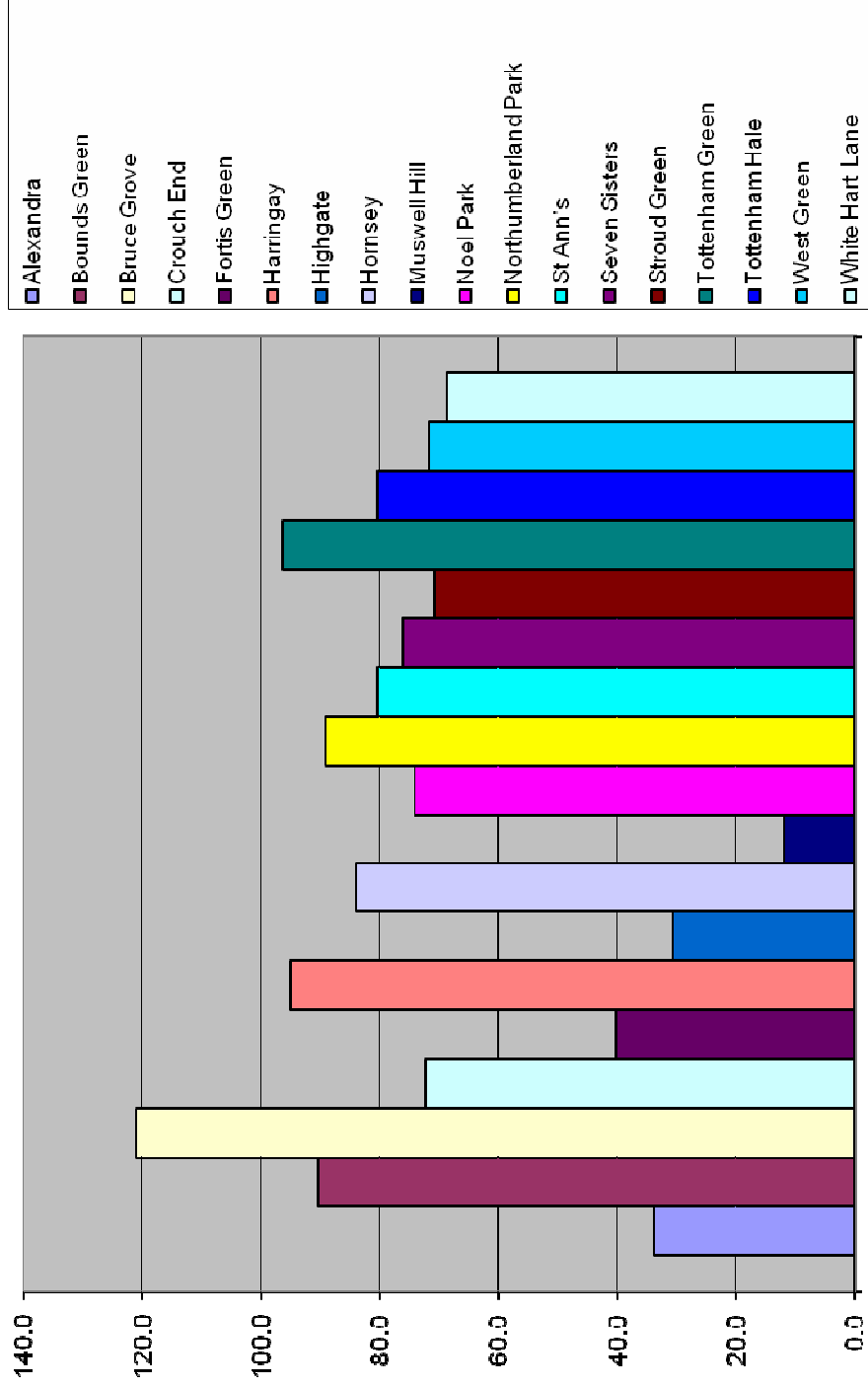

HARINGEY EMERGENCY HORMONAL CONTRACEPTION SCHEME

PRELIMINARY PROJECT REPORT FOR 2008/09

This report provides a brief summary of the activity of the emergency hormonal contraception scheme, funded by Haringey PCT and being implemented in Community Pharmacies across Haringey.

1. BACKGROUND

The 4YP EHC Scheme started in September 2002 and originally funded by a £75,000¹ grant from the Department of Health in support of local and governments strategies aimed at reducing teenage pregnancy rates in England and Wales, the U.K. having the highest teenage pregnancy rate in western Europe.

¹. The funding was provided for a joint scheme for both Enfield and Haringey

2. AIMS AND OBJECTIVES OF THE SCHEME

The aim of the Emergency Hormonal Contraception (EHC) Scheme is to provide EHC free of charge to women, up to the age of 18 in Haringey. This service forms part of the Teenage Pregnancy and Parenthood Strategy and is aimed at contributing to the reduction of conceptions (and terminations) in teenagers in the borough by:

- Providing EHC free of charge to women between the ages of 13 and 18 (inclusive).
- Increasing awareness and access to EHC of young women.
- Giving young women informal and confidential advice on contraception/sexual health, by trained community pharmacists, on their local high street.
- Increase partnership working and improve communication between pharmacists and other Healthcare professionals.
- Refer young women to GP/Family Planning Clinics (FPC) where appropriate.

3. THE PARTICIPATING PHARMACIES

During 2008/09 this scheme had 18 participating community pharmacists across the borough. 27 EHC trained pharmacists. Pharmacists who were interested in taking part in the scheme were recruited on the following criteria:

- Had successfully completed the training.
- Had an area within their Pharmacy suitable for confidential consultations.
- Were opened evenings and weekends.
- Had empathy with the scheme.

Particular attention was paid to make sure pharmacists were recruited in all areas of the boroughs and particularly in those areas with high rates of teenage pregnancy.

Initially pharmacists were trained in the supply of EHC under a Patient Group Direction (PGD) and following the guidance on best practices in the supply of EHC set out by the Royal Pharmaceutical Society. The training was undertaken principally by the Pharmaceutical Advisers at the PCTs.

During the period covered by this report no new pharmacies were recruited onto the scheme² however, a number of new pharmacists were trained to maintain adequate cover in all of the 18 advertised pharmacies participating on the scheme.

From December 2008 thirteen of the pharmacies on the scheme also provided free Chlamydia test kits to clients as part of a national strategy.

²The scheme currently has participating pharmacies throughout the borough and the scheme has concentrated on further developing these pharmacies rather than expanding the number of pharmacies providing the service.

4. THE CONSULTATION

Client between the ages of 13 to 18 requesting EHC under the scheme were assessed by the participating pharmacist. Those clients who meet all the criteria set by the Patient Group Direction were supplied with Levonelle-1500. Those clients under the age of 16 who were assessed as being 'Gillick competent' following the ruling of the House of Lords in *Gillick v West Norfolk & Wisbech Area Health Authority* [1985]. As part of the consultation the clients were asked to provide information outlined in the proforma/assessment sheet. All consultations were treated as confidential³ as is data regarding any individual client. In addition to information regarding EHC clients were also advised on long-term contraception and sexually transmitted diseases (if appropriate). Where the pharmacist, on the basis of information supplied was uncertain that EHC should be supplied, the client was referred to a GP or FPC. All clients were supplied with a patient pack containing further literature on contraception and sexually transmitted diseases as well as condoms.

³Rights to confidentiality may be overrule where a pharmacist believes that a young person is being exploited or abused, or in some danger of so being.

5. PUBLICITY CAMPAIGN

Publicity for the scheme was handled by the teenage pregnancy team at Haringey Council and by the sexual health team at Haringey PCT.

6. PROFORMA ANALYSIS OF CLIENTS REQUESTING EHC FROM HARINGEY PHARMACIES

During the year a total of **1080** clients requested EHC from participating pharmacies in Haringey, of these, 1069 (99%) satisfied all the requirements of the PGD and were supplied with Levonelle-1500. Clients not satisfying all the requirements were referred to either their G.P or to a Family Planning/Sexual health Clinic.

Day of consultation

Clients requested EHC through this scheme with regular frequency on all days of the week, with the exception of Mondays and Sundays. Less than 1% of clients requested consultations on a Sunday reflecting the lack of accessibility on this day (only one of the participating pharmacies is regularly opened on this day). This probably explains the apparent rebound on Mondays, which is the busiest day of the week. Interestingly nearly 50% of the requests for EHC on a Monday were from clients that had unprotected sex more than 48 hours before.

Age of clients

The scheme was originally designed to cater for clients up to the age of 21. However, due to budget limitations it was decided by the Contraceptive Services Sub-Committee to reduce the age limit to under 19. This change in policy was slowly implemented from January 2003. This scheme continues to allow pharmacists to exercise their discretion in exceptional circumstances when providing EHC to clients who fall outside the prescribed upper age limit.

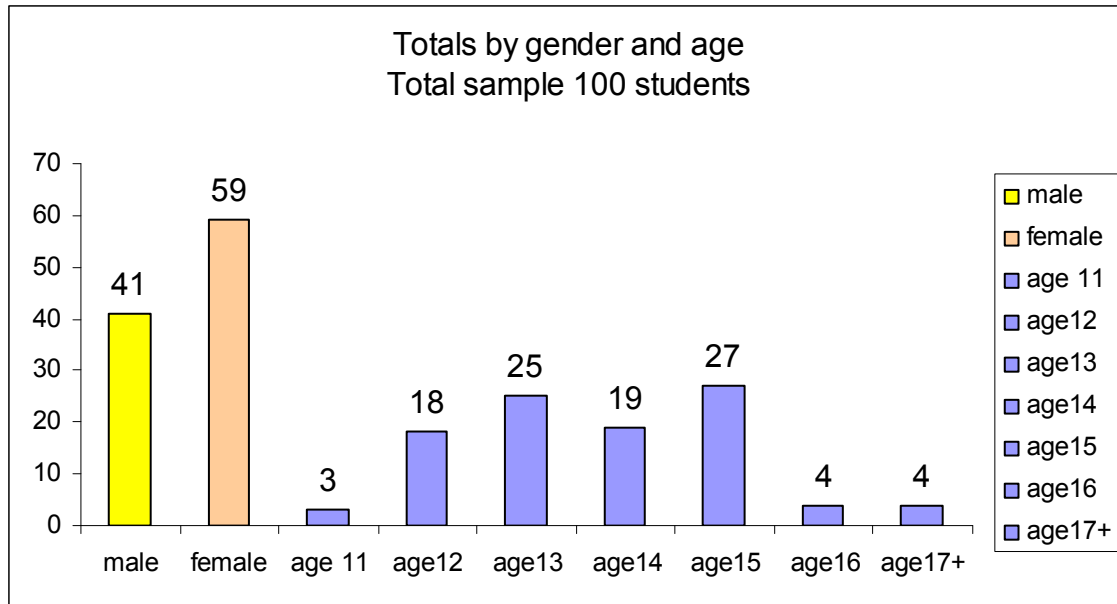
Introduction and summary of findings

Survey Sample

100 young people participated in the survey. All were elected members of their school council and were spread across the 11 to 18 age range. The survey was undertaken over a period of the Summer term 2008. Eight schools participated in the survey:

Alexandra Park School (10)
Gladesmore Community School (9)
Highgate Wood School (10)
Hornsey School for Girls (6)
Northumberland Park Community School (8)
Park View Academy (11)
St Thomas More Catholic School (24)
Woodside High School (22)

Numbers participating are shown in brackets. 41 males and 59 females participated in the survey. A gender and age breakdown is shown below.



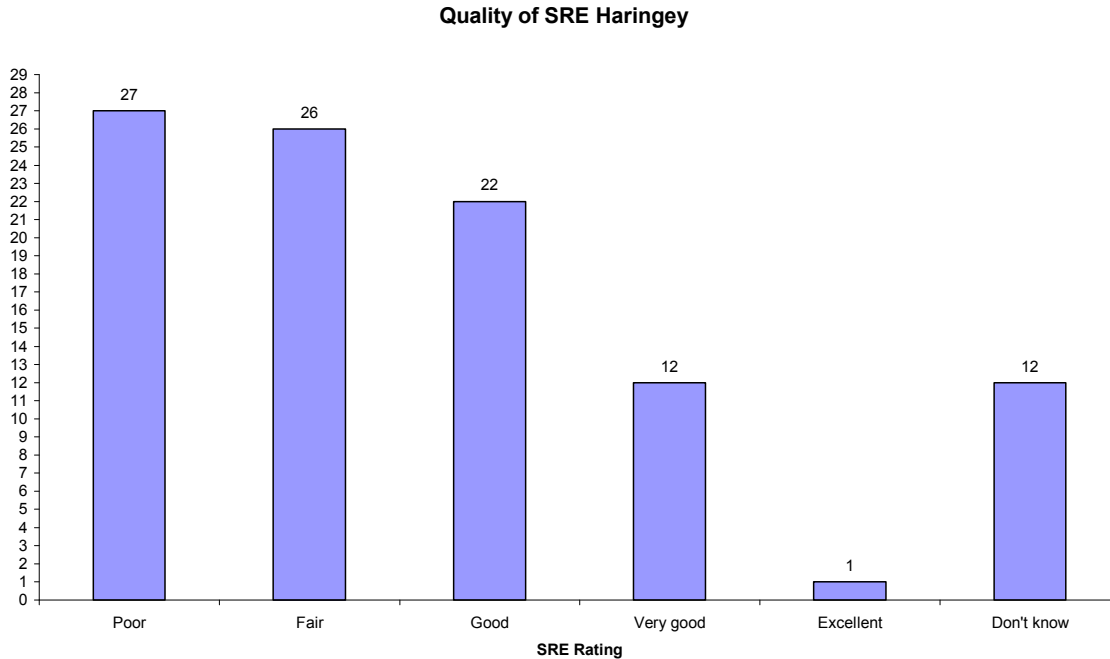
Survey aims

The broad aims of the survey were to gather information from a representative sample of secondary school students to find out about the key issues and skills they had learned in Sex and Relationships Education lessons, what they would like to learn, how they would like to learn and to gather views about the quality and usefulness of lessons. We also wanted to find out about their knowledge of and use of sexual health services.

The outcomes of the survey will help shape professional development training and pupil support. It is also intended that the survey findings will contribute to fine tuning our teenage pregnancy and sexual health strategies. A copy of the questionnaire which was partly informed by the Sex Education Forum's *Are you getting it right?* (A toolkit for consulting young people on sex and relationships education), is at the end of the report.

Survey findings

The headline results show that 46% found their SRE useful while 47% did not. In terms of the quality of SRE on a range from poor to excellent the spread was:



We asked participants about the subjects they had learnt about. The most common five topics were human reproduction, puberty, sexually transmitted infections, peer pressure and contraception. When asked what they would like to learn about the most important five topics were Being a parent, self awareness and emotional resilience, strategies for making choices, managing risk and assertiveness skills and same sex relationships. The emphasis on aspects of relationships issues and emotions reinforces the findings of the UK Youth Parliament 'Are You Getting It? Report (based on a survey of over 21,000 young people nationally).

We also asked students how they would like to learn. Interactive and participatory approaches came out top underlining the importance of making lessons active and varied in the style of delivery. The top preferred learning approaches were DVD/Film, visiting speakers/experts, debate, discussion, theatre groups and TV programmes. Least popular were textbooks and worksheets.

So far as knowledge of sexual health services is concerned 57% knew where to go for help and 67% had heard about 4YP services, while 28% had not. This indicates that information is getting across to a significant majority but a sizeable minority is not aware of the existence or location of support services.

We also asked students if they had someone in school who they could ask for advice on a sexual health problem. Only 45% said that they did know of someone they could ask for help.

Another question asked them if they had been asked for their views on sex and relationships education. Just over a quarter or 26% agreed that they had while 66% said they had not been asked. Some schools showed more positive assessment of learning or assessment for learning outcomes with a more even split, but a significant majority indicated that no consultation had been undertaken with students.

When asked for ideas about what information they would put on a school notice board a wide variety of ideas were recorded. Many included telephone numbers of Childline, local sexual health services, 4YP, hospitals and clinics. Most participants gave some points for the board. A selection of the suggestions made follows below.

Shout Out – Haringey Youth Council November 2008

We have also included in the report the outcomes of the two workshops held at the Shout Out event on 26th November 2008 organised by Haringey Youth Council. These were attended by almost 80 students from fifteen Haringey schools and indicate what young people believe to be some key action points around Sex and Relationships Education.

These action points from the Shout Out event reinforce the findings of this survey and those of the national UK Youth Parliament survey. The TellUS 3 survey also indicated young people said they had no one to talk to about personal issues. The key points that these surveys emphasise are that young people want::

- good quality SRE in schools
- they want more emphasis on the personal relationships and emotional aspects of sex
- they want more interactive and engaging methods of pedagogy

Another key message these young people are sending to education and health planners is that they want local sexual health agencies to support their teachers and that they need more information about where they can get help and advice.

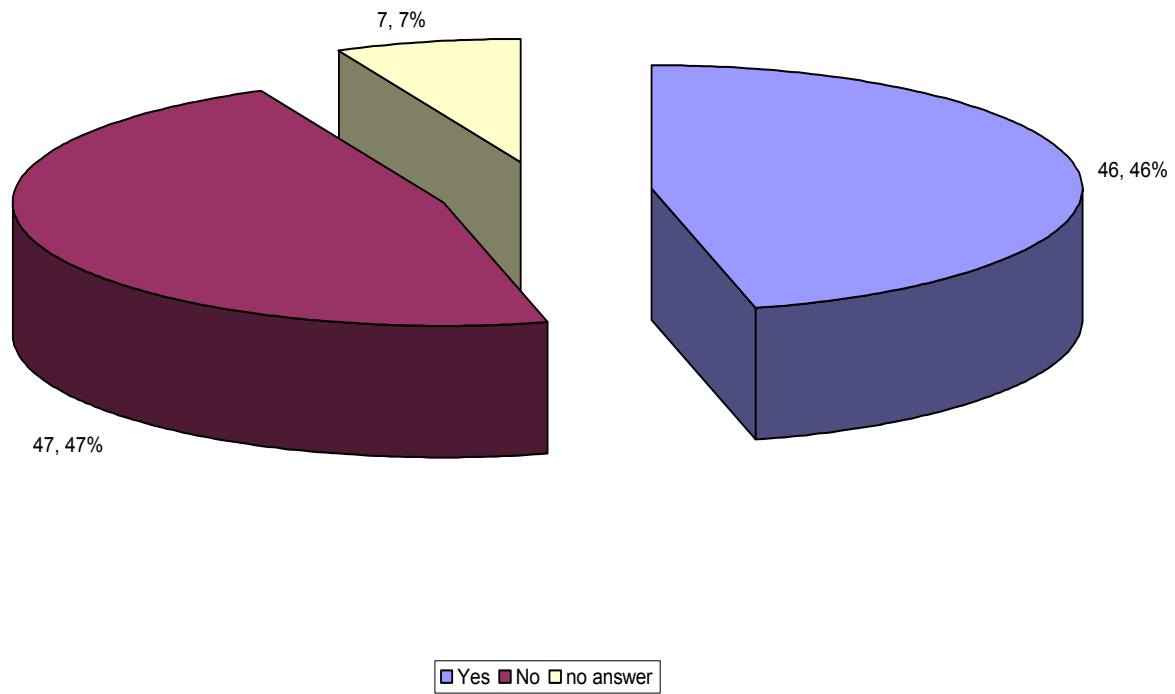

Haringey total SRE Learned

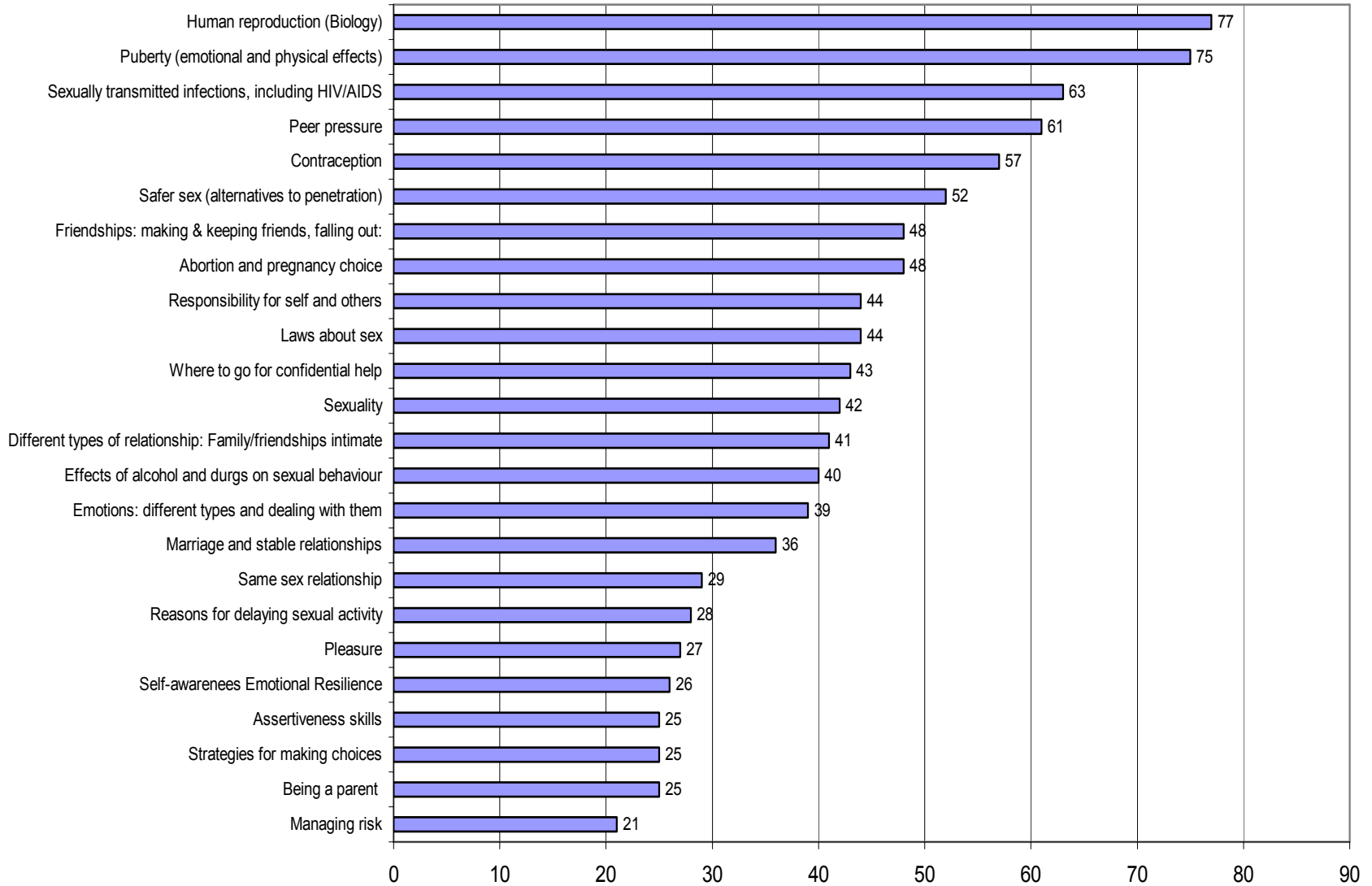

Haringey total SRE would like to learn

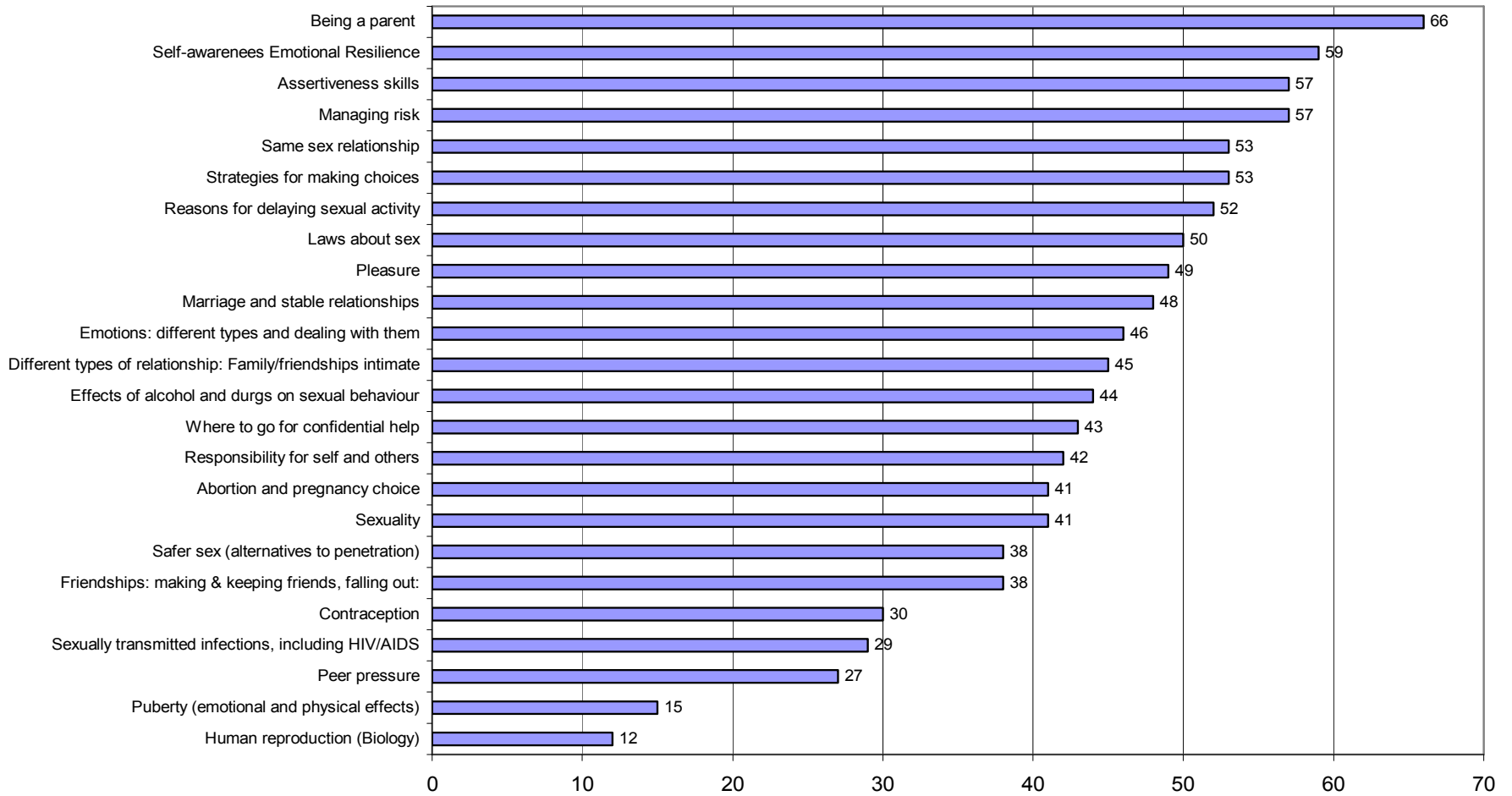

Sample 100 students - no limit of choice

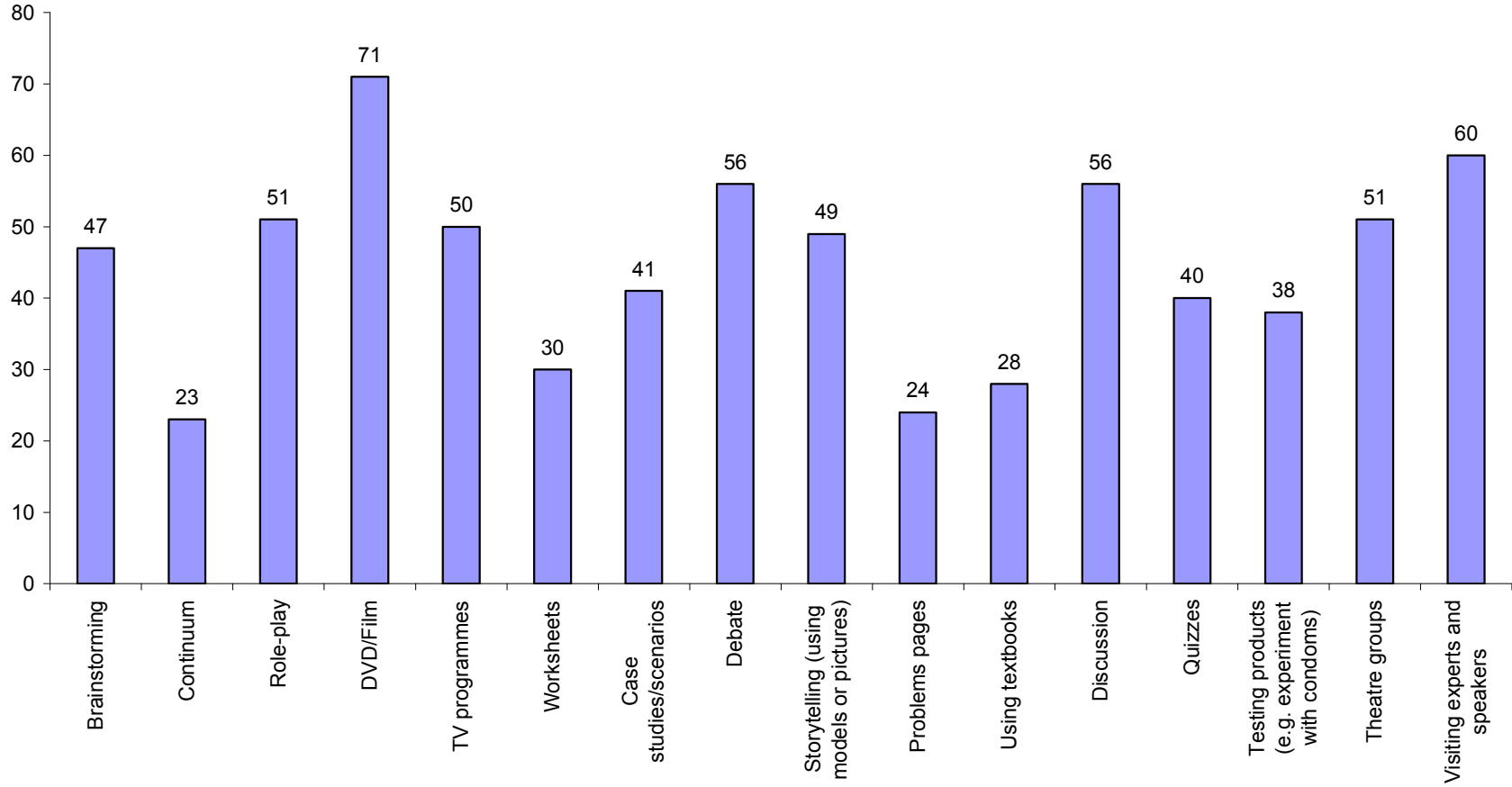

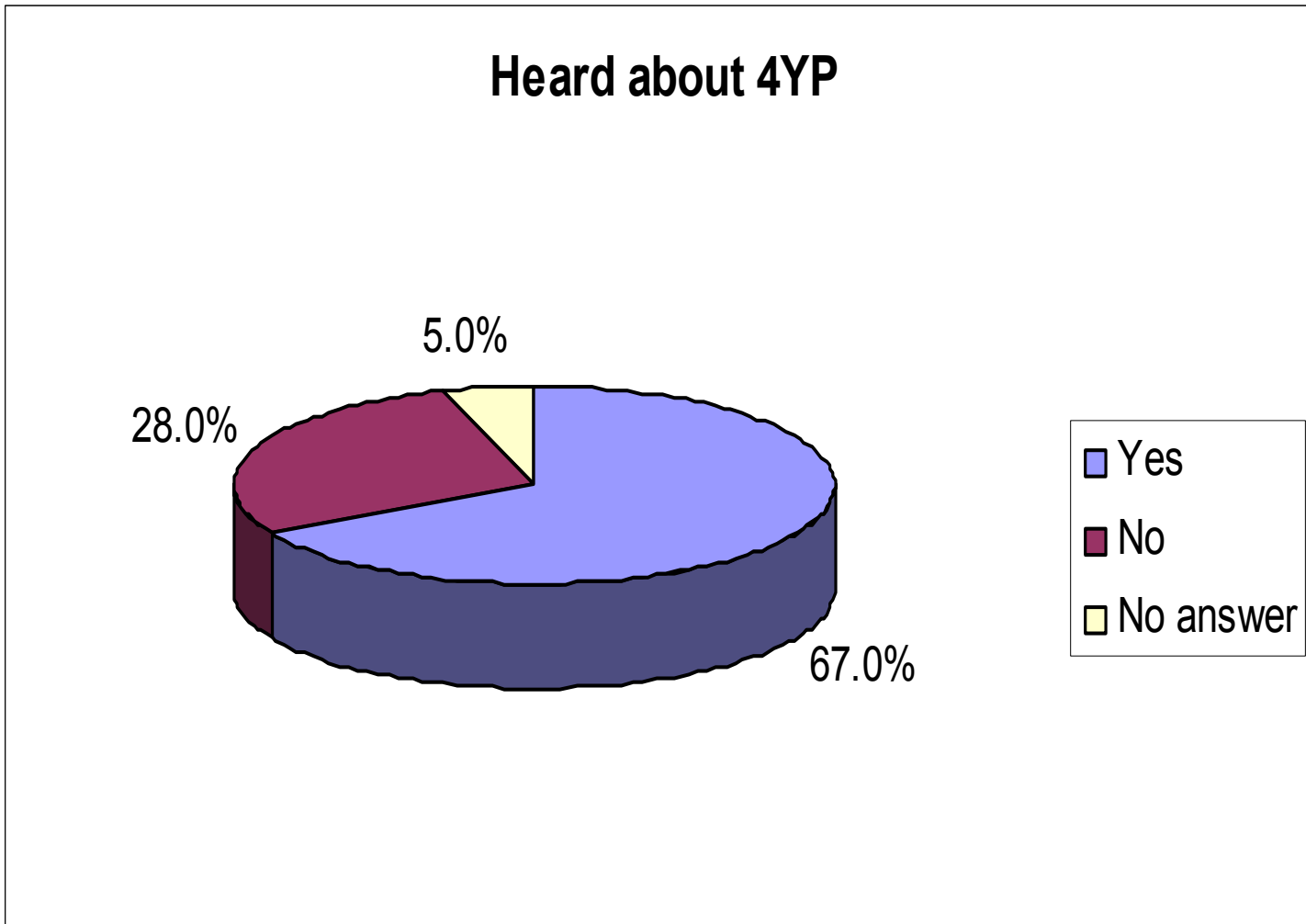
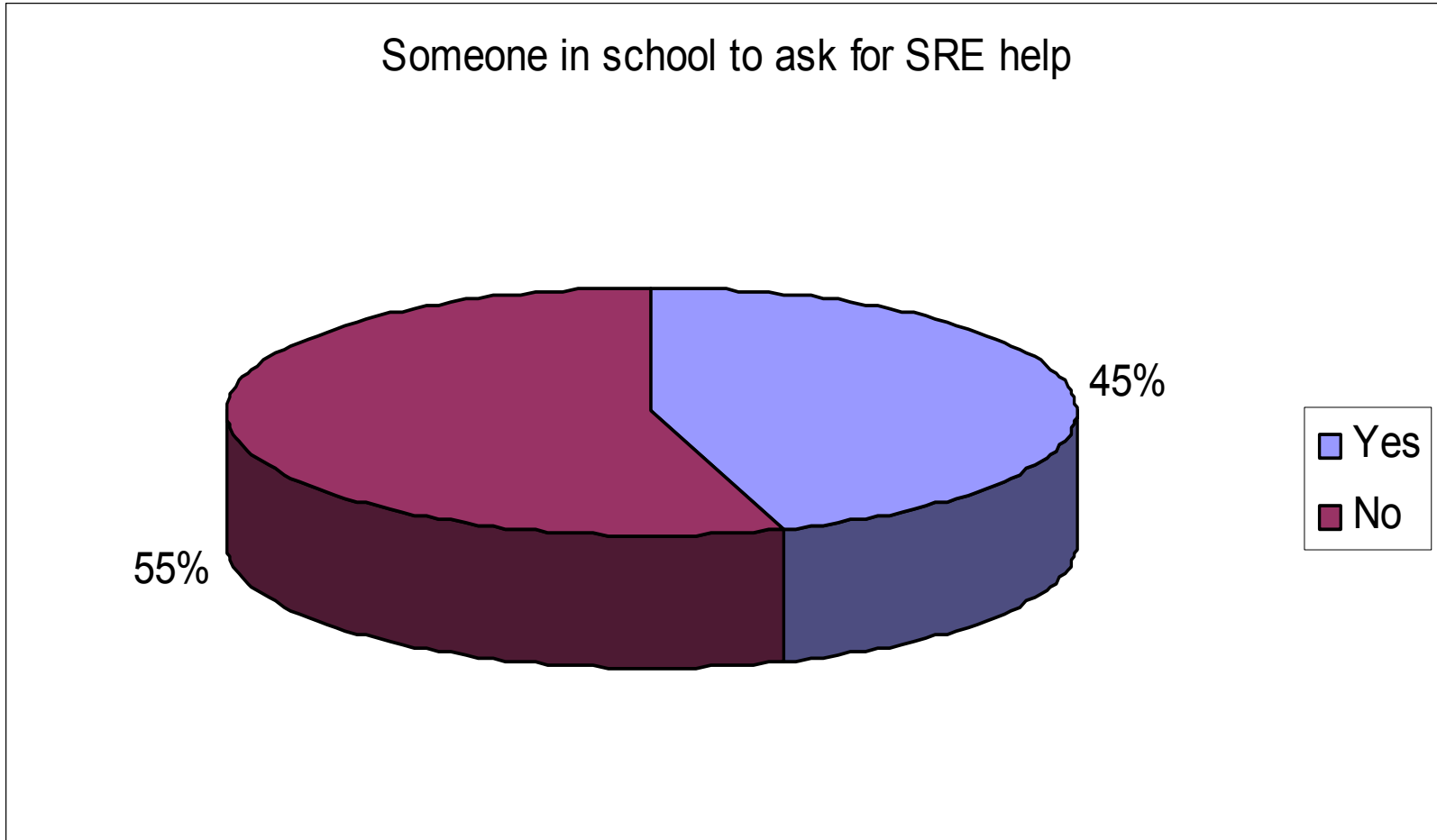

Do you know where to go for help on sex and relationships

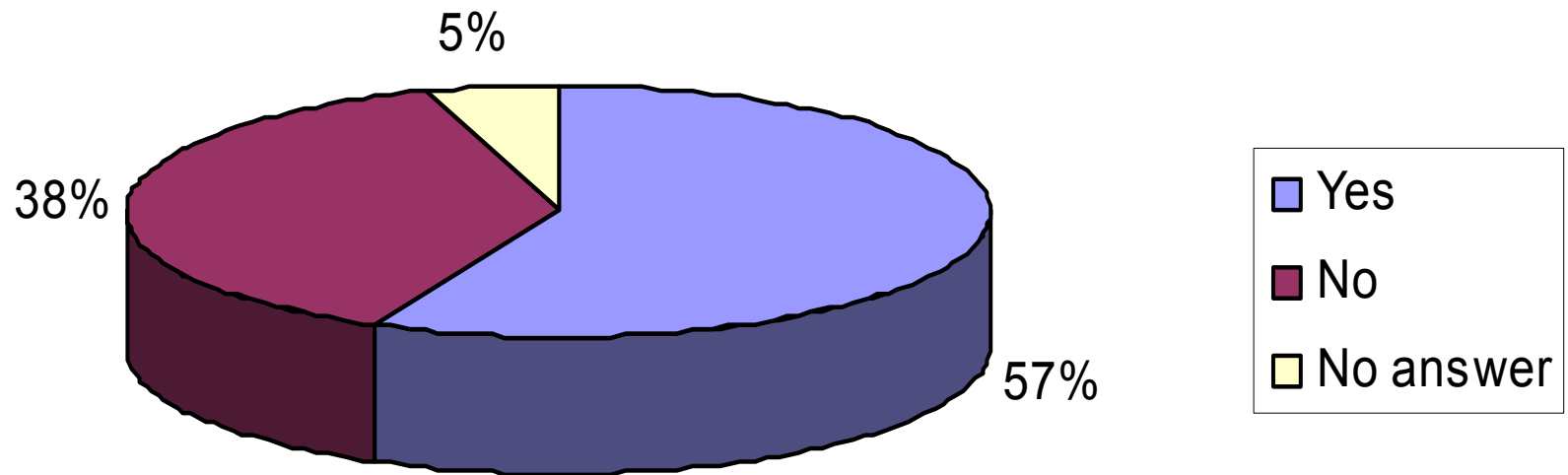

A summary report of the Health Related Behaviour Survey 2009

These results were collected from a sample of primary pupils aged 9 to 11 and secondary pupils aged 12 to 15 in Haringey during Autumn 2008 and Spring 2009. This work was funded by the Haringey Children and Young People's Service and NHS Haringey. The survey was co-ordinated by the Healthy Schools Team as a way of collecting robust information about young people's lifestyles. Teachers were informed on how to collect the most reliable data and then pupils

completed a version of the questionnaire appropriate for their age group.

Year 6 pupils completed the Primary version of the questionnaire. Pupils in Years 8 and 10 completed the Secondary version of the questionnaire. All were undertaken anonymously. A total of over 1800 pupils took part in 17 primary schools and 8 secondary schools in Haringey. The pupils at the PRU also undertook the exercise.

Completed questionnaires were then returned to SHEU in Exeter for processing

Cross-phase links


Many of the questions in each version of the questionnaire are identical or very similar. Some of the results of these questions are presented on page 6 of this document, so that behaviour can be seen across the age range.

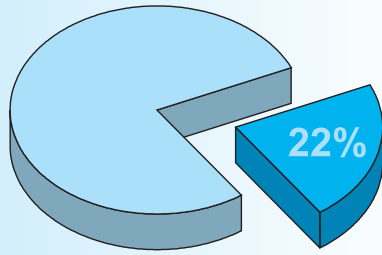

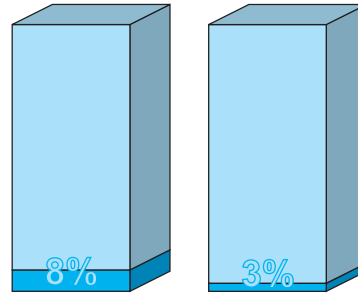

- 17% said they were 'fairly sure' or 'certain' they know someone who uses drugs (not as medicines), in the area where they live.
- 2% of pupils said that they had been offered cannabis, 2% said they had been offered other drugs.

Alcohol



8% of boys and 3% of girls said that they drank an alcoholic drink on at least one day in the week before the survey.

- 91% of pupils say that they don't drink alcohol. 2% of pupils reported that their parents 'never' or only 'sometimes' know if they drink alcohol.
- 1% of pupils drank beer or lager, 2% said wine, 1% said spirits in the week before the survey.

Tobacco

- 3% of pupils said they had tried smoking once or twice.
- 0% (1% of boys) said they had smoked at least one cigarette in the seven days before the survey.
- 79% of pupils said 'NO!' they won't smoke when they are older, 9% said 'maybe' 1% said 'yes'.

PUBERTY AND GROWING UP

When asked who the pupils had talked with about how your body and emotions change as you grow up, the top responses from a list were:

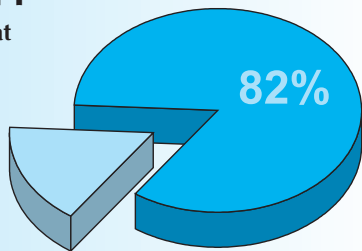
- 4% had nothing to eat or drink for breakfast on the day of the survey.
- 43% of pupils had cereal for breakfast and 40% toast or bread on the morning of the survey. 6% had Turkish breakfast, 4% had a chocolate bar or sweets.
- Pupils were asked to identify, from a list, the foods which they ate 'on most days'. 61% of pupils said they have fresh fruit and 43% said vegetables. 19% said crisps and 22% said sweets 'on most days'.
- 28% of pupils said that they 'rarely' or 'never' ate fish or fish fingers. 14% said they 'rarely' or 'never' had salads.
- 33% of pupils had eaten 5 or more portions of fruit and vegetables on the day before the survey, 7% had eaten none.
- 67% drank between 1 and 5 cups of water on the day before the survey, 28% said they had drank a litre or more while 5% said they had drank none. 90% of pupils said they can get water at school easily.
- 31% of pupils who had school meals said that they enjoy them 'most times' or 'always' 15% said 'hardly ever'.

Dental care

- 87% of pupils reported that they cleaned their teeth at least twice on the day before the survey (the recommended frequency). 1% said they did not clean their teeth at all the day before the survey.
- 31% of pupils said that they had a little pain from their mouth and teeth in the last 2 weeks 10% said 'quite a lot' or 'a lot'.

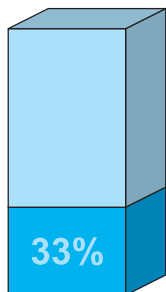
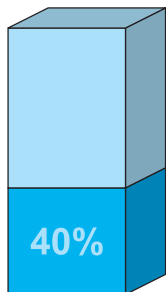
PHYSICAL ACTIVITY

- 82% of pupils reported that they enjoyed physical activities 'quite a lot' or 'a lot'.
- 71% of pupils thought that they were 'fit' or 'very fit'.
- 23% of boys and 8% of girls reported that they had exercised for five hours or more, in the last week, which made them breathe harder and faster. 29% said less than one hour.



- 13% of boys and 29% of girls said they worried 'quite a lot or 'a lot' about body changes as you grow up.
- 6% of pupils said that they wanted to know more about how boys/girls develop. 2% wanted to know more about physical aspects like spots etc.
- 60% of pupils said that they learned about puberty in Year 5, 11% said Year 4 and 29% said in Year 6.

EMOTIONAL HEALTH & WELL-BEING



- 40% of boys and 33% of girls had high self-esteem scores.
- 4% of pupils had low self-esteem scores.
- 73% of pupils said they worried about at least one of the items listed in the questionnaire.

- 91% of pupils said that their work was marked so that they could see how to improve it. 75% said they knew their targets and were helped to meet them.
- 60% said that their achievements inside and outside school were recognised.
- 46% of boys and 60% of girls spent time doing homework on the evening before the survey.

MAKING A POSITIVE CONTRIBUTION

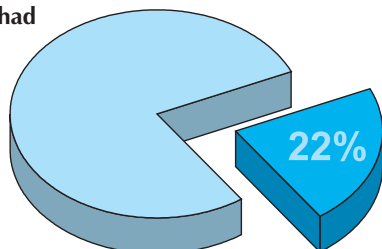
- 72% of pupils said that in their school people with different backgrounds were valued.
- 80% said that their school encouraged everyone to take part in decisions e.g. school council.
- 77% said that their school helped them to work as part of a team.
- After school yesterday, 79% of pupils spent time watching television. 36% played with friends, 51% played computer games and 33% listened to music.
- 46% played sport on the evening before the survey. 49% of pupils read a book for pleasure and 20% went to a club.
- 20% of pupils looked after someone at home the evening before the survey.

ECONOMIC WELL-BEING

- 57% report getting pocket money at least monthly. 13% said they didn't usually get any pocket money. 22% said they got money as they needed it.
- 30% received more than five pounds last time they had pocket money.

STAYING SAFE

- 3% of pupils reported that they felt afraid of going to school because of bullying 'often' or 'very often'. 20% said 'sometimes' while 77% said 'never'.
- 22% of pupils said they had been bullied once or more in the last year.
- 51% of pupils said that their school dealt with bullying well; 28% said 'don't know' and 21% said 'no it didn't'.
- The main behaviours pupils had experienced included being teased, called nasty names and being pushed/hit for no reason.
- 27% of pupils said these things happened outside at playtime/lunchtime. 26% said in a classroom at playtime/lunchtime. 14% said during lesson time.
- 27% of pupils said they had at some time been approached by adult, who scared or made them upset.
- 48% of those who had been scared by the approach of an adult, said they knew this person.
- 9% of pupils said they told an adult straight away while 9% said they kept it to themselves. 2% told the police.
- 72% of pupils have a bike, of those, 26% wear a safety helmet 'whenever possible'. 51% of cyclists said that they felt safe cycling on the roads 'most times' or 'always'.
- 85% of pupils wash their hands with soap 'whenever possible' after visiting the toilet.



SIGNIFICANT DIFFERENCES BETWEEN THE HARINGEY SURVEY AND THE SHEU REFERENCE SAMPLE

For most of the questions in the questionnaire, Haringey primary pupils give similar responses to the wider SHEU data. Some differences (more than 5%) include:

- Haringey pupils are less likely to describe themselves as White British compared with the wider sample.
- 19% of Haringey Year 6 pupils said that they had fruit for breakfast. This is higher than that seen in the wider sample. They are also more likely to have toast or bread for breakfast.
- Haringey Year 6 boys in particular are more likely to select healthy food choices compared with boys in the wider sample. More in Haringey eat fresh fruit and salad regularly and less have chips or roast potatoes 'on most days'.
- Haringey pupils are less likely to fear going to school because of bullying. 23% said they were worried at least 'sometimes'. This is lower than that seen in the wider sample.
- After school the day before the survey Haringey pupils were more likely to read a book for pleasure and do homework than pupils were in the wider sample.
- 39% of pupils said they had talked with their parents about drugs, 45% said teachers. These figures are lower than those seen in the wider sample. They are also less likely to have talked with their teachers about puberty.

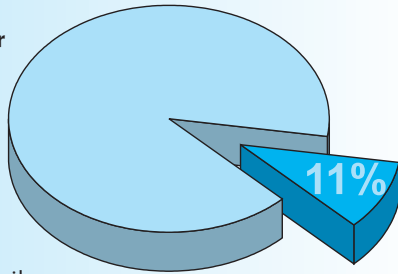

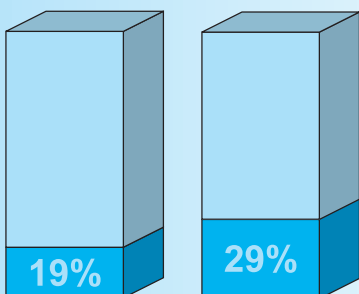

- 11% of pupils reported having nothing to eat or drink for breakfast on the day of the survey.
- 10% of pupils reported 'never' considering their health when choosing what to eat. 21% of pupils consider their health 'very often' or 'always'.
- 11% of the pupils would like to put on weight while 29% would like to lose weight. 61% of pupils are happy with their weight as it is.
- 19% of pupils said they had no lunch on the day before the survey. 28% of pupils ate a packed lunch from home or went home for lunch, 41% had school food and 12% bought lunch from a takeaway or shop.
- 32% of pupils said they eat sweets and chocolates 'on most days'. 25% said they ate crisps 'on most days'.
- 46% said they eat fresh fruit and 40% vegetables 'on most days'.
- 30% said they rarely or never ate fish.
- 18% of pupils had eaten 5 or more portions of fruit and vegetables on the day before the survey, 12% had eaten none.
- 61% of pupils said that they sit down for meals with their family 'most days'.
- 14% said that they had take-away meals 2 or more days a week.



PHYSICAL ACTIVITY

- 75% of pupils reported that they enjoyed physical activities 'quite a lot' or 'a lot'.
- 44% describe themselves as 'fit' or 'very fit'.
- Not including school lessons, 17% of pupils said that they 'never' or 'hardly ever' spent time doing physical activity.



- When asked what activities they would like to start doing or do more of 19% of boys said they would like to do more football. 29% of girls said they would like to do more swimming.

SEX AND RELATIONSHIPS

- 72% of boys and 61% of girls had heard of 4YP. 25% of Year 10 boys had used it and found it useful.
- 62% of pupils said that their lessons on sex and relationships had been useful.
- 62% of pupils said they thought that condoms were reliable to stop pregnancy. 34% (53% Year 10 girls) said that the 'Morning after pill' was reliable to stop pregnancy.
- 34% thought condoms would be reliable to stop infections like HIV.
- 16% of pupils said that they thought chlamydia can be treated and cured. 43% said either they have never heard of it or know nothing about it.

DRUGS, ALCOHOL & TOBACCO

Drugs

- 34% of Haringey secondary pupils are 'fairly sure' or 'certain' that they know someone who takes drugs.
- 18% of pupils have been offered cannabis. 16% said other drugs.
- By far the most commonly taken drug is cannabis, with 7% saying that they have taken cannabis.
- 10% of pupils have ever taken an illegal drug. 6% of pupils say they have taken an illegal drug within the last month.
- 6% of pupils reported taking an illegal drug and alcohol on the same occasion.
- Of the 3 most common drugs, the percentage of pupils saying they had taken them were:

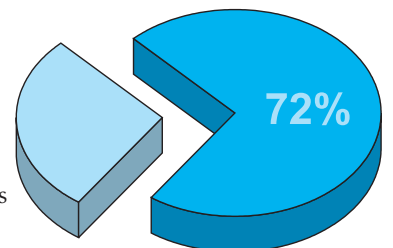

Alcohol

- 15% of pupils drank alcohol on at least one day in the week before the survey. 7% of pupils said that they got drunk on at least one day in the last week.
- 7% of Year 10 boys and 2% of Year 10 girls drank over the advised weekly limit for adult females of 14 units.
- 1% of pupils bought alcohol from a supermarket and 4% from an off licence who should only sell to over-eighteens.
- 1% of pupils drank alcoholic drinks in a pub or bar who should not be serving alcohol to under eighteens.
- 6% of pupils drank alcohol at home and 7% drank at a friend's or relation's home. 5% of pupils drank alcohol outside in a public place.

Tobacco

- 72% of pupils said they had never smoked at all.
- 6% said they had smoked at least one cigarette in the seven days before the survey.
- Boys: 4% of Year 8 boys and 11% of Year 10 boys smoke occasionally or regularly.
- Girls: 5% of Year 8 girls and 13% of Year 10 girls smoke occasionally or regularly.
- 44% of pupils said that someone smokes in their home 'on most days'.



EMOTIONAL HEALTH & WELL-BEING

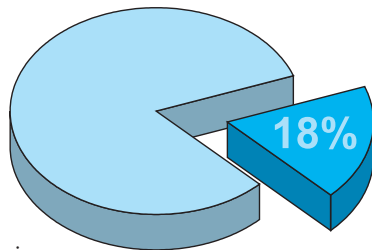
- 69% of pupils reported they are, in general, 'quite a lot' or 'very much' satisfied with their life at the moment.
- 61% of pupils had high self-esteem scores.
- 4% of pupils had very low self-esteem scores.
- 77% of pupils said they worried about at least one of the items listed in the questionnaire.
- Responses to individual items were as follows:**

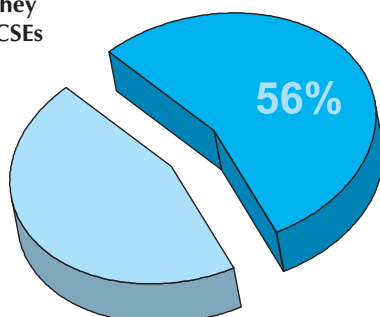
STAYING SAFE

- 21% of pupils reported that they felt afraid of going to school because of bullying at least said 'sometimes' while 79% said 'never'.
- 18% said they had been bullied at school at least in the last 12 months.**
- If they had been bullied, 53% said they reported it. Of those who reported it, 32% said to their parents, 20% to their teacher, 16% to head of Year and 11% said to their form tutor (pupils could list more than one person).
- 21% of pupils think that their school dealt with bullying effectively 34% said 'no' it didn't. 55% however did say that their lessons on bullying were useful.
- 13% hadn't been to the dentist within the past year. 25% said that they had experienced moderate or severe pain from their mouth or teeth in the last 2 weeks.
- 32% of pupils rate the safety of their area when going out after dark as 'poor' or 'very poor'. 8% say their safety when going to and from school is 'poor' or 'very poor' and 8% say the same about their safety at school.
- 9% of pupils reported that they or their friends carry weapons when going out.
- 12% reported that they had been a victim of violence or aggression in the area where they live, in the last twelve months.



ENJOYING AND ACHIEVING

- 64% of pupils report enjoying at least half of their school lessons. 8% of pupils enjoy hardly any of them.
- 56% of pupils said that they expect to take several GCSEs and get good grades.**
- 77% of pupils did homework on the previous evening. 51% reported they did more than an hour.

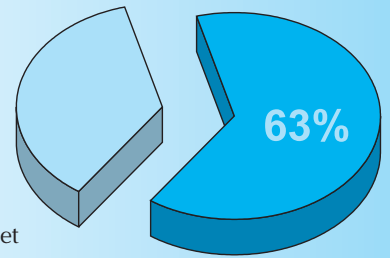


MAKING A POSITIVE CONTRIBUTION

- 91% watched some TV/DVDs on the evening before the survey and 10% watched for over 2 hours. 73% played computer games and 34% did this for more than 2 hours.
- 26% of pupils said that they would like to see more health services offered at their school. When asked to be specific, 10% said they would like the dentist.
- 66% of pupils said that they had found their lessons on citizenship useful.

ECONOMIC WELL-BEING

- 55% of pupils live with their mother and father together, 32% live with one parent while 3% don't live with either parent.
- 63% of pupils said they want to continue in full time education after leaving school.** 29% of pupils said they wanted to find a job as soon as possible. 45% of pupils said they want to get training for a skilled job.



- 35% of pupils have saved money in the past week.

SIGNIFICANT DIFFERENCES BETWEEN THE HARINGEY SURVEY AND THE SHEU REFERENCE SAMPLE

For most of the questions in the questionnaire, Haringey secondary pupils give similar responses to the wider SHEU data. Some differences (more than 5%) include:

- Haringey secondary pupils are more likely to say that they eat fruit 'on most days' compared with pupils in the wider sample. 46% of Haringey pupils said this compared to less than 40% of the wider sample.
- Haringey pupils are less likely to say that they are afraid to go to school because of bullying compared with the wider sample. 79% said 'never afraid' compared with 74% in the wider sample.
- Haringey pupils are more likely to say that they want to stay on in full time education after Year 11. They are less likely to say that they want to get training for skilled job. 61% of Year 10 boys said that they want to stay on in education compared with 52% saying the same in the wider sample.
- Haringey pupils were less likely to have a packed lunch compared with pupils in the wider sample. They were more likely to say that they didn't have any lunch on the day of the survey, 19% vs. 13%.
- Year 8 girls in Haringey are more likely to say they have never smoked at all. 83% said this compared with 75% of the wider sample.
- Haringey pupils are less likely to have drunk alcohol in the previous week 15% vs. 25%.
- Haringey pupils were less likely to say that they had been drunk in the previous week. 10% of Year 10 girls said that they had been drunk compared with 36% of the wider sample. Year 10 boys 11% compared with 29% in the wider sample.

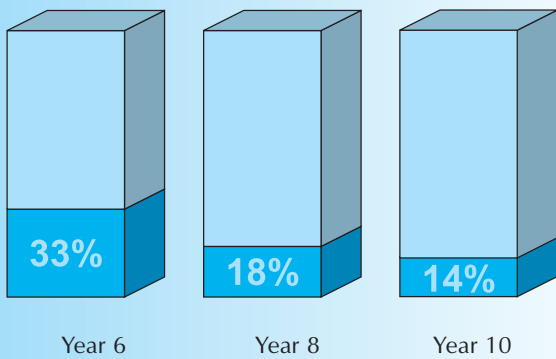

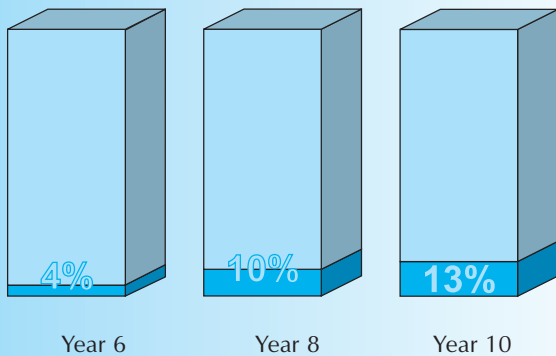
HEALTHY EATING

Five a day?

- Secondary school pupils are less likely to say that they had at least 5 portions of fruit and vegetables on the day before the survey, compared with primary aged pupils who said the same. 33% of Year 6 pupils compared with 18% of Year 8 and 14% of Year 10 pupils.



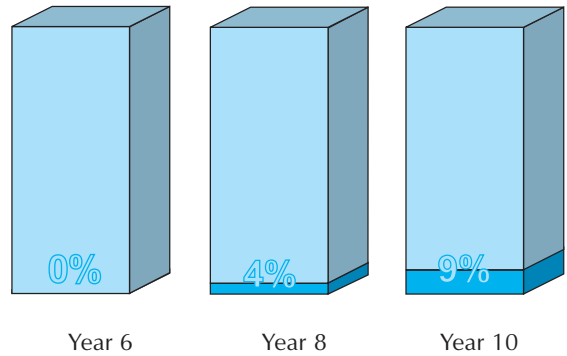
- Primary aged girls were less likely to report having nothing to eat or drink for breakfast: Year 6 girls 4%, Year 8 girls 10% and Year 10 girls 13%.



- There is an increase in pupils having crisps 'on most days' with age. 19% of Year 6 pupils, 25% of Year 8 and 25% of Year 10 pupils.

Did you smoke last week?

- 0% of the Year 6 pupils smoked a cigarette in the week before the survey. 4% of Year 8 pupils and 9% of Year 10 pupils said the same.

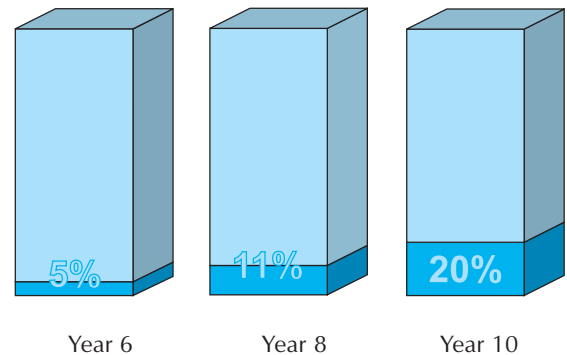


- 96% of primary pupils said that they had 'never smoked at all'. 81% of Year 8 pupils and 62% of Year 10 pupils said the same.

ALCOHOL

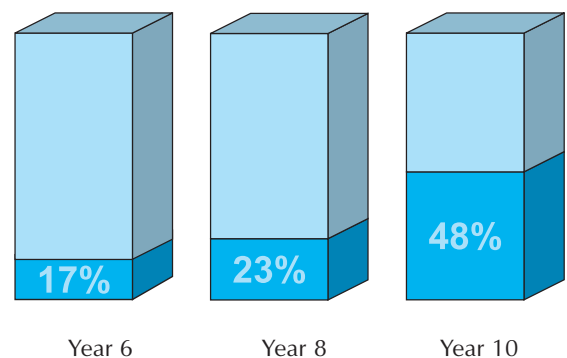
Have you had an alcoholic drink in the week before the survey?

ILLEGAL DRUGS

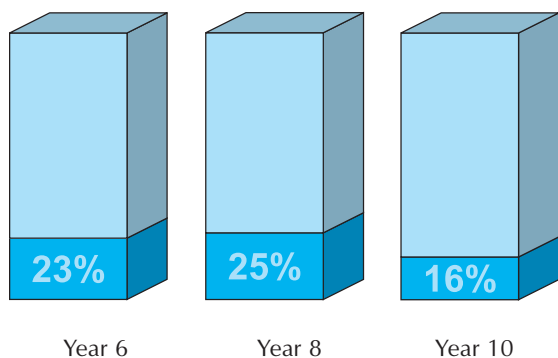

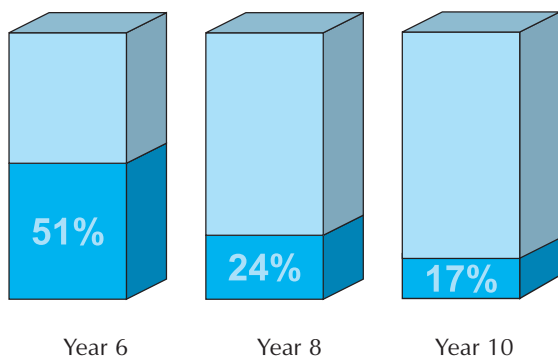
SAFETY

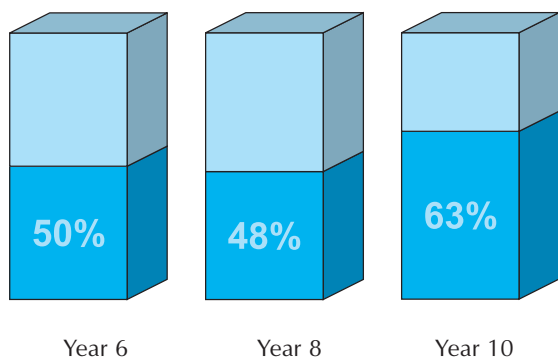

How much do you worry about problems?

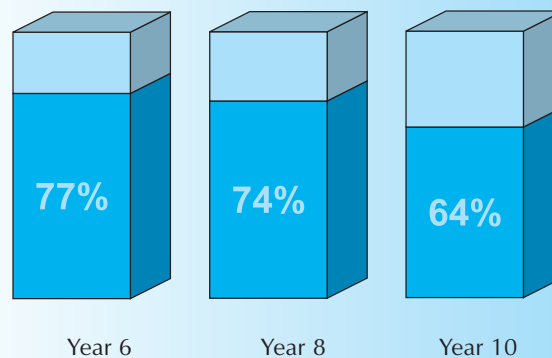

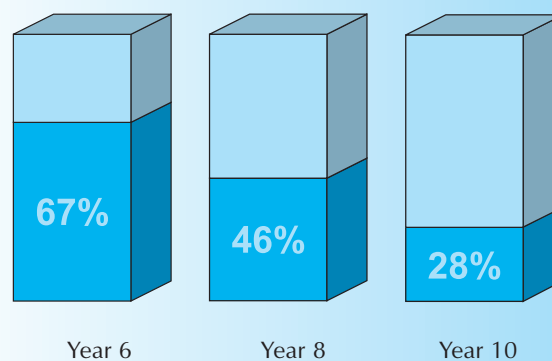
- 29% of secondary pupils worried about the way they looked, only 20% said the same in the primary survey.

PHYSICAL ACTIVITIES

- 81% of primary pupils said that they enjoy physical activities 'quite a lot' or 'a lot'. 75% of secondary pupils said the same.
- There is a drop in girls enjoyment of physical activity however:



- 81% of primary pupils describe themselves as 'fit' or 'very fit', 44% of secondary pupils said the same. **Again there is a big drop in the girls results:**



DENTIST

- 87% of primary pupils cleaned their teeth at least twice the day before the survey. 82% of secondary pupils said the same.
- 42% of primary pupils said that they had experience pain from their teeth or mouth in the past 2 weeks. 71% of secondary pupils said the same.

The Haringey C-Card and Medi+Vend Schemes

Background

Too many people in Haringey contract sexually transmitted infections (STIs) or get pregnant unintentionally when they are teenagers. Yet both of these can be prevented by the correct use of condoms.

In a bid to improve this situation, Haringey has now been selected to pilot a new scheme, the pan-London 'C-card Scheme' and 'medi+vend machines'. This is designed to encourage a sense of responsibility among those aged 25 years and under and provide coordinated condom distribution services across Haringey.

The C-card

The C-card is a registration and condom distribution scheme for young people. The scheme encourages correct, responsible condom use. When a young person registers for the scheme, they will be given sexual health messages, information on contraception and on sexual health and youth services in Haringey. This will also include information which promotes the delay/RU Ready messages specifically targeted at young people under 18. They will then be given a plastic key fob which can be used to obtain free condoms from any collaborating site across Haringey and London. As part of the scheme, the number of condoms available to each participant is monitored and referrals can be made to a clinic/sexual health professional. Staff will be trained to ensure that young people are signposted to relevant clinical or support services and child protection procedures are adhered to at all times.

Medi+vend Machine

The medi+vend is a dispensing machine that supports the C-card scheme. It does not require staffing and can dispense a range of resources. As part of the pilot the machine will provide access to sexual health information, condoms and Chlamydia screening kits. At a later date, this is expected to include the dispensing of pregnancy testing kits. The first machine will be sited in CONEL to support the on site contraception and sexual health nurse outreach service which started earlier this year. The intention is to purchase a further two machines in due course.

The Pan-London C-card and medi+vend pilots

The pan-London pilot links together all the collaborating boroughs into a London-wide Data Warehouse which will enable each borough to better understand the pattern and uptake of condoms and allow users to access condoms in other boroughs. A number of boroughs already have similar schemes in place.

The medi+vend pilot will run for one year and the C-card pilot will last four months and is funded by the Department of Health. The first phase of the pilot will include: the 4YP Haringey Services, CONEL and the contraception and sexual health clinics. The second phase will roll out the scheme to additional youth and health services such as community pharmacies and Connexions.

By being part of the pan-London pilot, the scheme will be subject to rigorous evaluation, initially through continuous consultation with young people, uptake and access data. In the longer term it will be evaluated against STI and unplanned pregnancy rates.
