LICENSING SUB-COMMITTEE HEARINGS PROCEDURE SUMMARY	
INTRODUCTION	
1.	The Chair introduces himself and invites other Members, Council officers, Police, Applicant and Objectors to do the same.
2.	The Chair invites Members to disclose any prior contacts (before the hearing) with the parties or representations received by them
3.	The Chair explains the procedure to be followed by reference to this summary which will be distributed.
NON-ATTENDANCE BY PARTY OR PARTIES	
4.	If one or both of the parties fails to attend, the Chair decides whether to:
	(i) grant an adjournment to another date, or
	(ii) proceed in the absence of the non-attending party.
	Normally, an absent party will be given one further chance to attend.
TOPIC HEADINGS	
5.	The Chair suggests the “topic headings” for the hearing. In the case of the majority of applications for variation of hours, or other terms and conditions, the main topic is:
	Whether the extensions of hours etc. applied for would conflict with the four licensing objectives i.e.
	(i) the prevention of crime and disorder,
	(ii) public safety,
	(iii) the prevention of public nuisance, and
	(iv) the protection of children from harm.
6.	The Chair invites comments from the parties on the suggested topic headings and decides whether to confirm or vary them.
WITNESSES	
7.	The Chair asks whether there are any requests by a party to call a witness and decides any such request.
8.	Only if a witness is to be called, the Chair then asks if there is a request by an opposing party to “cross-examine” the witness. The Chair then decides any such request.
DOCUMENTARY EVIDENCE	
9.	The Chair asks whether there are any requests by any party to introduce late documentary evidence.
10.	If so, the Chair will ask the other party if they object to the admission of the late documents.
11.	If the other party do object to the admission of documents which have only been produced by the first party at the hearing, then the documents shall not be admitted.

12.	If the other party object to documents produced late but before the hearing, the following criteria shall be taken into account when the Chair decides whether or not to admit the late documents:	
(i)	What is the reason for the documents being late?	
(ii)	Will the other party be unfairly taken by surprise by the late documents?	
(iii)	Will the party seeking to admit late documents be put at a major disadvantage if admission of the documents is refused?	
(iv)	Is the late evidence really important?	
(v)	Would it be better and fairer to adjourn to a later date?	
THE LICENSING OFFICER'S INTRODUCTION		
13.	The Licensing Officer introduces the report explaining, for example, the existing hours, the hours applied for and the comments of the other Council Services or outside official bodies. This should be as "neutral" as possible between the parties.	
14.	The Licensing Officer can be questioned by Members and then by the parties.	
THE HEARING		
15.	This takes the form of a discussion led by the Chair. The Chair can vary the order as appropriate but it should include:	
(i)	an introduction by the Objectors' main representative	
(ii)	an introduction by the Applicant or representative	
(iii)	questions put by Members to the Objectors

(vi)	questions put by the Applicant to the Objectors	
CLOSING ADRESSES



We are reviewing our security procedures and implementing the use of radio communication between security, bar and office where CCTV is monitored. Searches, bag searches.

The manager is reapplying for his SIA badge.

The owner is booking an SIA course.

5.4 Public Safety

Larger signs are going to be implemented with regards to Challenge 21, searching on the door, Noise policy when leaving, drinks and bottles being kept within the premises and taxi numbers displayed.

5.5 Public Nuisance

We are going to be constructing notice/chalk boards on the front of the premises where larger signage will be incorporated with regards noise levels, cab numbers, opening hours and other relevant information.

5.6 Child Protection

We will put up extra Challenge 21 posters, ensure all staff are aware of underage policy--at our monthly meetings—which excludes minors from the venue, and ensure all relevant ID checks are enforced by security and other staff.

I would like to confirm that I have considered the above proposal with regard to the prevention of public nuisance on behalf of the Enforcement Response (Noise) Team & would like to make representations to the Application

The operating schedule does not address the prevention of public nuisance from:

- airborne entertainment noise
- Structure borne noise or vibrations from entertainment
- Noise generated by patrons in external areas of the premises
- Noise generated from patrons queuing to enter
- Noise from patrons exiting the premises
- Noise from plant and machinery
- Light nuisance
- Cooking odour
- Litter nuisance

The proposed operating hours are inappropriate due to the close proximity of residential dwellings. The premises is located on Archway Road, and has a lot of residential flats above shop premises facing onto the entrance door to the Bar and above the bar itself.

The noise caused by patrons exiting the premises and locating suitable transport home is likely to be detrimental to the residential amenity. This may be exacerbated by the level of public transport available at the proposed closing hours. Therefore, it is considered that the premises should not open past its current opening hours.

If the sub-committee were to grant this application then we would recommend the following alterations/conditions to the operating schedule:

Prevention of nuisance from noise / vibration

All doors and windows will remain closed during the licensed regulated entertainment activities or in any event after 11pm. The entrance door will be fitted with a self-closing device and staff required to ensure that it is not propped open. A member of staff shall be made responsible to ensure the door is opened for as brief a period as possible. Where necessary adequate and suitable mechanical ventilation should be provided to public areas

Entry to the premises will be restricted to the front main entrance whilst the premises is being used for regulated entertainment licensed activity

Entrance/exit from the premises whilst regulated entertainment licensable activities are ongoing shall be via a lobbied door to minimise noise breakout.

The regulated entertainment licensable activity shall conclude 30 minutes before the premises is due to close to prevent excessive noise breakout as the premises empties

Structure borne noise

All speakers are mounted on anti-vibration mountings to prevent vibration transmission of sound energy to adjoining properties

Sound limits

The licensee shall ensure that no music played in the licensed premises is audible at or within the site boundary of any residential property including properties above the Bar.

The level of amplified regulated entertainment shall be controlled by means of limiting device set at a level which upon request may be agreed with the licensing authority

Outside Areas

No music will be played in, or for the benefit of patrons in external areas of the premises

No form of loudspeaker or sound amplification equipment is to be sited on or near the exterior premises or in or near any foyer, doorway, window or opening to the premises

Signs shall be displayed in the external areas/on the frontage requesting patrons to recognise the residential nature of the area and conduct their behaviour accordingly. The management must reserve the right to ask patrons to move inside the premises or leave if it is felt that they could be disturbing neighbours

The number of persons permitted to utilise the external area/frontage for smoking purposes will be restricted to 4 persons to minimise disturbance to nearby residential properties. Authorised SIA doormen to control the behaviour of persons when outside the premises.

Deliveries and collections.

Empty bottles and non-degradable refuse will remain in the premises at the end of trading hours and taken out to the refuse point at the start of the working day rather than at the end of trading when neighbours might be unduly disturbed

Plant and machinery

All plant and machinery is correctly maintained and regularly serviced to ensure that it is operating efficiently and with minimal disturbance to neighbours arising from noise

Dealing with complaints

A complaints book will be held on the premises to record details of any complaints received from neighbours. The information is to include, where disclosed, the complainant's name, location, date time and subsequent remedial action undertaken. This record must be made available at all times for inspection by council officers

Patrons entering/exiting premises.

There will be no queuing outside the premises.

Where people queue to enter the premises a licensed door supervisor shall supervise and ensure the potential patrons behave in an acceptable manner

Signs should be displayed requesting patrons to respect the neighbours and behave in a courteous manner

Door supervisors

A minimum of two SIA authorised Door men to be on duty at the premises from 22:00hrs until close of business.

When the premises turn out a licensed door supervisor shall supervise patrons and ensure the leave in a prompt and courteous manner, respecting the neighbours

A licensed door supervisor will be positioned on the exit door to ensure, as far as reasonably practical, that patrons do not leave with drinks

A licensed door supervisor will patrol the curtilage of the premises to prevent patrons urinating in public areas in the vicinity of the premises

Prevention of Nuisance from Odour

All ventilation and extraction systems shall be correctly maintained and regularly serviced to ensure that it is operating efficiently and with minimal disturbance to neighbours arising from odour

As a resident of the area and a single mother to two young daughters and carer for an old age pensioner, I must strongly object to the proposals to extend the opening hours, and with them the longer alcohol and music licenses for the Caipirinha Jazz Bar, based in Archway Road.

I fear that not only will these proposals bring with them a further threat to our personal safety and the security of our property, but the noise nuisance and anti-social behaviour impacts would be irreversible to the quality and safety of our lives, not to mention the potential damage to the value of the properties in the vicinity. Burglaries, car crime and threatening - if not violent - behaviour appear from my non scientific point of view to escalate proportionally with the consumption of alcohol and this proposal puts us all in greater peril.

Furthermore, this extension will set a precedent for other pubs and/or restaurants in the area, some even closer to home than the Caipirinha which could subsequently alter the entire nature and appeal of this neighbourhood.

My family and I reside in Cholmeley Park and are most concerned to learn that the Caipinniha Jazz Bar, 177 Archway Road has applied for further extended opening hours (for the sale and consumption of alcohol) and for a music licence. Cholmeley Park is a long road that runs between the Archway Road at one end up to Highgate High Street at the other. In particular, those Residents who live in Cholmeley Park (post codes N6 5EU and N65ET), Cholmeley Crescent and Causton Road, Highgate and Southwood Avenues, Langdon Park Road, Holmesdale and Orchard Roads etc will suffer unwarranted loss of amenity, noise pollution and disturbance.

I was very concerned to learn that the Caipirinha Jazz Bar, 177 Archway Road, Highgate, N6 has applied for a further extended opening hours licence and music licence. I understand in the application the venue is requesting at least the following:

New Opening time:

Monday-Thursday up and till 2.30 am

Friday-Saturday up and till 4.30 am

Sunday up and till 2.30 am

Alcohol sales should stop 30 minutes prior to closing times shown.

Music License Request times:

Monday-Wednesday up and till 2 am.

Thursday up and till 3 am.

Friday and Saturday up and till 4 am.

Sunday up and till 2.30 am.

I live in Causton Road and on a fairly regular basis am disturbed in the early hours of the morning. I cannot be certain that the people going by are from the club, but it is long after the Winchester has closed.

I have had people sitting on the step at the bottom of the path to my front door talking or arguing and have had to go down and switch lights on etc, and fortunately they got the message and moved off. The direction they have taken is back to the Archway Road and turned right - I assume, but do not know - back to the club.

A few months ago - I would say over 6 months - our road was in part shut off at the Archway end. I spoke to the policeman who was in attendance there, who said it was as a consequence

of a stabbing of someone who attended the club. I was told the victim's condition was serious and I hope they recovered.

I am often up early at weekends to go to the shops [and frequently with one or other of my children] and am also aware of people urinating late at night in the shop entrance to Richardsons. Not a great sight or smell, particularly off putting when you are with kids. I do not know if this is people from the club - and others may have a better idea about this.

Given the above - you will appreciate that as this is very much an area where people live rather than come to work - I would prefer there is no club there - it just does not fit in with the area at all. It is bad enough now, let alone if there is going to be a club open until 2.30am or 4.30am every night of the week - including Sundays.

I look forward to hearing from you on the above.

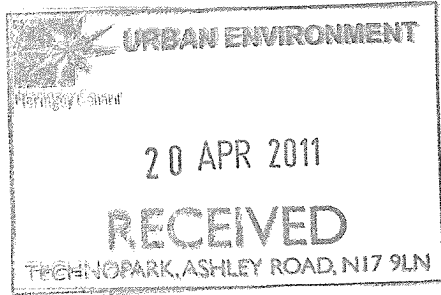

You will impede the right to a private life as the loud music will travel through the air (especially bass sounds, i.e. the lower wavelength of sound) and walls alike.

Finally, I am already noticing empty drug bags on North Hill (immediately off Archway Road) and litter and cigarette lighters on the pavements in the morning. If that is indicative of the nightlife that exists already, then I find this highly objectionable.

Haringey Council is already allowing various music festivals at Finsbury Park and Kenwood in increasing numbers purely to increase profitability.

The noise and pollution is counteracting the Human Right to Private life of the many for the benefit of a few.

My objection is withdrawn if revellers travel there by foot, by electric car or bicycle and the music is contained in a soundproofed room within the premises, with no sound travelling through the external doors (open or shut alike).

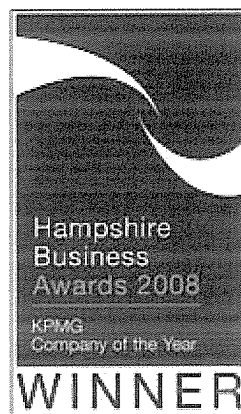
