LICENSING SUB-COMMITTEE HEARINGS PROCEDURE SUMMARY INTRODUCTION The Chair introduces himself and invites other Members, Council officers, Police, Applicant and Objectors to do the same. 2. The Chair invites Members to disclose any prior contacts (before the hearing) with the parties or representations received by them The Chair explains the procedure to be followed by reference to this summary which will 3. be distributed. **NON-ATTENDANCE BY PARTY OR PARTIES** 4. If one or both of the parties fails to attend, the Chair decides whether to: grant an adjournment to another date, or (ii) proceed in the absence of the non-attending party. Normally, an absent party will be given one further chance to attend. **TOPIC HEADINGS** 5. The Chair suggests the "topic headings" for the hearing. In the case of the majority of applications for variation of hours, or other terms and conditions, the main topic is: Whether the extensions of hours etc. applied for would conflict with the four licensing objectives i.e. (i) the prevention of crime and disorder, (ii) public safety, (iii) the prevention of public nuisance, and the protection of children from harm. (iv) 6. The Chair invites comments from the parties on the suggested topic headings and decides whether to confirm or vary them. WITNESSES 7. The Chair asks whether there are any requests by a party to call a witness and decides any such request. 8. Only if a witness is to be called, the Chair then asks if there is a request by an opposing party to "cross-examine" the witness. The Chair then decides any such request. **DOCUMENTARY EVIDENCE** The Chair asks whether there are any requests by any party to introduce late documentary evidence. 10. If so, the Chair will ask the other party if they object to the admission of the late documents. 11. If the other party do object to the admission of documents which have only been produced by the first party at the hearing, then the documents shall not be admitted.

Background

5.1 An application for a new Premises Licence, by Juliana Adetoun Orekan in respect of Mighty Rock Restaurant, 363 High Road, Tottenham, London N17 6QN under the Licensing Act 2003.

5.3 General

- Appropriate staff training will be provided.
- The premises will be managed and controlled by a responsible adult at all times.
- No binge drinking promotions will take place.
- Any person who appears to be drunk / aggressive will not be permitted on the premises.
- Notices will be placed in prominent positions to ask patrons to leave the premises quietly.
- There will be a suitable evacuation plan in place, in case of emergency.
 - Premise is smoke free and the required signs will be displayed at all times.

5.4 Crime and Disorder

- Internal and external CCTV will be installed at the premises.
- A full alarm system will be installed and maintained at the premises.
- No binge drinking promotions will take place.

- No glasses or bottles of alcohol shall be taken off the premises.
- Any person who appears to be drunk / aggressive will not be permitted on the premises.
- Registration with crime prevention initiatives run by the police.

5.5 Public Safety

- Staff will be fully aware of the Licensing laws and Health and Safety Policy.
- Regular electrical and gas safety checks by a competent and professional person.
- Fire Safety equipment will be installed and will be maintained on the premises.
- The emergency exit will be kept free from obstructions at all times.
- Staff will be fully trained in alcohol sales, fire safety and evacuation procedures.
- Any directives received from the authorities will be fully supported.

5.6 Public Nuisance

- Reasonable steps will be taken to recognise the rights of the public.
- All customers will be reminded of consideration to the public and noise levels when entering and leaving the premises.
- No entertainment will take place outside the premises.
- Doors and windows shall be kept closed.
- Notices to be placed in prominent positions to ask patrons to leave the premises quietly.
- No glasses or bottles of alcohol shall be taken off the premises.

5.7 Child Protection

- Training of staff to ensure compliance with the law in relation to consumption of alcohol by persons under 18 years of age, including prevention of adults buying alcohol for children.
- Customers who appear to be under age 18 will be asked for a photographic proof of age before any sale of alcohol is made.
- Any children under the age of 16 remain the responsibility of an accompanying adult when using the premises.
- A register of refusal of sales will be kept and maintained on the premises.
- No adult entertainment is permitted at the premises.








LOCATION PLAN SCALE 1 1250



I am writing as ward councillor for Bruce Grove with regard to the application for a premises license for 'Mighty Rock Restaurant' at 363 High Road, N17 6QN.

I would like to firstly state that I have no specific objection to the principle of a restaurant on this site, what with such a facility having the potential to enhance the composition of retail outlets in this part of Tottenham High Road and it being a more positive use of the space than has been the case with the derelict former Swan public house.

However, I object to the application in its present form on the following grounds, as outlined within the legislation:

THE PREVENTION OF PUBLIC NUISANCE

Due to the proposed hours of operation within the application extending each day until 2am, as well as including the provision for recorded and live music, this is very likely to cause the premises, were an application granted, to contravene guidelines on THE PREVENTION OF PUBLIC NUISANCE. The resultant noise will cause disturbance to local residents, dozens of whom live in flats only a matter of yards away. This particular location borders a densely populated residential area and is not an appropriate location for a late night facility with live music being open for business until 2 am, seven days a week, including Sundays.

The residential properties that I refer to in Bruce Grove ward include the flats above the various retail premises between 363 High Road and Library Court, Library Court itself, Nicholson Court, Old School Court, and the flats on Ambleside Close.

The same would apply to residential properties across the street in the neighbouring wards of Tottenham Green and Tottenham Hale, what with this particular location being in Bruce Grove ward yet bordering both of the other wards.

THE PREVENTION OF CRIME & DISORDER

The issue of patrons leaving the premises so late at night, whilst the streets are quiet and mostly deserted, will very likely increase the chances of the premises contravening guidelines on THE PREVENTION OF CRIME & DISORDER. This is particularly the case as patrons, some of whom will inevitably have been drinking alcohol, either cause disorder, or end up being at risk themselves of becoming a victim of crime as they make

their way home along this section of the High Road which has so many residential units above or adjacent to it.

The Bruce Grove Safer Neighbourhoods Team, when I asked them for their opinion on the application, said that this was already a problem location, what with the narrow and congested design of the pavement, as well as the existence of other late night facilities. They also questioned why the applicant would want to apply for a licence until 2 am, seven days a week. This stretch of the High Road is a street no-drinking zone. The point was also raised, to which I would concur, that the request to stay open until 5am on Christmas Eve is both highly unusual, as well as inappropriate on the same grounds as listed above. This wouldn't seem so unusual were it to be New Years Eve instead, even though I would object to a 5am opening time on any day of the year, what with the risks attached.

Bearing all of this in mind, I would like to request that the Licensing Committee only consider granting permission with:

- Reduced hours of no later than 11pm on Monday to Thursday
- Reduced hours of no later than 12.00am on Fridays and Saturdays
- Reduced hours of no later than 10.30pm on Sundays
- Reduced hours of no later than 12.00am on Christmas Eve

I would also like to request that the Licensing Committee consider imposing conditions that address the following issues:

- Security, including provision of staff on the door late at night
- Reasonable control of smoking on the street, including provision for disposal of cigarette butts
- Prevention of drinking in the street
- Noise control
- Control of hours for deliveries

Lastly, I would also like to notify you of my wish to attend the Licensing Committee that this application will be heard at so as to address members and give my views in person.

Please accept this email as my objection to the licensing application by the 'Mighty Rock Restaurant' at 363 High Road, N17 6QN.

I am one of the ward councillors for Tottenham Hale ward which of course has its boundary on the east side of the High Road opposite these premises.

Like other councillors who have written in, I have no objection to a restaurant on this site. But I too am concerned about the hours of operation and the potential for public nuisance caused by noise and possible disorder .

In recent years there has been intensive development of new residential homes within a short distance of these premises. The Council, Housing Associations, and private developers have made successful efforts to bring unused or underused properties back into use, e,g with flats above shops. New residential developments have been built. It is vital that these residents should as far as possible have quiet enjoyment of their homes -

particularly late in the evening and in the early hours. It is inappropriate for these premises to have a license for live music seven days a week until the early hours.

Similarly, the potential for crime and disorder is likely to increase.

There have long been problems in this part of the High Road with the Police and Council supporting no drinking zones.

I would ask the Licensing Committee to consider restricting the hours of this licence for the reasons above. I suggest that 11 pm should be sufficient for Mondays to Thursdays with midnight for Fridays and Saturdays. For Sunday evenings the limit should be 10.30pm.

I would also suggest it is important to have reasonable but firm conditions regarding door security - especially in the evenings and late at night.

It should be stipulated that the restaurant take reasonable steps to encourage their patrons to respect the nearby residents - including keeping down noise, not taking drinks outside to the street, disposal of cigarette ends etc.

This letter is in response to all representations and objections made against Mighty Rock Restaurant's Premises Licence Application.

Representations made by interested parties and ward councillors appear to be a reaction to and based on the history of the site when it was managed as a public house known as the Swan. We have no link to that business. Mighty Rock Restaurant is a new and completely different business by new and different owner and management.

Mighty Rock Restaurant is not a Public House. It is not a Dance Hall and it is not a Bar or a 'drinking hole' It will not be run as a place where people can just come for a drink.

It is a family run restaurant and food takeaway. We require a licence in order to enable customers to have alcoholic beverages with their meals inside the restaurant.

This is not an activity that will enhance or promote crime and disorder.

Mighty Rock Restaurant is primarily a restaurant and takeaway. Alcohol consumption will only take place inside the premises; and alcohol purchased by customers cannot be taken outside of the premises.

Another reason as to why these representations and objections have been unfair to Mighty Rock Restaurant is that the current premises is not the same premises as the Swan Pub.

Currently, the premises is now much smaller in size, since half of the Swan's premises has been sold off and converted into shops and flats. Also, the upper floor of Mighty Rock Restaurant does not belong to the restaurant.

Public safety and prevention of public nuisance will be paramount at all times at Mighty Rock Restaurant. Anti-social behaviour will not be tolerated at all times in and outside of the premises by customers. Also, Internal and external CCTV will be installed and operated at the premises, at all times.

Reasonable steps will be taken to recognise the rights of the public, at all times; and customers will be reminded of consideration to the welfare and well-being of the general public / residents.

We also require a licence to open late (longer hours) in order to give viability to the business.

Several surrounding establishments including bars in the area are licensed and already operate until 2.00 am.

There has never been any issue or concern in respect of Juliana Orekan's Personal Licence and as a Designated Premises Supervisor.

Restricting our opening hours to such as suggested by councillors Stuart McNamara, Richard Watson and Alan Stanton will greatly reduce the viability of the business and may very quickly lead to failure and closure.

As we are also located in their wards, for the sake of fairness Councillor McNamara could have invited a response or invited us to meet with him and the Bruce Grove Safer Neighbourhoods Team whose opinion he canvassed. This would have given us the opportunity to answer questions and discuss our plans to put people's mind to rest.

Imposing conditions that require security staff at the door as requested by the councillors again is highly unfair and gives no consideration to the business. Security staff at the door of a restaurant sends out the wrong message to potential customers — A trouble spot? A shady establishment? Fights? Crime?

The small size of the restaurant will also not financially support the additional unjustifiable and unnecessary cost of door security staff.

These representations and objections are unfair, unjustified, biased, one-sided, disproportionate, and beyond what is proper.

The Police have made comments and suggestions on this application. We have reached an agreement with the police and amended the application and they have withdrawn their representations.

The Fire Officer has made comments on this application and has made no representations upon response from us.

This demonstrates that we are willing to and will work and cooperate with relevant authorities such as the Council and Police on crime prevention initiatives, health and safety and preventing anti-social behaviour in the area.

We will also ensure that the premises is managed in accordance with the information supplied in the application and Licensing laws.

We would like Mighty Rock Restaurant to be treated fairly just like any other restaurants and businesses on the High Road.
