- **Report back from Broadwater Farm Resident Association on 'The Big Debate' [6.05pm]**

The Broadwater Farm Residents' Association was successful in receiving Making the Difference Funding to seek the views of young people on: their local area, facilities, and the type of guidance they would like to receive. This information guided the agenda for the 'big debate', a workshop session held for young people living on Broadwater Farm to discuss these issues further. Representatives from the Association will report back their findings to the Forum.

- **Regeneration in Tottenham [6.35pm]**

The Cabinet Member for Economic Investment, Social Inclusion and Planning will attend the meeting and feedback on regeneration in Tottenham, highlighting projects concerning the Bruce Grove and West Green area.

- **Crime and Disorder Update [7.00pm]**

The Community Safety and Data staff, with Inspector Hutchinson or a senior police representative in attendance, will present the headlines and key trends from this year's data assessment as they relate across Haringey and in the local area. The focus will be on sharing planned actions and responses to the challenges. Residents will have an opportunity to comment on these plans and make further suggestions.

- **Fortnightly Non Recyclable Rubbish Collections [7.30pm]**
