## 6. Regulatory Committee

6.1 The full Council appoints the membership of the Regulatory Committee including its Chair and Vice-Chair. By law there must be at least 10 but no more than 15 appointed Members. The Committee can still meet and undertake its business with a quorum of 4 Members.
7. Establishing the Licensing Sub-Committees and Planning Sub-Committee
7.1 The Regulatory Committee may establish Sub-Committees to assist with holding hearings. Although the membership for these has been
reported to Annual Council, legally it is the Regulatory Committee that fixes the Sub-Committees' membership.
7.2 In May 2011 there were two Licensing Sub-Committees established to deal with contested applications. The appointed membership of the Sub-Committees is fixed by law at 3 Members. The Council's own Local Licensing Procedure Rules set the quorum for hearings at 3 Members since this promotes better decisionmaking.
7.3 With membership of the Licensing Sub-Committees and Planning Sub-Committee having been established in May 2011, it is now necessary in light of the change in Membership of the Regulatory Committee made at Full Council on 18 July 2011, to vary the Membership of the Planning Sub Committee in order to fill the resultant vacancy. A further variation to the Membership of the Planning SubCommittee, and a variation to the Membership of Licensing Sub Committee B, are also proposed, as set out in Appendix 1.
7.4 The Committee is also reminded that on occasions an appointed Member of a Licensing Sub-Committee cannot take part in the decision on a particular case because of a conflict of interest or because the premises in question lie in the Member's own Ward. In such cases, and any other case where a Member is unexpectedly absent or seriously late, it will be necessary to appoint a substitute

Member often at short notice. Any such substitution will be made in accordance with the provisions of Appendix E, Section 9, Paragraph 1.4(k) and 1.4(I) of the Constitution. The Members appointed as substitutes would always be trained Members of the main Committee who were able to make themselves available.
