10. Improving air quality		The Wood Green area is one of nine areas in Haringey identified by TfL as an "NO2 Focus Area". In addition a modelling report carried out in 2009 for Haringey Council identified the Wood Green area as a 'hotspot' area for pollutants of NO2 and PM10. Particles or particulate matter (PM) are tiny bits of solids or liquids suspended in the air. PM10 are particles smaller than about 10 micrometers that can settle in the airway and deep in the lungs and cause health problems. These hotspots / focus areas are representative of relevant exposure, locations at which there may be a risk of exceeding the Government's hourly and annual objectives. The main source of air pollution in Haringey is from road vehicles and domestic gas, the emissions being nitrogen dioxide and PM10. Although many sources of emissions contribute to air pollution, in the immediate vicinity of roads, road traffic emissions sources dominate the pollution profile.
