##### **1b) Bullying in schools - update [6.55pm]**

At the forum meeting in April 2012, Broadwater Farm Residents Association provided feedback on their debate with young people living on the estate and a key concern raised was bullying in schools. This meeting takes forward this issue raised, and is a useful opportunity to share ideas on good practice and gain an understanding about how much this issue is reported in West Green and Bruce Grove schools. The Head of Alternative Provision will be available to answer any questions on prevention and early intervention in relation to tackling bullying in our schools. The Cabinet Member for Children and Head teachers and governors from local schools in the West Green and Bruce Grove Area have been invited to attend the forum to listen and take part in the debate.

**1c) Report from Inspector Hutchinson on the new arrangements in the safer neighbourhood teams and new local police model [7.30pm]**

Senior police officers and officers from the local Safer Neighbourhood Teams will be at the meeting to discuss new working arrangements, local policing priorities and areas of concern in relation to crime with residents.

**1d) Bruce Grove Public Realm Project update [7.55pm]**

Local residents will hear about the actions being taken forward for improvement of the public realm at Bruce Grove.

**1 e) House in Multiple Occupation – Policy for Tottenham [8.20pm]**

There is further fuller consultation about taking forward a HMO Licensing Scheme for certain houses in multiple occupation (HMOs) in all or part of the five wards which make up the Tottenham area (Northumberland Park, Bruce Grove, Tottenham Green, Tottenham Hale, Seven Sisters).
