PM10 are particles smaller than about 10 micrometers that can settle in the airway and deep in the lungs and cause health problems. These hotspots / focus areas are representative of relevant exposure, locations at which there may be a risk of exceeding the Government's hourly and annual objectives. The main source of air pollution in Haringey is from road vehicles and domestic gas, the emissions being nitrogen dioxide and PM10. Although many sources of emissions contribute to air pollution, in the immediate vicinity of roads, road traffic emissions sources dominate the pollution profile.
