INTRODUCTION	
1.	The Chair introduces him/herself and invites other Members, Council officers, Police, Applicant and Objectors to do the same.
2.	The Chair invites Members to disclose <ul style="list-style-type: none"> i) any prior contacts (before the hearing) with the parties or representations received by them; and separately ii) any declarations of interest.
3.	The Chair explains the procedure to be followed by reference to this summary which will be distributed in advance.
NON-ATTENDANCE BY PARTY OR PARTIES	
4.	If one or both of the parties fails to attend, the Chair decides whether to: <ul style="list-style-type: none"> (i) grant an adjournment to another date, or (ii) proceed in the absence of the non-attending party. <p>Normally, an absent party will be given one further opportunity to attend.</p>
TOPIC HEADINGS	
5.	The Chair suggests the “topic headings” for the hearing. In the case of the majority of applications for variation of hours, or other terms and conditions, the main topic is: <p>Whether the extensions of hours etc. applied for would conflict with the four licensing objectives i.e.</p> <ul style="list-style-type: none"> (i) the prevention of crime and disorder, (ii) public safety, (iii) the prevention of public nuisance, and (iv) the protection of children from harm.
6.	The Chair invites comments from the parties on any other topic headings to be discussed.
WITNESSES

8.	Only if a witness is to be called, the Chair then asks if there is a request by an opposing party to “cross-examine” the witness. The Chair then decides any such request.

10.	If so, the Chair will ask the other party if they object to the admission of the late documents.
11.	If the other party do object to the admission of documents which have only been produced by the first party at the hearing, then the documents shall not generally be admitted.

12.	If the other party object to documents produced late but before the hearing, the following criteria shall be taken into account when the Chair decides whether or not to admit the late documents:	
(i)	What is the reason for the documents being late?	
(ii)	Will the other party be unfairly taken by surprise by the late documents?	
(iii)	Will the party seeking to admit late documents be put at a major disadvantage if admission of the documents is refused?	
(iv)	Is the late evidence really important?	
(v)	Would it be better and fairer to adjourn to a later date?	
THE LICENSING OFFICER'S INTRODUCTION

1. Describe the issue under consideration

- 1.1 On 6th October 2016 the Licensing Authority received from Mpala Mufwankolo, a number of notifications in respect of proposed temporary licensable activities he wished to take place at N17 Lounge, 614 High Road Tottenham London N17 on 16 & 17/10/16 / 23 & 24/10/16 / 30 & 31/10/16 / 6/11/16 / 13 & 14/11/16 / 20 & 21/11/16 / 4 & 5/12/16 / 24,25 & 26/12/16 / 31/12/16, 1 & 2/1/17. These are attached at Appendix A apart from the application for 16 & 17th October 2016.

One of the applications notified on the 6th October 2016 was for a late temporary event Notice (16 & 17 October 2016), the notification being only 6 working days before the Proposed event, as a result of the Met Police /Enforcement Response objections the Notice fails automatically and is not therefore part of this report. Appendix B copy of objections.

1.2 Summary of the matter

The Licensing Act 2003 requires a licensing sub committee to consider such applications when an appropriate notice has been served by either the police or environmental health. The decision reached at the sub committee can be subject to the appeal process at the Magistrates Court.

- 1.3 The temporary event notices 23 & 24/10/16 / 30 & 31/10/16 / 6/11/16 / 13 & 14/11/16 / 20 & 21/11/16 / 4 & 5/12/16 / 24,25 & 26/12/16 / 31/12/16, 1 & 2/1/17 are requesting an extension of operating hours for licensable activity namely, regulated entertainment and supply of alcohol. The Licensing Sub Committee attention is drawn to the current operating hours of the existing licence which has recently been reviewed and conditions placed against it would now come into force. The Licensing authority served the decision notice on Mr Mufwankolo on 19th September 2016, the 21 days expired on Sunday 09th October 2016. We have received confirmation from Highbury Magistrates Court advising that Mr Mufwankolo lodged the appeal papers on 6th October 2016. That being the case Mr Mufwankolo is able to continue to operate under the existing licence a copy of which is at Appendix C.

The Licensing sub committee will note that there would be a period of no licensable activity being able to be undertaken once the licenced hours are reached. The premises can offer alcohol sales and regulated entertainment until 03.30am on a Sunday night into the Monday morning. The TENs are asking for these activities to continue from 4am-7am, there is a 30 minute window that no licensable activity other than the sale of hot food or hot drink can take place at the premises.

Likewise on a Monday night the existing licence allows alcohol sales and regulated entertainment until midnight only, therefore the premises would be looking to restart licensable activity some 4 hours later at 4am in the morning. We do not believe the applicant Mr Mufwankolo has a true appreciation of his permitted hours and the conditions under which he should operate the premises in order to uphold and promote the licensing objectives.

Some of the days applied for cover the Christmas period and New Years Day, there is no automatic right to these days so Mr Mwafankolo is right to submit TENs for any extension he wishes to make use of, this does need to be balanced against the rights of residents to have peaceful enjoyment of their home also. However the matters raised above apply to these days also.

2. Background

- 2.1 The premises at 614 High Road Tottenham N17 has operated as a public house and nightclub since July 2010. The licence was granted by the Licensing Sub Committee but with conditions and reduced hours than those Mr Mufwankola had applied for. This was due to the concerns expressed by the Enforcement

Response Team relating to the potential for noise nuisance to be a real problem for nearby residents should later hours be granted. This concern was echoed by the ward members and other residents.

The reduced hours granted to the premises allowed Mr Mwafankola to operate for a period time and attracted a small number of complaints during this time. Mr Mwafankola then applied to vary the licence in 2012, this application went through without being contested.

The increase in hours lead to a series of complaints relating to noise nuisance.

- 2.2 Mr Mr Mufwankola stepped down as DPS 27 Jan 2015 and this role was taken over by a Ms Basrika . Mr Mufwankola remained as the PLH and carried overall responsibility for the operation of the premises.

There was a subsequent transfer and DPS variation on 17th March 2015 to Lisa Nankunda. The Licensing Authority were not aware of Mr Mwafankola not being in charge at the premises and made contact with him following a number of complaints from residents regarding the venue. Mr Mwafankola then transferred the licence to Ms Nankunda as he was not in day to day control of the premises or licensable activity at the time . We are aware that Mr Mufwankola took back the premises from Ms Nankundu and this matter has been subject to a court case between the parties involved.

The premises ceased operation for a period of weeks while Mr Mwafankola attended court. The Licensing Authority was only made aware of this by residents who were happy to see a sign on the premises saying it was now closed.

Mr Mufwankola took back the licence in his name on 10th August 2015. He then named himself in the role of the DPS on 5th October 2015.

A further transfer of the licence was made to a Mr Illyunga on 12th November 2015. Mr Mufwankola then re-established himself as the premises licence holder on 30th March 2016.

It is fair to say that the operation of the premises has caused public nuisance over the years. The operation and management of the premises has been the cause for complaints from residents who have been disturbed by noise emanating from the premises.

This is further exasperated by the lateness of the hours for the premises in this locality. The Enforcement Response Team submitted an application for Review of the licence in August 2016. The outcome of the review is attached as Appendix D.

3 Licensing Policy

The committee will also wish to be aware of the guidance issued under section 182 of the Licensing Act 2003. Licensing is about regulating the provision of licensable activities on licensed premises, by qualifying clubs and at temporary events within the terms of the Licensing Act 2003. The terms and conditions attached to various permissions are focused on matters which are within the control of individual licensees and others granted relevant permissions.

Accordingly, these matters will centre on the premises and places being used for

licensable activities and the vicinity of those premises and places.

The objective of the licensing process is to allow for the carrying on of retail sales of alcohol and the prevention of public nuisance, prevention of crime and disorder, public safety and protection of children from harm. It is the Licensing Authority's wish to facilitate well run and managed premises with licence holders displaying sensitivity to the impact of the premises on local residents.

In considering licence applications, where relevant representations are made, this Licensing Authority will consider the adequacy of measures proposed to deal with the potential for public nuisance and/or public disorder having regard to all the circumstances of the case.

Where relevant representations are made, this authority will demand stricter conditions with regard to noise control in areas that have denser residential accommodation, but this will not limit opening hours without regard for the individual merits of any application. This authority will consider each application and work with the parties concerned to ensure that adequate noise control measures are in place.

This Licensing Authority in determining what action to take will seek to establish the cause of concern and any action taken will be directed at these causes. Any action taken to promote the licensing objectives will be appropriate and proportionate.

3.1 Licensing hours

Where relevant representations are made, the Council will consider the proposed hours on their individual merits. Notwithstanding this, the Council may require stricter conditions in areas that have denser residential accommodation to prevent public nuisance. The Council will endeavour to work with all parties concerned in such instances to ensure that adequate conditions are in place. The Council may restrict the hours that certain premises can offer alcohol for sale for consumption off the premises for preventing crime, disorder and nuisance. It may be the case that in order to uphold and promote the licensing objective the Council feels is appropriate to refuse an application in order to achieve that requirement.

3.2 Recommendations: Powers of a Licensing Authority

- o Grant the temporary events as requested
- o Refuse the temporary events
- o Grant with conditions in a Counter Notice to include conditions that are already on the licence.

3.3 Members are asked to give detailed reasons for their decision.

4. Other considerations

Section 17 of the Crime and Disorder Act 1998 states:

"Without prejudice to any other obligation imposed on it, it shall be the duty of each authority to which this section applies to exercise its various functions with due regard to

the likely effect of the exercise of those function on, and the need to do all that it reasonably can to prevent crime and disorder in its area".

4.1 Human Rights

While all Convention Rights must be considered, those which are of particular relevance to the application are:

- o Article 8 – Right to respect for private and family life.
- o Article 1 of the First Protocol – Protection of Property
- o Article 6(1) – Right to a fair hearing.
- o Article 10 – Freedom of Expression

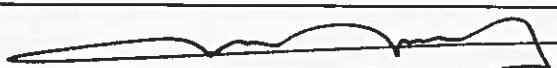

NOTES

General

In these notes, a person who gives a temporary event notice is called a "premises user".

The police and local authority exercising environmental health functions may intervene on the grounds of any of the four licensing objectives (the prevention of crime and disorder, public safety, the prevention of public nuisance, and the protection of children from harm) to prevent the occurrence of an event at which permitted temporary activities are to take place or to agree a modification of the arrangements for such an event. However, the licensing authority will intervene of its own volition in the cases described below.

First, it will issue a counter notice if there is an objection to a late temporary event notice (see note 7 below).

Secondly, it may issue a notice in relation to its decision to impose conditions on a temporary event notice (see note 2 below).

Thirdly, it will issue a counter notice if the first, second, third and fifth of the limits set out below would be exceeded. If any of the limits below are breached or if a counter notice has been issued, any licensable activities taking place would be unauthorised and the premises user would be liable to prosecution. The limitations apply to:

- the number of times a person may give a temporary event notice (50 times per year for a personal licence holder and 5 times per year for other people);
- the number of times a person may give a late temporary event notice (10 times per year for a personal licence holder and 2 times per year for other people);
- the number of times a temporary event notice may be given in respect of any particular premises (12 times in a calendar year);
- the length of time a temporary event may last for these purposes (168 hours or 7 days);
- the maximum aggregate duration of the periods covered by temporary event notices at any individual premises (21 days per calendar year); and
- the scale of the event in terms of the maximum number of people attending at any one time (a maximum of 499).

For the purposes of determining the overall limits of 50 temporary event notices per personal licence holder (in a calendar year) and of 5 for a non-personal licence holder (in a calendar year), temporary event notices given by an associate or a person who is in business with a premises user (and that business involves carrying on licensable activities) count towards those totals. The limits applying to late temporary event notices are included within the overall limits applying to the total number of temporary event notices. Note 15 below sets out the definition of an "associate".

When permitted temporary activities take place, a premises user must ensure that either:

- a copy of the temporary event notice is prominently displayed at the premises; or
- the temporary event notice is kept at the premises either in his own custody or in the custody of a person present and working at the premises and whom he has nominated for that purpose.

Where the temporary event notice is in the custody of a nominated person, a notice specifying that fact and the position held by that person must be displayed prominently at the premises.

Where the temporary event notice or a notice specifying the nominated person is not displayed, a constable or an authorised person (for example, a licensing officer, fire officer or environmental

**POLICE OBJECTION NOTICE to a Temporary Event Notice (TEN)

Police are satisfied that the grant of this Temporary Event Notice (TEN) would undermine the Prevention of Crime & Disorder and Public Nuisance objectives.

The venue has applied to extend licensable hours until 0700 hours on the days in question with the exception of 31st December 2016, 1st & 2nd January 2017 where the extension is until 0900. This venue was the subject of a recent Review after complaints from local residents about noise / disorder emanating from the venues patrons and patrons. There was also an instance of fighting amongst patrons early morning of 29th August 2016.

Whilst the venue does its best to discourage such behaviour the clientele who attend are prone to loiter outside the venue making noise nuisance and waking nearby residents. In September I met the applicant to collect CCTV and we discovered the anti-social behavior issues. He raised the point that if his clients were allowed to remain at the venue until later, 0700, then on leaving the nearby residents would already be awake and so not disturbed by the noise. Whilst I can see a certain logic in this my concerns are that even at 0700 adjacent residents are not necessarily awake for work or children going to school and at weekends they may well be woken. I am also concerned about clients who wish to leave prior to closing causing anti-social behavior as venue cannot insist they remain until 0700.

With regard alcohol sales extended until 0700 and 0900 I am concerned firstly that there is serious risk of crime / disorder originating from intoxicated clientele and secondly that intoxicated persons looking to continue drinking after other venues close, this would be latest opening venue in the area, would attend and attempt to gain entry which would risk disorder at the entrance should entry be refused.

Police consider the risk of crime / anti-social behavior at a venue selling alcohol would be increased to an unacceptable level by the extended hours applied for in this application and that despite the best intentions of the applicant that risk would still remain high.

Police object to the extended hours of alcohol sales and regulated entertainment applied for in these Temporary Event Notices.

NOTICE OF OBJECTION UNDER SECTION 104 (2) LICENSING ACT 2003.

Notice of objection is hereby given on behalf of the Enforcement Response Team for the above Temporary Event notices on the grounds of the prevention of public nuisance.

The area surrounding the premises is densely populated with residential property and the operation of the premises has led to noise nuisance some of which came from the premises operating beyond its permitted hours. This led to a premises licence review hearing on 15th September 2016.

We do not consider these hours to be appropriate having regard to the recent Review of the Premises Licence at these premises which restricted the opening hours (subject to appeal) due to anti social behaviour and noise around the premises in the early hours of the morning.

The applicant has neither considered nor proposed any measures to promote the licensing objectives, we therefore object to these TENs on the grounds that permitting these TENs would undermine the licensing objective of the Prevention of Public Nuisance.

1. No supply of alcohol may be made under the Premises Licence –
 - (a) At a time when there is no Designated Premises Supervisor in respect of the Premises Licence; or
 - (b) At a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.
2. Every supply of alcohol under the Premises Licence must be made, or authorised by a person who holds a Personal Licence.
3. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises.
 - a) games or other activities which require or encourage, or are designed to require or encourage, individuals to –
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
 - e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
4. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
5. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

Annex 1 –Mandatory Conditions

- (2) The designated premises supervisor in relation to the premises licences must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:-
- (a) a holographic mark or
 - (b) an ultraviolet feature.
6. The responsible person shall ensure that –
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures –
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Minimum Drinks Pricing

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Door supervision

All individual(s) at the premises for the purpose of carrying out a security activity must

- (a) be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or
- (b) be entitled to carry out that activity by virtue of section 4 of that Act

Annex 2 – Conditions consistent with the Operating Schedule

Staff will be made aware of, and actively promote, all four licensing objectives.

THE PREVENTION OF CRIME AND DISORDER

The premises will install and maintain a CCTV system.

CCTV is to be made available at the request of the police and other authorities and recordings must be kept for 30 days.

The premises will use registered security officers.

The premises will refuse to sell alcohol to anyone appearing to be drunk or disorderly and these people shall be removed from the premises.

The premises will work with the local authority, police, and the community.

Security Industry Registered door staff to be employed at the premises from 2000 until close when regulated entertainment is taking place.

On Tottenham Hotspur Football Club Match Days:

- Premises not to open for the sale of alcohol before 11.00 on Saturday and Sunday.
- All drinks dispensed from the bar are poured into plastic containers—4 hours before the scheduled kick off time until 1 hour after the end of the match.
- No glass bottles are sold over the bar—4 hours before the scheduled kick off time until 1 hour after the end of the match.
- A minimum of two Door Staff who have been approved by the Security Industry Authority to be employed on the premises to control the entry and exit of customers—4 hours before the scheduled kick off time until 1 hour after the end of the match.

PUBLIC SAFETY

The premises will co-operate with the local authority and the police.

THE PREVENTION OF PUBLIC NUISANCE

The premises shall be mindful as to the possibility of noise nuisance.

Customers leaving the premises after 11pm shall be supervised and directed to a different gate.

Signage will be displayed requesting that customers leave the premises quietly.

Regulated entertainment shall conclude 30 minutes before the premises is due to close to prevent excessive noise breakout as the premises empties.

Prevention of nuisance from noise / vibration

All doors and windows will remain closed during the licensed regulated entertainment activities or in any event after 11pm. The entrance door will be fitted with a self-closing device and staff required to ensure that it is not propped open. A member of staff shall be made responsible to ensure the door is opened for as brief a period as possible. Where necessary adequate and suitable mechanical ventilation should be provided to public areas

Entry to the premises will be restricted to one main entrance door to the front of the premises whilst the premise is being used for regulated entertainment licensed activity.

Annex 2 – Conditions consistent with the Operating Schedule

Entrance/exit from the premises whilst regulated entertainment licensable activities are ongoing shall be via a lobbied door to minimise noise breakout.

Structure borne noise

All speakers are mounted on anti-vibration mountings to prevent vibration transmission of sound energy to adjoining properties

Sound limits

The licensee shall ensure that no music played in the licensed premises is audible at or within the site boundary of any residential property

Outside Areas

No music will be played in, or for the benefit of patrons in external areas of the premises.

Signs shall be displayed in the external areas/on the frontage requesting patrons to recognise the residential nature of the area and conduct their behaviour accordingly. The management must reserve the right to ask patrons to move inside the premises or leave if it is felt that they could be disturbing neighbours

The number of persons permitted to utilise the terraced areas will be restricted to 5 persons at any one time.

The terraced area and conservatory may be used during the hours that alcohol is supplied.

Deliveries and collections

Deliveries and collections associated with the premises will be arranged between the hours 8 am and 8 pm so as to minimise the disturbance caused to the neighbours

Glasses will be collected from the terraced areas immediately after it shuts and no later, thereby preventing passersby access to any glasses left outside, and to prevent any neighbours in close proximity being unduly disturbed by noise of staff clearing up late at night.

Empty bottles and non-degradable refuse will remain in the premises at the end of trading hours and taken out to the refuse point at the start of the working day rather than at the end of trading when neighbours might be unduly disturbed

Plant and machinery

All plant and machinery is correctly maintained and regularly serviced to ensure that it is operating efficiently and with minimal disturbance to neighbours arising from noise

Dealing with complaints

A complaints book will be held on the premises to record details of any complaints received from neighbours. The information is to include, where disclosed, the complainant's name, location, date time and subsequent remedial action undertaken. This record must be made available at all times for inspection by council officers

Regular six monthly liaison meetings will be held where specifically requested by residents to enable neighbours to raise concerns about any aspect of the licensed activities

Patrons entering/exiting premises

Where people queue to enter the premises a licensed door supervisor shall supervise and ensure the potential patrons behave in an acceptable manner

Annex 2 – Conditions consistent with the Operating Schedule

Signs should be displayed requesting patrons to respect the neighbours and behave in a courteous manner.

Door supervisors

Door supervisors (minimum of one inside and one outside the premises) are required to be on duty from 20:00hrs until closing to ensure noise from patrons is kept to a minimum and that any anti social behaviour is prevented, thereby ensuring the nearby residents are not unduly disturbed and that patrons inside the premises behave in a safe and satisfactory manner, ensuring proper health and safety controls for all persons inside the premises.

When the premises turn out a licensed door supervisor shall supervise patrons and ensure the leave in a prompt and courteous manner, respecting the neighbours

A licensed door supervisor will be positioned on the exit door to ensure, as far as reasonably practical, that patrons do not leave with drinks

A licensed door supervisor will patrol the curtilage of the premises to prevent patrons urinating in public areas in the vicinity of the premises

Prevention of nuisance from odour

All ventilation and extraction systems shall be correctly maintained and regularly serviced to ensure that it is operating efficiently and with minimal disturbance to neighbours arising from odour

Prevention of nuisance from light

Illuminated external signage shall be switched off when the premises is closed

Security lights will be positioned to minimise light intrusion to nearby residential premises

THE PROTECTION OF CHILDREN

The premises will operate the Challenge 21 policy.

Experienced staff will be employed and there will be ongoing staff training.

After midnight those under the age of 16 must be accompanied by an adult.

Alcohol may only be sold to individuals over the age of 18 with valid proof of identification with one of the following:

- A valid passport
- A photo driving license issued in a European Union Country
- A proof of age standard card system
- A citizen card, supported by the Home Office

The premises will keep a refusals log book to record the details of the individual(s) who were refused alcohol because of lack of identification or identifications indicating that the individual is under age.

Annex 3 – Conditions attached after a hearing by the licensing authority

RESOLVED

The Committee (2010) decided to grant the application but only on a more restrictive basis and subject to a number of conditions in order to promote the licensing objectives.

Opening Hours: Monday to Thursday 07:00 to 00:30 the following day
Friday and Saturday 07:00 to 02:00 the following day
Sunday 07:00 – 00:00

Supply of Alcohol from 11am until half an hour before closing time

Provision of late night refreshment is granted as requested but must cease at closing times.

Live instrumental, non-amplified music may be played during the hours that alcohol is served but no other regulated entertainment is permitted. Non-amplified background music may be played.

All the conditions proposed in the operating schedule are to be imposed.

All of the conditions proposed by the noise team are to be imposed with the exception of the operating hours and the terrace area and conservatory which may be used during the hours that alcohol supply is permitted and restricted to 5 persons at any one time. Where these contradict the applicant's proposals, the noise team's conditions take precedence.

The conditions proposed by the police to prevent underage sales and relating to "match days" are imposed as is the Child Protection Agency Nominee's proposal to keep a refusals log book.

The premises licence shall only take effect once the Applicant has received written confirmation by the Licensing Authority that the aforementioned conditions have been met to its satisfaction.

CCTV is to be made available at the request of the police and other authorities and recordings must be kept for 30 days.

All parties are reminded if the licensing objectives are compromised the license can be reviewed

Appendix D

DECISION

The Committee carefully considered the application for a review of the premises licences, the representations made by the Licensing officer, the responsible authorities, the licence holder, the Council's Statement of Licensing Policy and the Revised Home Office Guidance issued under section 182 of the Licensing Act 2003.

The Committee was satisfied based on the evidence before it that public nuisance associated with the licensed premises had occurred both within the immediate vicinity of the premises and in the locality as well.

The Committee considered that it would be appropriate and proportionate to modify the license conditions in response to the evidence it heard because there was clear evidence of persistent noise nuisance and anti social behaviour directly associated with the premises. The licensing objectives of promoting public safety, preventing crime and disorder and the prevention of public nuisance were not being upheld by the license holder.

The times during which the Licence authorises the carrying out of licensable activities are modified as follows:

The Committee also RESOLVED that the following alterations/conditions be made to the Licensing conditions.

That the premises close no later than 23:30 Sunday to Thursday and 00:30 Friday and Saturday.

That regulated entertainment ceases thirty minutes prior to closing time i.e. 23:00 hrs Sunday to Thursday and 00:00hrs (midnight) Friday and Saturday.

That the provision of late night refreshment and the supply of alcohol cease 30 minutes before closing on Friday and Saturday only. The permitted hours are now:

Live Music and Recorded Music

Sunday to Thursday	1100 to 2300 hrs
Friday to Saturday	1100 to 0000 hrs

Amplified Music to be played until 30 minutes before closing time on days when live amplified music has been organised.

Provision of Late Night Refreshment

In addition to the conditions that already form part of the licence, the following conditions will now apply:

The licence holder will employ a minimum of two additional SIA approved doormen on Spurs home match days and on Friday and Saturday nights.

The license holder will also install a dedicated phone line for residents to contact him, in order to raise their concerns.

In addition to installing clearly legible signage reminding patrons to leave the premises quietly, the Committee recommends that the Licence holder introduce the use of security staff to act as marshals to ensure that patrons leave the premises quietly and keep noise in the surrounding streets to a minimum.

The Committee expressed that it takes the concerns raised by the responsible authority and the residents very seriously. The Committee strongly recommends that the licence holder engage in early and ongoing dialogue with the local residents. It is recommended that this could be achieved by the licence holder having scheduled meetings with the residents and or their representatives. The Committee also advises that the licence will be subject to further review if the conditions are not met.

The Committee approached its decision with an open mind and only reached a decision after having heard and considered the evidence of all the parties and considered that its decision was appropriate and proportionate in the circumstances.
