Report for Key/ Non Key Decision: Key decision

#### 1. Describe the issue under consideration

- 1.1. A new 5-year Medium Term Financial Strategy (MTFS) was presented to Cabinet on 14 February 2017 together with the proposed 2017/18 budgets. The budgets were approved by Full Council on 27 February 2017.
- 1.2. The strategy and budget contained plans for a number of waste services to be charged to the end user from 2017/18, including weekly garden waste collections, on-demand bulky waste collections and orders for new wheeled bins for refuse and recycling.
- 1.3. This report confirms the charging levels and start dates for the charged services agreed by Cabinet on 14 February 2017.

#### 2. Cabinet Member Introduction

- 2.1. The council is working to save £20million across the borough as agreed in February 2017. As part of this, following research and a budget consultation, it was decided efficiencies needed to be made within our waste service. The following changes will mean we can continue to provide a robust waste service while ensuring that more of Haringey's remaining resources can go into other essential areas.
- 3. Recommendations



- 3.1. The Cabinet Member is asked to approve the following new waste service charges for 2017-18:
  - 3.1.1. Bulky waste removal at £25 for 4 items and £10 per additional item from 24<sup>th</sup> July 2017;
  - 3.1.2. Replacement wheeled bins for refuse and recycling at £30 per bin from 31<sup>st</sup> July 2017;
  - 3.1.3. Green garden waste collections at £75 per annum from 23<sup>rd</sup> October 2017, with options for reduced capacity/cost available as set out in table 2 below.

#### 4. Reason for Decision

- 4.1. Full Council approved the 2017/18 budget and agreed the MTFS (2018/19-2021/22) on 27<sup>th</sup> February 2017 following the approval of the MTFS and proposed 2017/18 budgets by Cabinet on 14 February 2017.
- 4.2. Fees and charges relating to *existing* charged waste services were set out and agreed in an accompanying Cabinet report on 14 February 2017. However, it was intended that the new chargeable services that formed part of the MTFS would be the subject of a further Fees & Charges report following Full Council approval of the budget.
- 4.3. The Cabinet Member for Environment is now asked to approve the waste services charges and start dates, as set out in table 2 below.

#### 5. Other options considered

- 5.1. A range of savings proposals across the council's services was considered by Cabinet in December 2016 and subject to consultation.
- 5.2. Following the consultation, no other option has been considered, other than to present the charges set out within the MTFS report for formal approval by the Cabinet Member.

\* Note: The annual subscription period will be 1<sup>st</sup> April to 31<sup>st</sup> March. However, as an introductory offer, residents will, from October 23<sup>rd</sup> 2017, be able to sign up to receive the service until April 2019 for the price of twelve months. The current free of charge garden waste collection service will cease from the implementation date.

\*\* Bins will be 240 litre as standard but in special circumstances, eg. a front garden is too small to accommodate a standard size bin, the other options listed above may be possible, subject to a site visit.



# 6. Background information

- 6.1. The Council's 2017/18 budget was approved at Full Council on 27th February 2017 (Item 12: 2017/18 Budget) inclusive of proposals for introducing charges for various waste services, as laid out and agreed by Cabinet on 14<sup>th</sup> February 2017 (Item 11: Medium Term Finance Strategy 2017-18 and 2017/18 Budget). Full details of the service changes and other background were set out in Appendix 10, Annex 3 of the Cabinet report.
- 6.2. The chargeable services are expected to deliver the following financial benefits to the council in order to deliver the reduction in costs required by the MTFS:

7.1. The move to chargeable services for waste represents a significant element of the council's Medium Term Financial Strategy, the delivery of which is key to realising the ambitions for Haringey's communities as set out in the Corporate Plan.

## Finance and Procurement

8.1. The Chief Finance Officer has been consulted in the drafting of this report. The introduction of new waste charges was agreed in principle as part of the Budget and MTFS report that was approved by Cabinet in February 2017. Therefore, approval of the charges set out in this report is necessary to ensure that the original budget for waste services is delivered as approved by Cabinet and that the service does not overspend its approved cash limit.

8.2. The Assistant Director of Corporate Governance has been consulted and there are no legal implications arising from this report.
