1. Describe the issue under consideration

- 1.1 An application for the review of the Premises Licence for Harringey Snooker Club at the above address. The review application and supporting documents are located at Appendix 1. The licence is held by Mr Bahettin Dag. Mr Dag has held the licence since 3rd April 2019. A copy of the current premises licence is attached as Appendix 2.
- 1.2 Although Mr Dag transferred the premises into his own name in 2019, it is clear that he has had involvement in the day to day running of the premises as early as September 2012 when officers carried out a joint visit with the Gambling Commission and found 10 unauthorised and illegal gaming machines onsite in contravention of the Licensing Act 2003 and the Gambling Act 2005. The machines did not comply with the regulations or technical standards set by the Gambling Commission.
- 1.3 There were a further three inspection visits to the premises with the Gambling Commission and on each occasion Mr Dag was found to be continuing the practice of supplying and make use of illegal gaming machines onsite. He had been prosecuted previously in 2014 for this offence but as can be seen from the papers this did not deter his mode of operation and he went on to commit the same offence on a further three occasion. At the visit in October 2019 with Immigration Officers Mr Dag was found to be employing an individual that had restrictions placed on his stay in the UK making him unable to work. The individual was arrested by the Immigration Enforcement Officers.
- 1.4 Mr Dag is both the Premises Licence holder and the Designated Premises Supervisor under the terms of the licence and therefore carries the responsibility to ensure that the licensing objectives are being upheld and promoted.
- 1.5 The Licensing Authority is seeking a review of the premises licence on the grounds that the repeated siting of illegal gaming machines at this premises undermines the prevention of crime and disorder licensing objective and that this is detrimental to the wider community. The Licensing Authority have lost confidence in the premises licence holder as they have ignored repeated advice and have continued to replace the seized machines with other illegal machines.



- 1.6 The Guidance issued under section 182 of the Licensing Act 2003 (para 11.2) states
- that at any stage following the grant of a premises licence, a responsible authority, such as the Police or the Environmental Health Service, or any other person who can seek a review, may ask the Licensing Authority to review the premises licence because of a matter arising at the premises in connection with any of the four licensing objectives.
- 1.7 As such, in accordance with section 52(2) of the above-mentioned Act, the Licensing Authority must hold a hearing to consider the application and any relevant representations.

2. Licensing history of the premises

2.1 The premises has the ability to serve alcohol and is therefore able to apply to have gaming machines onsite. The Government's aim is for gaming machines to only be in premises where children's access is controlled. Qualifying alcohol licensed premises under the Licensing Act 2003 are entitled (under Automatic Entitlement) to provide two gaming machines of category C or D upon notification to the licensing authority (LA). Automatic Entitlements are only applicable to alcohol licensed premises, where there are bar facilities available on the premises for the sale and consumption of alcohol. In order to site more than two category C or D.

2.2 **Notification** (for a maximum of two machines)

To take advantage of this entitlement, the Premises Licence Holder must give notice to the Council of their intention to make gaming machines available for use, and must pay the prescribed fee.

2.3 **Permit** (for three or more machines)

Relevant premises may also apply for a permit to provide a greater number of machines. This means obtaining a Licensed Premises Gaming Machine Permit from the Council. A Licensed Premises Gaming Machine Permit allows any number of Category C or D machines to be provided in licensed premises.

- 2.4 Harringey Snooker Club has made no such application and does not hold either the normal notification of 2 machines or the Premises Gaming machine permit.
- 2.5 The current licence permits:

Supply of Alcohol

Sunday to Thursday 1100 to 2330 Friday & Saturday 1100 to 0130 Good Friday 1200 to 2230

Christmas Day 1200 to 1500 and 1900 to 2230

Provision of Late Night Refreshment

Sunday to Thursday 2300 to 0000 Friday & Saturday 2300 to 0200

Supply of alcohol for consumption ON the premises only



- 2.6 These review proceedings are brought under the licensing objectives crime and disorder. Mr Dag has a previous conviction for this activity and is facing further prosecution. The machines being placed on site are not being sourced and maintained by a Gambling Commission licensed supplier as required under the Gambling Act 2005.
- 2.7 If a machine is illegally supplied this poses a risk to the first licensing objective of keeping crime out of gambling. A machine that does not meet the regulations and technical standard requirements may also risk the fair and open licensing objective and therefore pose a risk of harm to members of the public interacting with these machines.
- 2.8 It is the responsibility of the business owner to ensure the machine meets the regulatory requirements prior to making them available for use to the public. If a machine fails to meet the requirements above, it is the business owner and not the machine supplier that is liable for this.
- 2.9 There are some gaming machines that are not permitted by anyone, even licensed premises. These include;
 - Joker Poker gaming machines these may not all pay out cash but accrue credits which are redeemed in another way.
 - Black Horse machines are not authorised by the Gambling Commission here in the UK and cannot be legally sited on a premises.

There is no application process that will enable premises to have these machines.

Betting Terminals are only permitted in premises licensed under the Gambling Act 2005 such as licensed book makers.

- 2.10 Advice on the legality of Joker Poker machines, these machines often state 'For Amusement Only'. The Gambling Commission Officer advised that:
 - 1. As poker is a game of chance the machines displaying poker are gaming machines.
 - 2. Gaming machines must be supplied by a Licensed (by the Gambling Commission) Gaming machine supplier.
 - 3. Gaming machines must comply with the Commission's technical standards joker poker machines have never been tested therefore would not comply with technical standards.
 - 4. Gaming machines must meet the S240 Regulations i.e. display appropriate signage, Social Responsibility information, stakes and prizes, gaming machine category.
- 2.11 The Gambling Commission Officer also stated that if officers simply ask the premises owner to remove the machines, the machines would remain in circulation and be moved to another premises in the borough. They therefore recommended seizing the machines instead.
- 2.12 It is an offence under Section 242 of the Gambling Act 2005 for a gaming machine to be illegally sited on any premises. It is also an offence under Section 243 of the Gambling Act 2005 to supply a gaming machine which does not comply with Section 241 of the Gambling Act 2005 and/or the supplier does not have the appropriate operating licence.



Both offences carry an unlimited fine and/or 51 weeks imprisonment upon conviction.

2.13 Mr Dag is represented by Mr Berg of Jane Solicitors and has submitted documents in support of Mr Dags position along with letters of support from users of the premises. (App 3)

3 Other considerations

- 3.1 A number of reviews may arise in connection with crime that is not directly connected with licensable activities. The Guidance (11.27) states that there are certain criminal activities that may arise in connection with licensed premises, which the Secretary of State considers should be treated particularly seriously. The list includes unlawful gambling.
- 3.2 The guidance (11.28) goes on to say that it is envisaged that responsible authorities will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence even in the first instance should be seriously considered.
- 3.3 The Licensing Authority RA is of the opinion that the problems associated with the alleged crimes are affecting the promotion of the licensing objectives. The Licensing Authorities duty is to take steps with a view to the promotion of the licensing objectives in the interests of the wider community and not those of the individual licence holder.
- 3.4 Reviews are part of the regulatory process introduced by the 2003 Act and they are not part of criminal law and procedure. There is, therefore, no reason why representations giving rise to a review of a premises licence need be delayed pending the outcome of any criminal proceedings. Some reviews will arise after the conviction in the criminal courts of certain individuals, but not all. In any case, it is for the licensing authority to determine whether the problems associated with the alleged crimes are taking place on the premises and affecting the promotion of the licensing objectives. Where a review follows a conviction, it would also not be for the licensing authority to go beyond any findings by the courts, which should be treated as a matter of undisputed evidence before them.
- 3.5 Where the licensing authority is conducting a review on the grounds that the premises have been used for criminal purposes, its role is solely to determine what steps should be taken in connection with the premises licence, for the promotion of the crime prevention objective. It is important to recognise that certain criminal activity or associated problems may be taking place or have taken place despite the best efforts of the licence holder and the staff working at the premises and despite full compliance with the conditions attached to the licence. In such circumstances, the licensing authority is still empowered to take any appropriate steps to remedy the problems. The Licensing Authority's duty is to take steps with a view to the promotion of the licensing objectives in the interest of the wider community and not those of the individual licence holder.

3.6 **Options**



The Committee must, having regard to the application and the representations, take such steps (if any), as it considers appropriate for the promotion of the licensing objectives. The options are:

- To modify the conditions of the licence
- To exclude a licensable activity from the scope of the licence
- To remove the designated premises supervisor
- To suspend the licence for a period not exceeding three months
- To revoke the licence
- To take no action.
- 3.7 The Sub-Committee must ensure that all licensing decisions have:
 - a direct relationship to the promotion of one or more of the 4 licensing objectives;
 - regard to the Council's statement of Licensing Policy;
 - regard to the Secretary of State's National Guidance.

Where the authority modifies the conditions or excludes a licensable activity from the scope of the licence it may determine that the modification or exclusion is to have effect permanently or for a period not exceeding 3 months.

- 3.8 The Licensing Authority's determination of this application does not have effect until the 21 days' appeal period has expired or if the decision is appealed, the date the appeal is determined and or disposed of.
- 3.9 Section 182 Guidance relevant sections.

The most recent statutory guidance was Issued in April 2018 and applies to this application.

3.10 The following provisions of the Secretary of State's guidance (2018) apply to this application:

Chapter 11-this chapter gives guidance around the review process and determining an application for a review.

- 3.9 Guidance issued under section 182 of the Licensing Act 2003 (para 11.2) states that at any stage following the grant of a premises licence or club premises certificate, a responsible authority, or any other person, may ask the licensing authority to review the licence or certificate because of a matter arising at the premises in connection with any of the four licensing objectives.
- 3.10 In accordance with section 52(2) of the Act, the Licensing authority must hold a hearing to consider the application and any relevant representations.
- 3.11 Section 11.27 -There is certain criminal activity that may arise in connection with licensed premises which should be treated particularly seriously. These are the use of the licensed premises:
 - for the sale and distribution of drugs controlled under the Misuse of Drugs Act 1971 and the laundering of the proceeds of drugs crime;
 - for the sale and distribution of illegal firearms;



- for the evasion of copyright in respect of pirated or unlicensed films and music, which does considerable damage to the industries affected;
- for the illegal purchase and consumption of alcohol by minors which impacts on the health, educational attainment, employment prospects and propensity for crime of young people;
- for prostitution or the sale of unlawful pornography:
- by organised groups of paedophiles to groom children;
- as the base for the organisation of criminal activity, particularly by gangs;
- for the organisation of racist activity or the promotion of racist attacks;
- for employing a person who is disqualified from that work by reason of their immigration status in the UK:
- for unlawful gambling; and
- for the sale or storage of smuggled tobacco and alcohol.

3.12 Section 17 of the Crime and Disorder Act 1998 states:

"Without prejudice to any other obligation imposed on it, it shall be the duty of each authority to which this section applies to exercise its various functions with due regard to the likely effect of the exercise of those function on, and the need to do all that is reasonable to prevent crime and disorder in its area".

3.13 Human Rights

While all Convention Rights must be considered, those which are of particular relevance to the application are:

- Article 8 Right to respect for private and family life.
- oArticle 1 of the First Protocol Protection of Property
- ○Article 6(1) Right to a fair hearing.
- ○Article 10 Freedom of Expression

This application relates to several different offences on different dates that I have listed in date order.

11th October 2019

On the 11th October 2019, Sarah Greer, ASB Specialist (Environmental Crime) carried out a joint visit with Mohammed Shafiq, Compliance Manager, Gambling Commission and officers from North London Compliance and Enforcement (ICE) Team, at Haringey Snooker Club, 1-5 Salisbury Promenade, Green Lanes, N8 0RX. Intelligence had been received that the business was making gaming machines available for use on the premises without an operating licence and person/s were working on the premises that were not permitted.

When we entered the premises only one person was working behind the counter, this male was spoken to by officers from North London Compliance and Enforcement (ICE) Team, and then subsequently arrested under the immigration Act 1971, for working in breach of his leave conditions.

Four (4) gaming machines were found to be on the premises in a concealed room These were inspected by the gambling commission and were found to be illegal as they were not compliant with the Gambling Regulations or Commissions Technical Standards.

Dag Bahattin, date of birth , of , of , Cheshunt, , came into the business and identified himself to me as the owner of Haringey Snooker Club, 1-5 Salisbury Promenade, Green Lanes, N8 0RX. Dag Bahattin informed me that the gaming machines had been on the premises for over one month.

As offences had been committed on the day under the Gambling Act 2005, this case has been referred for prosecution and a summons has been issued for a court hearing on the 21st July 2020 at Highbury Magistrates Court.



On the February 2020, Azhar Akram of HMRC, visited Haringey Snooker Club, 1-5 Salisbury Promenade, Green Lanes, N8 0RX. when he arrived on the premises, he observed four (4) gaming machines and one (1) betting terminal being made available for use. This information was passed over to the Gambling Commission and then forward onto me.

As offences had been committed on the day under the Gambling Act 2005, this case has been referred for prosecution.

31st October 2012
On the 31st October 2012, Dag Bahattin, date of birth , of Cheshunt, Cheshunt, came into the council office at Lea Valley Technopark, Ashley Road, Tottenham, N17 9LN to sign a simple caution for offences under the Gambling Act 2005.
On the 17 th September 2012, Haringey Council Officers visited the premises with officers from the Gambling Commission and found ten (10) gaming machines available for use on the premises. On the day the machines were inspected by the gambling commission and were found to be illegal as they were not compliant with the Gambling Regulations or Commissions Technical Standards.
As this was a first offence it was agreed that Dag Bahattin would be offered a simple caution, for the purpose of council records only. Dag Bahattin accepted that he had committed an offence and the caution was issued and signed.

- 1. I am Sarah Benning and I am employed by the London Borough of Haringey as a Tactical Enforcement Officer. Part of my duties includes the inspection of any premises within the London Borough of Haringey to ensure that the premises hold the correct authorisation, namely a premises licence issued under the Licensing Act 2003, by the Council, as the relevant Licensing Authority and to enforce offences contrary to the Gambling Act 2005.
- 2. A premises licence allows a premises to carry on a licensable activity on or from their premises namely; the sale by retail of alcohol, the supply of alcohol by or on behalf of a club to, or to the order of, a member of the club, the provisions of regulated entertainment and the provisions of late night refreshments. A premises Licence also allows for up to two category C or D gaming machines. All alcohol licensed premises which provide gaming machines for use on the premises must comply with any relevant Code of Practice issued by the Gambling Commission under Section 242 of the Gambling Act 2005. I exhibit a copy of the premises licence as SB01.
- 3. On Friday 21st March 2014, at 19:48 hours, I visited Harringay Snooker Club, Club 1-9, Salisbury Promenade, Green Lanes, Hornsey, N8 0RX, as part of a multi agency licensing inspection with the Police.
- 4. As I entered the premises I observed eight (8) gaming machines available for use within the business. I identified the machines as two (2) Black Horse gaming machines, two (2) Joker Poker gaming machines, one (1) Roulette Interplay gaming machine, one (1) Casino Crazy category B4 gaming machine and one (1) Cops and Robbers category B4 gaming machine. I observed a male playing on the Black Horse gaming machine. I exhibit photographs taken of the machines as SB1.
- I identified myself to a male who was working behind the counter by showing him my authorisation. The male gave his details as Sezer Tutmez, date of birth authorisation. Sezer Tutmez informed me that he was looking after the business whilst the manager was away in Turkey.
- The Manager arrived shortly after and I identified myself to him by showing him my authorisation. The Manager identified himself to me as Dag Bahattin, date of birth Dag Bahattin informed me that the machines had been in the premises for over three months and were supplied by a Turkish Cypriot male called Ozzie who comes in to collect the money from the machines every Monday. I informed Dag Bahattin that as I believed an offence had been committed under the Gambling Act 2005, I would be inviting him into my office

Dag Bahattin failed to attend this appointment. I exhibit a copy of the letter as SB7.
- 12. On the 2ND November 2014, I received an email from George Roberts, Enforcement response Officer informing me that that on a visit to Harringay Snooker Club, Club 1-9, Salisbury Promenade, Green Lanes, Hornsey, London, N8 0RX, he had observed several gaming machines on the premises. I exhibit a copy of the email as SB8.
- 13. On the 13th November 2014, I visited Harringay Snooker Club, Club 1-9, Salisbury Promenade, Green Lanes, Hornsey, London, N8 0RX, as part of a multi agency operation with the Police and the Gambling Commission.
- 14. As I entered the premises I observed six (6) gaming machines available for use within the business. I identified the machines as one (1) Black Horse gaming machine, two (2) Joker Poker gaming machines, one (1) Roulette Interplay gaming machine, one (1) Casino Crazy category B4 gaming machine and one (1) Cops and Robbers category B4 gaming machine. I exhibit photographs taken of the machines as SB9.

- 2. A premises licence allows a premises to carry on a licensable activity on or from their premises namely; the sale by retail of alcohol, the supply of alcohol by or on behalf of a club to, or to the order of, a member of the club, the provisions of regulated entertainment and the provisions of late night refreshments. I, Nigel OWEN, am employed by the Gambling Commission and prior to that the Gaming Board as a Sector Specialist - gaming machines. I have held this position since 2003.

My background is that of an engineer, I was awarded an honours degree in engineering in 1982 (B. Eng). My role as Sector Specialist - gaming machines covers the whole of Great Britain and requires me to, amongst other things, analyse aspects of gaming machine design and operation to ensure compliance with appropriate legislation, regulations and technical standards.

I have read the witness statement of Azhar AKRAM, Assurance Officer HMRC, dated 8 April 2020 and have been asked by the London Borough of Haringey to provide a statement regarding four machines observed during an inspection on 27 February 2020 of a snooker premises within the Borough. Two of the machines are marked with the wording 'Black Horse' and two have the name 'Royal Flush 500' on them. I have been asked to state whether in my opinion these are compliant gaming machines as defined by the Gambling Act 2005, Section 235(1) and associated regulations.

I have not been able to personally examine the machines and am basing my statement on four photographs provided by Azhar AKRAM of HMRC, referenced as AA1 in the statement of 8 April 2020.

The name 'Black Horse' is a product name given to generic gaming machine cabinets made by the manufacturer 'Vegas pi' a company in Poland. I have some experience of this specific make of machine, having previously examined several other examples and provided statements for court cases involving this make of machine over several years in the London and South Wales areas.

All of the cabinets of this name that I have seen in the past give the player the option to select from a number of different games such as roulette, poker and blackjack as well as more conventional fruit machine style reel based games.

The two 'Royal Flush 500' machines are superficially identical and show a representation of a poker game on their screens. These are of a type I have seen in the past and each machine only plays a single type of game, poker.

All four machines show graphics on screen which are at the very least 'presented as involving an element of chance', section 6(2)(a)(iii) of the Gambling Act 2005 defines this as a game of chance. On the assumption that a prize is offered this would make all four machines gaming machines.

Whilst I am unable to examine the machines, observations from the photographs tell me that three of the machines do not have the required statutory notices displayed such that they can be clearly seen. Without these statutory notices the machines are non-compliant. For completeness, notices of the following must be displayed as required by regulation:

- Category of gaming machine.
- Telephone number from which help for problem gambling may be obtained.
- No under 18s warning unless these are category D machines.
- · Information relating to the percentage of cost to play that is returned by way of prizes (%RTP).

One of the 'Royal Flush 500' machines does have a partly damaged statutory notice attached to the front of the machine to the top right of the main screen. This notice is





 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
 - e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 4. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 5. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

Annex 1 – Mandatory Conditions

- (2) The designated premises supervisor in relation to the premises licences must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:-
- (a) a holographic mark or
- (b) an ultraviolet feature.
- The responsible person shall ensure that
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures –
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Minimum Drinks Pricing

- A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979

Annex 2 - Conditions consistent with the Operating Schedule

THE PREVENTION OF CRIME AND DISORDER

CCTV will be installed and maintained and be in constant operation.

Customers will not be permitted to take alcoholic beverages outside of the premises.

Staff will be trained not to supply alcohol to intoxicated individuals.

Photo identification procedures will be introduced for holders of membership to the premises.

PUBLIC SAFETY

No person shall be admitted to membership of the said club without an interval of at least two days between nomination or application for membership and admission.

No intoxicating liquor may be sold or supplied otherwise than to: (a) A member of the club who has been a member for at least two days or whose nomination or application for membership was made at least two days before his admission. (b) A guest of such a member bona fide entertained by him at his expense.

The name and address of a person so applying must be prominently displayed on the club premises in a part frequented by members for at least two days before his election.

Intoxicating liquor may only be sold to members of the club meeting at the within mentioned premises for consumption by those members or their bona fide guests.

THE PREVENTION OF PUBLIC NUISANCE

Signage will be displayed requesting patrons depart the premises quietly and please respect the neighbours.

THE PROTECTION OF CHILDREN

Individuals under the age of 18 and non-members will not be permitted on the premises.

Alcohol may only be sold to individuals over the age of 18 with valid proof of identification with one of the following:

- A valid passport
- A photo driving licence issued in a European Union Country
- A proof of age standard card system
- A citizen card, supported by the Home Office.

1. General Background And Current Position

i.The current licensee of the The Haringey Snooker Club has held a licence permitting the sale of alcohol subject to the relevant conditions since the 24th November 2005. The licensee and DPS is Mr Bahattin Mr Bahattin Huseyin Dag is the son of the owner of the club Mr Bahattin Dag. Mr Bahattin Dag senior is described as the owner of the club on the basis that he is the sole shareholder and director of Haringey London Snooker Ltd which was incorporated on the 20th December 2017. The Club premises are held by virtue of a 20 year lease from Lazari Investments Ltd. It must be emphasized that it is Mr Bahattin Dag senior who has been prosecuted and cautioned in the past for permitting illegal gaming machines on the Club's premises.

ii.The Club occupies prominent first floor premises in Green Lanes Haringey. Facilities in the club include the following; 7 snooker tables, 1 3 ball table, 3 American Pool tables, 4 English Pool tables, 2 table tennis tables and 4 tables

for miscellaneous board games. There is bar and food is served during opening hours. The Club is open 7 days a week as per the licensing hours and entry and playing is restricted to members and their guests. There are normally 6 staff employed at the Club.

iii. The Club has obviously been closed since the start of "lockdown" and remains closed until the Government Covid restrictions for indoor sports venues are lifted. However during lockdown the club has undergone extensive redecoration and refurbishment and the premises will enjoy an enhanced environment as a consequence of this refurbishment upon re-opening which hopefully will be possible in the not too distant future. Like so many businesses the Club has suffered severe financial hardship as a consequence of the covid 19 pandemic and the aspiration of the owner and management is to reopen at the first available opportunity and continue to provide the normal facilities for the members and their guests.

2. Serving The Community

i. The membership of the Club clearly reflects the diversity of the community which it serves. Both Mr Bahattin Dag senior and his son are of Turkish background and origins. Over the past 15 years or so the Club has gained the status of a genuine community hub and meeting place. The premises are large and now decorated to an extremely high standard.

The letters and emails of support which have already been forwarded to the L.B. Haringey demonstrate the pleasure derived from members and how they would be genuinely disappointed if the Club was forced to close as a consequence of the present review of the licence. It will be noted in particular that the letters and emails of support have been sent by those representing local businesses and also individuals. In particular the following sections from those letters and emails include the following: " it's a safe environment for the young generation". it has increased our children's mental health greatly". "...... I have never experienced any trouble". " It's a good environment for teenagers and all ages". "..... I strongly believe it is a safe place and will be very disappointed if anything was to happen". " Haringey Snooker Club has always been at the heart of Green Lanes. It has been a role model for many establishments". And can confidently inform the community that the staff deals with every customer with the same satisfaction criteria ensuring the gender equality criteria are met". "As an engineer with 2 university degrees I can strongly and ethically say that the establishment is a cultural place for the community as it welcomes everyone form every background". "Mr dag has always been a helpful and trusted person to plenty of other businesses around the local area.....he is a pillar of this community and this is a feeling shared by many other

businesses around the local area including myself" "We are
all a family in Haringey Green Lanes, these bonds are built with trust
over the years and Mr Dag has played a huge role in being part of that".
"The team at Haringey Snooker Club helps also supporting
local public by having many wonderful offers such as happy hours and a
lot of other different discounts" I`m kind of surprised that our
local authorities are even considering applying such a severe measure
against our snooker club whatever the offence. " "Haringey needs
places like this "" I have known Mr Dag for so many years and I
know how important it is for him to keep his customers
safe"" "I would like it to be noted that most of our
community visits Haringey Snooker Club regularly due to it being a safe
environment where people could engage recreational activity to relieve
stress." "Haringey Snooker Club is most definitely one of the
safest thanks to management resolving any issues without letting it grow it

resolving disputes" "As Haringey community we believe
Haringey Snooker is a respectful and friendly centre" "The
snooker club has helped trouble youth to stay out of common trouble
and to ensure them to follow correct paths in staying safe and not being
encouraged by illegal activity".

- ii. Apart from serving the community to provide a popular sport the club sponsors a youth football team based in the Haringey area.
- iii. The above glowing testimonials clearly establish the importance of the club in the local community and as will be noted many of the authors of the letters emphasise the very safe environment which prevails at the premises. Against that background of support it would be an extremely drastic and disproportionate measure to deprive the club of it`s alcohol licence.

3. Reasons For Review

- i. The reasons for a review of the current licence are clearly set out in the Review Application served on the club on the 9th June 2020. On 4 occasions, February 2020, 11th October 2019, 13th November 2014 and the 17th February 2012 unlicensed gaming machines were discovered in the club by officers of the L.B. of Haringey. These findings have resulted in a formal caution and a prosecution of Mr Bahattin Dag the owner and at relevant times the licensee and DPS.
- ii. On behalf of the Haringey Snooker Club it is accepted that these breaches of the law are in direct conflict with the first licensing objective which is to "reduce crime and disorder". However, the Committee are

specifically requested to take into account the fact that the review is not precipitated by any of the following:-

Illegal sales of alcohol

Use of or availability of controlled drugs in the premises.

Disorderly conduct or situations in which police presence is required to break up or put a stop to unruly conduct. In fact on at least one occasion the management of the club provided the police voluntarily with CCTV footage which captured a violent fight which took place in Green Lanes.

Instances of fighting or other anti-social or violent behavior.

4. Going Forward

i. As stated in this document the current licensee is the son of the owner. He is a young man of 22 years of age and has successfully completed a recognized course on the subject of alcohol licensing. Licensing Committee and other interested parties before the sitting of the committee.

ii. The Club realizes that the repeated presence of unlicensed gaming machines has place the licence in jeopardy and is prepared to take measures to prevent situations of this nature occurring in the future.
