

NOTICE OF A CASE OF SPECIAL URGENCY FOR THE MAKING OF A KEY DECISION¹

¹ In accordance with Regulation 11(2) of the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012.

- 1. Where a decision maker intends to make a key decision,² that decision must not be made until at least 28 clear days public notice has been given³.
- 2. Where the publication of the intention to make a key decision is impracticable, that decision may only be made where the Chair of the Overview and Scrutiny Committee has been informed of the matter about which the decision is to be made, notice to the Chair has been made available for public inspection at the Council offices and published on the Council's website, and after 5 clear days have elapsed following the day on which notice to the Chair was made publicly available⁴.
- 3. Where the date by which a key decision must be made makes compliance with the requirements of paragraph 2 above impracticable the decision may only be made where the decision maker has obtained agreement from the Chair of the Overview and Scrutiny Committee that the making of the decision is urgent and cannot reasonably be deferred⁵.
- 4. This notice⁶ confirms that the Chair of the Overview and Scrutiny Committee has agreed that the making of the key decision in relation to the business set out below is urgent and cannot reasonably be deferred for the reasons set out below.

- to result in the local authority incurring expenditure which is, or the making of savings which are, significant having regard to the local authority's budget for the service or function to which the decision relates; or
- to be significant in terms of its effects on communities living or working in an area comprising two or more wards or electoral divisions in the area of the local authority.

3 March 2021	Hardship Fund allocation	In March 2020, the Government announced in the budget that it would provide local authorities with £500m of new grant funding to support economically vulnerable people and households in their local area. Haringey's allocation was £3,663,000, with £1.66m remaining to be allocated. The Hardship Fund is available until 31 March 2021, and a decision is required in order to distribute funds to those in need before the fund ends.	Cabinet Member Signing	Leader of the Council Director of Customer, Transformation and Resources	Report of the Director of Customer, Transformation and Resources	Public	The Hardship Fund allocated by the Government is available until 31 March 2021. An urgent decision is required to ensure that payments are made to support vulnerable people in the period to then. Any delay in taking the decision will impact on the support provided to families with children, other vulnerable households and individuals.

Please be advised that the Chair of Overview and Scrutiny has further agreed that the call-in procedure shall not apply to this urgent decision. This is because the decision is urgent and any delay in implementation caused by the call-in procedure would seriously prejudice the Council's or the public's interests due to the fact that any delay in decision making will impact on the timely support needed for families with children, other vulnerable households and individuals. Accordingly, the Chair of Overview and Scrutiny Committee has agreed that the decision is both reasonable in all circumstances, and that it should be treated as a matter of urgency. This is in accordance with Part 4, Section H, and Paragraph 18 of the Council Constitution.
