- 3. This notice is to inform the Chair of the Overview and Scrutiny Committee that it has been impracticable to give 28 clear days public notice of the item(s) set out below for the reasons set out below and that it is intended that the key decision(s) will be made on the date specified below.
- 4. Notice is also given to the public that the reasons why compliance with the requirements for publicity in connection with key decisions are impracticable are set out below.

5. The Chair of the Overview and Scrutiny Committee has agreed that the Cabinet may hold a private meeting to consider the business referred to in paragraph 4 above because the meeting is urgent and cannot reasonably be deferred for the reasons stated below.

Following the termination of the contract with Cosmur Construction (London) Ltd there is an urgent need to procure a contractor to complete remaining works. This will facilitate the relocation of Clarendon Road Recovery College into Canning Crescent allowing for Clarendon Road to be refurbished for homeless accommodation. It was originally intended to relocate services by March 2022. The significant delay is impacting on the delivery of this critical service both financially and operationally. It is also preventing the Council from meeting its obligations in the Corporate Plan to improve the mental health of our residents and to provide supported living accommodation. It was the intention to include this report in the November Forward Plan but protracted tender clarifications prevented the final report from being completed by this time. The decision cannot await until January 2024 as the works need to start to be completed as soon as possible.
