1. Describe the issue under consideration

Finance and Procurement

8.1 Some of the recommendations in this report are around publicity and communications and if agreed can be contained within the existing resources. However, a number of recommendations if agreed would subsequently require a much more in-depth financial analysis to ascertain the financial impact and these will have to be presented in separate reports for cabinet consideration and approval. Some of these recommendations relate to attraction and retention of professional and technical staff; retrofitting of sprinklers.

Legal

- 8.2 Under Section 9F Local Government Act 2000 ("The Act"), Overview and Scrutiny Committee have the powers to review or scrutinise decisions made or other action taken in connection with the discharge of any executive and non-executive functions and to make reports or recommendations to the executive or to the authority with respect to the discharge of those functions. Overview and Scrutiny Committee also have the powers to make reports or recommendations to the executive or to the authority on matters which affect the authority's area or the inhabitants of its area.
- 8.3 Pursuant to the above provision, Overview and Scrutiny Committee has conducted a review of Fire Safety in High Rise Blocks and made a number of recommendations to Cabinet. Overview and Scrutiny Committee must by notice in writing require Cabinet to consider the report and recommendations. Once approved, the report and recommendations should be presented to the next available Cabinet meeting together with an officer report where appropriate.
- 8.4 Under Section 9FE of the LGA, there is a duty on Cabinet to respond to the Report, indicating what (if any) action Cabinet proposes to take, within 2 months of receiving the report and recommendations.

- 8.5 The Council has a public sector equality duty under the Equalities Act (2010) to have due regard to:
 - Tackle discrimination and victimisation of persons that share the characteristics protected under S4 of the Act.
