The Premises Licence Holder listed on the Premises Licence for the venue on 21st June 2006 is Mr Huseyin Karakus who gave his registered address as the venue. The Designated Supervisor is listed as Melek Celik who is a Personal Licence Holder. I phoned Mr Karakus regarding the venues present position and he requested I liaise via his daughter Narin. I phoned Narin on 25th November 2019 and she was aware of the situation and willing to assist as her fathers representative and gave me her email address. She stated Mr Karakus was living in Bethnal Green and due to health concerns had been subletting the venue to another person for some years. I emailed her for further details of Mr Karakus and Ms Celiks connection with the operation of the premises relating to The Licensing Act 2003. She responded that Ms Melik Celik was their inlaw who was divorced and ended her connection with them around 2011 when Mr Karakus let the premises to Mr Sumbul. She stated that since then Mr Karakus and herself stopped the day to day running of the business premises and believes no one has even renewed the yearly fee for selling alcohol in the premises. The failure to pay the yearly licence renewal was confirmed by Haringey Council Licensing. An undated contract in her email let the venue to another person so at least 2 persons have sub-let the venue since 2011 running it under the Premises Licence with out that licence being Transferred or the Designated Premisise Supervisor being varied. This suggests for about 8 years this premises has had no Designated Premises Supervisor and was run with no input from the Premises Licence Holder.

PC Boulter the Dedicated Ward Officer covering the venue states both he and colleagues have received complaints from local residents that the venue attracted individuals who have the appearance of drug users to the area which causes residents to feel unsafe in the area.

On Wednesday 29th June 2016 Police attended the venue to execute a warrant issued by Highbury Corner Magistrates Court under Sec 23 (3) Misuse of Drugs Act 1971. Officers conducted the search of the premises and found a carton of sun exotic juice, empty with the bottom cut out, next to a sofa in the main area. It contained 19 small self bags of Cannabis. Officers arrested the lone male occupant who stated he was a customer but had keys to the venue stating he was looking after them. The suspect was not one of those mentioned in Narins email. CRIS: 2816419/16 refers.

On Thursday 1st December 2016 Police attended the venue to execute a warrant issued under Sec 23 (3) Misuse of Drugs Act 1971. They searched four persons inside the venue and arrested one of them for possession of cannabis for personal use. CRIS: 2831151/16 refers.

Narins email states Mr Karakus is considering sub letting the venue to another person.

The responsibility of the Premises Licence Holder is to promote the Licensing Objectives relating to The Prevention of Crime and Disorder, Public Safety, The Prevention of Public Nuisance and The Protection of Children whilst the Designated Premises Supervisor authorities the supply of alcohol. Police consider that Mr Karakas has failed in his obligations by having nothing to do with the day to day running of the premises for 8 years whilst there has been no Designated Premises Supervisor. Police consider this lack of attention to the venue has resulted in the drug dealing issues there and the resulting anti-social behaviour to local residents. Police consider the Premises Licence relating to this venue should be revoked.
