That the Cabinet agree the new charging model for Planning & Regeneration. That the Cabinet propose the increases are implemented from 1 April 2009.

That the Cabinet will formally approve the increases proposed to the existing fees &

charges that will apply from 1 April 2009.

## 5. Reason for recommendation(s)

- 5.1. The Council's external income policy has two fundamental principals: (i) Services should raise income wherever there is the power or duty so to do; and (ii) the income should (at least) cover the full cost, including all overheads of the service.
- 5.2 The Council's budget setting assumes an inflationary increase in Planning & Regeneration fees and charges.

6.1 The review of fees and charges considered the budgeted increase to charges.

  - Current economic climate
  - The fees and charges of neighbouring boroughs.
  - The increase in materials and other costs.

#### 7.2 Planning Fees

• Planning Fees are nationally set and will therefore not be appearing in this report.

## 7.3Building Control Fees

 Building Control Fees are set following a benchmarking exercise with 'nearest neighbours' that is yet to be completed. These fees are likely to increase and will be agreed under delegated powers.

### 8. Chief Financial Officer Comments

8.1 The proposed fees and charges set out in the appendices are broadly based on inflationary uplifts of 2% allowing for some rounding to collectable amounts. VAT in the appendices is charged at the rate of 15% where appropriate. The rate is expected to return to 17.5% from 1<sup>st</sup> January 2010.

The increases proposed in this report will be sufficient to meet the Planning & Regeneration budget target assumptions in respect of the services included. Generally fees and charges should be set in line with the Council's external income policy agreed by Members. The policy requires budget holders to review fees and charges against corporately set criteria as well as other factors that may be relevant.

All of the fees and charges being considered in this report have been reviewed and the policy is basically being complied with or steps are being taken to achieve compliance.

## 9. Head of Legal Services Comments

9.1. The Head of Legal Services agrees with the recommendations and notes that the proposals entail consultation. An increase in line with a 2% overall uplift is considered legally sound provided there are no exceptional disproportionate uplifts well in excess of 2% in any particular case.
