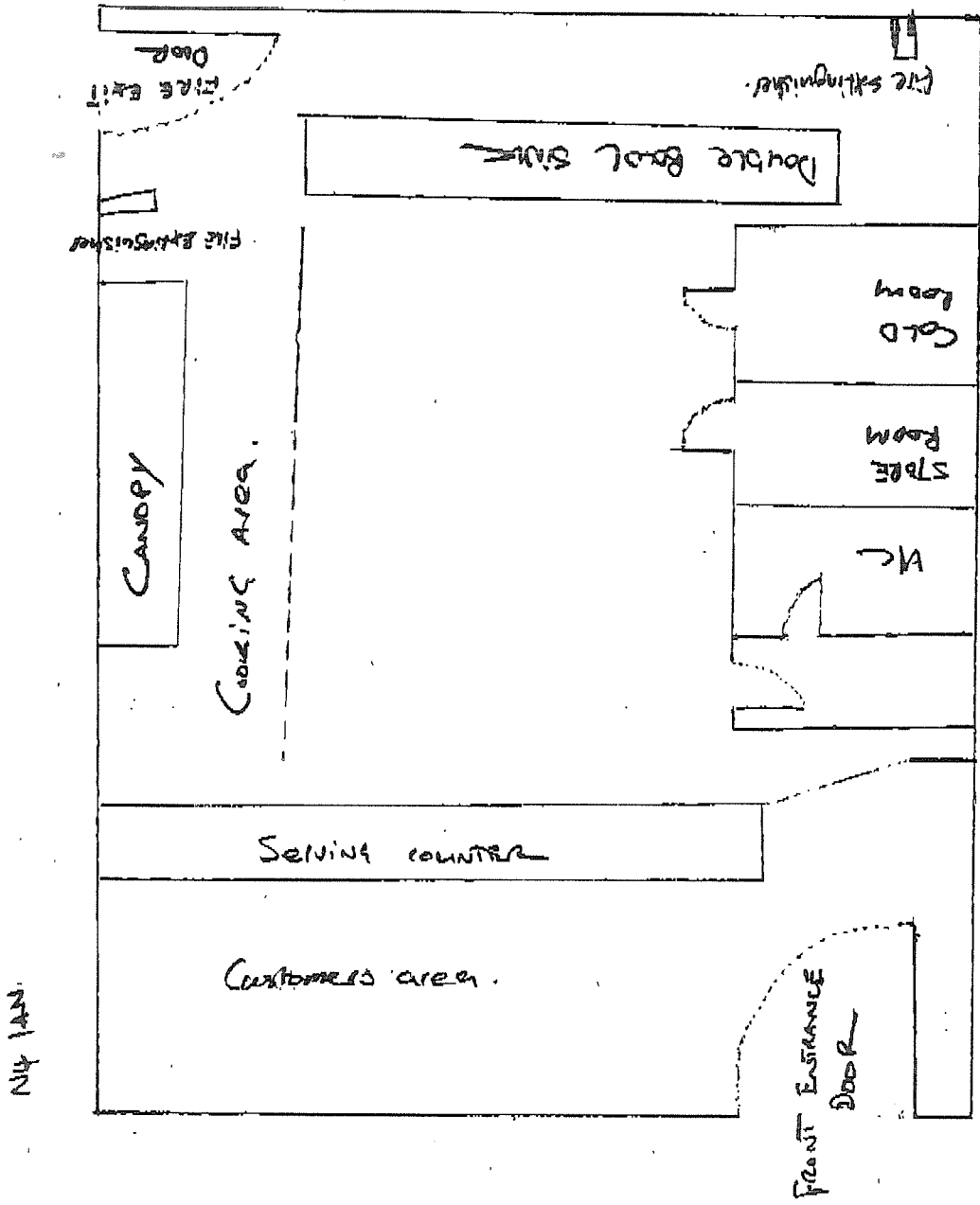

To whom it may concern:

I am contacting you to object to the current application from Zam's Fried Chicken, 527 Green Lanes, London N4 for a late night takeaway license. As a local resident, I clearly see the litter already created by this establishment, and allowing them to stay open later will only add to this problem. Chicken bones and packaging is scattered around the bottom of Seymour Road every morning as it is.

I am also worried about the fact that a late night opening will attract even more drunk individuals, and so increase the risk of violence and anti-social behaviour in this particular part of Green Lanes. The business directly opposite is an off license, so we already have our fair share of drunken and disorderly behaviour late at night. It does not make me feel safe if I come home late and have to pass groups of people gathering outside.

In addition, quite a few of Zam's Chicken's customers favours eating their food in their cars, engine running and music blaring, which results in yet more nuisance and noise pollution for the neighbours.

We have enough restaurants in this part of Green Lanes, we do not need another one being open late at night.

I hope you will take this objection in to consideration when making your final decision.
